

## HOUSE CONCURRENT RESOLUTION

24 source of great pride to all those associated with Everman High

1 School, and it is indeed appropriate that they receive special  
2 legislative recognition at this time; now, therefore, be it

5 basketball team on winning the 2003 UIL Class 3A state championship  
6 and extend to them sincere best wishes for continued success; and,
