1 WHEREAS, Residents of Lacy-Lakeview lost a beloved neighbor,
2 friend, and community leader with the passing of B. R. Ralston
3 "Boots" Douglas on March 12, 2003; and

4 WHEREAS, Born on April 8, 1906, Mr. Douglas married the
5 former Gladys Bell, and the couple enjoyed a rich and rewarding
6 marriage until her passing; they were blessed with two cherished
7 daughters, Cheri Jeanene Ruff and Virginia Lynn Money; and

8 WHEREAS, This esteemed community leader served as the mayor
9 of Lacy-Lakeview in 1977-1978 and as a city councilman for many
10 years; he was active with the Boy Scouts of America, Knights of
11 Columbus, and the local school board; and

12 WHEREAS, A charter member of St. Joseph's Catholic Church, he
13 gave generously of his time and talents in support of his church and
14 his fellow congregants over the years; in addition to serving as a
15 CCD teacher and lay minister, he was the only school bus driver the
16 church ever had and served many years as its maintenance man; he is
17 also credited with planting many of the pine trees that now grace
18 the church's property; and

19 WHEREAS, Mr. Douglas was a man of integrity, dedication, and
20 unwavering faith, and while he will be greatly missed, his memory
21 lives on in the hearts and minds of the many people whose lives he
22 touched; now, therefore, be it

24 hereby pay tribute to the life of B. R. "Boots" Douglas and extend
