METHODS OF FILING PROOF OF FINANCIAL RESPONSIBILITY  
FOR SUSPENSIONS RESULTING FROM CONVICTIONS

1. A certificate of motor vehicle liability insurance (Form SR-22).
2. A bond in the amount of \$15,000 signed by two persons owning real estate equal in value to at least twice the amount of such bond.
3. A certificate of deposit of money or securities with the State Treasurer in the amount of \$15,000.

METHODS OF SHOWING FINANCIAL RESPONSIBILITY  
FOR PAST ACCIDENTS

1. A motor vehicle liability insurance policy in effect at the time of the accident (Form SR-21).
2. A release from liability signed by all damaged or injured persons.
3. An agreement to pay damages in installments.
4. An adjudication of non-liability by a court of competent jurisdiction in a civil action.
5. A cash security deposit in an amount determined by the Department to be sufficient to pay any judgement for damages that might be obtained against the depositor.
