- 5 SECTION 1. Section 132.007, Local Government Code, is
- 6 amended to read as follows:
- 7 Sec. 132.007. INFORMATION, SERVICES, AND PAYMENT THROUGH
- 8 THE INTERNET. (a) A county or municipality may provide through
- 9 the Internet:
- 10 (1) access to information; [ex]
- 11 (2) collection of payments for taxes, fines, fees,
- 12 court costs, or other charges; or
- (3) other county and municipal services authorized by
- 14 <u>law</u>.
- 15 (b) A county or municipality may charge a reasonable fee for
- 16 providing access, collecting payments, or providing services [a
- 17 **cervice**] authorized by this section.
- 18 (c) A county or municipality that provides access to
- 19 information or provides services through the Internet under
- 20 Subsection (a)(1) or (3):
- 21 (1) may only charge a fee for the access or service if
- 22 <u>the fee is</u> designed to recover the costs directly and reasonably
- 23 incurred in providing the access or service; and
- 24 (2) may charge the fee only if the governing body of

- the county or municipality determines that providing access to the
- 2 information or providing the service through the Internet would not
- 3 be feasible without the imposition of the charge.
- 4 (d) A county or municipality may contract with a vendor to
- 5 provide access, collect payments, or provide services [perform a
- 6 service] authorized by Subsection (a). A vendor must promptly
- 7 submit to the county or municipality all payments collected on
- 8 behalf of the county or municipality under this section. The county
- 9 or municipality must approve any fee charged by a vendor [for a
- 10 service performed] under a contract authorized by this subsection
- 11 [section].
- 12 SECTION 2. This Act takes effect September 1, 2003.
