19	CLASSIFICATIONS. The board by rule may establish classifications						
20	of pharmacy licenses in addition to the classifications under						
21	Section 560.051 if the board determines that:						
22	(1) the practice setting will provide pharmaceutical						
23	care services to the public;						
24	(2) the existing classifications of pharmacy licenses						

- 1 are not appropriate for that practice setting; and
- 2 (3) establishment of a new classification of pharmacy
- 3 license is necessary to protect the public health, safety, and
- 4 <u>welfare.</u>
- 5 SECTION 3. Section 562.101, Occupations Code, is amended by 6 adding Subsection (g) to read as follows:
- 7 (g) For a pharmacy license classification established under
- 8 Section 560.053, the board shall adopt rules that provide for the
- 9 supervision of the pharmacy by a pharmacist. Supervision under the
- 10 board rules must require at least continuous supervision by a
- 11 pharmacist according to the needs of the pharmacy.
- 12 SECTION 4. This Act takes effect September 1, 2003.
