- [\(\frac{\(\frac{\(\beta\)}{\(\percase\)}\)] A person commits an offense if the person, during a period that a suspension of the person's vehicle registration is in effect under this chapter, knowingly permits a motor vehicle owned by the person to be operated on a highway.
  - (b) [(c)] It is an affirmative defense to prosecution under this section that the person had not received notice of a suspension order concerning the person's [driver's license, nonresident's operating privilege, or] vehicle registration. For purposes of this subsection, notice is presumed to be received if the notice was mailed in accordance with this chapter to the last known address of the person as shown by department records.
- 14 (c) [(d)] Except as provided by Subsection (d) [(e)], an offense under this section is a misdemeanor punishable by:
  - (1) a fine of not less than \$100 or more than \$500; and
- 17 (2) confinement in county jail for a term of not less 18 than 72 hours or more than six months.
- 19 (d) [(e)] If it is shown on the trial of an offense under 20 this section that the person has previously been convicted of an 21 offense under this section [or under Section 521.457], the offense 22 is punishable as a Class A misdemeanor.

S.B. No. 582 1 only to an offense committed on or after the effective date of this Act. For purposes of this section, an offense was committed before 2 3 the effective date of this Act if any element of the offense 4 occurred before that date. 5 (b) An offense committed before the effective date of this Act is covered by the law in effect when the offense was committed, 6 and the former law is continued in effect for that purpose. 7 8 SECTION 4.
