

SENATE CONCURRENT RESOLUTION

2 WHEREAS, The conference committee report for House Bill No.
3 3588 contains technical errors that should be corrected; and

4 WHEREAS, Those corrections should be made after the bill has
5 been adopted by the senate and the house of representatives and when
6 the bill is enrolled; now, therefore, be it

7 RESOLVED by the 78th Legislature of the State of Texas, That
8 the enrolling clerk of the house be instructed to correct House Bill
9 No. 3588 as follows:

10 1. On page 14, line 13, insert a comma between "property"
11 and "other".

12 2. On page 14, line 15, insert a comma between "facility"
13 and "that".

14 3. On page 14, line 18, insert "An option to purchase
15 property" between "property." and "Property" and strike
16 "Property".

17 4. On page 25, line 10, insert a comma between "chapter" and
18 "revenue".

19 5. On page 27, strike lines 3 through 16.

20 6. On page 33, line 9, strike "municipality" and insert
21 "authority".

22 7. On page 37, line 13, strike "in this state" and insert "in
23 the authority's area of jurisdiction".

24 8. Page 38, line 3, insert ", subject to the transportation

1 project being in the authority's area of jurisdiction" between
2 "department" and the period.

3 9. On page 57, strike lines 5 through 8 and on line 9, strike
4 "(c)" and insert "(b)".

5 10. On page 58, strike the sentence on line 8 of Section
6 370.163, that starts "An authority" and ends with "361.165."

7 11. On page 70, line 8, between "(j)" and "An" insert the
8 following language: "If the transportation project is a project
9 other than a public utility facility,".

10 12. On page 70, line 9, delete "other than a public utility
11 facility".

12 13. On page 70, line 10, delete "other than a public".

13 14. On page 70, line 11, delete "utility facility".

14 15. On page 122, line 23, strike "amendment" and insert
15 "section".

16 16. On page 125, line 11, strike "expand" and insert
17 "expend".

18 17. On page 149, line 14, insert "each calendar year"
19 between "collector" and "shall".

20 18. On page 149, lines 5 through 12, reinstate the deleted
21 text and on line 6, insert "and this chapter" between "Code," and
22 "is".

23 19. On page 149, line 16, insert "in the preceding calendar
24 year" between "chapter" and the period.

25 20. On page 151, line 5, insert "each calendar year" between
26 "collector" and "shall".

27 21. On page 151, line 7, insert ", in the preceding calendar

1 year" between "Code" and the period.

2 22. On page 297, strike line 26 through page 299, line 2.

3 23. On page 307, strike lines 4 through 17 and insert the
4 following:

5 "SECTION 20.02. (a) The comptroller shall establish the
6 Texas Mobility Fund debt service account as a dedicated account
7 within the general revenue fund.

8 (b) Notwithstanding Section 780.002(a) and (b), Health and
9 Safety Code, as added by this Act, of the money allocated to the
10 undedicated portion of the general revenue fund by Section
11 780.002(a), Health and Safety Code, as added by this Act, other than
12 money that may only be appropriated to the Department of Public
13 Safety, in fiscal year 2004 the comptroller shall deposit that
14 money to the credit of the Texas Mobility Fund debt service account
15 which is subject to the provisions of Subsection (d).

16 (c) Notwithstanding Section 542.4031(g)(1), Transportation
17 Code, as added by this Act, of the money allocated to the
18 undedicated portion of the general revenue fund in Section
19 542.4031(g)(1), Transportation Code, in fiscal year 2004 the
20 comptroller shall deposit that money to the credit of the Texas
21 Mobility Fund debt service account which is subject to the
22 provisions of Subsection (d).

23 (d) Funds deposited to the Texas Mobility Fund debt service
24 account pursuant to Subsections (b) and (c) may be transferred to
25 the Texas Mobility Fund upon certification by the Texas
26 Transportation Commission to the comptroller that a payment is due
27 under an obligation pursuant to Article 3, Section 49-k of the Texas

1 Constitution. Funds in the Texas Mobility Fund debt service
2 account are not appropriated in the state fiscal year ending August
3 31, 2004."

4 24. On page 307, line 26, at the end of Section 20.03, add
5 "Section 51.607, Government Code, as added by Senate Bill 325, 78th
6 Legislature, Regular Session, does not apply to court costs imposed
7 under this Act."
