THIS IS JERRY WILLIAMS AND TODAY IS DECEMBER 6, 2001. I AM INTERVIEWING MR. ALBERT H. VOSS, JR. THIS INTERVIEW IS TAKING PLACE IN FREDERICKSBURG, TEXAS. ALBERT IS HERE TO ATTEND THE 60<sup>TH</sup> ANNIVERSARY OF THE PEARL HARBOR SURVIVORS AS THEY GATHER TO CELEBRATE, OR AT LEAST TO ACKNOWLEDGE THE EVENTS THAT TOOK PLACE THAT DAY. THE INTERVIEW IS IN SUPORT OF THE NATIONAL MUSEUM OF THE PACIFIC WAR'S CENTER FOR WAR STUDIES FOR THE PRESERVATION OF HISTORICAL INFORMATION RELATED TO WORLD WAR II.

MR. VOSS, MAY I CALL YOU A.H. WHICH YOU WERE KNOWN AS IN THE NAVY AND I GUESS YOU STILL ARE TODAY, STILL GO BY A.H..

A.H.

FOR MANY YEARS AMONG NAVY PERSONNEL.

JERRY

WE WANT TO THANK YOU TAKING THE TIME OUT OF YOUR DAY WHILE YOU ARE HERE. I KNOW YOUR TIME IS LIMITED, BUT WE APPRECIATE YOU RELATING YOUR EXPERIENCES THAT YOU UNDERWENT DURING WORLD WAR II AND IN PARTICULAR AT PEARL HARBOR THAT DAY.

TO START WITH, I WOULD LIKE TO ASK YOU WHERE AND WHEN WERE YOU BORN?

A.H.

I BORN MARCH 21, 1921 IN A SOD HOUSE NEAR HEMMINGFORD, (SP???) NE., ON A HOMESTEAD. MY FOLKS WENT HOMESTEADING IN NEBRASKA. THEY RAISED POTATOS, A LOT OF POTATOS BUT NOBODY WOULD BUY THEM.

JERRY

WAS HEMMINGFORD IN WESTERN NEBRASKA?

A.H.

YES. IN THE SAND BELT.\

JERRY

OK. DO YOU RECALL WHERE YOUR PARENTS WERE BORN AND WHAT THEIR NAMES WERE? THE NAMES YOU PROBABLY REMEMBER VERY WELL.

A.H.

MY MOTHER MARGARITA ANNA (COULDN'T UNDERSTAND THE FULL NAME) FROM MINEOLA, IOWA . MY DAD WAS BORN IN COUNCIL BLUFFS, IOWA. WE ACTUALLY HAD TWO FAMILIES. THE OLDER FAMILY WERE THE FOUR OF US KIDS AND THE YOUNGER FAMILY HAD FOUR MORE KIDS. WE HAD TWO FAMILIES BY THE TIME I JOINED THE NAVY.

JERRY

YOU HAD 7 OR 8 BROTHERS AND SISTERS?

A.H.

I DON'T RECALL THE EXACT NUMBER.

JERRY

IT WAS A LARGE FAMILY, OF COURSE, THEY WERE LARGE IN THOSE DAYS.

A.H.

AN INTERESTING THING; I HAD PNUEMONIA WHEN I WAS AN INFANT. THEY THOUGHT I WAS GOING TO DIE, SO MY FATHER BAPTIZED ME. HE BAPTIZED ME BECAUSE HE THOUGHT I WAS GOING TO DIE.

**JERRY** 

AND HE DID THAT AS A LAY PERSON?

A.H.

AS A LAY PERSON; INTERESTING.

**JERRY** 

THAT IS INTERESTING.

A.H.

I THOUGHT THAT WAS INTERESTING, I THOUGHT I WOULD TOSS THAT IN THERE.

**JERRY** 

WERE YOU THE OLDEST OF YOUR SIBLINGS?

A.H.

NO, I WAS THE THIRD CHILD. I HAD TWO OLDER SISTERS AND I WAS THE FIRST BOY.

JERRY

DO YOU RMEMBER THE NAMES AND AGES OF YOUR BROTHERS AND SISTERS?

A.H.

OH YEAH. MY OLDEST SISTER DIED. HER NAME WAS ELIZABETH, ISABELL ACTUALLY. WE CALLED HER IZZIE. SHE WAS BORN ON THE 4<sup>TH</sup> OF JULY, BY THE WAY. MY OTHER SISTER'S NAME WAS DOROTHY AND SHE WAS BORN ON ST. PATRICK'S DAY. MY OTHER SISTER'S NAME WAS ????? DOROTHY AND SHE WAS BORN ON ST. PATRICK'S DAY AND I WAS BORN THE FIRST DAY OF

SPRING, THE  $21^{ST}$ . (NAME UNCLEAR) AND SHE WAS BORN ON APRIL  $24^{TH}$ . SHE IS STILL ALIVE AND WE VISIT IN NEVADA. HE WAS IN THE NAVY ALSO. HE ENDED UP ????? IN NEVADA AT AN AIR FORCE BASE.

**JERRY** 

WAS HE THE ONLY BROTHER OR SISTER THAT SERVED?

A.H.

YES. HE WAS PART OF THE OLDER FAMILY. I HAD YOUNGER SIBLINGS. DON'T ASK ME ABOUT THEM. I'LL GET IT ALL SCREWED UP.

JERRY

SHARE WITH US IF YOU WILL WHERE YOU WENT TO SCHOOL.

A.H.

I STARTED SCHOOL IN HENNINGFORD , NEBRASKA AND STARTED IN THE  $1^{\rm ST}$  GRADE. WE DIDN'T HAVE ANY KINDERGARDEN. ON THEN I CAN REMEMBER, BUTTONING A LITTLE GIRL'S COAT AND I WAS MADLY IN LOVE WITH HER IN THE  $1^{\rm ST}$  GRADE. THEN, WE WENT TO COUNCIL BLUFFS, IOWA AND I WENT TO ??????? SCHOOL IN COUNCIL BLUFFS THROUGH THE SEVENTH GRADE. THEN, THEY DIDN'T HAVE ANY FACILITIES FOR  $8^{\rm TH}$  GRADE SO THEY SENT US TO THOMAS JEFFERSON HIGH SCHOOL TO GO TO THE  $8^{\rm TH}$  GRADE. I WENT TO THOMAS JEFFERSON HIGH SCHOOL IN THE  $9^{\rm TH}$  GRADE AND I GRADUATED FROM ABRAHAM LINCOLN HIGH SCHOOL FROM THE  $10^{\rm TH}$  TO THE  $12^{\rm TH}$  GRADE.

**JERRY** 

YOU HAVE EXCELLENT RECALL. YOU REALLY DO.

A.H.

I DIDN'T DO TOO BAD THEN.

JERRY

THAT'S GOOD. WHEN YOU MOVED TO COUNCIL BLUFFS, DID THAT HAVE ANYTHING TO DO WITH THE DEPRESSION?

A.H.

OH YEAH. THAT'S WHERE THE JOBS WERE. I GRADUATED IN '38. I COULDN'T FIND A JOB OF COURSE IN THE DEPRESSION TIMES. I THINK I FOUND ONE JOB WHERE I GOT PAID 50 CENTS AN HOUR. 50 CENTS AN HOUR WAS A HUGE AMOUNT OF MONEY. IT DOESN'T SEEM LIKE THAT BUT IT WAS. I DECIDED I MIGHT JOIN THE NAVY I WENT DOWN TO SEE IF I COULD GET IN THE

NAVY. WE HAD AN OLD FURNACE IN THE HOUSE. WE BURNED TIES. WE COULDN'T AFFORD COAL OR ANYTHING BUT THERE WERE A LOT OF OLD RAILROAD TIES AROUND THAT WE COULD GET. WE GOT THOSE TIES AND CUT THEM UP AND BURNED THEM IN THE FURNACE. I DROPPED ONE OF THOSE TIES ON MY TOE. I DIN'T BREAK IT BUT I SMASHED IT PRETTY BADLY AND I WAS AFRAID THEY WOULDN'T LET ME IN THE SERVICE BECAUSE OF MY SMASHED TOE. THEY LET ME GO AHEAD. I JOINED THE NAVY WHEN I WAS SEVENTEEN. I GOT IN ON WHAT THEY CALLED A "SCIVVY CRUISE". WHEN I REACHED THE AGE OF 21, I WAS SUPPOSED TO GET OUT. I REALLY INTENDED TO STAY 20 YEARS BECAUSE GUYS THAT RETIRED FROM THE NAVY WERE GETTING \$200 A MONTH RETIREMENT PAY. THAT WAS AN UNHEARD OF SUM OF MONEY IN THOSE DAYS. ON \$200 A MONTH, YOU COULD LIVE LIKE A KING. THAT WAS MY INTENTION WHEN I JOINED THE NAVY.

## **JERRY**

HOW DID YOU HAPPEN TO SELECT THE NAVY AS OPPOSED TO ARMY AT THAT TIME.

A.H.

I HAVE NO IDEA. NO RECOLECTION EXCEPT THAT I CHOSE. I JUST DID.

# **JERRY**

THE REASON THAT SOMETIMES THAT QUESTION IS INTERESTING, AND I KNOW THAT THE NAVY DOES HAVE SOME VERY SUCCESSFUL RECRUITING PROGRAMS OUT OF THE MIDWEST, I THINK EVEN TODAY, BUT WHY ALL THESE LAND LOCKED PEOPLE OUT OF THE MIDWEST, A GREAT MANY OF THEM END UP JOINING THE NAVY.

A.H.

A LOT OF THEM WAS THE GRAMMER THEY ASSOCIATED WITH THE NAVY, AND MOVIES OF COURSE. THE GUYS WERE ALWAYS SEEN DANCING WITH ALL THESE PRETTY GIRLS. I THOUGHT, THAT LOOKS LIKE FUN. SING AND DANCE WITH THOSE PRETTYY GIRLS ON A BATTLESHIP, THAT WOULD BE GREAT. IT WAS KIND OF A MISLEADING THING TO DO.

# JERRY

THEY ACTUALLY DIDN'T (GARBLED) SHOW ME THE CONCEPT OF THIS "SCIVVY CREW". THAT IS A NEW CONCEPT FOR ME.

A.H.

THEY FIGURED THAT WHEN YOU REACHED THE AGE OF 21. YOU GET OUT.

JERRY

THAT WAS YOUR CONTRACT WITH THE NAVY.

A.H.

I DON'T KNOW IF THEY STILL DO IT THAT WAY OR NOT. IF YOU WENT IN AT 17, YOU GOT OUT AT 21. YOU DIDN'T HAVE TO PUT IN 4 YEARS.

JERRY

WHEN YOU SIGNED UP WITH THE NAVY, WHERE DID YOU GO FOR BASIC? WHAT HAPPENED AT THAT JUNCTURE?

A.H.

WE WENT TO GREAT LAKES TRAINING STATION. I STLLL HAVE A LOT OF BROCHURES FROM GREAT LAKES. THEY PUT OUT A NEWSPAPER OR A PRINTED FORM. I STILL HAVE A NUMBER OF THEM LEFT; WHAT WAS HAPPENING AND THAT SORT OF THING. GREAT LAKES OF COURSE WAS THE BIGGEST LAKE I HAD EVER SEEN. I THOUGHT THAT WAS AMAZING, THE SIZE OF THAT LAKE. THEY TOLD US HOW TO ROW A BOAT AND THAT SORT OF THING. WE SLEPT IN HAMMOCKS. THERE WAS A LITTLE PLATFORM YOU USED TO GET INTO YOUR HAMMOCK. OF COURSE, GUYS WOULD FALL OUT OF THOSE HAMMOCKS. WE HAD QUITE A TIME AN INTERESTING THING IS THAT THE FIRST CHRISTMAS EVE AT THE NAVAL TRAINING STATION.

JERRY

THIS WOULD HAVE BEEN CHRISTMAS EVE IN 1938?

A.H.

1938, YES. THEY PUT ME ON GUARD IN THE HEAD, WHICH IS THE TOILET. I HAD NO IDEA WHY THEY HAD ME IN THERE. I THOUGHT THAT WAS REALLY INTERESTING. I SPENT MY FIRST CHRISTMAS DUTY ON GUARD IN THE TOILET. SOMETHING TO WRITE HOME ABOUT. I STILL HAVE A MENU THAT THEY PUT OUT FOR THE CHRISTMAS DINNER WE HAD. I HAVE THAT MENU AT HOME. IT WAS VERY IMPRESSIVE.

JERRY

PRETTY GOOD FOOD?

A.H.

THERE WAS A LOT OF IT. IT WAS THE WHOLE TRADITIONAL FEAST. I DON'T KNOW THAT I WAS ALL THAT IMPRESSED BUT THE DINNER WAS PRETTY NICE. AS I SAY I STILL HAVE (THE MENU), IT WAS PRETTY INTERESTING.

AT BASIC, WHERE YOU DID YOUR BASIC AT GREAT LAKES BUT THAT WAS ESSENTIALLY MARCHING?

A.H.

YEAH. THE THING THAT WAS INTERESTING THERE WAS THAT I HAD HAD ROTC IN HIGH SCHOOL AND I KNEW ALL THE COMMANDS AND ALL THAT SORT OF STUFF AND I WANTED TO BE A PETTY OFFICER. THEY HAD PETTY OFFICER RATINGS FOR THE GUYS WHO GOT TO LEAD THE PARADES AND THAT SORT OF THING AND I FIGURED I SHOULD BE ONE OF THOSE BECAUSE I KNEW ALL THE PRIMARY THINGS. I PUT ON KP AND WHILE THEY WERE DOING ALL THIS STUFF AND PUTTING OUT ALL THESE RATINGS, I WASN'T AVAILABLE SO I DID KNOW ABOUT THAT. EVENTUALLY, I ENDED UP WITH A FIRST CLASS BOOT CAMP PETTY OFFICER RATING. I ALWAYS FIGURED THAT WAS KIND OF NASTY BECAUSE I HAD TO DO THAT KP DUTY.

JERRY

DIDN'T EVERYBODY AT SOME POINT HAVE TO DO SOME KP DUTY?

A.H.

NOT EVERYBODY. IF YOUR NAME IS DRAWN, YOU DID IT. THAT'S THE WAY IT WAS.

**JERRY** 

WHAT WAS BOOT CAMP LIFE LIKE GENERALLY? WAS IT REALLY TOUGH IN THOSE DAYS? A.H.

WE WERE A BUNCH OF YOUNG KIDS. WE HAD TO LEARN TO SCRUB OUR OWN SCIVVIES AND THAT SORT OF THING. I LEARNED A LOT OF NASTY SONGS WE SANG. IT WAS A GROWING UP EXPERIENCE.

JERRY

DID YOU ESTABLISH ANY RELATIONSHIPS, FRIENDSHPS?

A.H.

NO. ONE OF THE KIDS FROM COUNCIL BLUFFS, I HAVE A PICTURE OF HE AND I TOGETHER IN BOOT CAMP. THEY PUT THAT PICTURE IN ONE OF THE LOCAL NEWSPAPERS ONE TIME. HIS NAME WAS FIELDS BUT I NEVER DID SEE HIM AFTER BOOT CAMP. I HAVE BOOT CAMP PICTURE AND I HAD A PICTURE OF ONE GUY SITTING THERE AND HIS NAME WAS GROBBS AND THAT IS ALL I CAN REMEMBER ABOUT HIM. I CAN'T REMEMBER THE CHIEF THAT WAS IN CHARGE OF OUR COMPANY WAS A QUARTERMASTER, BUT I CAN'T REMEMBER HIS NAME.

**JERRY** 

YOU WERE IN BOOT CAMP FOR WHAT? 4 MONTHS?

A.H.

YES.

JERRY

FROM THERE WHEN YOU GRADUATED FROM BOOT CAMP?

A.H.

IF YOU WERE INTELLIGNET ENOUGH, AND MADE THE RIGHT KINDS OF GRADES, YOU GOT SHIPPED TO A SCHOOL. I GOT SHIPPED TO A RADIO SIGNALLING SCHOOL IN SAN DIEGO. THAT'S WHERE I LEARNED CODE. ANYBODY THAT LEARNED THE CODE; IF YOU ARE PROFICIENT AT LEARNING THE CODE, YOU BECAME A RADIOMAN. IF YOU WEREN'T QUITE PROFICIENT, YOU BECAME A SIGNALMAN. WE HAD TO LEARN THE SEMAPHORE AND THE CODE. KEYING IN THE CODE WAS NOT NEARLY AS IMPORTANT AS THE COPYING THE CODE. HERE AGAIN, WE DIDN'T USE A STICK. WE DIDN'T WRITE THE CODE DOWN WITH A PENCIL. WE USED A TYPEWRITER. YOU HAVE TO BE VERY, VERY FAST.

#### JERRY

WHAT WAS IT LIKE FOR YOU AS A MIDWESTERNER, AFTER SPENDING A COLD WINTER IN CHICAGO, THEN GOING TO SAN DIEGO TO SIGNALMAN SCHOOL?

A.H.

IT WAS DIFFERENT. I WAS YOUNG. I WAS A YOUNG KID. IT WAS A DIFFERENT EXPERIENCE. I THINK I GOT A BIT HOMESICK NOT AT THAT PARTICULAR MOMENT. WE GOT TO GO HOME ON LEAVE, BY THE WAY, FROM BOOT CAMP. MY DAD GAVE ME A DOLLAR BILL. I'LL NEVER FORGET THAT. HE GAVE ME A DOLLAR BILL TO SPEND ANYWAY I WANTED. I WAS MAKING 21 DOLLARS A MONTH. I WAS MAKING MORE MONEY THAN HE WAS. I GAVE HIM BACK HIS DOLLAR. I GOT 21 DOLLARS A DAY, ONCE A MONTH.

**JERRY** 

OF COURSE YOU HAD ALL YOU MEALS.

A.H.

THAT WAS SPENDING MONEY, PRETTY MUCH. IT WENT A LONG WAY.

JERRY

IN SIGNALMANS SCHOOL, HOW LONG DID IT LAST?

A.H.

I DON'T REMEMBER, I REALLY DON'T,

WAS IT A YEAR OR LESS THAN THAT?

A. H.

OH. WAY LESS THAN THAT.

JERRY

MAYBE SIX MONTH?

A.H.

I REALLY DON'T REMEMBER. I GOT SICK AND SPENT SOME TIME IN THE HOSPITAL AND THAT SCREWED UP MY RADIO SCHOOL A LITTLE BIT. ALL I REMEMBER IS BEING SICK.

JERRY

AFTER RADIO SCHOOL, OBVIOUSLY YOU CONTINUED THAT.

A.H.

AFTER RADIO SCHOOL, I WAS ASSIGNED TO COMMANDER, BATTLESHIPS, BATTLE FORCES. THE FLAGSHIP WAS THE *USS WEST VIRGINIA* AND I WAS ASSIGNED TO THAT. AT THAT TIME, IT WAS UP IN SAN FRANSISCO.I WAS IN SAN DIEGO. THAY PUT ALL OF US TROOPS ABOARD AN AIRCRAFT CARRIER. I DON'T REMEMBER WHICH ONE IT WAS. IT WAS EITHER THE *LEXINGTON* OR THE *YORKTOWN*. THOSE TWO SHPS WERE VERY INTERESTING TOO. THEIR KEELS WERE LAID DOWN TO BE CRUISERS. THEY DECIDED THEY NEEDED CARRIERS. THIS WAS WAY BACK WHEN. THEY HAD A LOT OF MOVEMENT TO THEM WHEN THEY WENT TO SEA. ALL THE PLANES WERE ON THE HANGER DECK, LINED UP TWO ROWS APART. EVERYBODYS IS LINED UP LIKE TWO ROWS APART. I DIDN'T UNDERSTAND WHAT WAS GOING ON. A GUY STANDING CLOSE TO ME SAID, "YOU KNOW, THESE GUYS ARE ALL GETTING SEASICK. THE THING FOR US TO DO IS TO GO OUT AND GET SOME FRESH AIR." WE GOT UP AND GOT SOME FRESH AIR AND WENT UP TO THE GUN EMPLACEMENT ALONGSIDE THE FLIGHT DECK. IF YOU HAD A HORIZON TO KEEP YOUR EYES ON, YOU DIDN'T FEEL ANY MOTION. (SECTION UNINTELLIGIBLE)

JERRY

IT JUST LASTED A DAY OR TWO?

A.H.

WHEN WE GOT TO SAN FRANSISCO, THE WEST VIRGINIA WAS IN DRY DOCK. THE ADMIRAL CHANGED HIS FLAG TO THE USS NEW MEXICO. I SPENT TIME ON THE USS NEW MEXICO. I SLEPT IN A HAMMOCK, EVERY MOIRNING IT WAS HEAVE OUT AND LASH UP. THAT MEANT, GET OUT OF YOU HAMMOCKS AND LASH IT UP, TIE IT TOGETHER, TAKE IT UP TO THE HAMMOCK LOCKER.

THIS WAS A RITUAL. THE BIG SHOTS AMONG THE ENLISTED PERSONNEL, HAD COTS AND MATRESSES. THEY HAD TO ROLL UP THEIR MATTRESSES.

#### JERRY

THIS WAS THE SENIOR RATED THAT HAD THE COTS.

A.H.

IF YOU SEE THE MOVIE, "PEARL HARBOR", YOU WILL SEE GUYS IN BUNKS AND THAT WASN'T THE WAY IT WAS. WE DIDN'T HAVE BUNKS. YOU WILL SEE SOME AUTOMATIC WEAPONS TOO IN THAT MOVIE. THERE WEREN'T ANY AUTOMATIC WEAPONS AT THAT POINT IN TIME, NOT AT PEARL HARBOR. ANOTHER THING, WHEN THE *OKLAHOMA* ROLLS OVER, YOU SEE ALL THESE SAILORS SLIDING DOWN THE FOC'SAL. NO SAILOR WAS EVER ASSIGNED TO THE FOC'SAL DECK AS A BATTLE STATION. THESE GUYS JUST WOULDN'T BE THERE SLIDING DOWN TO THE WATER. IT IS JUST ONE OF THOSE THINGS.

#### JERRY

DRAMATIZATION FOR HOLLYWOOD. YOU ARE ABOARD THE NEW MEXICO NOW? WHEN THE WEST VIRGINIA CAME OUT OF DRY DOCK, YOU WENT BACK TO THE WEST VIRGINIA. WHEN DID THE WEST VIRGINIA DEPLOY? DO YOU REMEMBER AN APPROXIMATE TIME?

#### A.H.

I DON'T REMEMBER. I HAVE MY NAVY RECORDS BY THE WAY AND IT DOESNT FILL ALL THIS STUFF IN. IT'S PRETTY CLOSE. WE ENDED UP AROUND BEACH HARBOR WITH THE BATTLESHIP ANCHORED AND WE WOULD GO OUT AND BOMBARD SAN CLEMENTE ISLAND FOR GUNNERY PRACTICE. THE FIRST TIME I EVER SAW 16 INCH SHELLS FLYING THROUGH THE AIR WAS WHEN WE WERE PRACTICING IN SAN CLEMENTE HARBOR, YOU COULD ACTUALLY SEE THOSE SHELLS FLYING THROUGH THE AIR. I SAID, "THAT'S A BUNCH OF MALARKEY." HE SAID, "OH NO, YOU CAN." I SAID, "WELL, I'D LIKE TO SEE THAT." HE SAID, "I'LL FIX THAT UP. WE COULD GO UP TO MY BATTLE STATION ON TOP DECK." THEY FIRED A 16 INCH ROUND. THE FIRST ROUND JUST SCARED THE FOOL OUT OF ME. I COULDN'T ANY MORE SEE THE SHELL THAN THE MAN IN THE MOON. HE SAID, "THEY ARE GOING TO FIRE AGAIN AND NEXT TIME, YOU WATCH AND COVER YOUR EARS." WE DID THAT AND SURE ENOUGH YOU COULD SEE THE SHELL FLYING THROUGH THE AIR. ONE OF THE THINGS THEY TOLD US IN BOOT CAMP WAS THAT BATTLESHIPS CAN'T BE SUNK. THEY ARE UNSICKABLE BECAUSE THEY HAVE ALL THIS ARMOR PLATING ALL THIS WATER TIGHT INTEGRITY. I THINK I COULD PROBABLY SUE THE NAVY FOR PEARL HARBOR ?????? 'CAUSE THEY WEREN'T REALLY TELLING ME THE TRUTH. THEY KIND OF LIED TO ME

UNTIL PEARL HARBOR, I DON'T KNOW THAT ANY OF THEM HAD BEEN SUNK.

A.H.

WE ARE BACK IN THE TIME FRAME OF 1940 OR SO, AFTER BOOT CAMP AND RADIOMANS SCHOOL.

A.H.

IN 1939 IS WHEN THE FLEET WENT TO PEARL. THE BATTELSHIP FLEET SAILED OUT OF LONG BEACH FOR PEARL HARBOR.

JERRY'

THAT WAS STILL IN 1939?

A. H.

THAT'S WHEN WE CROSSED THE EQUATOR. I HAVE A BOOK ABOUT US GOING ACROSS THE EQUATOR, FROM POLYWOG TO ??????.

CAPT. ALEXANDER WAS THE CHIEF EXECUTIVE OFFICER ON THE WEST VIRGINIA. THAT WAS SOMETHING ELSE AGAIN.

**JERRY** 

BETWEEN THE TIME THEN THAT YOU LEFT LONG BEACH AND THEY MOVED THE FLEET TO PEARL, WERE THERE ANY INTERESTING STORIES THAT YOU WANT TO SHARE OR FEEL WORTHY OF SHARING CONCERNING THE TRAINING THAT YOU RECEIVED?

A.H.

I'LL TELL YOU THIS. EVERYTHING WAS ??????? THE CHIEF RADIOMAN, CHIEF RHINEHARD WAS CHIEF RADIOMAN IN CHARGE OF FLAG RADIO DIVISION AND HE WANTED EVERYBODY TO BE ABLE TO COPY PRESS. WCX, 30 JS, PRESS WIRELESS SENT OUT PRESS BULLITENS EVERY SO OFTEN ON A REGULAR SCHEDULED BASIS AND THESE MESSAGES WERE SENT OUT ABOUT 45-50 WORDS A MINUTE IF YOU CAN IMAGINE THAT. HE WANTED EVERYBODY TO BE ABLE TO COPY PRESS. WHEN WE WERE OFF DUTY AND DOWN IN THE RADIO SHACK, NOT BEING PRESSED OR

WHATEVER, HE COULD FIND IF IT WAS HIGH SPEED. WE GOT SO WE COULD COPY PRESS. KGN-6 AND 7 SENT OUT EQUALLY AS FAST, LIKE WCX AND JS. WE PUT OUT A NEWSPAPER EVERY DAY.

JERRY

HOW MANY SIGNALMEN WERE ABOARD THE BATTLESHIP?

A.H.

HOW MANY SIGNALMEN WERE THERE? I DON'T KNOW.

JERRY

I MEANT IN THE RADIO GANG?

A.H.

THERE WERE ABOUT 35 OR 40 OF US I WOULD SAY. I HAVE A WHOLE LIST OF THE GUYS THAT WERE ABOARD THE WEST VIRGINIA THAT WERE IN THERE AT PEARL. I'VE GOT THAT BOOK.

**JERRY** 

WHAT KIND OF WATCHES DID YOU STAND USUALLY?

A.H.

WE WOULD STAND A WATCH FROM BREAKFAST TO LUNCH AND ANOTHER ONE FROM LUNCH TO DINNER, THEN FROM DINNER TO MIDNIGHT, AND FROM MIDNIGHT TO BREAKFAST. THE MID-WATCH, FROM MIDNIGHT TO BREAKFAST WAS THE LOUSY WATCH. YOU HAD TO TAKE YOUR TURN. IT WAS ALL ROTATED. WE GOT STUFF TO EAT ON THE MID-WATCH. (GARBELED) BECAUSE WE WERE SUPPOSED TO BE CRAZY. IF WE WEREN'T CRAZY, WE WOULDN'T BE ABLE TO COPY THAT STUPID CODE. WE GOT VIENNA SAUSAGES AND SALMON AND COFFEE BY THE BARREL.

IF THE BRIG WASN'T BEING UTILIZED, THE MIDNIGHT WATCH GOT TO SLEEP IN THE BRIG.

JERRY

THEY ROTATED THE WATCHES?

A.H.

YOU WERE ASSIGNED TO A PARTICULAR WATCH. THERE WAS MORE TO IT THAN THAT.

**JERRY** 

I WOULD LIKE FOR YOU TO TALK A LITTLE BIT MORE ABOUT THE JOB YOU DID. AFTER A BIT WE ARE GOING TO TALK ABOUT THE EXPERIENCES AT PEARL HARBOR. YOUR RECOLLECTIONS FROM THAT IN PARTICULAR. ANY COMMENTS THAT YOU MIGHT WANT TO MAKE ABOUT-----

A.H.

I'LL TELL YOU THIS. WE WERE BEING TRAINED TO FIGHT WORLD WAR I. THERE IS JUST NO TWO WAYS ABOUT IT. THE CHIEF WANTED US TO MEMORIZE ALL OF THE CALL SIGNS OF ALL OF THE BATTLESHIPS BECAUSE WE WERE COMMANDER BATTLESHIPS BATTLE FORCE. (SECTION GARBLED) EACH BATTLESHIP HAD A FOUR LETTER CALL SIGN. ALL THE SHIPS HAD A FOUR LETTER CALL SIGN BUT THESE WERE THE BATTLESHIPS. WE WERE SUPPOSED TO KNOW THE FOUR LETTER CALL SIGN OF EACH BATTLESHIP. THE WEST VIRGINIA WAS NEDJ DAH DAH DIT, DAH DAH. THE OKLAHOMA WAS NADN. I THINK THE ARIZONA WAS NACD BUT I'M NOT SURE ANY MORE. SOME OF THEM ESCAPE ME. THE NEW MEXICO WAS NEDN. CALIFORNIA WAS NAFT. IT'S A REALLY FUNNY CALL SIGN BECAUSE IT GOES (CODE SOUND).

#### **JERRY**

YOU COULD PUT IT TO MUSIC. ANY EXERCISES OR TRAINING ASSIGNMENTS THAT YOU REMEMBER IN PARTICULAR?

#### A.H.

LIKE I SAY, WE WERE A LITTLE BIT DIFFERENT THAN THE REST OF THE CREW. WE HAD AN ENSIGN COME ABOARD, I DON'T REMEMBER WHICH SHIP I WAS ON AT THE TIME BUT, HE CAME ABOARD AND HE WAS GOING TO MAKE US ALL GUNG HO SAILORS AND HE WAS GOING TO MAKE US ALL STRONG. HE TRIED TO MAKE US DO EXERCISES. IT NEVER DID WORK. WE NEVER DID. WE GOT OUT OF EVERYTHING. WHEN THE SMOKING LAMP WAS OUT, (GARBLED)

WHEN WE LOADED AMMUNITION ABOARD, THE SMOKING LAMP WOULD BE OUT, YOU COULD GO DOWN TO MAIN RADIO AND STILL HAVE A CIGARETTE. THINGS LIKE THAT ACTUALLY TRANSPIRED. AS DUTY GOES, WE HAD IT PRETTY SOFT. WHEN YOU CONQUER THE CODE, IT DOES SOMETHING TO YOU, I DON'T KNOW WHAT IT IS.

#### JERRY

THEY TOOK GOOD CARE OF YOU THOUGH?

A.H.

YEAH. ONE OF THE THINGS, AFTER THE CHIEF GOT ON ME ALL THE TIME BECAUSE WE WERE SO SLOW. LOOKING BACK ON IT, I THINK HE WAS SO PROUD OF US..MY GOAL IN LIFE AT THAT PARTICULAR MOMENT WAS TO BE ABLE TO DRINK COFFEE, SMOKE A CIGAR, TALK IN CODE AND TALK TO SOMEBODY, ALL AT ONCE. YOU WERE SUPPOSED TO BE ABLE TO DO THESE THINGS, YOU CAN DO IT.

# **JERRY**

YOU DID IT. IT'S AMAZING.

A.H.

YOU HAVE TO WORK AT IT.

**JERRY** 

I IMAGINE YOU HAVE TO WORK A LOT AT IT.

A.H.

IT GETS A LITTLE SCREWED UP. I'VE BEEN SCREWED UP EVER SINCE.

**JERRY** 

TALK TO US ABOUT THE SITUATION AND I DON'T KNOW HOW MANY DAYS YOU MADE OUT OF PORT ON DEPLOYMENT. LEAD US UP TO THE DAY AND TELL US WHAT YOU WERE DOING. SHARE WITH US THE EXPERIENCES AS YOU REMEMBER THEM.

A.H.

WE HAD A LOT OF PRACTICE RUNS. WE PULLED SLEDS AND THE DIVE BOMBERS WOULD DIVE BOMB THE SLEDS AND THAT SORT OF THING. AIRCRAFT WOULD PULL SLEEVES AND WE WOULD FIRE ANTI-AIRCRAFT GUNS AT THEM. THOSE WERE 5 INCH DUAL PURPOSE ANTI-AIRCRAFT GUNS. THEY WERE THE BIG SHELLS. EVENTUALLY, SHORTLY BEFORE PEARL, WE HAD SOME 3 INCH GUNS MOUNTED ON EITHER SIDE OF THE BRIDGE. THEY MAKE A REAL SHARP CRACK, I'LL TELL YOU THAT. THAT WAS IT. WE DIDN'T HAVE ANY AUTOMATIC WEAPONS TO SPEAK OF. THEY HAD MACHINE GUNS BUT THEY WERE NEVER MOUNTED AND NOBODY EVER THOUGHT OF USING THEM. I MET A GUY JUST TODAY THAT WAS ON A SHIP THAT HAD 1.1 SEMI AUTOMATIC GUN. THERE WERE 4 SHELLS, THEY PUT THEM DOWN AND THEY WENT FUMM, FUMM, FUMM. THEN THEY PUT IN ANOTHER ROUND. THEY WENT OFF DURING PEARL. I THOUGHT THOSE GUYS ARE REALLY GOING TO DO SOMETHING. THAT WAS THE AUTOMATIC WEAPON. I GUESS THEY GOT A COUPLE OF MACHINE GUNS WORKING BUT I DID NEVER KNOW THAT.

JERRY

WHERE WERE YOU THAT DAY? WHAT HAPPENED?

A.H.

I'LL TELL YOU QUITE FRANKLY. I HAD LIBERTY THAT DAY. I COULD HAVE BEEN ASHORE. I WAS TIRED. I HAD 32 DOLLARS, WHICH WAS A LOT OF MONEY. I DIDN'T KNOW WHETHER I WOULD GO ASHORE AND BLOW IT IN ????? SOMEWHERE OR IF I SHOULD SAVE IT AND SEND IT HOME FOR THE KIDS FOR CHRISTMAS. I OPTED TO DO THAT. I WAS GOING TO SEND IT HOME FOR CHRISTMAS. NEVER DID GET MY \$32 BY THE WAY. IT WAS SUNK. NAVY, YOU OWE ME \$32.

WE WERE IN OUR LIVING COMPARTMENT, WHICH IS DOWN JUST ABOUT WATER LINE OR BELOW WATER LINE. POWER STATION WAS ON FLIGHT RADIO THREE, WHICH IS WAY UP HIGH. IT

IS ON THE BRIDGE WHERE THE ADMIRAL HAD HIS CHAIR. THEY SOUNDED GENERAL QUARTERS. I THOUGHT, THAT'S STUPID TO SOUND GENERAL QUARTERS ON SUNDAY. THEY ARE REALLY PRACTICING SCREWY TODAY, WE LEFT FOR THE BRIDGE. AS WE WERE RUNNING ACROSS THE FOC'SAL TO GET TO A LADDER TO GO UP TO THE BRIDGE. THERE WERE TWO ONE DOLLAR BILLS LAYING ON THE FOC'SAL AND WE BOTH PAUSED SIMULTANOUSLY TO SEE. NEITHER ONE OF US PICKED UP THE DOLLAR BILL. TO MY KNOWLEDGE. IT WERE STILL THERE WHEN THE BLITZ WAS OVER. I'M NOT SURE. WE WENT UP TO OUR BATTLE STATIONS. HE WENT ONE WAY AND I ANOTHER. I GOT UP TO THE BRIDGE, ????? RADIO AND THERE WAS A TIE BACK ON THE DOOR. THIS IS A METAL DOOR UP ON THE BRIDGE. WE WERE ALL SET FOR AN INSPECTION SO NOBODY WOULD GO IN THERE AND MESS THINGS UP. YOU HAVE TO REMEMBER THIS WAS DURING DEPRESSION DAYS. WE DIDN'T HAVE ENOUGH TYPEWRITERS TO GO AROUND TO ALL THE POSITIONS. WHENEVER FLAG RADIO WAS MANNED, A YOEMAN WAS ASSIGNED TO CARRY FROM MAIN RADIO ALL THE WAY UP TO THE BRIDGE. HIS NAME WAS GRISSINGER BY THE WAY. TWO OF US GUYS HAD GONE UP TO THE BRIDGE TO MAN FLAG RADIO. I BANGED AGAINST THE STEEL DOOR WITH MY LEFT SHOULDER. I STILL HAVE ARTHRITIS IN THAT--- THAT'S ANOTHER THING THE NAVY, ARTHRITIS IN MY LEFT SHOULDER. I BANGED INTO THAT STEEL DOOR. THAT WAS THE MOST STUPID THING I COULD DO. SURE ENOUGH. HERE CAME GRISSINGER CARRYING THE TYPEWRITER AND THE KEY TO THE TIE BACK. HE OPENED THE TIE BACK AND WENT INTO THE RADIO. PUT ON OUR HEADSETS AND I CALLED----WE HAD A COMMUNICATIONS BUZZER BETWEEN FLAG RADIO AND ???? WE HAD SOUND PHONES BETWEEN THE TWO. WE HAD A SOUND POWER PHONE AND I GOT ON THE PHONE. I CALLED MAIN RADIO WHICH WAS MR (CODE SOUNDS). THERE WAS AN INTERCHANGE BETWEEN MAIN RADIO AND BRIDGE RADIO. MAIN RADIO INFORMED BRIDGE RADIO THAT THEY WERE ABANDONING SHIP. WE DIDN'T HAVE ANYTHING TO DO SO WE GOT TO WATCH THE WHOLE SHOW.

ONCE IN A WHILE WE WOULD GO INTO THE CONNING TOWER. THE CONNING TOWER WAS THE HUGE EDIFICE ABOARD SHIP THAT HAS 14 INCH ARMOR PLATING ALL AROUND IT AND IT HAD THESE LITTLE APPETURES THAT YOU COULD SEE THROUGH. I SPENT SOME TIME IN THERE. CHIEF RADIOMAN RHINEHARDT. WE HAD TWO CHIEFS. CHIEF RADIOMAN REEVES WAS THE LEADING CHIEF BECAUSE HE HAD MORE TIME IN THAN RHINEHARDT. RHINEHARDT WAS WITH ADM. POWELL ?????? WHEN HE WAS COMMANDER OF BATTLESHIP BATTLE FORCE. REEVES WAS WITH COMMANDER BATTLE FORCE BEFORE COMMANDER BATTLE FORCE WENT ON TO SOME OTHERE DUTY. HE (TRANSCRIBER IS NOT SURE WHO HE IS) WAS KILLED. HE RECEIVED THE MEDAL OF HONOR POSTHUMASLY. RHINEHARDT DECIDED HE WOULD KEEP ALL THE RADIOMEN PERSONNEL TOGETHER AND WE WOULD GO OUT AND COMMANDEER ANOTHER VESSAL AND ADMIRAL ????? WOULD PROBABLY (UNABLE TO UNDERSTAND)

WE GOT IN THE ADRMIRAL'S BARGE AND WENT OVER TO FORD ISLAND. WE WERE THERE FOR JUST A SHORT TIME. I REMEMBER ONE GUY WE PULLED OUT OF THE WATER. HE HAD A

BLISTER THE SIZE OF A DINNER PLATE ON HIS BACK. I HELPED HIM UP THE LADDER. HE SAID, "DON'T WORRY ABOUT ME. BUT THE GUY BEHIND ME." A LOT OF THINGS LIKE THAT HAPPENED. I CAN'T REMEMBER NAMES OF THE GUYS, BUT THESE TWO RADIOMEN WERE BOTH FROM THE SAME TOWN. ONE WAS FROM THE HIGH SOCIAL END OF TOWN AND THE OTHER WAS FROM THE OTHER SIDE OF THE TRACKS. THE GUY FROM THE OTHER SIDE OF THE TRACKS PICKED THIS OTHER GUY UP WHO HAD GOTTEN BURNED AND HIT WITH SOME SHRAPNEL AND WRAPED HIM UP IN A BLANKET AND TOOK HIM ALL THE WAY OVER TO THE HOSPITAL. HE ESCORTED HIM ALL THE WAY OVER THERE. WHEN I TALKED TO THIS GUY IN THE HOSPITAL, HE TOLD ME THAT THIS OTHER GUY HAD DONE THAT. I SAW THE SAME GUY THAT WAS WOUNDED BACK IN SAN FRANSISCO, ONE OF THE HOSPITALS. I WENT TO SEE HIM AND HE DEVELOPED SOME RETTY BAD BED SORES. HE WAS ONE UNHAPPY SAILOR. I THOUGH, YOU DON'T KNOW HOW LUCKY YOU ARE TO EVEN BE ALIVE. THIS OTHER GUY SAVED YOUR LIFE. THAT'S ONE OF THOSE THINGS TOO.

#### JERRY

YOU WERE THERE FOR THE DAY OF THE ATTACK?

A.H.

I DIDN'T GO BACK WHERE I WAS. WE WERE ON FORD ISLAND. THE CHIEF KEPT US ALL TOGETHER. THERE WAS A FERRY BOAT THERE. HE SAID WE WERE GOING TO GET ON THE FERRY BOAT AND WE ARE GOING TO GO ACROSS PEARL OVER TO THE SUBMARINE BASE AND THEN WE ARE GOING TO SEE WHAT TRANSPIRES FROM THERE. ON THIS FERRY BOAT GOING ACROSS PEARL HARBOR, THE DESTROYER BACKED DOWN AND HIT THE FERRY BOAT. SOME OF US SAW THE DESTROYER WAS GOING TO HIT THE FERRY BOAT SO WE GOT UP ON THE GUNWAL JUST IN CASE THEFERRY BOAT SANK. ACTUALLY IT HIT JUST A GLANCING BLOW JUST ENOUGH TO KNOCK US OFF IN THE WATER. I ACTUALLY WAS IN PEARL HARBOR. I COULDN'T SWIM VERY WELL. I DID MANAGE TO STAY AFLOAT AND A CAPTAIN'S GIG CAME BY AND FISHED ALL OF US OUT OF THE WATER AND TOOK US OVER TO THE SUBMARINE BASE. THAT WAS THE ONLY TIME THAT I WAS ON AN ADMIRAL'S BARGE AND THE CAPTAIN'S GIG, BOTH ON THE SAME DAY, DECEMBER 7<sup>TH</sup>, 1941. I WAS REALLY PRETTY IMPORTANT.

# **JERRY**

IN SPITE OF ALL THE STUFF THAT WAS GOING ON.

A.H.

WHILE WE WERE ON THIS FERRY BOAT, CHIEF RHINEHARDT POINTED OUT THE WEST VIRGINIA AND THE CALIFORNIA. HE SAID, "WELL, THERE'S YOUR OLD HOME AND THERE'S YOUR NEW HOME. HE INTENDED TO BE A COMMANDER. HE FIGURED IF THE WAR STARTED, HE WOULD END UP AS A COMMUNICATIONS COMMANDER. THE LAST I SAW HIM, HE WAS STILL A CHIEF.

WHEN ALL HELL BROKE LOOSE THAT DAY, DID YOU FEAR FOR YOUR LIFE?

A.J.

I SAW THE FIRST TORPEDO PLANE. HE DROPPED A TORPEDO AND THE TORPEDDO HIT US AND HE STRAFED THE LIBERTY PARTY. I HEARD THEM YELLING FOR A CORPSMAN. THE SHIP WAS JOLTED WHEN THE TORPEDO HIT US AND I THOUGHT WE WERE GETTING UNDERWAY. I THOUGHT THEY WERE SURE PRACTICING CLOSE. ONE OF THE JAPANESE PLANES WENT DOWN IN FLAMES, JUST LIKE IN THE MOVIES. WHEN I GOT UP THERE ON THE BRIDGE AND ALL OF THESE THINGS WERE TRANSPIRING, I SAID, WELL, LORD IT'S YOU AND ME AND IT'S UP TO YOU.

**JERRY** 

DID YOU REALIZE RIGHT AWAY THAT IT WAS THE JAPANESE?

A.H.

I KNEW THAT AFTER BEING STRAFED. I KNEW THAT IT WAS NO LONGER PRACTICE. I THOUGHT IT WAS JUST PRACTICE AT FIRST. THEY HAD NEVER DONE THAT BEFORE AND NEVER IN THE HARBOR.

**JERRY** 

HOW DID THEY UTILIZE ---- WHAT DID YOU DO THE REST OF THE DAY AFTER THE ATTACK WAS OVER?

A.H.

THE CHIEF KEPT US ALL TOGETHER AND HE SAID WE ARE GOING TO HAVE TO BED DOWN SOMEWHERE AND I'LL SEE IF WE CAN FIND A PLACE TO BED DOWN. I/M SURE WE WILL GET A SHIP AND DO SOMETHING. I'M NOT SURE BUT I'LL FIND WE FOUND THIS SUBMARINE SAILOR OUT HERE. I ASKED HIM IF THERE IS ONE ABOARD HIS BOAT. WE WENT ABOARD THE SUBMARINES TO SEE IF WE COULD FIND A PLACE TO STAY FOR OVERNIGHT. THERE WASN'T ANY ROOM ABOARD FOR US. WE ENDED UP IN THE USS PETIUS (SP ????) WHICH IS A SUBMARINE TENDER. I SPENT ONE NIGHT ABOARD THE SUBMARINE TENDER. FROM THERE WE WENT TO MAKALAKA RADIO STATION. THAT WAS INTERESTING TOO.

**JERRY** 

WHERE WAS MAKALAKA RADIO STATION?

A.H.

IT WAS CLOSE TO HONOLULU BECAUSE WE DIDN'T GO VERY FAR.

WAS THAT ON ONE OF THE HILLS NEARBY?

A.H.

NO. IT WASN'T ON THE HILL THIS IS ANOTHER INTERESTING THING THAT HAPPENED.
YOU REALIZE WE SHOT DOWN SOME OF OUR PLANES THE NEXT MORNING. THAT NIGHT OR ONE
OF THE SUCCEEDING NIGHTS, AT THE MAKALAKA RADIO STATION, WE HAD A MARINE
ROTECTING THE COMPLEX. THERE WAS A SOLDIER UP ABOVE PROTECTING ANOTHER COMPLEX
AND HE TOOK A SHOT AT OUR MARINE GUARD. HE CAME IN AND SAID THERE WAS GOING TO BE
ONE DEAD DOGFACE IF THAT SOB SHOOTS AT ME AGAIN. THESE THINGS TRANSPIRE.

THEN, WE HAD AN ALERT. WE HAD A RACK OF 30 CALIBER RIFLES. ONE OF THE RADIOMEN GOT ONE OF THESE RIFLES (GARBLED). THESE ARE THINGS THAT TRANSPIRE.

**JERRY** 

YOU WERE OBVIOUSLY AT THE RADIO STATION FOR A WHILE.

A.H.

NOT VERY LONG. WE ENDED UP. YOU KNOW, KIMMEL WAS THE ADMIRAL IN CHARGE OF THE PACIFIC FLEET, THE ASIATIC FLEET, ALL OF THE UNITS IN THE PACIFIC. VICE ADM. CRYER (SP???) WAS THE ONE I WAS WORKING FOR, WAS IN COMMAND OF THE BATTLESHIP BATTLE FORCE. WHEN THEY CASHIERED KIMMEL AND WHY THEY DIDN'T CASHIER CRYER WAS ONE OF THOSE THINGS I NEVER HAVE UNDERSTOOD. THEY HAD TO CASHIER SOMEBODY. THEY HAD TO PUT THE BLAME ON SOMEBODY. SO THEY TOOK THE HIGHEST RANKER.

WE ENDED UP THEN AT THE SUBMARINE BASE AND A LOT OF THE SURVIVORS WERE AT THE SUBMARINE BASE. THEY HAD A LOT OF BUNKS THERE AND EVERYTHING. OUR RADIO GANG AND NIMITZ'S RADIO GANG STOOD WATCH AND WATCH. WATCH ON AND WATCH OFF. WE SPENT QUITE A BIT OF TIME THERE AT PEARL. I SAID, "WELL, JUST TELL HIM HI." SHE SAID, "WHAT DO YOU MEAN HI?" I SAID, "WELL JUST GO H I AND USE SEMAPHORE." SHE SAID, "ARE YOU SEROUS?" I SAID, "YEAH SAY H I". PRETTY SOON FROM THE BRIDGE, THE GUY CAME BACK WITH THE H I. I SAID, "HE SAID HI TO US. WE HAD A GOOD TIME.

I LIKE TO THINK A LOT OF THINGS HAPPENED, BUT THE WHOLE CONCEPT OF NAVAL WARFARE CHANGED. BILLY MITCHELL WAS WAY AHEAD OF THE GAME BACK IN WORLD WAR I. HE SAID THIS IS THE WAY IT WILL BE AND IT WAS. THE JAPANESE LATCHED ON TO THAT. THEY WERE WAY AHEAD OF US IN THAT REGARD. IT WAS VERY DIFFICULT EVEN AFTER THE WAR STARTED FOR THE PEOPLE IN WASHINGTON TO DETERMINE THAT THE BATTLESHIPS WERE NOT IMPORTANT. THEY WERE NOT THE THING. THEY ARE STILL BUILDING BATTLESHIPS. THEY USED THEM AS ANTI-AIRCRAFT PLATFORMS.

THEY BROUGHT A FEW OF THEM BACK INTO SERVICE FOR VIETNAM.

THEY HAD THEM IN THE GULF WAR. THEY HAD BATTLESHIPS. THEY SPENT A LOT OF MONEY PUTTING CRUISE MISSLES ON THEM AND THAT SORT OF THING, ALL OF WHICH WAS RIDICULOUS. THEY TOOK SEVERAL SHIPS THAT THEY HAD DECOMMISSIONED AND THEY WERE ALSO MODERN IN COMPARISON TO ANYTHING THAT I EVER KNEW. I COULD HARDLY UNDERSTAND WHY THEY WOULD DECOMMISSION THEM. MISSLE CRUISERS, MISSLE DESTROYERS, MISSLE THIS AND MISSLE THAT. THEY'RE OUTMODED.
