



## PERSPECTIVE

#### **Welcome to PRS**

Those of us in health and human services are used to gigantic problems. We always have our share.

The rising cost of health care, the rising tide of drug and alcohol abuse, the growing number of aging people who need long-term care — all of these are problems that need solutions.

But no problem is more acute, more potentially destructive to our society than the worsening plight of children.

Recently, Lt. Gov. Bob Bullock issued a report called "Bridges to the Future," which gives us some alarming statistics:

- One in four children live in a family with an income below the minimum needed to be self-sufficient.
- More than 2 million Texas children have no health insurance.
- Every child who grows up in poverty and without adequate health care is much more likely to be dependent on society, drop out of school, need public assistance, or end up in the criminal justice system.

We're well aware of the association between poverty and abuse, and between health problems and abuse. So it's clear that the risk to our most vulnerable citizens is great and growing.

The results of abuse are all too evident—emotional problems, fear, anger, injuries, and even death. Many abused children grow up to repeat the only cycle they know and become abusers themselves.

Last year, the Legislature decided that Child Protective Services (CPS) was so important to this state's future that it should be in a separate, new agency that could focus on protective and regulatory services. The Legislature also determined that this new agency protect vulnerable children in day-care settings, as well as adults who are elderly and physically fragile, and people with disabilities, in their own homes and in institutions.

As you all know, the new Texas Department of Protective and Regulatory Services (PRS) is getting up and running. There is a fine new board, headed by Susan Stahl of Dallas, who has demonstrated her leadership in human services. They have hired an interim executive director, Lt. Gov. Bullock's former director of policy and research, Camille D. Miller. In my short tenure in Texas, I have found her extremely knowledgeable, compassionate, and innovative.

The job is a difficult one, complex and controversial. Errors in some agencies can result in inconvenience. In this one, they can result in death. Our CPS caseworkers are daily called upon for the wisdom of Solomon, the patience of Job, and the dedication of St. Peter. Luckily, most of their decisions are correct. But newspapers don't write about planes that land safely.

Our children are our future. PRS is critically important to their well-being, as well as to adults who need the agency's services.

Children are the number-one priority for the Health and Human Services Commission as well, and we will be working closely with the new agency to develop strong new policies to ensure that every young Texan has all the opportunities to develop into a productive citizen.

And children deserve our support and assistance in this transition to an independent agency.

## Camille D. Miller Named PRS Interim Executive Director

AMILLE D. MILLER, former policy and research director for Lt. Gov. Bob Bullock, was named interim executive director of the Texas Department of Protective and Regulatory Services (PRS) by the agency's board at its Aug. 7 meeting.

"I was very pleased to be selected as interim executive director," Miller said. "The position will be very challenging. I am confident that I can help PRS become a dynamic agency that will make many fragile Texans a little safer. Every action I take and decision I make will have one focus — the client. I will do everything I can to give our caseworkers the support they need to do the best possible job," she said.

Miller served on the transition team for Lt. Gov. Bullock's move



from the state comptroller's office. She supervised development of the 1991-92 appropriations bill, as well as legislation pertaining to the state performance audit and comprehensive reorganization of environmental and human services.

Miller served as Lt. Gov. Bill Hobby's human services specialist and policy and research director. She has also worked for the Office of the State Comptroller of Public Accounts, the Texas Department of Community Affairs, the Office of the Governor under Govs. Preston Smith and Dolph Briscoe, and the Governor's Committee on Aging under Gov. Smith.

Miller holds a bachelor's degree in sociology and chemistry and a master's degree in social work from the University of Texas at Austin.

## Stahl speaks at conference

Susan Stahl, chairwoman for the Texas Board of Protective and Regulatory Services, was one of several people who addressed the 1992 Texas Summit on Adolescent Pregnancy Prevention on Oct. 27 to 29 at the Austin Hilton Hotel.

## Support services staff, equipment to transfer

According to an agreement between Camille D. Miller, PRS interim executive director, and Burt Raiford, Texas Department of Human Services (DHS) commissioner, all support functions for PRS will be separated from DHS effective March 1, 1993. Because some of DHS's funding for support staff is being transferred, PRS will be entitled to a percentage of DHS's support staff and their equipment.

To ensure that there is a minimal amount of disruption in both agencies, PRS staff will talk with DHS regional administrators, and deputy and associate commissioners, as well as the employees themselves to see if they want to be transferred.

## PRS conducts worker survey

One of the first activities conducted by the Office of the Interim Executive Director was a survey of APS, CPS, and CCL workers. Of the more than 2,800 surveys, more than 900 have been returned.

The responses have been summarized by program and region, and were issued to members of the Texas Board of Protective and Regulatory Services as background information for the agency's Strategic Plan and Legislative Appropriation Request. The results are also being given to program staff so that they can attend to specific items, and use the information as a planning tool for their work with regional staff.


The central theme from workers who returned the surveys was a concern about not being able to do a good job because of high caseloads, excessive paperwork, and other tasks that take time away from clients. They also expressed the need for more support services, such as additional case aides and clinical staff.
