PROCEDURES FOR FUTURITY HORSE PROJECT NOMINATIONS

All 4-H futurity nominations must be sent to or taken to the CEA office by March 15. Nominations (Attachment #1) will be attached to a County Summary Sheet (Attachment #2) which is filled out by the CEA and then sent, along with fees, to the Horse Specialists' office. Individual nominations are due to the CEA office on or before March 15. As per the State 4-H Horse Committee meeting, NO LATE NOMINATIONS will be accepted. CEAs have until March 20 to mail the County Summary Sheet and individual nominations to Horse Specialists office. This procedure was started last year with the introduction of the County Summary Sheet. This procedure has worked well and better ensures that CEA offices know who is involved in the futurity project.

The futurity program continues to grow. Last year, 93 CEAs handled some 250 futurity nominations by 4-Hers with geldings or fillies nominated for 1) yearling halter, 2) yearling longe line, 3) two-year old western pleasure and 4) three-year-old stock horse.

In working with 4-Hers planning to nominate young horses for 2000, CEAs are asked to please emphasize that this young horse training project is for older, more experienced 4-Hers who have developed the skills and maturity needed to successfully undertake a project where they do all of their own training with a young horse. Please make sure 4-Hers and families have read and are familiar with futurity rules, found on pages 2, 36, 37, 38 and 39 of Texas State 4-H Horse Show 2000 Rules and Regulations (Publication AS3-2.043).

2000 SUMMER HORSEMANSHIP SCHOOLS - REQUEST BY JANUARY 31

Attachments #3 and #4 are forms to use in requesting either a 2-day or 3-day long horsemanship school for this summer. Costs are the same as last year, \$550 for a 2-day and \$750 for a 3-day school.

This will be the 28th consecutive year for the program. Last summer, 37 schools were conducted. Riding sessions with potential Horse Program Assistants begin here in late January and the instructors will be selected by mid-March. A good group of knowledgeable young horsemen have expressed interest in trying out for the program. So, please request your school by January 31. Call Pete G. Did You Know?

The TAEX Summer Horsemanship School Program began in 1973. Over 27 consecutive years, a total of 927 county schools have been taught by 142 different college-aged students (Horse Program Assistants) traveling the state in teams to work closely with county 4-H horse programs. The program represents 2,888 teaching days and has reached 34,988 youth, parents and volunteer leaders.

SIGNIFICANT 4-H HORSE SHOW RULES, REVISIONS AND REMINDERS

CEA offices received the 2000 Rules and Regulations back before the end of the year. Please make copies as needed for 4-H families in your county. Or, access the rule book at http://animalscience-extension.tamu.edu.

Listed below are some important changes, clarification or reminders:

- All 4-H horses must be owned by the 4-Her, their parents, brother, sister, grandparents or legal guardian. (See Rulebook, page 3) this includes Drill and Precision Team horses as well. (Page 39) No leased horses.
- 2) Futurity project horses must be owned on or before March 15. Futurity project nomination forms mut be turned in to the CEA office no later than March 15. CEA verifies accuracy of information, signs each form and mails forms along with a County Summary Sheet and fees to Horse Specialist's office by March 20 (Rulebook, pages 3 and 36)
- 3) All other horses must be owned and certified by May 1 in order for that 4-Her and horse to be eligible for district and/or State show participation (Rulebook, page 3).
- 4) At District and State shows, a horse may be ridden by only one 4-Her in the qualifying portion of the show, and by only one 4-Her in the open portion of the show. However, the same horse may be shown by one 4-Her in the qualifying show and by another 4-Her in the open show, provided that the 4-Hers are siblings, the ownership requirements are met, and the horse has been properly identified as a 4-H project by both siblings. Futurity horses may never be ridden by more than one person. (Rulebook, page 3)
- 5) At the discretion of the county horse show committee, a 4-H member may be allowed to change horses between county and district shows, provided all horses involved meet ownership requirements. It is recommended that, in hardship cases, this substitution be allowed. Under no circumstances will horses be changed during a district show, and no change of horses will be allowed from district to state in the qualifying show. A change of horses may be allowed for the open classes, provided the horse was properly owned and identified on or before May 1. (Rulebook, page 3)
- 6) Qualifying For State All exhibitors earning 1 or more points in the Qualifying portion of the district show shall be eligible for Qualifying show classes at State. They may then enter a total of 4 qualifying show classes at the State Show. (Rulebook, page 5)
- 7) Team Roping A 4-Her enters an individual and may enter only once. The partner can be any 4-Her who also is entered in the Team roping. A 4-Her may help as many times as desired. Points will be awarded only to the person entered, not the helper. Teams receiving a time in the first go will progress to the final go. Duplicate awards presented to top placing teams overall (Rulebook, page 22)
- 8) Western Riding A third pattern has been added (Rulebook, page 33)
- 9) Trail For 2nd year now, it is an Open Class at state Show. (Rulebook, page 33) In the

prelims, the gate is obstacle #1. Exhibitors have 30 seconds to open and pass through the gate. (Rulebook, page 34)

10) Reining Pattern #2 - Changed to include 4 spins each way (page 27).

NEW TEXAS STATE 4-H OFFICE RULE ON 4-H MEMBERS AGE

On page 2 of the Texas State 4-H Horse Show Rules (AS 3-2.043 - 10/99) General Rules and Regulations, Eligibility of Participants, see Member Age Requirements rule. **This rule should be modified, to correlate with a new State 4-H Office rule. In 2000 a 4-H members' age is determined as of August 31 (not January 1)** to coincide with Fall 4-H club enrollment. For example, if a 4-H horse club member is 18 years of age on or before August 31 and turns 19 years of age September 1 to December 31, that 4-Her is a legal 4-Her until August 31 of the following year. If he/she is 19 years of age on August 31, he/she is not a legal 4-H member. (Note: This actually allows Fall birthday 4-Hers another legal year in 4-H.) If questions, contact your local CEA.

Note: DED offices will receive a document entitled 'Guidelines for Conducting a Successful District 4-H Horse Show' in early 2000. Any CEA office wanting a copy may contact the Horse specialists' office at (409) 845-1562.

The State 4-H Horse Show will be held in Abilene at the Taylor County Expo Center in 2000, 2001 and 2002.

2000 TEXAS 4-H ROUNDUP - PARTICIPANT GUIDE

The guide was sent out by the 4-H office in the fall of 99. Counties with Horse Judging, Quiz Bowl and Horse Demonstration Teams should pay particular attention to the Eligibility Information on pages 4 & 5 of the guide.

Remember, 4-H members are not eligible to enter a contest in which they have 1) previously been a part of a first place entry at State or 2) been on a 4-H competitive team entry to the "national" contest.

In Horse Judging, the All American Quarter Horse Congress is classified as the "national" event. But remember, this does not apply to horse judging teams that have judged at the Congress representing TQHA as a result of the Ft. Worth Livestock Show Contest.

In Horse Quiz Bowl and Horse Demonstrations, the National Western in Denver, Colorado is classified as the "national" contest.

HORSE BOWL CHANGES

CEAs received Quiz Bowl information in late October from 4-H Specialist Jeff Howard. Note these changes for 2000. <u>Printed Materials</u> - the Texas 4-H Quiz Bowl Guide (AS 3-2.030 - 8/99) and Texas 4-H Horse Quiz Bowl Supplement (AS 3-2.031 - 8/99) replace the old Horse Bowl Manual; <u>Contest Procedures</u> - there are a few minor changes; <u>References</u> - be sure references are current. B.I.G. HORSE SHORT COURSE

CEA Doug Andrews in McLennan County and the B.I.G. Horse Committee have planned the horse program for January 18 in Waco. This year's focus is "Raising Kids Using Horses" and will include a demonstration by Doug Householder with youth participants on the qualities desired in a "Youngsters First Horse." CEA John South will conduct two demonstrations involving youth called "Horse Owners in Training" and "Train Your Own Horse." CEA Tammy Cantrell will conduct demonstrations involving youth members in "Horse Judging" and Speaking Publicly About Horses," while Ken Johnson, 4-H specialist, will take volunteers for a quick "Horse Quiz Bowl" demonstration. The evening program contains a Parent Panel to address questions related to youth, horses and life skills.

The program starts at 4:00 p.m. at the Red Barn on the H.O.T. Fairgrounds in Waco. Registration fee is only \$2 per person.

TETRA CONVENTION IN BELTON

January 14-15-16, the 2nd Annual Texas Equestrian Trail Riders' Association Convention will be at the Bell County Expo Center in Belton. Live demonstrations, educational presentations and a trade show will make up this event expected to again draw several hundred people. Whether you are a trail rider or any kind of performance horse enthusiast, this is a large event worth attending.

TEXAS FARM BUREAU HORSE COMMODITY GROUP

Texas Farm Bureau comes to College Station in late January and early February for meetings covering many commodity areas.

The Horse Commodity Group will meet on February 2. Topics will include 1) Social and Economic Importance of the Texas Horse Industry, 2) Horse Theft Legislative initiative and 3) Trail Riding Opportunities for Texas Ranchers. Open discussion and interaction will deal with emerging issues that have regulatory/legislative implications in the future.

AMERICAN FARM BUREAU FEDERATION FORMS ALLIANCE WITH HORSE INDUSTRY

A national Horse AFBF Conference was held recently in Lexington, Kentucky, where Farm Bureau staff from 17 states met to discuss expanded cooperation with their state's horse industries. Texas Farm Bureau was instrumental in facilitating this conference. The Texas Farm Bureau will in the future be seeking expanded opportunities to cooperate in educational and promotional horse programs and horse policy activities with TAEX and other groups.

TAMU MARE/FOAL WORKSHOP FEBRUARY 25

Mare owners seeking information on broodmare management and raising foals will have an opportunity to attend a day-long program focusing on just that at the 4th Annual TAMU Mare/foal Workshop on Friday, February 25, 2000 at Texas A&M University

The workshop will be held at the Louis Pearce Pavilion and Animal Science Department's Horse Center. This location will allow for hands-on approach to some of the workshop topics. Mare owners will be able to gain experience using the body condition scoring system, with mares on hand for scoring and discussion. Weight estimation and broodmare nutrition will be covered.

Basic reproductive function, estrus detection and teasing, and signs of foaling will be discussed and demonstrated. Health care and restraint of mares, as well as foal handling and neonatal care will be covered.

The workshop includes information on moderate vs. rapid growth and selecting or formulating acceptable feeds for foals, weanlings and yearlings.

Additional topics will be an overview of the social and economic importance of the Texas horse industry, and resource material related to horse theft awareness and prevention.

This day-long workshop is designed for mare owners. It is not intended to be a breeder's school and will focus much more on mare management than on breeding procedures. The information should be useful for the mare owner, regardless of the number of mares they own or manage.

Instruction will be provided by equine faculty from both the College of Veterinary Medicine and the Equine Sciences section of the Animal Science Department.

Creating awareness and providing education on minimizing or preventing theft of horses and equipment is ongoing. Stand alone programs can be developed and other horse programs can be designed to include presentations and demonstrations on permanent identification. There are good resource persons available, from freeze branders to TSCRA representatives. Counties can get funding to cover expenses related to Facilities and Equipment rental, travel and honoraria for speakers/technicians/resource persons, and related expenditures. Funding cannot be used for meals or refreshments. Call or e-mail for details. Remember the Downing Exhibit and display on Theft Protection that is available in each of the 12 District offices. 4-HERS PREPARING METHODS DEMONSTRATION - NEW INSTRUCTIONAL VIDEO AVAILABLE

A 4-H method demonstration instructional video is now available through CEA Offices. The video is 30 min. in length and includes step-by-step instructions for 4-H members preparing 4-H method demonstrations or illustrated talks. The video focuses on the development of visual aides with suggestions on judging demonstrations. There is also an example illustrated talk presented by a 9 year old 4-H member. THE INFLUENCE OF THE TEXAS 4-H HORSE PROGRAM ON LIFE SKILL DEVELOPMENT IN STATE 4-H HORSE SHOW ENTRANTS

The 4-H Horse Program instills life-skills and values in young people. However, very little data has been collected to quantitavely measure program impact on youth. To determine the 4-H Horse Program's impact on teaching life skills and values to its members, ninety-five surveys were randomly distributed to entrants at the 1999 4-H State Horse Show in Abilene, Texas. State Show entrants were asked to evaluate the impact that the 4-H Horse Program had on them in developing or enhancing the following skills: communication, problem-solving, integrity, goal setting, self confidence, persistence, discipline, and attitudes about competition. Of the 95 surveys distributed, 54 were returned - a 56% response ratio. The entrants overwhelmingly responded that the 4-H Horse Program had positively affected their lives, as follows: 89% of those surveyed either agreed or strongly agreed that the 4-H Horse program has improved their communication skills, 86% agreed or strongly agreed that the program has enhanced their problem-solving skills, 85% agreed or strongly agreed that the program has instilled honesty and respect (integrity) within them, 83% indicated that the goal setting process of the 4-H Horse Program had enhanced their ability to set and achieve goals, 85% agreed or strongly agreed that 4-H has given them greater self-confidence and courage, 99% agreed or strongly agreed that the horse program had taught them that success comes from persistence, 79% indicated that their self-discipline had improved due to the 4-H Horse Program, and 82% of those surveyed indicated that competitive events encouraged them to strive for their best and improve their performances more than non-competitive events did. Overall, entrants at the 4-H State Horse Show indicated that the 4-H Horse Program had positively contributed to the acquisition or enhancement of many life skills. [Note: This study was conducted by Torri Whitaker, M.S. Student, Dept. of Agricultural Education, TAMU. Torri worked in the Extension Horse Specialist's Office in the summer of 1999 and at the Texas State 4-H Horse Show.]


