### Junior Olympic Shotgun Program

Registration materials for the Junior Olympic Shotgun Program to be held at the Lackland Rod and Gun Club are enclosed. #### **EXPO** is Coming

For some of you this is an enigma. For others it is just a reminder of lots of work with thousands of kids in a couple of days. The 1997 Wildlife EXPO will be here before you know it. Many 4-H instructors from all over the state participate in the workshop sessions each year - teaching basic firearms safety and staffing the various shooting events. We NEED help in all events at this massive event, and if we get enough you can visit the EXPO yourself and see what is going on in all the shows and booths. Last year about 10 of us put nearly 4000 young people through an airgun shooting range in two days. We need twice that many to make it safe and fun for the kids while allowing the staff to take a break now and then. Why not sign up to assist this year? Both we and the kids will appreciate it.



If you are not sure what had s or you associated it with Captain Billy, you may not be a sporting clays shooter. Each year the top six shooters in each age class from all the events using the Texas Parks and Wildlife Department 5-Stand trailer get to come the day before EXPO officially starts to shoot in an exhibition sporting clays event. Lots of prizes are rounded up and made available to the participants, and the winners attend the opening banquet with a parent. You have to play during the year to qualify, and you can enter as many times as you like. The last qualifier is the State Shoot. See you at Cap'n Scotty's Whiz Bang!

#### **Newsletter Situation**

The hard copy will continue to be available as a subscription item, starting at a \$10.00 annual rate for each year's four issues. County offices, 4-H Shooting Sports Volunteer Management Committee members, and members of the Texas 4-H Shooting Sports Training Team will continue to receive a hard copy as a courtesy. A subscription form is attached for those of you who wish to continue getting the hard copy. I wish we did not need to do this, but fiscal realities demand that we do something to cover costs.

Most of the current subscribers are national committee members or national training team members, but the forum is an open one.

### Shoot G Registrations Enclosed

Registration materials for several events are attached. With so many registration forms in one newsletter, please be careful to review each one to be sure you are entering the intended events. Shoulder to shoulder matches include the following.

**Texas 4-H Archery Match** - This event will take place on the weekend of June 20-22 June in Bay City. It will feature basic archery, 18 meter archery, Easton Round, field round, 3-D, clout, the team relay round, and a flight round. Several divisions exist in some of these events, so be specific.

**Texas 4-H Silhouette Match** - This year's silhouette match will be held at the Texas Muzzle Loading Rifle Association Range in Brady on July 12. We will include air pistol and air rifle silhouettes along with smallbore hunter's pistol and smallbore rifle silhouettes this year.

**Texas 4-H Five Star Matches** - These 4-H championship matches will be held at the Austin Rifle Club range between Manor and Elgin on July 19. This year's venues will include 5 m BB gun, precision air rifle, sporter air rifle, air pistol, smallbore pistol, centerfire pistol, light rifle, 50 meter 3-position rifle, sporter high power rifle, muzzleloading rifle, and a hunter skills trail.

**Texas 4-H Trap, Skeet and Sporting Clays Shoot** - The 1997 shoot will include the same events as we had previously. Please note that the international events will be using international rules on shot charges (approximately 7/8 ounce of shot), rather than permitting the standard target load of 1<sup>1</sup>/<sub>6</sub> ounce. Prepaid ammunition orders are also included for those who want either Federal or Winchester factory ammunition for their shooting.

Two postal league registration forms are included in this newsletter. They are:

#### **Texas 4-H Smallbore Rifle Silhouette Postal**

**League** - Registrations are due in the State Office by 15 May. Each participant must shoot 3 matches between May and December with all scores back to the office by December 15, 1997.

#### **Texas 4-H Trap and Skeet Postal League** -Registrations are due in the State Office by June 15

for a 3 match shoot (one in each month) from June through August. All scores must be received before September 15, 1997.

Meet Some New State Training Team Members Texas was very fortunate to have 15 new state team members trained in the Southwest Regional 4-H Shooting Sports Workshop at Brownwood. We lost all of our archers to various problems, but Linvel Baker and Bob Russell (Black Powder), Craig and Beverly Sullivan (coordinators), Roxann French and Brent Russell (hunting), James Jahn and David Williams (pistol), Jennie Dietrich, Rick Monger, and David Nichols (rifle), and David Lackey, Ricky Linex and David Williamson (shotgun) successfully completed the courses. Rick Dromgoole was forced to leave early but is committed to work with the coordinators to complete his training as an apprentice. I am extremely pleased with this group, and I hope that you will be, too.

#### Next Year's National Workshop

The 1998 National Workshop will be held in West Virginia in May. As in the past, I am looking for a few good people to attend this workshop if space permits. In addition to those who were snookered this year and unable to attend, others are welcome to apply. Our challenge in distant workshops is transportation, but we are still in the process of building those regional teams of instructors. Any experienced volunteer or agent may apply to attend.

### Hunting Curriculum Almost Ready

We thought that we had this curriculum ready to go, but a couple missing pieces remain. A fall working session is planned to bring the hunting materials into final form before they are distributed. We have approximately 150 copies of the current materials on hand if someone needs a set in the interim. Among the things we failed to cover (and this is unbelievable) was dove hunting. 40 lashes with a wet noodle on that one!

### Making the Calendars Work for You

Judy and I try to put everything that folks share with us into the calendars so they are up to date on events and activities related to shooting. Unfortunately, we get lots of notices after a publication date when the next newsletter will be too late. I know it is hard to be thinking about July in March, but that is exactly what we need to do in order to get the information out there for those who would like to use it. How about helping us to get that calendar full and to make it most useful for everyone? Keep us posted on your shoot dates where they are open or invitational shoots.

### **Texas 4-H Shooting Sports Camp**

Enclosed you will find application materials for a statewide 4-H Shooting Sports Camp to be hosted by Ward County in Monahans. Scheduled for July 15-18, 1997, the program will involve up to 15 males and 15 females between the ages of 12 and 17. Four adult volunteer instructors are also needed. Applications are due in the Ward County office by June 2 with payment of the \$165 fee due after notification of acceptance. The program as it has been discussed with me looks like an excellent week for the folks involved. ### FAST Still Available

Several newsletters back we discussed the FAST program developed in Arizona as an early intervention model for kids who had committed minor firearms offences. Like defensive driving, the program is a classroom approach to instilling safety awareness and socially acceptable use of firearms. Parents, youth and juvenile officers attend together with 4-H Shooting Sports volunteers providing the instruction. The program has a proven track record in preventing subsequent violations. We are still looking for a few places to put it to the test. Interested??

### **Domestic Violence Bill**

Without debating either its merits or its implications for others, we note the passage of the Domestic Violence Bill. This bill makes it a felony for anyone who has been convicted on a misdemeanor charge of domestic violence (any type - any time) to have access to a firearm or ammunition (some have interpreted that as including dummy ammunition). We need to be sure that neither the volunteers nor the participants in our shooting programs fall under the purview of this new law, even though it is currently being challenged by numerous law enforcement organizations and the military. Perhaps the best way to avoid invasion of privacy while being sure we comply with the law is to make everyone aware of its scope and implications. I do not believe archery equipment is included in this, but muzzleloaders would be defined as both firearms and ammunition. What a can of worms this opens!

#### Who is a Certified Leader/Coach?

Certified leader/coaches are individuals who have successfully completed a training program in 4-H Shooting Sports. We require that a certified person be physically present when any shooting discipline is being taught in the 4-H program. This is done to protect everyone - Extension, coaches, youth and observers. These certified leaders can supervise others who assist them, but they must be physically present when the other volunteers are instructing or supervising youth on the shooting line.

### **Getting People Certified**

We certify volunteers in three ways. First, they can attend a state-level training workshop. We hold at least 3 of them each year, in January, March and September. The January and September workshops move from place to place as we are invited by host counties. Second, they can attend a "local" workshop, usually in a single discipline conducted by a member of the state training team. Every member of the state training team has agreed to work with these local workshops as they have the time and when adequate numbers of volunteers are involved (generally 10-15 in a discipline). Finally, in a limited number of situations where volunteers have certification from another organization that parallels our own AND the agent makes sure the person understands the objectives and principles of the 4-H program AND they are individually approved by the State Office, we may grant "emergency" certification until the individual can get to a workshop. This route is not a way around the certification process, but a means of assisting counties who have immediate needs that cannot be satisfied otherwise.

### Workshop Invitations Open

Currently, the January and September slots for 1998 and beyond are open and awaiting invitations. We have a strong interest in serving Districts 4, 11 and 12; but bids for workshops will be accepted from any county. Needs for a workshop site include a common meeting area adequate to hold all participants, classroom space for each of the six (6) disciplines, safe range locations for all disciplines, catering support for meals, motel or other housing for instructors and out-of-town volunteers, and a local coordinator. Shotgun instruction requires an open area where hogs do not forage at least 400 feet deep. Archery requires an open area with about as much space behind the targets as in front of them. Rifle and pistol can be taught with air guns if necessary, but range space is a bonus. Hunting needs open areas in which to explore the discipline. Muzzleloading needs a range with an adequate backstop and at least 50 feet of depth. If personal protection is taught, it needs a range similar to muzzleloading. Most of these ranges can be makeshift, as long as we can make them safe. The next workshop could be in your backyard, but it won't be unless we get the invitation. Now would be a good time to act.

### **Advanced Workshops**

The advanced workshop in shotgun went very well at the January workshop. As a result, we will continue to offer those workshops that have adequate numbers of enrollees. Advanced workshop offerings will be included in the regular registration package for each workshop. Those that meet the minimum levels established by their leaders will be offered. We will cancel any workshop that fails to meet those minimum standards of enrollment.



#### Thank You

About 28 of you signed up for and worked the San Antonio Expo at National Gun Club. Although some confusion reigned and many of you were placed in odd jobs

rather than being used in the most effective manner, you represented 4-H Shooting Sports well. I appreciate your going the extra mile or miles. If it happens again, we will make sure the organization is better, tighter and more appropriate to your talents.

#### **Parting Shots**

Shooting Sports and Citizenship Education Kids identified citizenship education as a significant part of their learning when we looked at the impacts of 4-H Shooting Sports on youth, parents and volunteers. Even so, we may not think of this program as citizenship education. In spite of that, it is. A democratic republic like our own demands much of its citizens. We must be involved in the political process. We must strive to keep informed on the issues before us. We must exercise personal responsibility for our actions and for the shaping of our government. We must recognize that "government" is not an authority over us, but an extension of us -- that it derives its powers from the consent of the people being governed. It demands that we make choices, exercise responsibility and uphold a constitutional standard that places the burdens of society on our shoulders. That is a major set of demands, a requirement for advanced citizenship.

What are the possibilities for citizenship education in this curriculum? How about understanding, analyzing and acting on public policy issues, including informed and serious comment to legislators at all levels? Perhaps youth could address a current societal issue that involves firearms and propose alternatives that make sense to them. Perhaps they could study the history of gun control or the second amendment or related issues. They may want to make a personal study of the various points of view expressed in the media and their sources about issues related to firearms. Perhaps they would like to sponsor a forum or debate on issues related to shooting, firearms control, or other areas of their choosing. Perhaps they would like to review sources of statistical information with an eye toward detecting bias or selection of data to make a point. There are many issues and points of view to be considered, weighed and acted upon for every citizen. This is real practice.

On the other side of the citizenship coin is active involvement at the local level. Here, too, the program offers a multitude of possibilities. Young people can sponsor and instruct in firearms safety awareness meetings for other youth or adults. They could plan and execute a shooting event where the proceeds are used to support a local charity. They could get involved in many areas that are outside the shooting and firearms area as well, like roadside cleanups, storm drain stenciling, recycling or reuse campaigns, hazardous waste amnesty days, food drives for local food pantries, home improvement or building projects(e.g Habitat for Humanity), and much more. The key is getting out into the community and doing something substantive as a citizen for the community in which they live.

In a time when many have all fallen victim to the notion that nothing can be done without a "government grant," personal responsibility and action seem a bit out of place. But, that is exactly what is expected of citizens in a democratic republic. One must be responsible, informed, discriminating (note that this is quite different from discriminatory), and actively involved to claim the title "citizen." Along the way, the citizen must learn how to think and draw conclusions rather than being told what to think and which conclusions to draw.

This is an outstanding program to develop those elements of mature citizenship. Are you including them either in passing or by design? If not, you should be. It is the only way to maintain the society so many have sacrificed to create. Thomas Jefferson phrased the role of citizenship education like this:

"I know of no safe depository of the ultimate powers of society but the people themselves; and if we think them not enlightened enough to exercise their control with wholesome discretion, the remedy is not to take it from them but to inform their discretion."

Are we doing our part to "inform their discretion?" My sincere hope is that we are!





#### What are the Five-Star Matches?

The Five-Star Matches are the Texas 4-H Championship matches in Air Pistol, Precision Air Rifle, Sporter Air Rifle, Smallbore Pistol, Centerfire Pistol, Light Rifle, 50 Meter 3-Position Rifle, 100 Yard High Power Sporter Rifle, Muzzleloading Rifle, and Hunter's Skills. They are open to all currently enrolled 4-H shooting sports members between the official ages of 9 (or entering the third grade) and 18. The late summer event is scheduled for July 19 in 1997. The Austin Rifle Club Range near Austin in Manor, Texas, will be the headquarters for the 1997 event.

#### **Registration and Entry Fees**

Pre-registration is required for all events, but a shooter may compete in as many events as they desire. The complex set of events requires some lead time for the event coordinators. As a result, the **registration deadline** is **June 19, 1997**. All registration forms and accompanying fees must be received by the **State 4-H Office, 7607 Eastmark, Suite 101, College Station, TX, 77843-2473**, by that date. Make all checks payable to **Texas 4-H Foundation**. Note that the entry fee is **\$12.50** for the **first event** and **\$6.50** for each succeeding event. Late **registration fees (after June 19) will be \$15.00** for the **first event** and **\$10.00** for each succeeding event. Adults and non-competing youth spectators **must be registered**. The spectator registration fee is **\$2.00**, and it provides accident insurance for the duration of the event. The insurance fee is **included** in competitor registration fees. **Do not add it to the event registration fees for shooters**.

#### Age Divisions and Awards

Competitors are divided into three age classes with equivalent awards to the top three finishers in each event and class. The official age for registration is the shooter's age **on December 31, 1996**. **Sub-juniors** are all young people between the official ages of nine (9) [or in the third grade] and twelve (12). **Juniors** include all young people with the official ages of thirteen (13) and fourteen (14). **Seniors** are all eligible young people between the ages of fifteen (15) and eighteen (18). Young people who are members of college or military teams or clubs where coaching is provided are **not** eligible to compete. Participation in other shooting events at any level **does not disqualify** an otherwise eligible shooter.

#### Awards

All registered shooters will receive an official Five-Star Match patch. Plaques will be awarded to the top three shooters in each event and age level. Plaques will be awarded at the conclusion of each event. Team awards will be presented to those registered in a team event.

### **Events**

Descriptions of each event or division within an event are attached. Coaches requiring more information about these events may contact the state office, the shoot coordinators, the event coordinator or the appropriate rules (NRA or 4-H).

#### Lodging

Lodging in the Austin area is the responsibility of the coach. RV sites are available at the Austin Rifle Club Range for a small fee. There are limited water and electricity hookups. Contact Jennifer Dietrich in advance to make arrangements at (512) 836-6284. There are several hotels in austin near the intersections of Hwy 290 and IH35 or IH35 and Hwy 183.

#### **Food Service**

Lunch July 19 will be available at the range. For 3.00 a ½ lb hamburger, chips and tea or lemonade may be purchased. Lunch is being provided by the Ben Hur Shrine Provost Guard unit. Additionally, the members of the Austin Rifle Club will be offering Gatorade, fruit drinks and soft drinks for purchase to help offset the cost of putting the range together and the cleanup after the events.

## Knowledge of Courses of Fire and Rules

Brief summaries of the courses of fire for the various events are included in this packet. Current Texas 4-H Shooting Sports Rules govern the events. These depart very little from existing NRA or JOAD rules, but the 4-H rules take precedence where conflicts exist. It is the shooter's responsibility to be familiar with the course of fire and the rules in each event entered. Tight time schedules require that the events be run in a timely and effective manner.

### **Orientation and Inspection of Equipment**

A **required** orientation session will be conducted at the Austin Rifle Club Range near Austin at **8:00 a.m.**, July 19. All shooters must attend that session. Equipment must be **inspected** to assure compliance with the rules in several events. Required inspections must take place before the shooter will be allowed to fire in the event, therefore shooters should report to their respective ranges at least 30 minutes prior to their scheduled relay.





# Announcing the 1997 TEXAS 4-H TRAP, SKEET & SPORTING CLAYS SHOOT JULY 23-26 NATIONAL GUN CLUB, SAN ANTONIO, TX

Enclosed are the entry forms for registering your 4-H Trap, Skeet and Sporting Clays Shooters and Volunteer Officials for this year's state event. Each county **must** provide at least two (2) or more volunteer officials with a working knowledge of the events for which they volunteer. We are asking for the **NAMES AND ADDRESSES** of the volunteer officials so that prior to the shoot, we can provide a new 4-H Skeet Rules.

Please list your contestants using three age divisions: Sub-junior 9-12; Junior 13-14; and Senior 15-19. Remember that a sub-junior may shoot on a junior or senior team. A junior may shoot on a senior team, but a senior can only shoot on a senior team.

We will have 2- and 3-member teams, as well as individual competition in Trap and Skeet, however, Sporting Clays will be individual competition only, but scores will be counted in overall county scores. All shooters, (including 2- and 3-member teams) will compete for individual awards. Trap and skeet teams must consist of the same team members, in order to be eligible for high overall awards.

Once a shooter is classified in one of the three age divisions, he or she will only qualify for the awards available in that division within each set of disciplines. For example, a junior shooting as a senior in American Skeet must also compete as a senior in Trap. He/she may compete as a junior in either the International events or in Sporting Clays. In order to qualify for overall team honors, the shooters must be on the same trap and skeet teams.

List shooters names A SECOND TIME if they are shooting in a different age classification in International trap or skeet.

All teams may be composed of either sex.

All currently enrolled 4-H shooting sports members are welcome. Send all who want to come and shoot for either recreation or competition.

**NOTE:** Safety Precaution-Action Open Rule: Actions of all guns must remain open until the shooter is on the station and the previous shooter has fired. A shell may be placed in the chamber when the shooter is **on the station, but the shooter will not close the action until the previous shooter has fired.** Any shooter not adhering to the established range rules will be disqualified after one (1) warning.

**ALSO NOTE:** Ammunition restrictions for International Skeet (maximum shot charge 7/8 ounce (24 gram), maximum shot size #7½). Rule 3.17a and International Clay Pigeon (maximum shot charge 7/8 ounce (24 gram), maximum shot size #7½) Rule 3.17b.

Other details of the shoot are as follows:

 Registration -- registration for the International events will begin at 3:00 p.m. and close at 5:00 p.m., on Wednesday, July 23. A county may register all of their shooters for all events at this time. Practice fields will be available at the discretion of the club.

If a county does not register all shooters on Wednesday, **REGISTRATION TIMES** for American Trap and Skeet and Sporting Clays events are:

Trap -- 10:00 a.m. to 4:00 p.m., Thursday, July 24 Skeet & Sporting Clays -- 10:00 a.m. to 4:00 p.m., Friday, July 25

# **REGISTRATIONS MUST BE CONFIRMED BY 4:00 P.M.** YOU MAY CONFIRM BY PHONE IF YOU ARE DELAYED IN ROUTE.

Each shooter will be assessed a \$20 registration fee. These fees are used to defray a portion of the cost of the awards and operation of the shoot.

2. Shooting fees (approximate costs)

All round fees for trap, skeet, and International events will be \$3.50 per round. Sporting Clays fees will be \$15 per round

of 50 birds. Only **one round** of 50 birds will be fired for competition record in Sporting Clays. Round fees must be paid to the Gun Club.

3. Order of the shoot:

Thursday, July 24 -- International Events (Clay Pigeon and Skeet) and Sporting Clays Friday, July 25 -- American Trap and Sporting Clays Saturday, July 26 -- American Skeet

4. Be on time:

When a squad is called to a field and one or more members of the squad are absent, the squad will be placed at the last of the shooting order if time permits. Squads should be ready to take the field at least 30 minutes early.

5. Awards presentation:

At the end of each day, there will be an awards ceremony for high individuals and high teams in the day's events. Sporting Clays awards will be presented Friday evening unless shootoffs are required. Lewis class awards will be made after necessary shootoffs. The overall high individuals and teams will receive their awards during the Saturday awards presentation.

6. Squadding procedures:

We will squad all Trap and Skeet shooters based on registration forms. Please be accurate. Changes made at the shoot cause delays in posting squads. Last day for changes will be July 21 (409-845-1214). We will squad by county; however, in order to complete squads, there may be more than one county on a squad.

**SPORTING CLAYS** will not be squadded **until shooters report to the fields**. A group of shooters can start at any time that they are available to shoot. Starting will be based on course availability and a predetermined "start and end time-frame" as established by the course and announced at the beginning of the shoot.

7. Safety:

Safety rules will be followed strictly enforced. Any shooter not following all safety rules, will be disqualified.

8. Accommodations:

See Motel information sheet included with this Newsletter.

# **RULES AND REGULATIONS**

# 1997 4-H TRAP, SKEET & SPORTING CLAYS SHOOT

(USSCA Rules Attached)

### GENERAL RULES AND INFORMATION

- 1. Dates July 23-26, 1997. Orientation begins each day at 8:30 a.m. Competition shooting starts at 9:00 a.m., July 24, 1997, and each day thereafter.
- 2. Place National Gun Club San Antonio, TX
- 3. Sponsor The Texas 4-H Shooting Sports Program, Texas Agricultural Extension Service, The Texas A&M University System, in cooperation with The Texas 4-H Foundation.
- 4. Host National Gun Club
- 5. The Olympic events, trap and skeet, will each be shot on separate days, if the management determines the number of registrants makes it necessary.
- Registration Begins: Wednesday, July 23 3:00 p.m. Registration - Ends : Friday, July 25 - 4:00 p.m Shoot Ends: Saturday, July 26, after the awards ceremony, approximately at 7:00 p.m.
- 7. Practice It is expected that practice fields will be open each day beginning Wednesday, July 23; however, the availability of these fields, after 4-H shoot hours, will be at the discretion of the club management.
- 8. Shoot Fees:
  - A. Registration Fee \$20
  - B. Practice and Contest Rounds Regular Gun Club fees to be \$3.50 per round and \$15 for 50 bird flight Sporting Clays.
- 9. Age Division:
  - A. Sub-junior 9 to 12 years of age (must have reached their 9th birthday or be in the third grade) but not their 13th birthday by December 31 of the previous year.
  - B. Junior 13 to 14 years of age (must have reached their 13th birthday, but not their 15th birthday, by December 31 of the previous year).
  - C. Senior 15 to 18 years of age (must have reached their 15th birthday, but not their 19th birthday, by December 31 of the previous year).
  - D. Shooting at a higher level Sub-juniors or Juniors may elect to shoot at a higher classification in any set of events. The level must be stated on the entry forms. All members of two- or three-member teams must shoot at the same level. Shooters may shoot one set of events at a higher level and revert to their official classification for another set of events. For example, a sub-junior may shoot as a junior in American trap and skeet, but remain a sub-junior for the International events and sporting clays.
- All contestants must be currently enrolled and active members of a county 4-H Shooting Sports Program. All registrations for the shoot must be approved by the County Extension Agent's signature, which serves as the enrollment validation.
- 11. College Students 4-H members who are members of a collegiate or military competition or members of any collegiate or military shooting club or team having a coach, sponsor or advisor, are ineligible to participate in the state 4-H Trap and Skeet Shoot.
- 12. Any bona fide 4-H member meeting rule requirements may enter and shoot in the individual competition matches.
- 13. A county may enter as many teams or individuals as desired.
- 14. All shooters may elect to shoot trap, skeet, sporting clays, or all of them plus the Olympic events.

- 15. Shooters must furnish their own ammunition for shooting. Be sure to allow extra ammunition for malfunctions, proof doubles and shoot-offs.
- 16. The official score is kept on the field by the scorer or referee. Scores kept by coaches and parents are not official and will not be considered.
- 17. Actions of all guns must remain open until the shooter is **on the station**, **and the previous shooter has <u>fired</u>**. A sheil may be placed in the chamber when the shooter is on the station, but the action must remain open until the previous shooter has fired. All guns must be made safe, empty with actions open, at any break in the shooting, as in a trap malfunction or broken target in International Trap. Any shooter not adhering to the established range rules will be disqualified after one warning.
- 18. All entries and registration fees must be sent to Dr. Ron Howard, 7607 Eastmark Drive, Suite 101, College Station, TX 77843 by June 23, 1997 telephone number (409) 845-1214.
- 19. If a team or individual fails to show, the registration fee will be forfeited.
- 20. If the members of a team are not present at the range at their scheduled time to shoot, they will be rotated to the bottom of the shooting order if adequate time is available.
- 21. Camper spaces are available.
- 22. COACHES AND PARENTS ARE ASKED NOT TO BRING AND/OR CONSUME ALCOHOLIC BEVERAGES DURING THE SHOOT.
- 23. Proper ear protection (plugs or muffs) is required of all persons on the firing line in any 4-H Shooting Sports activity or event at all levels (club, county, district, or state). No exceptions will be made.
- 24. Adequate eye protection is required for all persons on the firing line in any 4-H Shooting Sports activity or event at all levels (club, county, district, or state). Shooting glasses, industrial safety glasses, or tempered eye glasses may be worn. ISU Shooting glasses may be worn only if both eyes are protected. No exceptions will be made.

- 7. Ties for 6th place will be decided in a 25 target shoot-off round. Any ties remaining will be decided by the score in the previous round.
- 8. The top six (6) shooters in each age class will fire a finals round of 25 targets. Scores from the finals round will be added to the preliminary round scores to determine final standings. Ties will be broken using the scores in the finals round and the last preliminary round, in that order.

# **INTERNATIONAL TRAP RULES**

1. Rules -- International Shooting union regulations for Olympic trap rules\* will be used for firing and scoring. Note the following rules for exceptions or modifications.

- 2. Age Divisions Three standard 4-H age classes will be used.
- 3. Squadding -- Squads will be of mixed ages.
- 4. Course of fire -- 50 targets.
- 5. Guns -- Any shotgun 12 gauge or smaller and capable of shooting doubles may be used. An over-under choked, modified and full is best. \*NOTE ported barrels WILL be allowed. (I.S.U. Rule Change 1989).
- 6. Ammunition Shot charge no greater than 7/8 ounce (24 grams) and shot size no larger than #71/2.
- 7. Ties for 6th place will be decided in a 25 target shoot-off round. Any ties remaining will be decided by the score in the previous round.
- 8. The top six (6) shooters in each age class will fire a finals round of 25 targets. Scores from the finals round will be added to the preliminary round scores to determine final standings. Ties will be broken using the scores in the finals round and the last preliminary round, in that order.

# SPORTING CLAYS SHOOT

# **GENERAL RULES AND INFORMATION**

- 1. Sponsor: The United States Sporting Clays Association.
- 2. Registration will be the same day as Trap and Skeet but the competition will be conducted only on Thursday and Friday, July 24 and 25.





# Announcing the TEXAS 4-H TRAP AND SKEET POSTAL LEAGUE June - August, 1997 RULES AND REGULATIONS

#### Introduction

The Texas 4-H Shooting Sports Program will conduct the fifteenth annual Trap and Skeet Postal League for 4-H members enrolled in shooting sports projects during June-August in 1997.

The objectives for this program are as follows:

- 1. To encourage 4-H members to participate in Trap and Skeet shooting projects.
- 2. To teach 4-H youth shooting skills while developing a lifetime activity.
- 3. To teach the principles of economics, wise purchasing and evaluation of costs.
- 4. To offer 4-H members informal, low-key competition.
- 5. To offer 4-H members a low cost system of competition.
- 6. To develop in 4-H youth leadership skills, citizenship qualities and teaching abilities.

#### ELIGIBILITY

All currently enrolled 4-H shooting sports members between the official ages of 9 (or in the 3rd grade) and 18 are eligible.

#### COMPLETING THE REGISTRATION FORM

- Make 2 additional copies of the attached COUNTY REGISTRATION FORM. LIST all contestants on all three copies of the registration form by age classification. Begin with Sub-Juniors, then Juniors and Seniors. Please type or print all entries, making sure that all names are spelled correctly, thus eliminating mistakes when awards are engraved.
- 2. Indicate events T for trap only; S for skeet only; B for both trap and skeet.
- 3. Calculate total entry fees and enter. Make **one** check payable to the **TEXAS 4-H FOUNDATION** Memo: **Trap & Skeet Postal**.
- 4. Mail one copy and your check to the State 4-H Office by June 15, 1997.

#### AGE CLASSIFICATION

There will be three age divisions based on the official age as determined on December 31, 1996.

**Sub-junior** – any person who has entered the third grade or is 9 to 12 years of age **Junior** – 13-14 years of age

Senior -- 15-18 years of age, may not have reached their 19th birthday, by December 31 of the previous year).

#### LEAGUE DATES

June 1 through August 31, 1997.

#### COMPETITION

A county may enter as many 4-Her's as interested in each age classification. All competition will be on an individual basis. No team scores will be used.

POSTAL LEAGUES are separate, local events. Scores from any other competitive event such as a district shoot or the state shoot may not be used.

#### NUMBER OF SHOTS

Each contestant must shoot the required number of targets each month for each event entered. The required targets may be shot on any day during the month, but not be repeated to better the score. If a shooter is entered in both trap and skeet, the required targets for each may be shot on separate days.

#### RULES

- 1. NSSA and ATA rules or current 4-H Trap and Skeet Rules apply.
- 2. ADEQUATE EAR PROTECTION (PLUGS AND/OR MUFFS) WILL BE REQUIRED OF ALL PERSONS ON THE FIRING LINE IN ALL 4-H SHOOTING SPORTS ACTIVITIES OR EVENTS.
- 3. ADEQUATE EYE PROTECTION (TEMPERED PRESCRIPTION GLASSES, SHOOTING GLASSES, OR INDUSTRIAL SAFETY GLASSES) WILL BE REQUIRED OF ALL PERSONS WHILE ON THE FIRING LINE.

#### COURSES OF FIRE

Each age division must complete a minimum course of fire each month. The official rounds must be designated BEFORE they are shot and may not be repeated to improve the score. Please do not turn in scores for any extra rounds shot.

Senior	75 targets
Junior	50 targets
Sub-Junior	25 targets

#### **KEEPING AND REPORTING SCORES**

- 1. Coaches are to keep scores on the remaining two registration score forms.
- 2. Postal League scores should be entered for each shooter each month.
- 3. When the August postal is completed, the coach is to tally all scores and return one (1) copy of the registration score form to the State 4-H Office by **September 15, 1997**. Scores must reach the 4-H Office by September 15 to be eligible for awards.

#### BREAKING TIES

Ties for both Trap and Skeet will be broken as necessary to determine district and state award winners. In the event of ties, awards will be decided on the basis of the longest run, from the front, then the longest run from the back. Ties that cannot be resolved will receive duplicate awards.

### AWARDS

- 1. Participation Recognition -- Each participant will receive a special league patch.
- 2. Minimum Qualifying Standards -- Minimum standards of performance, based on the percentage of targets broken for each age group, have been established in order to qualify for All District or All State Team recognition.

- All District Teams The top qualifying shooters in each age classification for each district will be named to the All District Teams. Eight shooters will be selected for each district team in each age group.
- All State Team -- The All State Team will be selected from the All District Teams in each age classification. Eight shooters in each age class will be selected to the All State Teams.

Each All District and All State Team member will receive a plaque or trophy as recognition for their accomplishment.

#### **RESULTS AND WINNERS**

Results and winners will be announced as soon as possible after September 15.

LATE RESULTS -- Scores received after September 15 are disqualified from the competition.
