

Texas Nonagricultural Wage and Salary Employment (Seasonally Adjusted)

The Total Nonagricultural Employment series has added jobs for 26 of the past 28 consecutive months. A total of 243,700 jobs were added to the Texas labor market since January 2006, resulting in an annual growth rate of 2.5 percent. From January 2006 to January 2007, ten of the eleven major industries added jobs, with nine of those industries ranging from 12,000 to 49,100 jobs added. Professional and Business Services led over-the-year growth, followed by Leisure and Hospitality.



Mining employment increased 1,800 jobs in January. This industry has added jobs each month since November of 2003 and recorded significant year-over-year payroll additions. The annual growth rate rose from 11.9 percent in December 2006 to 12.7 percent in January. A total of 22,100 positions have been added in Mining since January 2006.

Government employment gained 3,200 jobs in January. Since this past summer, Government has expanded by 15,000 jobs. The annual growth rate dropped slightly from 1.9 percent in December 2006 to 1.8 percent in January, bringing the number of jobs added in this industry to 30,300 since January 2006.

Financial Activities employment grew for the third straight month, adding 1,500 jobs in January. A total of 12,800 jobs were added in the industry since last January. The annual growth rate increased from 1.9 percent in December 2006 to 2.1 percent in January 2007.

Following an increase of 2,800 jobs in December, Professional and Business Services employment gained 800 positions in January. This was the sixth consecutive positive over-the-month change. The annual growth rate was 4.1 percent in January, adding 49,100 jobs since January 2006.

Employment in Information increased by 500 jobs in January following a decrease of 100 positions in December. This was the first positive over-the-month employment change since September 2006. The annual growth rate rose from -0.9 percent in December to -0.4 percent in January. This sector lost 1,000 positions since January 2006.

Employment in Leisure and Hospitality gained 200 jobs in January following a gain of 2,700 positions in December. This was the sixth consecutive month of payroll expansions. The annual growth rate was 4.4 percent in January, an increase of 40,400 positions since January 2006.

Following an increase of 100 jobs in December, Other Services employment lost 1,000 positions in January. This was the first negative monthly employment change since July 2006. The annual growth rate remained constant in January at 0.2 percent, an increase of 800 jobs since January 2006.

After five consecutive months of employment growth, Construction employment decreased by 1,200 jobs in January. This industry has added employment in 19 of the past 24 months. The annual growth rate was 4.5 percent, representing the addition of 26,600 positions in Construction since January 2006.

Following an increase of 300 jobs in December, employment in Trade, Transportation and Utilities lost 2,200 positions in January. This was only the fourth monthly employment drop in the last thirteen months. This industry gained 20,500 jobs since January 2006 with an annual growth rate of 1.0 percent.

ANNUAL HOUSEKEEPING

With the release of January 2007 statistics, the Labor Market and Career Information Department has incorporated required revisions following the Bureau of Labor Statistics methodology. Both the Local Area Unemployment Statistics series and the Current Employment Statistics series have been updated.

Metropolitan Statistical Area (MSA) Nonagricultural Wage & Salary Employment (Not Seasonally Adjusted)

The annual growth rate for Total Nonagricultural Employment remained unchanged at 2.6 percent, well above the average January annual gain for the past five years of 0.8 percent. All MSAs posted expected over-the-month seasonal losses with the exception of the Tyler MSA. Total Nonagricultural Employment in the MSAs lost 136,100 jobs in January. The Houston-Sugar Land-Baytown MSA and the Dallas-Plano-Irving area were responsible for almost half of January's employment loss.

Retail Trade employment declined in January by 53,000 jobs due to seasonal factors following the holiday shopping period. In comparison, the average January decrease in Retail Trade employment over the past five years was 53,500. The largest decreases in Retail Trade employment again were seen in the Houston-Sugar Land-Baytown MSA and the Dallas-Plano-Irving area, with losses of 14,200 and 11,300 jobs, respectively. Retail Trade gained 8,800 jobs over the year, well above the five-year-average annual gain for January. The Victoria MSA posted the highest annual growth rate, followed by the Laredo MSA, with increases of 4.6 percent and 4.3 percent, respectively.

Employment in Leisure and Hospitality fell by 12,300 positions in January. This loss of personnel was due to seasonal factors and resulted in an annual growth rate of 5.2 percent. The Tyler MSA grew


by 15.7 percent from January 2006 in Leisure and Hospitality. This was the largest over-the-year percentage change throughout the various MSAs and was due in large part to steady expansion. With the exception of four MSAs, all areas achieved annual growth rates that exceeded 2.0 percent. The Tyler MSA and the San Angelo MSA each reached double-digit annual growth rate increases within this sector while ten more MSAs grew by more than 5.0 percent.

Total Nonagricultural employment in Texas MSAs increased by 308,500 jobs since January 2006. The more populated areas were the largest contributors to job gains. From January 2006 to January 2007, the Houston-Sugar Land-Baytown MSA added the most jobs with 99,100. The Dallas-Plano-Irving area and Austin-Round Rock MSA ranked second and third, adding 78,900 and 33,900, respectively. All of the top five MSAs experienced over-the-year growth in excess of 16,000 jobs.

In addition to looking at actual job growth counts, growth rates allow for a comparison of areas regardless of employment levels. The statewide over-the-year job growth rate is 2.6 percent, while the top three fastest growing MSAs, Midland, Austin-Round Rock, and Odessa, reached growth rates as high as 5.0 percent, 4.9 percent, and 4.9 percent, respectively. All of the top ten MSAs had an over-theyear growth rate of 3.4 percent or higher.

Highlights of the Texas Labor Force (Not Seasonally Adjusted)

The Texas unemployment rate was 4.7 percent in January 2007. This is the lowest January rate since 2001, indicating an improved labor market from previous years. The rate dropped 0.7 percentage points since January 2006. The United States' jobless rate rose to 5.0 percent from 4.3 percent in December. In addition, the January U.S. rate is one-tenth of a percentage point lower than last year's rate of 5.1 percent. This is the second consecutive month that the Texas unemployment rate has been lower than the United States rate since early 2001.

The number of Texas jobholders decreased over the month, a seasonal drop of 138,200 employed. The decline brought the state employment total to 10,980,100. This is the first over-the-month drop since August 2006. Since last January, the number of Texas jobholders rose by 259,200. This is the highest January over-the-year employment gain since 1984.

Unemployment historically increases during the month of January. Over the month, Texans seeking employment increased by 72,100 to total 546,500 job seekers. The average increase in unemployed job seekers occurring during the month of January since 1970 is 65,600. Since January of last year, unemployment declined by 62,500.

The number of people receiving unemployment benefits in Texas rose by 3,400 to total 88,868 claims in January 2007. Seven Metropolitan Statistical Areas (MSAs) observed claims count decreases over the month, while eighteen MSAs realized increases in claims. The Tyler MSA recorded the largest decrease with 49.1 percent less claims, followed by the Killeen-Temple-Fort Hood MSA which logged a 13.6 percent drop in claims for unemployment benefits. The San Angelo MSA posted a 38.0 percent increase in claims for the month of January.

GLOSSARY OF LABOR MARKET TERMS

Actual or Not Seasonally Adjusted - This term is used to describe data series not subject to the seasonal adjustment process. In other words, the effects of regular, or seasonal, patterns have not been removed from these series.

Civilian Labor Force (CLF) - Is that portion of the population age 16 and older who are employed or unemployed. To be considered unemployed, a person has to be not working but willing and able to work and actively seeking work.

Consumer Price Index (CPI) - Is a measure of the average change over time in the prices paid by urban consumers for a market basket of consumer goods and services. The CPI provides a way for consumers to compare what the market basket of goods and services costs this month with what the same market basket cost a month or a year ago.

Current Employment Statistics (CES) - A monthly survey of nonfarm business establishments used to collect wage and salary employment, workers hours, and payroll, by industry and area. It is sometimes known as Nonagricultural Employment.

Employed (Emp) - Persons 16 years and over in the civilian noninstitutional population who, during the reference week, (a) did any work at all (at least 1 hour) as paid employees, worked in their own business, profession, or on their own farm, or worked 15 hours or more as unpaid workers in an enterprise operated by a member of the family, and (b) all those who were not working but who had jobs or businesses from which they were temporarily absent because of vacation, illness, bad weather, childcare problems, maternity or paternity leave, labor-management dispute, job training, or other family or personal reasons, whether or not they were paid for the time off or were seeking other jobs. Each employed person is counted only once, even if he or she holds more than one job.

Local Area Unemployment Statistics (LAUS) - The Federal/State cooperative program which produces employment and unemployment

estimates for states and local areas. These estimates are developed by State Employment Security Agencies in accordance with Bureau of Labor Statistics (BLS) definitions and procedures. Data is used for planning and budgetary purposes as an indication of need for employment and training services programs. Estimates are also used to allocate Federal funds.

Metropolitan Division (MD) - A Metropolitan Statistical Area which contains a single core with a population of 2.5 million or more may be subdivided into smaller groupings of counties referred to as Metropolitan Divisions. Titles of Metropolitan Divisions are typically based on principal city names. Texas has two Metropolitan Divisions, the Dallas-Plano-Irving MD and the Fort Worth-Arlington MD, which combine to form the Dallas-Fort Worth-Arlington MSA.

Metropolitan Statistical Area (MSA) - A geographic area that contains at least one urbanized area of 50,000 or more population plus adjacent territory that has a high degree of social and economic integration with the core urban area. An MSA in Texas is made up of one or more counties. The U.S. Office of Management and Budget defines metropolitan areas according to published standards that are applied to Census Bureau data. Texas has 25 MSAs and two Metropolitan Divisions (MD).

Seasonally Adjusted (SA) - Seasonal adjustment removes the effects of events that follow a more or less regular pattern each year. These adjustments make it easier to observe the cyclical and other non-seasonal movements in a data series.

Unemployed (Unemp) - Persons 16 years and over who had no employment during the reference week, were available for work, except for temporary illness, and had made specific efforts to find employment sometime during the 4-week period ending with the reference week. Persons who were waiting to be recalled to a job from which they had been laid off need not have been looking for work to be classified as unemployed.

CHANGES FOR 2007

Release Schedule for Revised Data

The Labor Market and Career Information Department has almost completed its annual benchmark revisions. Revised Nonagricultural Wage and Salary employment estimates, including annual averages, are now available for 2005 and 2006. Under the guidelines of the Bureau of Labor Statistics, other years may have experienced changes in employment levels.

Labor force estimates (Civilian Labor Force, Employed, Unemployed, and Unemployment Rate) for Texas have been revised and are now available. Labor force estimates for all other geographic areas will be revised and released based on the schedule below. Three Cities Added to Labor Force Statistics Data

Under Bureau of Labor Statistics-mandated methodology, in order for citylevel labor force estimates to be produced, a city must meet three criteria:

- Have a population of 25,000 or more
- · Be controlled by a form of local government
- Have an annual population estimate produced by the U.S. Census Bureau

Three additional cities have met the above criteria and data will be available beginning with January 2007 estimates. The additional cities are Eagle Pass, Schertz, and Waxahachie. Now, data is available for 103 cities in Texas.

Reminder about Elimination of Monthly Revision

In accordance with a change in policy instituted last year by the Bureau of Labor Statistics, we no longer perform monthly revisions to labor force estimates for the state or any sub-state area. Once published, monthly labor force estimates, including the number of employed, the number of unemployed and the unemployment rate, will stand until the annual benchmark revisions are completed in March of each year.
