

# Texas Nonagricultural Wage and Salary Employment (Seasonally Adjusted)

Total Nonagricultural Employment grew for the nineteenth consecutive month, gaining 4,400 jobs in April 2006. All industry groups in the Goods-Producing sector added jobs, while increases and decreases in the Service-Providing sector partially offset one another, leaving the sector down over the month. The annual growth rate for Total Nonagricultural employment in Texas remained strong at 2.5 percent.



Financial Activities employment posted an over-the-month gain of 3,700 positions in April, the biggest monthly job gain recorded in the group since July 1999. The annual growth rate improved to 3.5 percent and has stayed positive for over a decade. Financial Activities employment has grown by 21,000 jobs since April 2005.

Natural Resources and Mining employment grew for the third consecutive month, increasing by 1,200 jobs in April. However, the annual growth rate decreased, dropping from 6.5 percent in March to 5.7 percent in April. A total of 9,300 jobs have been added in Natural Resources and Mining since April 2005.

Employment in Construction gained 2,600 jobs in April, following an increase of 5,000 jobs in March. Since last April, 29,100 jobs were created in Construction. Consequently, the annual growth rate was 5.2 percent in April and has remained positive for the past eighteen months.

Employment in the Manufacturing sector grew by 1,200 jobs in April, following a gain of 1,100 in March. The annual growth rate of 0.9 percent represents an addition of 8,500 jobs since April 2005.

Employment in Education and Health Services observed a modest gain of 500 jobs in April, following a significant increase of 3,100 positions in March. As a result, the annual growth rate dropped from 3.1 percent in March to 2.9 percent in April, an over-the-year increase of 33,600 positions.

Following a decrease of 1,500 jobs in March, Leisure and Hospitality Services employment rebounded with a gain of 1,100 positions in April. However, the annual growth rate decreased from 2.2 percent in March to 1.5 percent in April, an increase of 14,000 jobs over the year.

Government employment grew for the fourth month in a row but only recorded a modest increase of 300 jobs in April. As a result, the annual growth rate dipped slightly from 1.5 percent in March to 1.4 percent in April. A total of 23,200 jobs have been added in Government since April 2005.

After a sizeable addition of jobs in March, Trade, Transportation and Utilities employment dropped for the first time this year, recording a modest loss of 1,000 jobs in April. Annual growth remained strong at 2.4 percent, up from 2.0 percent in April 2005.

Following a gain of 800 positions in March, employment in Information lost 3,000 jobs in April. Subsequently, the annual growth rate dropped to -1.6 percent, a decrease of 3,500 positions over the year. This was only the second time the annual growth rate has been in negative territory since August 2005.

Following an increase of 3,600 jobs in March, employment in Professional and Business Services posted a loss of 1,700 positions for the month of April. This was the first over-the-month drop in employment since September 2004. As a result, the annual growth rate dropped from 6.1 percent in March to 5.2 percent in April. This industry has gained 59,400 jobs over the year.

Employment in Other Services decreased by 500 jobs in April, following a small loss in March. The annual growth for this group dropped from 1.0 percent in March to 0.6 percent in April, an increase of 2,100 jobs over the year. This was the smallest annual growth rate this year.










# Metropolitan Statistical Area (MSA) Nonagricultural Wage & Salary Employment (Not Seasonally Adjusted)

Total Nonagricultural Employment in the MSAs increased by 19,700 jobs in April. The Midland MSA posted the largest percentage in job growth in April with 1.0 percent, or 600 jobs. The greatest overthe-month employment gains were in the Dallas-Plano-Irving area, which added 4,500 jobs, and the Fort Worth-Arlington area, which gained 3,800 jobs. Monthly employment gains were also recorded in the Austin-Round Rock MSA, the Houston-Sugar Land-Baytown MSA, and the San Antonio MSA, which added 3,200, 3,000, and 2,900 jobs, respectively. The majority of April's job growth was due to continued seasonal hiring in the Leisure and Hospitality sector.




Employment in the Leisure and Hospitality industry increased by 12,200 jobs in April, following a gain of 15,400 in March. This marks the third consecutive month of growth for the MSAs. The Dallas-Fort Worth-Arlington MSA led in the creation of jobs, with 5,500 positions, but the Killeen-Temple-Fort Hood MSA had the greatest percentage increase in employment at 4.9 percent. The Dallas-Plano-Irving area contributed 4,100 jobs to the industry growth followed by the San Antonio MSA, which added 1,600 jobs. The highest annual growth rate for the Leisure and Hospitality industry was in the Sherman-Denison MSA at 7.1 percent. The Dallas-Plano-Irving area posted an annual growth rate of 2.3 percent and had the highest over-the-year change with 4,200 positions.

Professional and Business Services employment increased by 2,700 jobs across the MSAs in April. The Dallas-Plano-Irving area accounted for over fifty percent of the growth, adding 1,400 jobs. Over the year, the Amarillo MSA employment grew by 8.9 percent, representing 800 jobs and the largest percentage growth rate of any MSA in this industry. The Odessa and Midland MSAs followed with an annual growth rate of 8.1 percent and 7.8 percent, respectively.

Financial Activities employment added 1,200 jobs in April, the third consecutive month of positive growth. The major contributors, the Dallas-Plano-Irving area and the San Antonio MSA, generated 500 jobs each and the Houston-Sugar Land-Baytown MSA was a close second with 400 jobs. The Texarkana MSA held an impressive spot, with the highest percentage growth both in over-the-month and over-the-year, at 4.0 percent and 13.0 percent, respectively. Overall, employment in Financial Activities for all of the MSAs posted a 2.8 percent annual growth rate.

Employment in Government experienced an increase of 2,700 jobs. Local government contributed to the majority of the increase with 2,400 jobs. The Fort Worth-Arlington area led with an addition of 1,000 positions, followed by the San Antonio MSA, with an increase of 800 jobs. The Austin-Round Rock MSA followed closely with an increase of 700 jobs. The Victoria MSA logged the highest percentage growth rate in April at 2.3 percent. The second highest percentage growth rate for April was seen in the Beaumont-Port Arthur MSA at 1.1 percent.

After two previous months of notable job growth, Manufacturing reported a decline of 900 jobs. While the majority of the MSAs posted employment declines, three MSAs recorded April job gains. After nine consecutive months of no job growth in Manufacturing, the College Station-Bryan MSA had the largest monthly percentage of job growth at 1.6 percent. The El Paso MSA had an over-the-month job gain of 0.5 percent, or 100 jobs. The San Antonio MSA posted the largest monthly employment gain in Manufacturing by adding 400 jobs. This job increase can be attributed to the recent hiring activity for a new automobile manufacturing plant.

# Highlights of the Texas Labor Force

(Not Seasonally Adjusted)

The Texas unemployment rate declined for a third consecutive month, dropping 0.2 percentage points to 4.8 percent in April 2006. This month's unemployment rate decline is 0.1 percent less than the average decline of 0.3 percent that usually occurs from March to April. The current rate is the lowest so far in 2006 and is 0.3 percentage points lower than April 2005. The United States' jobless rate dropped for a second month in a row by 0.3 percentage points to 4.5 percent. This decline is typical for the United States unemployment rate between March and April and is the lowest April rate since 1999. In addition, the April rate is four-tenths of a percentage point lower than the year-ago level.

The number of Texas jobholders increased slightly by 6,200 from March to April. This month's gain is below the historical average increase of 40,200 that is normally observed between March and April. The rise brought the state employment total to 10,797,100. Over the year, employment has increased by 219,100 workers.

The number of Texans seeking employment continued to edge downward over the month, decreasing by 15,500 to total 548,300 job seekers. This is the lowest March-to-April decline since 2002 and is less than the historical average decline of 25,500 job seekers occurring between March and April. Since January, the number of unemployed has dropped by 45,100 job seekers.

The number of people receiving unemployment benefits dropped over the month by 7,000 to 80,900 in April. All but three of the twenty-five Metropolitan Statistical Areas (MSAs) observed a claim count decrease over the month. The Lubbock MSA recorded the largest percentage decline at 44.4 percent fewer claims, while the Victoria MSA registered the largest increase, a 2.5 percent rise in claims for unemployment benefits.

Twenty-one of the state's twenty-five MSAs recorded a drop in their unemployment rate between March and April 2006. The Midland MSA continues to have the lowest unemployment rate in Texas, at 3.4 percent, a position they have held since January 2005.

All estimates are subject to revision. \*Metropolitan Division (MD). The Dallas-Fort Worth-Arlington MSA is comprised of the Dallas-Plano-Irving MD and the Fort Worth-Arlington MD.

## GLOSSARY OF LABOR MARKET TERMS

**Actual or Not Seasonally Adjusted** - This term is used to describe data series not subject to the seasonal adjustment process. In other words, the effects of regular, or seasonal, patterns have not been removed from these series.

Civilian Labor Force (CLF) - Is that portion of the population age 16 and older who are employed or unemployed. To be considered unemployed, a person has to be not working but willing and able to work and actively seeking work.

Consumer Price Index (CPI) - Is a measure of the average change over time in the prices paid by urban consumers for a market basket of consumer goods and services. The CPI provides a way for consumers to compare what the market basket of goods and services costs this month with what the same market basket cost a month or a year ago.

**Current Employment Statistics (CES)** - A monthly survey of nonfarm business establishments used to collect wage and salary employment, workers hours, and payroll, by industry and area. It is sometimes known as Nonagricultural Employment.

Employed (Emp) - Persons 16 years and over in the civilian noninstitutional population who, during the reference week, (a) did any work at all (at least 1 hour) as paid employees, worked in their own business, profession, or on their own farm, or worked 15 hours or more as unpaid workers in an enterprise operated by a member of the family, and (b) all those who were not working but who had jobs or businesses from which they were temporarily absent because of vacation, illness, bad weather, childcare problems, maternity or paternity leave, labor-management dispute, job training, or other family or personal reasons, whether or not they were paid for the time off or were seeking other jobs. Each employed person is counted only once, even if he or she holds more than one job.

Local Area Unemployment Statistics (LAUS) - The Federal/State cooperative program which produces employment and unemployment

estimates for states and local areas. These estimates are developed by State Employment Security Agencies in accordance with Bureau of Labor Statistics (BLS) definitions and procedures. Data is used for planning and budgetary purposes as an indication of need for employment and training services programs. Estimates are also used to allocate Federal funds.

Metropolitan Division (MD) - A Metropolitan Statistical Area which contains a single core with a population of 2.5 million or more may be subdivided into smaller groupings of counties referred to as Metropolitan Divisions. Titles of Metropolitan Divisions are typically based on principal city names. Texas has two Metropolitan Divisions, the Dallas-Plano-Irving MD and the Fort Worth-Arlington MD, which combine to form the Dallas-Fort Worth-Arlington MSA.

Metropolitan Statistical Area (MSA) - A geographic area that contains at least one urbanized area of 50,000 or more population plus adjacent territory that has a high degree of social and economic integration with the core urban area. An MSA in Texas is made up of one or more counties. The U.S. Office of Management and Budget defines metropolitan areas according to published standards that are applied to Census Bureau data. Texas has 25 MSAs and two Metropolitan Divisions (MD).

Seasonally Adjusted (SA) - Seasonal adjustment removes the effects of events that follow a more or less regular pattern each year. These adjustments make it easier to observe the cyclical and other non-seasonal movements in a data series.

**Unemployed (Unemp)** - Persons 16 years and over who had no employment during the reference week, were available for work, except for temporary illness, and had made specific efforts to find employment sometime during the 4-week period ending with the reference week. Persons who were waiting to be recalled to a job from which they had been laid off need not have been looking for work to be classified as unemployed.

## "HAPPENINGS AROUND THE STATE"

#### **Samsung Plant Construction Begins**

AUSTIN, TX (Austin American-Statesman—Kirk Ladendorf)—South Korean computer chip maker, Samsung, has begun construction of a second chip factory in Austin, which is expected to be three to four times larger than the existing plant in Austin. The factory is expected to employ around 900 workers, including both Samsung employees and those of supply companies who will work in the factory.

Local and state officials think it is the largest-ever investment by a foreign company in a U.S. plant. The price tag is estimated at \$3.5 billion to \$4 billion. Construction is expected to be done by late 2007 with the factory beginning production of advanced computer memory chips in late 2007 or early 2008. Samsung expects that it will take several years to completely outfit the factory.

#### Firm to Hire Up to 800

FORT WORTH, TX (Fort Worth Star-Telegram—Aman Batheja)—DigiSource, a manufacturer of printing materials for cellular manufacturers, plans on doubling its workforce at a facility in north Fort Worth this year, according to a recruiting firm hired by the company.

DigiSource plans to hire as many as 200 people immediately and as many as 600 additional people in the next few months, said Andy Wimpee, a spokesman for Dallas-based HumCap Staffing, a human resources firm recruiting for

DigiSource. HumCap will hold four job fairs to fill the positions at DigiSource's offices on Alliance Gateway Freeway.

#### Sunoco Relocates to Sugar Land

SUGARLAND, TX (City of Sugar Land Economic Development)—The Western Division Headquarters of Sunoco Logistics has started operations in Sugar Land. In relocating from Tulsa to Sugar Land, Sunoco will invest over \$3.7 million in facility improvements and bring over 150 new jobs to the city. Of these, an estimated 85 jobs will be filled locally with an average annual salary of \$65,000 before benefits. "We are extremely excited that the City's economic development program continues to attract quality companies like Sunoco to our community," said Joe Esch, Sugar Land's Executive Director for Business and Intergovernmental Relations.

#### 120 Workers added to Tyson

SHERMAN, TX (Sherman-Denison Herald Democrat)—Tyson Foods has moved closer to fulfilling the promise of 1,600 new jobs in Sherman by the end of the year. After a recent tour of the newly opened Sherman plant, CEO John Tyson announced the addition of 120 workers to its current 830 member staff. "I'm pleased with the progress this plant has made since beginning production six weeks ago. Our Sherman team has done a great job preparing this facility and the growing workforce for a successful start of operations," said Tyson.


