Texas Nonagricultural Wage and Salary Employment (Seasonally Adjusted)

Trade, Transportation and Utilities added 3,900 jobs in June 2006. It was the fifth monthly increase this year and brings the total jobs gained during the year to 14,000. The annual growth rate for the sector remained unchanged at 2.3 percent.

Total Nonagricultural Employment recorded the largest monthly increase so far in 2006 with a gain of 30,000 jobs in June. Nine of the eleven major industry groups added jobs between May and June 2006. Professional and Business Services led the growth adding 11,200 jobs followed by Construction which posted a gain of 4,000 positions. The annual growth rate for Total Nonagricultural Employment rose slightly from 2.6 percent in May to 2.7 percent in June.

Employment in Information gained 2,100 jobs in June following a decrease of 700 positions in May. This was the largest over-themonth increase in six years. The annual growth rate improved from -1.8 percent in May to -0.9 percent in June.



Employment in Professional and Business Services posted a significant boost of 11,200 employees in June, following an increase of 2,600 positions in May. This was the largest over-the-month change since October 1998. The annual growth rate rose from 5.8 percent in May to 6.3 percent in June, an increase of 72,200 jobs since June 2005. This was the biggest annual growth rate since December 2005.

After recording a gain of 3,200 positions in May, employment in Construction continued to improve, increasing by 4,000 jobs in June. The annual growth rate climbed from 5.6 percent in May to reach 6.2 percent in June, the highest growth rate recorded since June 2000. A total of 32,500 jobs have been created in Construction since June 2005.

Following a gain of 2,600 jobs in May, Education and Health Services employment increased by 2,300 positions in June. The annual growth rate rose from 3.0 percent in May to 3.1 percent in June, a gain of 37,100 positions since June 2005.

Following a month of unchanged employment, Natural Resources and Mining added 1,300 jobs in June contributing to an over-the-year job gain of 8,100 positions for this sector. Despite June's employment increase, the annual growth rate fell to 4.9 percent, the lowest growth rate registered since September 2004.

Following a decrease of 1,900 jobs in May, Other Services' employment gained 1,600 positions in June. This was the largest over-the-month increase since November 2002. The annual growth rate rose from -0.2 percent in May to 0.3 percent in June, an increase of 1,000 jobs since June 2005.

Manufacturing employment increased for the third time this year adding 2,800 jobs in June. This was the largest monthly gain since October 2004. The annual growth rate rose as well from 0.6 percent in May to 0.7 percent in June, representing an addition of 6,500 jobs since June 2005.

Government employment maintained six consecutive months of job gains with the expansion of 1,100 jobs in June. The annual growth rate dropped minimally from 1.4 percent in May to 1.2 percent in June. Employment in Government has grown by 12,000 jobs so far in 2006, while 20,300 jobs have been added since June 2005.

Employment in Leisure and Hospitality remained unchanged in June, following a significant increase of 5,000 jobs in May. The annual growth rate remained constant at 1.8 percent, an increase of 16,600 positions since June 2005.

Financial Activities employment posted its first monthly job loss in 2006 with a decrease of 300 jobs in June. The last time the group experienced a month of declining employment was January 2005. June's annual growth rate dropped to 3.3 percent, bringing the number of jobs added since June 2005 to 19,800.








Metropolitan Statistical Area (MSA) Nonagricultural Wage & Salary Employment (Not Seasonally Adjusted)

The Metropolitan Statistical Areas Total Nonagricultural Employment added 1,100 jobs in June. The largest monthly employment gain occurred in the Dallas-Fort Worth-Arlington MSA, which reported an addition of 9,100 jobs. The San Angelo MSA posted the highest percentage of monthly job growth with 0.9 percent job growth rate. Most of the major industry groups recorded job increases in June with Professional and Business Services and Leisure and Hospitality posting the largest job gains. These job additions were partially offset by seasonal declines in Government and Education and Health Services as area schools and education-related businesses began their summer vacation.




The Professional and Business Services industry gained 10,600 jobs in June. The major contributor was from the Dallas-Fort Worth-Arlington MSA with 5,200 jobs—3,500 of which were in the Dallas-Plano-Irving area. The Houston-Sugar Land-Baytown MSA wasn't far behind with 2,200 new jobs. Several MSAs around the state added employment in this industry and recorded significant monthly job growth rates. The Sherman-Denison MSA gained the most employment percentage wise this month with a 3.7 percent job growth rate, while the Abilene MSA registered a 2.4 percent job growth rate from May to June 2006.

Following normal seasonal patterns, Leisure and Hospitality employment posted a gain of 11,000 jobs in June. The majority of the increase occurred in the Dallas-Forth Worth-Arlington MSA with an increase of 3,300 jobs, driven by seasonal hiring in the Fort Worth-Arlington area with 1,800 new jobs. In addition, the San Antonio MSA registered 2,300 new jobs over the month. Percentage wise, the Amarillo MSA logged the highest job growth rate of 2.6 percent for June.

Employment in Natural Resources, Mining, and Construction experienced an increase of 3,900 jobs for the MSAs in June. The largest gains occurred in the Austin-Round Rock MSA, Dallas-Fort Worth-Arlington MSA, and the San Antonio MSA, which together added 4,100 jobs. Two MSAs lost employment between May and June 2006, which partially offset job growth in this industry. The Wichita Falls MSA had the largest monthly job growth rate of 2.6 percent.

Financial Activities employment expanded 3,300 jobs over the month for the MSAs. There were no MSAs that lost employment in this industry between May and June 2006. The Houston-Sugar Land-Baytown MSA continued an upward trend, gaining 900 jobs in this industry for June. The Austin-Round Rock MSA gained 300 jobs over the month. The McAllen-Edinburg-Mission MSA also experienced a significant boost in the Financial Activities industry. They added 200 jobs over the month and are at an all-time high of 8,600 jobs.

Government had a decline of 39,600 jobs in June. This decline was driven by seasonal activity in local school districts and Texas colleges and universities as schools began to release staff for the summer. While a large part of the MSAs reported seasonal declines in Government between May and June, there were two MSAs that posted increases. The San Angelo MSA added 200 jobs and the Waco MSA added 100 jobs. The Laredo MSA and Texarkana MSA recorded the highest percentage over-the-year job growth at 10.0 percent and 8.3 percent, respectively.

Highlights of the Texas Labor Force (Not Seasonally Adjusted)

The Texas unemployment rate moved upward over the month, rising 0.6 percentage points to 5.5 percent in June. This month's change is smaller than the average increase that normally occurs in June. The current rate is 0.1 percentage point lower than June of last year and is the lowest June unemployment rate since 2001. The United States' jobless rate increased over the month by 0.4 percentage points to 4.8 percent, a normal movement for the unemployment rate during the month of June.

The number of Texas jobholders increased for the fifth straight month, a mark up of 85,600 employed. The rise brought the state employment total to 10,905,900. This is the largest May-to-June increase since 1991 and is above the historical average increase of 79,200 that is normally observed during this time period. Since last June, the number of Texas jobholders rose by 280,900.

The number of Texans seeking work increased for the second consecutive month in June, growing by 74,500 to total 636,300. This is less than the average May-to-June increase in job seekers of 78,900 recorded over the past thirty years. June's increase in the number of people seeking work was partially attributed to seasonal reductions at local school districts as non-contract personnel were released for the summer break.

The number of people receiving unemployment benefits in Texas rose by 6,500 to total 86,000 claims in June. Twenty-three of the twenty-five Metropolitan Statistical Areas (MSAs) observed claims count increases over the month. The Lubbock MSA recorded the largest increase with 34 percent more claims, while the Odessa MSA registered the smallest increase, a 0.4 percent rise in claims for unemployment benefits. The El Paso MSA realized a 2.4 percent drop in claims for the month of June.

All twenty-five MSAs in Texas recorded an increase in their number of unemployed between May and June 2006. These increases are partially attributed to normal summer seasonal patterns. Seventeen MSAs noted either the same or a decrease in their unemployment rate from June 2005 to June 2006.

GLOSSARY OF LABOR MARKET TERMS

Actual or Not Seasonally Adjusted - This term is used to describe data series not subject to the seasonal adjustment process. In other words, the effects of regular, or seasonal, patterns have not been removed from these series

Civilian Labor Force (CLF) - Is that portion of the population age 16 and older who are employed or unemployed. To be considered unemployed, a person has to be not working but willing and able to work and actively seeking work.

Consumer Price Index (CPI) - Is a measure of the average change over time in the prices paid by urban consumers for a market basket of consumer goods and services. The CPI provides a way for consumers to compare what the market basket of goods and services costs this month with what the same market basket cost a month or a year ago.

Current Employment Statistics (CES) - A monthly survey of nonfarm business establishments used to collect wage and salary employment, workers hours, and payroll, by industry and area. It is sometimes known as Nonagricultural Employment.

Employed (Emp) - Persons 16 years and over in the civilian noninstitutional population who, during the reference week, (a) did any work at all (at least 1 hour) as paid employees, worked in their own business, profession, or on their own farm, or worked 15 hours or more as unpaid workers in an enterprise operated by a member of the family, and (b) all those who were not working but who had jobs or businesses from which they were temporarily absent because of vacation, illness, bad weather, childcare problems, maternity or paternity leave, labor-management dispute, job training, or other family or personal reasons, whether or not they were paid for the time off or were seeking other jobs. Each employed person is counted only once, even if he or she holds more than one job.

Local Area Unemployment Statistics (LAUS) - The Federal/State cooperative program which produces employment and unemployment

estimates for states and local areas. These estimates are developed by State Employment Security Agencies in accordance with Bureau of Labor Statistics (BLS) definitions and procedures. Data is used for planning and budgetary purposes as an indication of need for employment and training services programs. Estimates are also used to allocate Federal funds.

Metropolitan Division (MD) - A Metropolitan Statistical Area which contains a single core with a population of 2.5 million or more may be subdivided into smaller groupings of counties referred to as Metropolitan Divisions. Titles of Metropolitan Divisions are typically based on principal city names. Texas has two Metropolitan Divisions, the Dallas-Plano-Irving MD and the Fort Worth-Arlington MD, which combine to form the Dallas-Fort Worth-Arlington MSA.

Metropolitan Statistical Area (MSA) - A geographic area that contains at least one urbanized area of 50,000 or more population plus adjacent territory that has a high degree of social and economic integration with the core urban area. An MSA in Texas is made up of one or more counties. The U.S. Office of Management and Budget defines metropolitan areas according to published standards that are applied to Census Bureau data. Texas has 25 MSAs and two Metropolitan Divisions (MD).

Seasonally Adjusted (SA) - Seasonal adjustment removes the effects of events that follow a more or less regular pattern each year. These adjustments make it easier to observe the cyclical and other non-seasonal movements in a data series.

Unemployed (Unemp) - Persons 16 years and over who had no employment during the reference week, were available for work, except for temporary illness, and had made specific efforts to find employment sometime during the 4-week period ending with the reference week. Persons who were waiting to be recalled to a job from which they had been laid off need not have been looking for work to be classified as unemployed.

"HAPPENINGS AROUND THE STATE"

Jet Maker Brings Jobs to San Antonio

SAN ANTONIO, TX (San Antonio Express-News—Sean M. Wood)—Sino Swearingen Aircraft Corp. announced it will build a new business jet in San Antonio, a move that will bring 850 new jobs with an average salary of \$50,000.

The company plans to expand its facility at San Antonio International Airport and plans to build 100 SJ30-2 jets a year by 2010. North San Antonio Councilman Kevin Wolf said, "We have begged for manufacturing partners. We've always been known as a low-wage service town. This is a huge win for us."

Pearland Shopping and Entertainment Center Begins

HOUSTON, TX (Houston Chronicle)—Construction of an 800,000-square-foot center for shopping, dining, and entertainment in northwest Pearland has started, and is scheduled to be complete in October of 2007. The 127-acre development, touted as a "lifestyle center," had its ground-breaking ceremony on June 22, which was attended by several city officials including Mayor Tom Reid.

The Promenade Shops at The Spectrum project is expected to create 1,200 to 1,500 jobs, according to Fred Welch, executive director of the Pearland Economic Development Corp.

Kohl's Calls on Corsicana

Dallas, TX (Dallas Business Journal)—Wisconsin-based Kohl's Corp. plans to open a new call center in Corsicana this month. The main reason for the 250-job call center locating to Corsicana is a plentiful labor force and low cost of living, according to Lee McCleary, director of economic development for the city. "They are ramping up pretty quickly, "McCleary said, noting that Kohl's is looking for bilingual operators.

According to Kohl's spokeswoman, Julie Lando, the company will initially hire 60, and then increase in groups of 12 and 24 until it reaches critical mass of up to 250 jobs. Kohl's has 749 stores in 43 states, and has nine distribution centers nationwide.

Detention Center Could Mean 400 Jobs

RAYMONDVILLE, TX (Harlingen Valley Morning Star)—A new \$50 million federal detention center is expected to hire around half of its 400 employees from Willacy County, according to a local official. Most of the remaining jobs will likely be filled by Cameron County residents, said Jackie Robinson, economic development manager for the city of Ramondville. Willacy County has signed a contract with the federal government to develop the detention center to hold 2,000 illegal immigrants, officials said.


