New Texas Asbestos Health Protection Rules

If you haven't already heard, Texas has newly revised asbestos rules. The Texas Asbestos Health Protection Rules (TAHPR) were revised and published for comment in the December 6, 2002 Texas Register. In March 21, 2003 the final rules were published and became effective on March 27, 2003.

I would like to thank everyone who made comments to help improve the rules. I know how long it takes to read through changes, consider the impact, and write down your concerns. I can't tell you how much it helps us to have persons who deal with asbestos abatement concerns on a daily basis to take the time to review the proposal and provide us comments. Without your help we would continue to view the regulation of the industry through the same perspective. So, thank you for your hard work and concern to make the rules even better.

Every time new rules are developed, in spite of everyone's best efforts, some things get missed until after the rules have been published. Some people read them in order to see the changes or others may read them for the first time and discover things that may need to be addressed. Many times, it is only at this point that certain idiosyncrasies are noticed. Many times, the issue that is brought to our attention is not related to a new change, but is something that has been in the rules for a long time. Whatever the issue, we still welcome your comments, even after the rule has been published in its final form. It is through these comments that we compile the list of issues that need to be addressed in the next round of rule changes. So, if you see something that has been bugging you for years, or something that doesn't make sense in the new rules, please let us know so that we can help you.

Continue the good work addressing your asbestos challenges and remember that we are always ready to help you with your questions.

Request for 2-day Consultant Refresher Course

The Asbestos Training Provider Licensing Program (Program) received a request to conduct a 2-day Consultant Refresher course and we would like to share the results of our efforts based on that inquiry. The basis of this request comes from §295.65(e), where the following is stated, "... Consultants shall attend an approved two-day annual refresher training course, or four separate refreshers consisting of project designer, inspector, management planner, and air monitoring technician." The program discussed this issue at length with the Department's Office of General Council (OGC). It is the position of the Program that it can not allow the combining of individual training courses into a single "Consultant Refresher" course, since it is both outside the approval authority delegated to the Department from the Environmental Protection Agency (EPA), and it is in direct conflict with a number of the Sections in the Texas Asbestos Health Protection Rules (TAHPR).

The following TAHPR citations provide our rationale to the conclusion derived above:

In the TAHPR, §295.64(a)(1) states, "The provisions of the Environmental Protection Agency (EPA) Model Accreditation Plan (MAP) reaffirm the principle that each of the accredited training disciplines is distinct from the others, because each reflects a different functional job role. Training courses for all disciplines shall be in accordance with the MAP."

In the EPA MAP, Part 763, Subpart E, *I. Asbestos Model Accreditation Plan for States*, Section D "Continuing Education", (5) states, "... The refresher course shall be specific to each discipline. Refresher courses shall be conducted as separate and distinct courses and not combined with any other training during the period of the refresher course. ..." This is even confirmed in the Preamble to the MAP, Vol. 59, No 23, Thursday, February 3, 1994, Section II Summary of Changes, C. Distinct Training Disciplines, page 9. "Even where training programs cover common subjects, these same subjects need to be given a different priority and emphasis depending upon the particular discipline a person is being trained for. ..."

In the TAHPR, §295.64(a)(2) states, "Each initial and refresher training course offered for accreditation must be specific to a single discipline, and not combined with training for any other discipline." And, in the new rule, the Program extended the prohibition of combining instruction to the hands-on training portion of training courses.

In the TAHPR, §295.55(d)(9)(C) states, "Basic or refresher courses shall be conducted in only one discipline and not be combined with courses of other disciplines, i.e., an abatement worker course and a contractor/supervisor course cannot be taught as a combined course." And, in the new TAHPR, the Program added the following language to the rule: "This prohibition against combined training applies to hands-on training sessions as well as other aspects of the course."

Lastly, the TAHPR, §295.64(a)(6) states, "... No more than eight hours of instruction are authorized within a calendar day."

In conclusion, the Program sees no option under the TAHPR that would allow a combined 2-day Consultant Refresher Course, since the Department is either bound to the requirements of the MAP or prohibited by virtue of the TAHPR. The Program will consider this concern during a future rule change. The argument is that since the air monitor technician course is not covered by the MAP, Texas could allow additional training in this category to be offered in the same day, beyond the eight hour limit for MAP courses.
