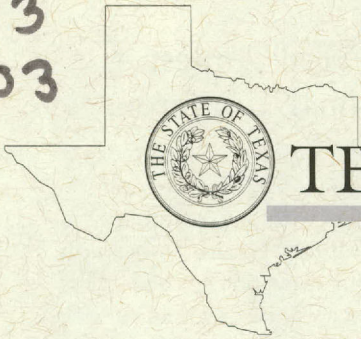

Legislative Update

The recently completed 79th Texas Legislative Regular Session produced several bills that were signed into law that will impact vital statistics. The list below briefly enumerates and describes the new statutes. For full access to the new laws, see www.capitol.state.tx.us.

HB 93 impacts the Certificate of Death. This law mandates that the manner of death of an inmate of the Texas Department of Criminal Justice who is executed will be indicated as "Judicial Execution." When the Certificate of Death next goes through the revision process, Texas Vital Statistics will include this manner of death option.

HB 209 impacts the challenge period for an Acknowledgment of Paternity (AOP). This law allows for a minor who has signed an AOP to have four years after the minor's 18th birthday to challenge the signed AOP.

HB 240 impacts the accessibility of sealed adoption records. This law states that an adopted person over the age of 18 who knows the name(s) of birth parent(s) on the original Certificate of Birth to obtain a non-certified copy of the original record without a court order. This law will apply only to Texas Vital Statistics.

HB 723 impacts District Clerks. This law requires District Clerks to complete sections of the Suits to Affect the Parent Child Relationship form if the applicant or attorney have not completed it.

HB 1604 impacts timeframes for filing very specific Certificates of Birth. This law allows for 15 days

to file a birth record if the family, for religious reasons, requests the extension for naming of the child. (See article on this page.)

HB 2100 creates a new heirloom wedding anniversary commemoration to be issued only by Texas Vital Statistics. The cost of this parchment commemoration will be \$50.

HB 2101 mandates the Texas Department of State Health Services to promote and sell heirloom Certificates of Birth and increases the cost to \$50.

HB 2769 impacts the Certificate of Death. This law mandates that the question "was the decedent ever a peace officer?" be changed to "was the decedent a peace officer or an honorably retired peace officer in this state?" When the Certificate of Death next goes through the revision process, Texas Vital Statistics will make this change.

SB 239 requires Texas Vital Statistics to issue non-certified copies of birth and death records to Child Fatality Review Teams at no charge.

SB 271 impacts birth registration. This law creates a "certificate of birth resulting in stillbirth" to be issued by Texas Vital Statistics upon the parents' request.

SB 1524 extends application of the preservation fee created in the 78th Legislative Session. This law extends the collection of a \$1 record preservation fee to county clerks for issuance of birth, death, fetal death, marriage, divorce and annulment records. This fee is also extended to records issued through the Remote Birth Access site.

All new statutes signed into law in

will take effect on September 1, 2005. The specifics of implementation will be thoroughly discussed at the Regional Conferences in August (see pages 2 & 3 for registration information). Watch for more information in future newsletter issues.

Timeliness & TER-Birth

With the implementation of TER at the beginning of the year, training users and eliminating any bugs and glitches in the system so that all births will be registered online have been the first priority. There have been some rough patches as we all learn the system and respond to unanticipated problems, such as the AOP backlog. Successful registration has been the focus!

Now that the transition to electronic birth registration is leveling out, Texas Vital Statistics will soon resume tracking the timeliness of each birth facility's registration. Texas Health and Safety Code (HSC) 192.003(d) says that births must be registered within 5 days of the event. (continued on page 4)

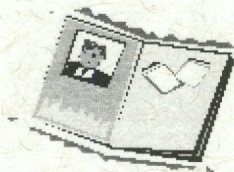

Passport Initiative

A joint press release issued by the U.S. Department of State and the U.S. Department of Homeland Security announced the Western Hemisphere Travel Initiative, an initiative to secure and expedite travel. This initiative will require all U.S. citizens (as well as Canadians, citizens of the British Overseas Territory of Bermuda and citizens of Mexico) to have passports or other accepted secure documents to enter or re-enter the U.S. by January 1, 2008.

This initiative will impact all Texans who are accustomed to traveling to Mexico without a passport and for all who issue birth certificates. Some local registrars have already reported an increase in requests for certified copies of birth records from customers who have heard of the upcoming passport requirement for travel that previously did not require passports. This new passport requirement will also have implications related to possible increase in individuals seeking to fraudulently obtain birth records.

The Texas Vital Statistics website has been revamped and integrated into the Texas Department of State Health Services website. The new website has two sections: Request Processing and Vital Registration.

The Request Processing section of the website contains information about how to order records and verifications, how to amend records, the Central Adoption Registry, establishment of paternity and fees. Applications are also on the site, and can be downloaded by customers and sent to our office via mail or fax.

The Vital Registration section of the website includes information about the Remote Birth Access site, Delayed Certificate of Birth registration, location of local registrars, marriage and divorce records, electronic death registration (TER-Death), lists of Remote Birth Access site participants statewide and a new Field Services site.

The Field Services site at www.dshs.state.tx.us/vs/field highlights the latest information on training opportunities like the regional and annual conferences, funeral director continuing education, AOP certification seminars, online medical certifier training and the Master Registrar Certification Course for local registrars. Be sure to check this site often to find out about future training, especially training related to the implementation of TER-Death, the online death registration system

With the passage of HB 1604 (see page 1 for description of this new statute), effective immediately, birth clerks may allow for up to 15 days to report the name of the newborn if the parents request the delay for religious reasons. This extension is only available when a specific religious belief of conflicts with the 5-day requirement. No special procedure or notification of the State or the local registrar is required when accomodating parents in this situation.
