Note from the Director

Indicators of border business activity for the month of July demonstrated an increase of thirteen indicators over eight indicators that decreased. In addition, for the year-to-date (YTD) figures, fifteen indicators were up and five were down. Selected YTD comparisons to 1999 reported by border cities include the following:

- · Southbound pedestrian crossings into Mexico were down 1.6 percents. Laredo gained 0.9 percent, Rio Grande jumped 24.1 percent, McAllen registered an increase of 7.4 and El Paso rose 0.8 percent.
- Southbound vehicle crossings were up 2.7 percent. Brownsville grew by 2.0 percent, and Eagle Pass gained 11.3 percent. El Paso went up 8.8 percent and Laredo rose 2.4 percent. Pharr increased 6.5 percent.
- Southbound truck crossings into Mexico were up 9.7 percent. Eagle Pass went up 64.2 percent. Pharr increased 26.6 percent, and Laredo rose 10.3 percent. Harlingen was up 4.0 percent.
- Northbound truck crossings into Texas were up 5.3 percent, Falcon increased 18.2 percent, Pharr gained 16.7 percent and Eagle Pass posted a 9.1 percent increase. Brownsville increased 15.3 percent, Laredo rose 1.3 percent, Del Rio marked an increase of 7.5 percent, as well as Rio Grande with a gain of 9.7 percent.
- Southbound shipments by rail were up 11.1 percent.
- Northbound shipments by rail were up 18.7 percent.
- Revenues collected by U.S. Customs were down by 0.5 percent.
- Revenues collected by U.S. Bridge operators were up 8.3 percent.
- Total building permits issued were up 4.2 percent. Laredo rose 24.1 percent, Eagle Pass gained 34.0 percent, while McAllen-Hidalgo rose 4.7 percent, and Brownsville registered an increase of 12.3 percent.
- Total building permit values increased 8.2 percent. Laredo increased 50.9 percent, and Brownsville rose 33.9 percent. McAllen-Hidalgo gained 3.2 percent.
- Total employment was up 1.6 percent, with 6,808 jobs gained. The average unemployment rate in July 2000 was 8.3 percent for the border.

Machinery and Transportation Equipment Head the List of Products Exported to Mexico by Way of Texas Border Ports

In an earlier issue of the *BBI* (July 2000), a table was presented exhibiting the top three U.S. exports to Mexico handled by individual Texas-Mexico border ports for the period of January-May 2000. At times, the detailed 5-digit Standard International Trade Classification (SITC) descriptions for the top three dominated the table and did not allow for a more inclusive depiction of what types of products pass through these ports. By stepping back and looking at a more general description (see the list below), one can acquire a feel for the activities taking place on the border.

- · SITC 0 Food And Live Animals
- SITC 1 Beverages And Tobacco
- SITC 2 Crude Materials, Inedible, Except Fuels
- · SITC 3 Mineral Fuels, Lubricants And Related Materials
- · SITC 4 Animal And Vegetable Oils, Fats And Waxes
- · SITC 5 Chemicals And Related Products
- · SITC 6 Manufactured Goods Classified Chiefly By Material
- SITC 7 Machinery And Transport Equipment
- · SITC 8 Miscellaneous Manufactured Articles
- · SITC9 Commodities And Transactions Not Classified Elsewhere In The SITC

The tables to the right, which are continued on the next page, show the ranked order of the U.S. dollar values for the products that were exported to Mexico through the respective ports for January through May 2000. The aggregate dollar value of all groups at all Texas-Mexico border ports for this period was a little over \$30.0 billion dollars and the group that comprised the biggest percentage was SITC 7 —machinery and transport equipment— with 54.5 percent of the total or \$16.4 billion. SITC groups that also registered values of over a billion dollars were SITC 6, SITC 8, SITC 5 and SITC 0.

The ports that handled 76.8 percent of the group 7 amount were Laredo with \$8.6 billion (52.8%) and El Paso with \$3.9 billion (24.0%). Nine of the eleven ports had SITC 7 ranked as the top dollar value. The remaining two ports were Rio Grande which registered SITC 9 at the top, and Progreso which recorded SITC 0 in the top position.

With over \$4.9 billion dollars total for all Texas border ports combined, SITC 6 —manufactured goods classified chiefly by material— was the second ranked group in terms of value. It comprised 16.4 percent of the total exports for January through May 2000.

Laredo and El Paso were the ports that again processed about \$3.8 billion, or 77.9 percent of the whole.

SITC 8's —miscellaneous manufactured articles— total value for all border ports in Texas was \$3.5 billion. This constituted 11.6 percent of all exports for the same period.

Laredo's share of the value was 42.1 percent, or about \$1.5 billion. El Paso garnered the next biggest share of 30.6 percent, or \$1.1 billion.

These three groups (6,7,8) combined accounted for \$24.8 billion, or 82.5 percent of the total \$30.0 billion in exports into Mexico. These products appear to have been destined for Mexico's manufacturing and consumer sectors as illustrated in the following short lists of the product descriptions. These lists are a sampling of the products that are exported to Mexico by way of the Texas border ports. A complete list would be too lengthy to include.

The last two groups which were over \$1.0 billion in value were SITC 5 —chemicals and related products— with \$2.4 billion accounting for 7.9 percent share of the total value of exports and SITC 0—food and live animals— with \$1.1 billion, or 3.8 percent.

Laredo handled 67.8 percent or \$1.6 billion worth of group 5, and Brownsville a distant second with 14.4 percent share, or \$340 million.

Again, the port of Laredo processed 59.5 percent, or \$678 million of group 0, and El Paso garnered a 14.7 percent share, or \$168 million.

The five groups (7, 6, 8, 5, 0) accounted for 94.2 percent of the total export value, or \$28.3 billion.



Rio Grande increased 15.4 percent, Brownsville gained 11.3 percent, Eagle Pass rose 4.1 percent, El Paso went up 3.2 percent, and Laredo went up 8.4 percent. Progreso jumped 22.5 percent, and McAllen-Hidalgo was up 7.4 percent. YTD, total southbound pedestrian crossings into Mexico slipped 1.6 percent. El Paso southbound pedestrian crossings, which make up 32.6 percent of all crossings, increased a slight 0.8 percent YTD. Laredo, accounting for 27.0 percent of total crossings, increased 0.9 percent YTD. Brownsville, with a 17.4 percent share, decreased 8.2 percent YTD. Progreso, with 9.2 percent share, declined 4.7 percent.

El Paso, accounting for 14.7 percent of all southbound vehicle crossings, rose 8.8 percent YTD. McAllen-Hidalgo, with 15.5 percent of all southbound vehicle crossings, experienced a 1.2 percent decrease YTD.

July northbound truck crossings into Texas decreased 8.2 percent over June's crossings. Eagle Pass was down 6.5 percent, Brownsville slipped 9.0 percent, Progreso rose 3.7 percent, Pharr slid 3.9 percent. Laredo decreased 9.3 percent. 

Export Rail YTD % Change 99-00







% Unemployed July 99-00







Passenger Arrivals % Change YTD 99-00





July air passenger departures for reporting Texas border cities were up 4.2 percent. McAllen increased 8.8 percent, Harlingen gained 3.7 percent, Laredo went up 9.2 percent, and El Paso grew 3.3 percent. YTD air passenger departures were down 1.0 percent from a year ago. El Paso, with 62.5 percent of all departing passengers, was down 1.4 percent YTD. Harlingen, with 18.6 percent of all departing passengers, declined 0.6 percent YTD. McAllen, with 12.7 percent of all departing passengers, increased 1.2 percent, YTD. Laredo, with 3.6 percent of all departing passengers, rose 1.3 percent YTD. Brownsville, with 2.6 percent of all departing passengers, declined 7.3 percent YTD.



Dry bulk, which accounted for 7.5 percent of the port's inbound cargo for July, increased 1.4 percent from June. Total inbound cargo tonnage was up 7.5 percent YTD.

% Share July 2000 Inbound Cargo





Dry bulk, which accounted for 6.2 percent of the total outbound cargo for July, decreased 55.6 percent from June. YTD total outbound cargo tonnage was up 27.1 percent.



The Port of Brownsville had an increase of 42.6 percent in total cargo tonnage over the previous month. Break Bulk, which accounted for 57.6 percent of the total cargo tonnage for July increased 34.2 percent from June's figures. Petroleum, which made up 35.5 percent of the total cargo for July dropped 52.7 percent from the previous month. YTD figures showed a 42.7 percent increase in Break Bulk tonnage –50.8 percent of total tonnage. Grain –4.0 percent of total tonnage– had a YTD decrease of 1.7 percent. Petroleum –42.3 percent of total tonnage– grew 36.7 percent. YTD total tonnage was up 39.2 percent.
