* Indicators of border business activity for the month of August demonstrated an increase of nine indicators while eleven indicators decreased. In addition, for the year-to-date (YTD) figures, sixteen indicators were up and four were down. Selected YTD comparisons to 1999 reported by border cities include the following:

- Southbound pedestrian crossings into Mexico were down 1.2 percent. Laredo gained 1.2 percent, Rio Grande jumped 22.2 percent, McAllen registered an increase of 7.6 and El Paso rose 1.1 percent.
- Southbound vehicle crossings were up 2.3 percent. Brownsville grew by 2.1 percent, and Eagle Pass gained 11.8 percent. El Paso went up 8.8 percent and Laredo rose 0.7 percent. Pharr increased 5.7 percent.
- Southbound truck crossings into Mexico were up 10.3 percent. Eagle Pass went up 56.5 percent. Pharr increased 23.1 percent, and Laredo rose 11.2 percent. Harlingen was up 5.1 percent.
- Northbound truck crossings into Texas were up 5.5 percent, Falcon increased 7.4 percent, Pharr gained 17.8 percent and Eagle Pass posted a 9.5 percent increase. Brownsville increased 14.1 percent, Laredo rose 1.6 percent, Del Rio marked an increase of 3.7 percent, as well as Rio Grande with a gain of 10.5 percent.
- Southbound shipments by rail were up 11.3 percent.
- Northbound shipments by rail were up 13.8 percent.
- Revenues collected by U.S. Customs were down by 1.2 percent.
- Revenues collected by U.S. Bridge operators were up 8.6 percent.
- Total building permits issued were up 3.7 percent. Laredo rose 19.7 percent, Eagle Pass gained 22.5 percent, while McAllen-Hidalgo rose 5.4 percent, and Brownsville registered an increase of 14.4 percent.
- Total building permit values increased 6.1 percent. Laredo increased 38.7 percent, and Brownsville rose 38.4 percent. McAllen-Hidalgo decreased 2.3 percent.
- Total employment was up 1.6 percent, with 7,069 jobs gained. The average unemployment rate in August 2000 was 7.9 percent for the border.

Machinery and Transport Equipment Dominate the List of Products Imported from Mexico Through Texas Border Ports

The September 2000 issue of the *Border Business Indicators* outlined a broader view of the type of U.S. products being exported to Mexico through the Texas-Mexico border ports. Details showed that SITC group 7 comprised the largest percentage of the dollar value of these ports. In this issue, U.S. imports had a similar breakdown with one SITC group dominating the composition via these Texas ports. Below is the list of the one-digit SITC groupings.

- · SITC 0 Food And Live Animals
- · SITC 1 Beverages And Tobacco
- SITC 2 Crude Materials, Inedible, Except Fuels
- SITC 3 Mineral Fuels, Lubricants And Related Materials
- · SITC 4 Animal And Vegetable Oils, Fats And Waxes
- SITC 5 Chemicals And Related Products
- · SITC 6 Manufactured Goods Classified Chiefly By Material
- SITC 7 Machinery And Transport Equipment
- · SITC 8 Miscellaneous Manufactured Articles
- SITC 9 Commodities And Transactions Not Classified Elsewhere In The SITC

To the right are some tables which detail the ranked order of the U.S. dollar values for the products that were imported from Mexico to the U.S. through the respective ports for January through May 2000. The total dollar value of all groups at all Texas-Mexico border ports for this period was \$33.1 billion dollars. As in the export figures, the group with the largest percentage share was SITC 7 —machinery and transport equipment— with 67.0 percent of the total or \$22.2 billion.

The ports handling the brunt of this group were Laredo with \$12.1 billion (54.6%) and El Paso with \$6.0 billion (26.9%). Unlike the exports, five of ten ports had SITC 7 ranked as the top dollar value. Fabens was the only port without import activity for the specified period. Other SITC groups that registered values of over a billion dollars were SITC 8 and SITC 6.

Miscellaneous manufactured articles or SITC 8's total value for all border ports in Texas was \$5.6 billion and was the second ranked group in terms of value. It comprised 16.9 percent of the total imports for January through May 2000.

Laredo and El Paso were the ports that again processed about \$4.1 billion, or 74.4 percent of the whole.

SITC 6 —manufactured goods classified chiefly by material—was valued at \$2.7 billion dollars for all Texas border ports combined. This constituted 8.1 percent of all imports for the same period.

Laredo's share of the value was 67.6 percent or \$1.8 billion. El Paso, a distant second, registered the next biggest share of 11.9 percent or \$318.3 million.

These three groups (6,7,8) combined accounted for \$30.5 billion or 92.0 percent of the total \$33.1 billion in imports from Mexico. These products appear to have been destined for the U.S. consumer and for some manufacturing/assembling sectors visible in the following lists of product descriptions. The lists take all Texas border ports into account but are arranged according to highest dollar value within their respective groups.



Southbound pedestrian crossings into Mexico for August were down 4.1 percent. Rio Grande increased 0.4 percent, Brownsville fell 5.6 percent, Eagle Pass rose 4.8 percent, El Paso went up 3.0 percent, and Laredo went down 6.8 percent. Progreso declined 30.7 percent, and McAllen-Hidalgo was down 4.5 percent. YTD, total southbound pedestrian crossings into Mexico slipped 1.2 percent. El Paso southbound pedestrian crossings, which make up 33.1 percent of all crossings, increased a slight 1.1 percent YTD. Laredo, accounting for 27.1 percent of total crossings, increased 1.2 percent YTD. Brownsville, with a 17.4 percent share, decreased 7.3 percent YTD. Progreso, with 8.6 percent share, declined 4.6 percent.

Southbound vehicle bridge crossings into Mexico were down 4.8 percent in August from July's figures. Eagle Pass was up 2.4 percent, Del Rio dropped 4.5 percent, Rio Grande slid 3.6 percent, and McAllen-Hidalgo fell 1.6 percent, and Brownsville went down 2.1 percent. Harlingen decreased 10.4 percent, and Laredo declined 14.4 percent. YTD total southbound vehicle bridge crossings were up 2.3 percent. Laredo, with 22.4 percent of all

southbound traffic, was up 0.7 percent YTD. Brownsville, with 19.6 percent of all southbound vehicle bridge crossings, had a 2.1 percent increase YTD. 

Export Rail YTD % Change 99-00











% Unemployed August 99-00







YTD air passenger arrivals were down 2.0 percent. El Paso, with 62.4 percent of all arriving passengers, was down 0.6 percent YTD. Harlingen, accounting for 18.7 percent of all arrivals, slipped 8.0 percent YTD. McAllen, with 12.6 percent of all arrivals, was up 0.6 percent YTD. Laredo, with 3.7 percent of all arrivals, increased 0.9 percent YTD. Brownsville, with 2.6 percent of all arrivals, fell 5.9 percent YTD.

Passenger Arrivals % Change YTD 99-00





Brownsville, with 2.6 percent of all departing passengers, declined 6.5 percent YTD.



% Share August 2000 Inbound Cargo







The Port of Brownsville had a decrease of 18.4 percent in total cargo tonnage over the previous month. Break Bulk, which accounted for 48.8 percent of the total cargo tonnage for August dropped 30.8 percent from July's figures. Petroleum, which made up 47.4 percent of the total cargo for August gained 8.9 percent from the previous month. YTD figures showed a 35.1 percent increase in Break Bulk tonnage -50.6 percent of total tonnage. Grain -3.6 percent of total tonnage- had a YTD decrease of 8.9 percent. Petroleum -42.8 percent of total tonnage- grew 38.3 percent. YTD total tonnage was up 35.1 percent.
