Indicators of border business activity for the month of April were down. Sixteen monthly indicators were down and six were up when compared to March. However, for the year-to-date (YTD), sixteen indicators were up and six were down. Selected YTD figures reported by border cities include the following.

- Southbound pedestrian crossings into Mexico were up 12.6 percent.
 Brownsville was up 22.2 percent, McAllen-Hidalgo was up 11.2 percent,
 Laredo was up 9.2 percent, and El Paso increased 6.7 percent.
- Northbound pedestrian crossings into Texas were up 7.4 percent. McAllen-Hidalgo was up 21.4 percent, El Paso was up 13.3 percent, Brownsville increased 9.0 percent, but Laredo was down 3.1 percent.
- Southbound vehicle bridge crossings were up 6.7 percent. Laredo was up 14.5 percent, El Paso was up 4.1 percent, and Brownsville increased 2.1 percent. However, McAllen-Hidalgo decreased 8.2 percent.
- Northbound vehicle bridge crossings into Texas were up 3.4 percent with El Paso up 9.4 percent, Brownsville up 8.1 percent, and McAllen-Hidalgo was up 0.2 percent. Laredo decreased 1.1 percent, and Eagle Pass decreased 0.3 percent.
- Southbound truck shipments into Mexico were up 12.8 percent. Laredo had
 a 17.5 percent increase, Brownsville was up 9.6 percent, but McAllenHidalgo decreased 4.8 percent.
- Northbound truck shipments into Texas were up 14.2 percent. Laredo had a 31.0 percent increase, Brownsville increased 3.5 percent, but McAllen-Hidalgo was down 23.0 percent.
- Revenues collected by U.S. Customs were up 1.9 percent, and revenues collected by U.S. Bridge operators were up 12.4 percent.
- Building permits issued were up 23.6 percent. El Paso increased by 32.2 percent, and Laredo was up 4.5 percent.
- Building permit values were up with a YTD increase of 16.2 percent. El Paso increased 20.5 percent. Laredo was up 3.6 percent, and McAllen increased 6.0 percent.
- Total employment was down by 2.1 percent (8,500 jobs lost) YTD. The average unemployment rate in April 1996 was 12.5 percent, up from the 10.4 percent in April 1995.

Due to incomplete data, El Paso rail data for north and south bound have not been included for this issue.







Southbound pedestrian bridge crossings into Mexico for April were down 20.0 percent compared to March. Progreso was down 54.5 percent, Harlingen was down 32.3 percent, Del Rio decreased 29.6 percent, and Brownsville decreased 28.4 percent. Rio Grande decreased 19.0 percent, McAllen-Hidalgo was down 14.2 percent, El Paso was down 13.2 percent, Eagle Pass decreased 7.6 percent, Roma decreased 6.7 percent, and Laredo was down 5.4 percent. YTD total southbound pedestrian bridge crossings were up 12.6 percent. El Paso southbound pedestrian crossings, 30.9 percent of all crossings, were up 6.7 percent. Laredo, accounting for 26.2 percent of all crossings, was up 9.2 percent YTD. Brownsville was up 22.2 percent with 22.8 percent of all crossings in the month of April.

% Share Pedestrians for April 1996





Northbound pedestrian crossings into Texas were down 13.3 percent in April. Progreso decreased 42.0 percent, McAllen-Hidalgo decreased 31.1 percent, Brownsville was down 18.2 percent, Presidio decreased 11.3 percent, and Eagle Pass decreased 10.9 percent. El Paso was down 7.1 percent, Roma decreased 6.7 percent, and Laredo decreased 3.7 percent. However, Del Rio increased 15.8 percent, and Rio Grande was up 0.2 percent. YTD total northbound pedestrian crossings into Texas were up 7.4 percent. El Paso, accounting for 37.1 percent of all northbound pedestrian crossings, was up 13.3 percent YTD. Brownsville, with 21.2 percent of all northbound crossings, was up 9.0 percent. However, Laredo, with 23.4 percent of all northbound pedestrian crossings, had a 3.1 percent decrease in crossings YTD.

Southbound vehicle bridge crossings into Mexico decreased 2.4 percent in April from March's figures. Progreso was down 10.7 percent, Harlingen decreased 9.4 percent, and Pharr decreased 6.0 percent. Laredo was down 3.7 percent, Eagle Pass decreased 3.6 percent, El Paso was down 3.4 percent, Del Rio decreased 2.6 percent, Brownsville was down 2.0 percent, Rio Grande decreased 1.7 percent, and Roma was down 1.0 percent. However, McAllen-Hidalgo increased 5.1 percent. YTD total southbound vehicle

bridge crossings were up 6.7 percent. Laredo, with 24.0 percent of all traffic, was up 14.5 percent YTD. El Paso, 15.6 percent of all southbound vehicle bridge crossings, had a 4.1 percent increase YTD. Brownsville, accounting for 18.5 percent of all southbound vehicle crossings had a 2.1 percent increase YTD. However, McAllen-Hidalgo, with 15.1 percent of all southbound vehicle crossings, experienced an 8.2 percent decrease YTD.

Northbound vehicle bridge crossings into Texas for April were down 0.8 percent since March. Progreso was down 9.4 percent, Harlingen decreased 6.8 percent, Roma decreased 5.8 percent, Rio Grande decreased 5.7 percent, Eagle Pass decreased 1.6 percent, El Paso was down 1.5 percent, Brownsville was down 1.4 percent, and Laredo decreased 1.3 percent. However, Del Rio was up 5.7 percent, McAllen-Hidalgo increased 3.3 percent, and Presidio rose

1.5 percent. YTD northbound vehicle bridge crossings into Texas were up 3.4 percent. El Paso, with 24.3 percent of all crossings, was up 9.4 percent. However, Laredo northbound vehicle bridge crossings, 21.4 percent of all crossings, were down 1.1 percent YTD. Brownsville, with 17.3 percent of all crossings, was up 8.1 percent YTD. McAllen-Hidalgo, with 15.7 percent of all crossings, was up 0.2 percent.

Southbound truck shipments into Mexico decreased 3.4 percent from March shipments. Eagle Pass was down 16.5 percent, Pharr decreased 15.8 percent, Roma was down 15.2 percent, Progreso decreased 13.1 percent, Laredo decreased 4.6 percent, and McAllen-Hidalgo was down 4.1 percent. However, Rio Grande increased 21.6 percent, Brownsville was up 7.3 percent, and Del Rio increased 0.2 percent. YTD, southbound truck shipments were up

12.8 percent. Laredo, accounting for 45.2 percent of all southbound truck traffic, had a 17.5 percent increase YTD. Brownsville, with 19.6 percent of shipments, experienced a 9.6 percent increase YTD. McAllen-Hidalgo, with 14.4 percent of all southbound truck shipments into Mexico, had a 4.8 percent decrease YTD.

Northbound truck shipments into Texas were up 0.6 percent in April. Del Rio was up 8.8 percent, McAllen-Hidalgo increased 6.5 percent, Eagle Pass increased 6.0 percent, and Rio Grande was up 4.1 percent. Progreso increased 3.8 percent, and Laredo was up 2.5 percent. However, Brownsville decreased 15.5 percent, and Roma decreased 9.3 percent. YTD, total truck traffic had an increase of

14.2 percent. Laredo, with 63.1 percent of all northbound shipments, experienced a 31.0 percent increase YTD. Brownsville, with 12.7 percent of all northbound shipments, had a 3.5 percent increase YTD. However, McAllen-Hidalgo, 12.9 percent of all truck traffic, decreased 23.0 percent.



Southbound rail shipments into Mexico increased 7.6 percent in April. It must be noted that this does not include El Paso data. Brownsville had a 159.0 percent increase over March's shipments. However, Eagle Pass decreased 2.6 percent, and Laredo was down 2.2 percent. YTD total southbound rail shipments into Mexico during the month of April were up 25.7 percent. Laredo, with 70.5 percent of all southbound rail shipments YTD, was up 26.7 percent. Eagle Pass, with 14.7 percent of all southbound shipments, increased 82.5 percent YTD. Brownsville, with 14.8 percent of all southbound rail shipments, was down 15.5 percent YTD.



Northbound rail shipments into Texas decreased 10.1 percent in April. El Paso data is not currently available. Brownsville was down 29.0 percent, Laredo decreased 6.1 percent, and Eagle Pass decreased 1.9 percent. YTD total northbound rail shipments into Texas were up 54.7 percent. Laredo, with 67.9 percent of all shipments during the month of April, was up 62.1 percent YTD. Brownsville, accounting for 15.9 percent of all northbound rail shipments, was up 97.7 percent YTD, and Eagle Pass was up 8.6 percent YTD with a 16.2 percent share of all shipments in April.



Total U.S. Customs revenues for the District of Laredo decreased 5.9 percent in April. Eagle Pass decreased 25.6 percent, Rio Grande was down 13.2 percent, Laredo was down 10.8 percent, Brownsville was down 6.9 percent, and Del Rio decreased 5.3 percent. However, Progreso increased 111.9 percent, McAllen-Hidalgo was up 15.7 percent, and Roma increased 4.0 percent. YTD revenue

figures were up 1.9 percent compared to April 1995. Laredo, accounting for 62.0 percent of total District revenues, was up 5.4 percent YTD, McAllen-Hidalgo with 19.3 percent of total revenues, was up 12.1 percent YTD, but Brownsville, with 8.4 percent of total revenues, decreased 14.8 percent YTD. Eagle Pass, with 1.0 percent of total revenues, was down 41.7 percent YTD.

Revenues (in U.S. Dollars) Collected by U.S. Bridge Operators





YTD, U.S. bridge operators' revenues were up 12.4 percent. Laredo, accounting for 36.6 percent of total U.S. bridge operators' revenues, had a 24.3 percent increase YTD. El

Paso, accounting for 20.2 percent of total U.S. bridge revenues, increased 6.3 percent YTD. Brownsville, 12.1 percent of the total bridge revenues, was up 5.7 percent YTD. Eagle Pass, 9.0 percent of total U.S. bridge operators' revenues, was up 5.6 percent. However, McAllen-Hidalgo, which accounts for 13.2 percent of total U.S. bridge revenues in April, was down 4.7 percent YTD.



Tourist Visas YTD April 95-96





Employment/Unemployment Rates —Texas Border



In April, total employment in reporting Texas border cities decreased 0.1 percent (582 jobs lost) from March figures. Eagle Pass decreased 1.1 percent (86 jobs lost), El Paso decreased 0.5 percent (1,115 jobs lost), and Laredo decreased 0.3 percent (174 jobs lost). However, McAllen was up 1.1 percent (437 jobs gained), Brownsville and Harlingen both had a 0.6 percent increase (224

and 129 jobs gained, respectively), Del Rio increased slightly (3 jobs gained). YTD, the total employment in Texas border cities was down 2.1 percent (8,500 jobs lost) from a year ago. The average unemployment rate for the border was 12.5 percent compared to 5.7 percent for Texas and 5.4 percent for the U.S. in April.

% Unemployed April 95-96









% Share April 1996 Inbound Cargo




