#### **Note from the Director**

# Depository Dallas Public Library

Indicators of border business activity for the month of November demonstrated an increase of eight indicators over fourteen indicators that decreased. In addition, for the year-to-date (YTD) figures, seventeen indicators were up and four were down. Selected YTD comparisons to 1998 reported by border cities include the fowllowing:

- Southbound pedestrian crossings into Mexico were up 4.2 percent. El Paso gained 10.0 percent, Eagle Pass jumped 7.4 percent, and Laredo increased 6.3 percent.
- Northbound pedestrian crossings into Texas were up 5.8 percent. Laredo increased 19.8 percent, Roma rose 15.2 percent, while Eagle Pass jumped 4.2 percent and El Paso gained 4.7 percent.
- Southbound vehicle crossings were up 6.8 percent. Harlingen rose 18.1 percent, Pharr increased 16.3 percent, McAllen-Hidalgo gained 11.3 percent, and Del Rio jumped 7.1 percent.
- Northbound vehicle bridge crossings into Texas were up 6.8 percent.
   Harlingen jumped 19.7 percent, Del Rio increased 19.5 percent, McAllen-Hidalgo gained 18.5 percent and Roma posted an increase of 15.5 percent.
- Southbound truck crossings into Mexico were up 6.8 percent. Progreso increased 68.0 percent, Eagle Pass was up 60.9 percent and Roma rose 51.1 percent.
- Northbound truck crossings into Texas were up 13.6 percent, Pharr increased 23.2 percent, Falcon gained 19.7 percent and Rio Grande posted a 17.9 percent increase.
- Southbound shipments by rail were up 13.8 percent.
- Northbound shipments by rail were up 21.3 percent.
- Revenues collected by U.S. Customs were down slightly by 5.1 percent.
- Revenues collected by U.S. Bridge operators were up 15.8 percent.
- Building permits issued were up 10.2 percent. Laredo rose 42.4 percent, Harlingen gained 9.0 percent, Eagle Pass was up 7.1 percent, while McAllen-Hidalgo declined 4.1 percent.
- Building permit values were up with a YTD increase of 21.8 percent.
   Harlingen increased 63.3 percent, McAllen was up 40.4 percent, Browsville rose 30.8 percent and El Paso reported a 28.4 percent increase.
- Total employment was down with 296 jobs lost YTD. The average unemployment rate in November 1999 was 8.3 percent for the border.

Changes in the reporting format used by our contributors for truck crossings has required us to alter our format. "Export Shipments by Trucks into Mexico" has been changed to "Truck Crossings into Mexico" and "Import Shipments by Trucks into Texas" has been changed to "Truck Crossings into Texas."

# The Texas Border Region Enjoys a Decade of Strong Growth (Part Three of a Three Part Series)

In part one of our three part series (see the November 1999 issue of the BBI), we focused on the strong population, employment, and industry sales experienced in the Texas border region, and in particular, the metropolitan areas of Brownsville, McAllen, Laredo, and El Paso during the 1990s. In part two (see the December 1999 issue of the BBI), we looked at the fastest growing sectors in the border metropolitan areas based upon employment and the top job gaining categories. In part three, the final part of our series, we will examine the slowest growing sectors in the border metropolitan areas, pinpointing those industries and job categories that lost jobs in the decade of the 1990s. Also covered in part three is a comparison of the relative changes in public sector employment over the decade.

As we reported in part two of our series, even though all the border metropolitan areas posted net job gains during the 1990s, they also lost close to 17,000 jobs. The job losses however were not shared equally across industries and metropolitan areas. Rather, they were concentrated in the food & kindred products, agricultural products & services, and apparel & other textile products industries, which accounted for 56 percent of the total number of jobs lost. The El Paso and McAllen metropolitan areas suffered the largest job losses (Table 1).

The concentration of job losses in the labor intensive agriculture, food processing, and textile assembly sectors will not be a surprise to NAFTA watchers. These are the sectors where low cost Mexican labor, under free trade, has a competitive advantage over their American counterparts. El Paso has seen several of its larger apparel & other textile products manufacturers shift their operations into Mexico over the past decade, qualifying the city for federal trade adjustment assistance under NAFTA provisions. The sharp decline in agriculture and food processing activity in the Rio Grande Valley (McAllen and Brownsville metropolitan areas) in recent years has also displaced thousands of seasonal workers adding to the area's already high unemployment rate.

Over the decade of the 1990s, public sector employment, as a percentage of total (public and private) employment, stood at roughly 17.5 percent for the State compared to 22.9 percent for the Brownsville metropolitan area; 24.9 percent for the McAllen metropolitan area; 22.5 percent for the Laredo metropolitan area; and 21.4 percent for the El Paso metropolitan area. Public sector employment in the border metropolitan areas is concentrated in the local school districts, which accounts for roughly 75 percent of total public employment (Table 2).

The pace of employment growth in border metropolitan area school districts is expected to remain strong over the next decade or two, as new schools come on-line to accommodate the region's exploding population. Federal and state employment in the border region is also expected to continue its sharp rise over the past decade (Table 2) to 1) meet growing manpower needs to facilitate and control the sharp increase in U.S.-Mexico merchandise trade taking place at the border, and 2) expand immigration and drug interdiction activities at the region.



Southbound pedestrian crossings into Mexico for November was up 7.4 percent. Rio Grande increased 39.5 percent, Progreso rose 39.4 percent, Laredo grew 8.7 percent, Eagle Pass also gained 8.7 percent, and McAllen-Hidalgo was up 5.7 percent. YTD, total southbound pedestrian crossings into Mexico were up 4.2 percent. El Paso southbound pedestrian crossings, which made up 34.7 percent of all crossings in November, increased 10.0 percent, YTD. Laredo, accounting for 27.7 percent of total crossings in November, was up 6.3 percent, YTD and Brownsville, with a 16.2 percent share in November, was down 6.5 percent, YTD.

#### % Share Pedestrians for November 1999





Northbound pedestrian crossings into Texas were up 5.7 percent in November, Progreso increased 25.5 percent, Rio Grande was up 24.1 percent, McAllen-Hidalgo rose 16.1 percent, Laredo gained 14.6 percent. YTD total northbound pedestrian crossings into Texas were up 5.8 percent. El Paso, accounting for 40.7 percent of northbound crossings in November, was up 4.7 percent, YTD. Laredo, with 25.7 percent of all northbound crossings in November, was up 19.8 percent, YTD and Brownsville, with 15.6 percent of all northbound pedestrian crossings in November, declined 8.0 percent in crossings YTD.

Southbound vehicle bridge crossings into Mexico was down 3.3 percent in November from October's figures. Del Rio was down 8.8 percent, McAllen-Hidalgo fell 7.7 percent, Laredo dropped 5.6 percent, Pharr decreased 2.4 percent, Brownsvile declined 1.5 percent, Rio Grande was down 1.7 percent, and Eagle Pass decreased 0.5 percent. YTD total southbound vehicle bridge crossings were up 6.8 percent. Laredo, with 22.9 percent of all south-

bound traffic in November, was up 4.3 percent, YTD. Brownsville, with 19.9 percent of all southbound vehicle bridge crossings in November, had a 7.2 percent increase, YTD. McAllen-Hidalgo, with 14.8 percent of all southbound vehicle crossings in November, experienced a 11.3 percent increase, YTD. El Paso, accounting for 14.4 percent of all southbound vehicle crossings in November, fell 2.2 percent, YTD.

Eagle Pass registered a 10.4 percent decrease, McAllen-Hidalgo was down 8.7 percent, Laredo fell 3.1 percent, El Paso dropped 2.7 percent, and Brownsville declined 0.9 percent. Progreso increased 4.2 percent, Presidio rose 3.2 percent and Del Rio was up 1.8 percent. YTD northbound

vehicle bridge crossings into Texas were up 6.8 percent. Laredo, with a 24.5 percent of all crossings in November, was up 9.5 percent, YTD. Rio Grande dropped 10.2 percent, Del Rio decreased 8.4 percent, Progreso fell 8.3 percent, Eagle Pass was down 6.5 percent, and Harlingen declined 5.3 percent. 

#### Export Rail YTD % Change 98-99















#### Passenger Arrivals % Change YTD 98-99





November air passenger departures for reporting Texas border cities were slightly up 0.1 percent. Laredo decreased 6.3, Harlingen fell 2.4 percent, and Brownsville declined 1.9 percent. McAllen was up 5.4 percent, and El Paso increased 0.1 percent. YTD, air passenger departures were up 2.5 percent from a year ago. El Paso, with 64.6 percent of all passengers departing in November, was up 2.2 percent, YTD. Harlingen, with 16.9 percent of all passengers departing in November, was up slightly 0.4 percent, YTD. McAllen, with a 12.7 percent of all departing passengers in November, increased 6.1 percent, YTD. Laredo, with 3.2 percent of all departing passengers in November, rose 13.4 percent, YTD. Brownsville, with 2.5 percent of all departures in November, was down 4.3 percent, YTD.



#### % Share November 1999 Inbound Cargo




