Indicators of border business activity for the month of October were up. Twenty-two monthly indicators increased while one decreased when compared to September. In addition, for the year-to-date (YTD) figures, fourteen indicators were up and nine were down. Selected YTD comparisons to 1997 reported by border cities include the following:

- Southbound pedestrian crossings into Mexico were up 1.3 percent. Eagle Pass rose 27.7 percent, McAllen-Hidalgo increased 2.1 percent while Laredo was down 0.9 percent and Brownsville declined 4.6 percent.
- Northbound pedestrian crossings into Texas were up 0.8 percent. Eagle Pass rose 8.5 percent, El Paso was up 0.7 percent while Brownsville decreased 2.3 percent and Laredo dipped 1.8 percent.
- Southbound vehicle bridge crossings were up 7.3 percent. Pharr rose 42.4 percent, Brownsville increased 11.9 percent, Laredo gained 4.5 percent and El Paso was up 3.2 percent.
- Northbound vehicle bridge crossings into Texas were up 2.7 percent with Laredo increasing 7.5 percent, El Paso gained 1.9 percent, McAllen-Hidalgo was up 1.7 percent and Eagle Pass posted an increase of 0.8 percent YTD.
- Southbound truck shipments into Mexico were up 20.9 percent. Pharr increased 73.4 percent, Brownsville rose 28.0 percent and Laredo gained 20.1 percent.
- Northbound truck shipments into Texas were up 9.4 percent with Eagle Pass increasing 18.8 percent, Laredo gained 13.1 percent and Pharr posted a 7.6 percent increase YTD.
- Southbound shipments by rail were down 0.6 percent.
- Northbound shipments by rail were down 1.7 percent.
- Revenues collected by U.S. Customs were down 9.4 percent YTD. Revenues collected by U.S. Bridge operators were up 13.4 percent.
- Building permits issued were up 17.3 percent. El Paso rose 20.6 percent, Eagle Pass gained 15.8 percent, Brownsville was up 13.2 percent and Laredo increased 11.2 percent.
- Building permit values were down with a YTD decrease of 8.0 percent. Brownsville decreased 24.3 percent, Harlingen was down 23.8 percent, El Paso fell 11.3 percent while Laredo reported a 4.5 percent increase.
- Total employment was up with 9,967 jobs gained YTD. The average unemployment rate in October 1998 was 10.2 percent.



Southbound pedestrian bridge crossings into Mexico for October was up 10.2 percent compared to September. Roma increased 27.2 percent, Eagle Pass rose 20.8 percent, Progreso was up 20.5 percent, McAllen-Hidalgo gained 18.1 percent, Brownsville increased 13.2 percent, Laredo rose 7.6 percent and El Paso was up 6.8 percent. However, Del Rio fell 58.3 percent and Rio Grande dipped 26.7 percent. YTD, total southbound pedestrian crossings into Texas were up 1.3 percent. El Paso southbound pedestrian crossings, which make up 34.7 percent of all crossings in October rose 3.0 percent. Laredo, accounting for 26.2 percent of all crossings, was down 0.9 percent and Brownsville was down 4.6 percent with 19.6 percent of all crossings YTD.

#### % Share Pedestrians for October 1998





Northbound pedestrian crossings into Texas were up 6.0 percent in October. Progreso rose 20.4 percent, Roma was up 15.8 percent, McAllen-Hidalgo increased 13.5 percent, Eagle Pass gained 12.2 percent, Brownsville rose 9.1 percent, Laredo was up 3.7 percent, El Paso increased 3.5 percent and Presidio was up slightly at 0.1 percent. However, Del Rio decreased 26.9 percent and Rio Grande fell 21.6 percent. YTD total northbound pedestrian crossings into Texas were up 0.8 percent. El Paso, accounting for 44.0 percent of the northbound crossings, was up 0.7 percent YTD. Laredo, with 20.6 percent of all northbound crossings, was down 1.8 percent and Brownsville with 16.6 percent of all northbound pedestrian crossings, had a 2.3 percent decrease in crossings YTD.

Del Rio increased 17.0 percent, El Paso was up 14.7 percent, Harlingen rose 11.1 percent, Brownsville gained 10.0 percent, Pharr jumped 9.4 percent, Rio Grande posted an increase of 9.0 percent, Roma increased 8.8 percent, Eagle Pass was up 8.6 percent, McAllen-Hidalgo rose 8.2 percent and Laredo gained 4.8 percent. YTD total southbound vehicle bridge crossings were up 7.3 percent. Laredo, with 24.8

percent of all southbound traffic in October, was up 4.5 percent YTD. Brownsville, with 19.4 percent of all southbound vehicle bridge crossings, had an 11.9 percent increase YTD. McAllen-Hidalgo, with 15.4 percent of all southbound vehicle crossings, experienced a 4.7 percent increase YTD. El Paso, accounting for 14.5 percent of all southbound vehicle crossings had a 3.2 percent increase YTD.

Northbound vehicle bridge crossings into Texas for October were up 4.8 percent since September. Del Rio registered a 16.1 percent increase, Roma rose 8.4 percent, Harlingen jumped 8.2 percent, Progreso reported an increase of 7.9 percent, Brownsville and El Paso gained 6.7 percent, Rio Grande increased 6.2 percent, Eagle Pass rose 5.2 percent, McAllen-Hidalgo was up 6.2 percent and

Presidio was up slightly at 2.7 percent. However, Laredo decreased 2.3 percent. YTD northbound vehicle bridge crossings into Texas were up 2.7 percent. Laredo with 22.3 percent of all crossings in October was up 7.5 percent YTD. El Paso, with 23.4 percent of all crossings, gained 1.9 percent and Brownsville with 17.4 percent of all crossings, was up 1.2 percent YTD.

Southbound truck shipments into Mexico were up 5.8 percent in October. Progreso increased 38.6 percent, Eagle Pass gained 21.7 percent, Del Rio rose 12.5 percent, Roma grew 11.6 percent, Pharr was up 7.5 percent, Rio Grande increased 6.3 percent, Laredo gained 6.0 percent, McAllen-Hidalgo rose 2.5 percent and Harlingen jumped 1.3 percent. However, Brownsville decreased 0.1 percent. YTD, southbound truck shipments were up 20.9 percent. Laredo

with 51.9 percent of all southbound shipments in October, experienced a 20.1 percent increase. Brownsville, with 18.6 percent of all southbound shipments, had a 28.0 percent increase YTD. Pharr with 11.0 percent registered an increase of 73.4 percent and McAllen-Hidalgo, with 3.3 percent of all truck crossings, fell 51.0 percent.

Northbound truck shipments into Texas increased 3.6 percent from September's shipments. Rio Grande increased 19.3 percent, Pharr rose 11.1 percent, Eagle Pass gained 8.4 percent, Brownsville was up 8.1 percent, Roma grew 6.3 percent, Del Rio jumped 5.4 percent, Laredo was up slightly at 0.7 percent and Falcon remained unchanged. However, Progreso decreased 23.4 percent. YTD north-


bound truck shipments were up 9.4 percent. Laredo, accounting for 62.9 percent of all northbound truck traffic in October had a 13.1 percent increase YTD. Pharr, with 14.6 percent of shipments, experienced an 7.6 percent increase YTD. Brownsville, with 11.7 percent of all northbound truck shipments in October, dipped 1.0 percent YTD.

Southbound rail shipments into Mexico increased 14.2 percent in October. Eagle Pass was up 68.9 percent and Laredo increased 4.7 percent. However, Brownsville dipped 4.7 percent. YTD, total southbound rail shipments into Mexico from Texas were down 0.6 percent. Laredo, which accounts for 59.8 percent of all southbound rail shipments in October was down 4.1 percent. Eagle Pass, accounting for 25.6 percent of all southbound rail shipments, increased 6.5 percent. Brownsville, with 14.5 percent of all southbound rail shipments in October, rose 4.9 percent YTD.



Northbound rail shipments into Texas increased 11.4 percent in October. Laredo rose 15.0 percent and Eagle Pass increased 7.1 percent. However, Brownsville registered a 2.3 percent decrease. YTD, total northbound rail shipments into Texas from Mexico were down 1.7 percent. Laredo, which accounts for 65.1 percent of all northbound rail shipments in October was down 2.3 percent. Eagle Pass, accounting for 28.8 percent of all northbound rail shipments in October, decreased 2.4 percent and Brownsville, with 6.0 percent of all northbound rail shipments, increased 5.6 percent YTD.



## Revenues (in U.S. Dollars) Collected by U.S. Customs District of Laredo



Total U.S. Customs revenues for the former District of Laredo increased 9.3 percent from September's figures. Roma rose 27.3 percent, Laredo increased 16.1 percent, Del Rio gained 8.9 percent, Eagle Pass grew 8.2 percent and Progreso was up 2.2 percent. However, McAllen-Hidalgo dipped 8.9 percent, Brownsville slid 7.9 percent and Rio Grande fell 1.9 percent. YTD revenue figures were down 9.4 percent compared to October 1997. Laredo, ac-

counting for 63.2 percent of the former district's revenue, was down 15.1 percent YTD. McAllen-Hidalgo with 15.0 percent of total revenues, was down 1.5 percent YTD. Eagle Pass, accounting for 11.1 percent of all revenues YTD, was up 23.7 percent. Brownsville, with 8.9 percent of total revenues, declined 6.4 percent YTD.







#### **Tourist Visas YTD October 97-98**







#### Residential Phones % Change October 97-98









#### Passenger Arrivals % Change YTD 97-98







#### % Share October 1998 Inbound Cargo




