The New Rules Are Here!

The revised rules are currently being printed and mailed to all licensees. The Texas State Board of Examiners of Marriage and Family Therapist Board Rules were amended and adopted on November 22, 1996. The following are sections in the rules that are either new or have significant changes:

§801.19 Continuing Education Requirements §801.261 §801.299 Administrative Penalties Suspension of License for Failure to Pay Child Support

The three different types of licenses provided by the Board are; a Temporary License, a Provisional License for those who complete all requirements and successfully pass the exam. Those who hold a licensure

DISCIPLINARY ACTIONS

As a result of an order issued by the Board; revocations, suspensions, probations, reprimands and any other disciplinary action will be printed in future Board newsletters along with the individuals name, license number, type of violation, and action taken.

COMPLAINT HOTLINE

Those who wish to file a complaint against a Licensed Marriage and Family Therapist may call the Board office at 1-800-942-5540. This toll free number is for complaints against marriage and family therapists only!

The Board is under legislative constraints concerning lobbying. If you feel strongly about a particular issue which may affect you, the public, or the profession of marriage and family therapy. You are encouraged to call or write the Board, your State Senator, State Representative, or the Texas Association of Marriage and Family Therapy.

VERY INTERESTING!

Three of the mental health profession regulatory boards are now housed under the Texas Department of Health's Professional Licensing and Certification Division; the Texas State Board of Examiners of Marriage and Family Therapists, the Texas State Board of Licensed Professional Counselors, and the Texas State Board of Social Work Examiners. Remember, if you are applying for licensure with one or more of the above mentioned programs you MUST send all applicable documentation to each program along with the required applications and fees.

EXAMINATION INFORMATION

The Texas Marriage and Family
Therapy examination was developed
by Applied Measurement Services, a
testing company from New Jersey,
with the guidance of various
professional members of the Texas
State Board of Examiners of Marriage
and Family Therapists, a national
panel of professionals at Princeton
and Educators from several
universities throughout Texas which
offer marriage and family therapy
degree programs.

The test consists of 200 multiple choice questions. Examinees are given four hours to complete the test. The examination is broken down into the following content areas:

Assessment and Diagnosis - 19%

Designing a Treatment Plan - 17% Conducting a Course of Treatment -21% Establishing and Maintaining Appropriate Networks - 12% Assessing the Outcome of Treatments - 15% Maintaining Professional Standards - 16%

EXAMINATION RESULTS FOR 1997

The marriage and family therapy examination was given in Austin, Texas on June 14th, 1997. There was a total 29 test given, 3 failures, with a 90% pass rate at the June exam. The next exam will be given on October 11, 1997.

FUTURE TEST DATES (2)

Future examinations will be held on the second Saturday of February,
June, and October of each year. All tests will be held in Austin, Texas.
Applicants meeting the qualifications for examination will be notified of the exact times and locations.
Additional information regarding testing procedure may be found in Subchapter H. of the Board rules, or by contacting the board office.

- By Bobby D. Schmidt, Executive Director This office sends out your renewal notice 45-days prior to your expiration date. The renewal envelope has the renewal letter, survey form, continuing education documentation form, renewal coupon, and a color-coded envelope. You must return the survey form, the continuing education form (documenting 20-hours of continuing education) and the coupon with the \$40.00 renewal fee. All items should be submitted together in the color-coded envelope. If the renewal envelope is NOT postmarked on or before the last day of the renewal month, your are subject to applicable late fees, and your license status is "expired". You cannot practice under Texas Civil Statues, Article 4512c-1 as a Marriage and Family Therapist until you have satisfied all renewal requirements.

Please remember that ALL licensees are required to submit documentation of 20 hours of continuing education per licensure cycle annually. For example, if your birthday is in March; your licensure cycle runs from April 1 to March 31 EVERY YEAR. Your licensure expiration date is March 31 of each year. In addition, you must submit 3 hours of ethics every three years. This is a very simple process, please do not "what if" it to death - take it at face value. This is not meant to be critical or demeaning in any way, but we answer these questions at least 50 or more times a month.

I would like to take this opportunity to say farewell to Donna Roberts. Donna has had some medical problems that have escalated in recent months and disabilities beyond her control. We will all miss her very much. In the interim this program has been short staffed since October. I would like to personally thank and commend Sandy Guyn and Barbara Jackson for their hard work. I appreciate their diligence and determination.

Q -Is it possible for those licensees who maintain dual licenses (ie, LPC, LMSW etc... to combine their continuing education hours and apply them as a "group" at this time.

A -No. At this time, each profession has its' own continuing education requirements and guidelines. Although many seminars often contain materials that are applicable to a myriad of professions, most are geared towards a specific function. This is an idea to be considered though; keep reading The Communicator for any changes!

Q - Is it possible to list continuing education courses in future issues of "The Communicator".

A -Not at this time. Remember, this agency approves continuing education sponsors for 5-year cycles, not each individual continuing education course.

HAS YOUR ADDRESS CHANGED?

Licensees and applicants MUST notify the Board office of any address changes. The Board is not responsible for lost, misdirected or undelivered correspondence if sent to the last address reported in writing to the Board.

Up close and personal...

This month, Maria T. Flores, Ph.D.

Meet Maria T. Flores, Ph.D., one of the original board members, chair of the Ethics Committee, and currently the Director of the Marriage and Family Institute of San Antonio where she is in full-time clinical practice. She also teaches graduate students at these local universities, University of Texas at San Antonio, and Our Lady of the Lake University. She received her doctorate from Purdue University in Marriage

and Family Therapy with a related area in Psychology. She is an approved clinical supervisor for AAMFT, LMFT, LPC and a member of the American Family Therapy Academy. She is the author of several journal articles, book chapters and book reviews. She was the principal Psychological Consultant of the Spanish translation of "The Introduction to Types," by Isabel Briggs Myers.

Straight from Maria Flores "One of my jobs on the State Board of Examiners of Marriage and Family Therapists is to be the Chair of the Ethics Committee. It is a very serious matter to deliberate over allegations against therapists who are accused of violating rules governing the practice of helping others, "the art of healing". A case against a therapist who violate patients that have come to them for emotional, mental, and behavioral problems is a very serious matter. The investigators take their job very seriously and do a very thorough investigation of any allegation.

There are two other members of the Ethics Committee besides myself; George Pulliam, M.S.S.W. (Professional member) and Leslie Goolishian (public member). We meet in an Executive Session which is closed to other board members and the public. In these meetings, we come prepared with both case notes and the investigative report of the complaint scheduled for deliberations, In these executive sessions, we hear the investigators verbal report and ask pertinent questions. If we do not think we have enough information to make a decision to dismiss a case and/or invoke disciplinary action, we ask the investigator to continue with a more lengthy inquiry. Our legal counsel is present to explain any legal aspects and/or questions we may have about how a

particular case violates the board statue or rule and what penalties we can impose. Also present is the Executive Director, Bobby Schmidt and the Executive Assistant, Sandra Guyn. Who process the follow-up paperwork from this committee. These deliberations are difficult, lengthy and sober; we eventually come to a decision. Sometimes we postpone a deliberation for more information, or when we have

a complete, detailed report, make recommendations such as revocation or suspension of a license. We may put a license on probation, send them a letter of reprimand or recommend a disciplinary action depending on the violation. We can now also place a financial penalties(sanctions) on a licensee. In some cases, complaints do not have sufficient evidence and/or the licensee has not violated a rule governing the practice of Marriage and Family Therapy; these complaints are closed and the licensee and complainant is informed in writing of such by the Executive Director. After these deliberations, we exit executive session and go into open session for formal recommendations. Since this session is open to the public, we make our recommendations using only case numbers. At the board meeting usually held the next day, we ask the full board to accept our report. Again, we only use case numbers, no names or detail. Confidential procedures are in place to protect all parties involved.

The Ethics Committee of the TSBEMFT is in place to protect the public from psychotherapists that have violated their own standard of integrity by violating a rule of conduct governing the practice of Marriage and Family Therapy.

People have been asking for feedback

from the Ethics Committee on distinct violations. Please feel free to ask us questions, and I with the other members of the Ethics Committee will attempt to clarify your concerns. 
