

U.S.-Mexico Trade: Activity at the Major U.S.-Mexico Border Ports

U.S.-Mexico border ports processed \$88.2 billion or 81.4 percent of the total trade dollar value of U.S.-Mexico merchandise (\$108.4 billion) crossing the border for the period January-April 2007. The percent share was up compared to 79.9 percent for the same period last year.

The list below shows the top three types of merchandise —SITC 2-Digit—traversing at the nine major U.S.-Mexico border ports. Each port handled over \$1 billion in merchandise (both U.S. exports and imports) from January to April 2007. —B. Garcia




Note from the Director

Indicators of border business activity for April 2007 year-to-date (YTD) demonstrated ten indicators increased and twelve decreased. 2007 YTD comparisons to 2006 reported for the border are listed below:

- · Pedestrian bridge crossings into Mexico were down 3.6 percent.
- Pedestrian bridge crossings into Texas were up 1.8 percent.
- Vehicle bridge crossings into Mexico fell 6.1 percent.
- Vehicle bridge crossings into Texas fell 6.3 percent.
- Truck bridge crossings into Mexico lost 2.2 percent.
- Truck bridge crossings into Texas gained 1.7 percent.
- Rail car bridge crossings into Mexico went up 4.1 percent.
- Rail car bridge crossings into Texas went down 4.8 percent.
- · Revenues collected by U.S. Customs increased 14.0 percent.
- Revenues collected by U.S. bridge operators registered a loss of 3.4 percent.
- Tourist visas issued for entry into Mexico were down 5.3 percent.
- Total employment was up 1.2 percent, with 5,678 jobs gained. The average unemployment rate for the border in April 2007 was 5.5 percent.
- Total building permits issued rose 0.2 percent.
- · Total building permit values increased 88.8 percent.
- Power connections in service for residential were up 2.7 percent, commercial were up 3.3 percent and industrial were down 2.3 percent.
- Air passenger arrivals were down 16.4 percent, and departures were down 18.2 percent.
- Total cargo for the Port of Brownsville decreased 2.8 percent.
- Inbound cargo for the Port of Corpus Christi went down 1.7 percent, and outbound cargo went up 23.6 percent.





Vehicles into Texas All Cited Cities April 2006 vs. April 2007: Down 7.0% (In Millions)




Pedestrians into Texas All Cited Cities April 2006 vs. April 2007: Up **2.6%** (In Millions)










Trucks into Texas All Cited Cities April 2006 vs. April 2007: Up **4.8%** (In Thousands)



Rail Cars into Mexico All Cited Cities April 2006 vs. April 2007: Up **3.6%** (In Thousands)







Tourist Visas Issued All Cited Cities April 2006 vs. April 2007: Down 12.6%










Power Connections All Cited Cities April 2006 vs. April 2007 (Residential – In Thousands): Up **2.9%**



Port of Corpus Christi Cargo April 2006 vs. April 2007 (Inbound – In Millions of U.S. Tons): Down **6.4**%


