

# U.S.-Mexico Trade: Continued Growth in September 2006

September 2006 year-to-date trade figures between the U.S. and Mexico marked continued growth. The total trade dollar value of the merchandise flowing between the trading partners registered a worth of \$248.3 billion. This figure was 16.8 percent above last year's figure of \$212.6 billion for the January-September period. U.S. exports to Mexico, \$99.9 billion year-to-date, have increased over last year's figure by 13.5 percent. U.S. imports have maintained its growth too in the same period, \$148.4 billion year-to-date, an increase of 19.1 percent over last year.

The tables below focus specifically on the top five border ports of entry on the U.S.-Mexico border and the merchandise processed. The dollar values are of total trade (U.S. exports to Mexico plus U.S. imports from Mexico) for the 2005 and 2006 year-to-date periods. Also included in these tables are the Standard International Trade Classification (SITC) codes and their descriptions. —B. Garcia


# Note from the Director

Indicators of border business activity for September 2006 year-to-date (YTD) demonstrated sixteen indicators increased and six decreased. 2006 YTD comparisons to 2005 reported for the border are listed below:

- · Pedestrian bridge crossings into Mexico were up 1.1 percent.
- Pedestrian bridge crossings into Texas were up 3.4 percent.
- · Vehicle bridge crossings into Mexico fell 2.6 percent.
- Vehicle bridge crossings into Texas fell 2.5 percent.
- · Truck bridge crossings into Mexico gained 8.6 percent.
- Truck bridge crossings into Texas gained 4.7 percent.
- Rail car bridge crossings into Mexico went up 0.5 percent.
- Rail car bridge crossings into Texas went up 22.6 percent.
- Revenues collected by U.S. Customs increased 4.0 percent.
- Revenues collected by U.S. bridge operators registered a gain of 9.1 percent.
- Tourist visas issued for entry into Mexico were up 3.7 percent.
- Total employment was up 3.1 percent, with 14,897 jobs gained. The average unemployment rate for the border in September 2006 was 5.7 percent.
- Total building permits issued rose 13.7 percent.
- Total building permit values increased 1.0 percent.
- Power connections in service for residential were up 2.6 percent, commercial were up 1.9 percent and industrial were down 0.4 percent.
- Air passenger arrivals were down 3.1 percent, and departures were down 3.0 percent.
- Total cargo for the Port of Brownsville increased 16.8 percent.
- Inbound cargo for the Port of Corpus Christi went up 1.5 percent, and outbound cargo went down 2.7 percent.






Pedestrians into Mexico All Cited Cities Sep. 2005 vs. Sep. 2006: Up **4.5%** (In Millions)






Trucks into Mexico All Cited Cities




Trucks into Texas All Cited Cities Sep. 2005 vs. Sep. 2006: Down 2.4% (In Thousands)




Employment & Unemployment Rates (Texas Border)




Power Connections All Cited Cities Sep. 2005 vs. Sep. 2006 (Residential – In Thousands): Up **2.3**%






Port of Brownsville Total Cargo Sep. 2005 vs. Sep. 2006: Down 9.9% (In Thousands of Metric Tons)
