Indicators of border business activity for the month of October were up. Twenty monthly indicators were up while three indicators were down when compared to September. In addition, for the year-to-date (YTD) figures, seventeen indicators were up and six were down. Selected YTD comparisons to 1996 reported by border cities include the following:

- Southbound pedestrian crossings into Mexico were up 28.7 percent. El Paso was up 70.3 percent, McAllen-Hidalgo rose 14.6 percent, Laredo increased 11.9 percent and Brownsville was up 2.7 percent.
- Northbound pedestrian crossings into Texas were down 1.1 percent. McAllen-Hidalgo fell 11.7 percent, Brownsville was down 6.4 percent, and Laredo decreased 4.7 percent. However, El Paso increased 5.8 percent.
- Southbound vehicle bridge crossings were up 4.8 percent. El Paso was up 6.8 percent, McAllen-Hidalgo rose 7.0 percent, Brownsville increased 6.3 percent and Laredo was up 4.7 percent.
- Northbound vehicle bridge crossings into Texas were up 3.2 percent with Brownsville increasing 8.7 percent and El Paso gaining 2.9 percent. However, Laredo was down 1.7 percent and McAllen-Hidalgo fell 1.4 percent YTD.
- Southbound truck shipments into Mexico were up 18.7 percent. Laredo increased 26.4 percent and Brownsville rose 15.7 percent while McAllen-Hidalgo decreased 15.9 percent.
- Northbound truck shipments into Texas were up 5.1 percent with Eagle Pass increasing 16.5 percent, Brownsville gained 3.6 percent and Laredo posted a 1.7 percent increase YTD.
- . Southbound shipments by rail were up 17.1 percent.
- . Northbound shipments by rail were unchanged.
- Revenues collected by U.S. Customs were up 7.9 percent YTD. Revenues collected by U.S. Bridge operators were up 8.2 percent.
- Building permits issued were down 14.3 percent. Brownsville decreased by 6.4 percent, McAllen fell 9.7 percent and Laredo was down 8.8 percent.
- Building permit values were up with a YTD increase of 11.5 percent. Brownsville increased 96.6 percent, McAllen was up 6.5 percent, Laredo gained 28.3 percent and Harlingen reported a 3.2 percent increase.
- Total employment was up with 19,576 jobs gained YTD. The average unemployment rate in October 1997 was 10.7 percent, matching that of October 1996.



Southbound pedestrian bridge crossings into Mexico for October were up 2.5 percent compared to September. Harlingen increased 41.5 percent, Rio Grande rose 23.4 percent, Progreso was up 19.7 percent, McAllen-Hidalgo increased 18.2 percent, Eagle Pass rose 17.3 percent and Del Rio was up 15.8 percent. Roma increased 13.0 percent, Laredo registered a 5.5 percent increase and El Paso was up 4.4 percent. However, Brownsville fell 16.0 percent. YTD, total southbound pedestrian crossings into Texas were up 28.7 percent. El Paso southbound pedestrian crossings, which make up 45.0 percent of all crossings in October, were up 70.3 percent. Laredo, accounting for 21.9 percent of all crossings, was up 11.9 percent and Brownsville was up 2.7 percent with 16.5 percent of all crossings YTD.

% Share Pedestrians for October 1997





Northbound pedestrian crossings into Texas were up 1.1 percent in October. Eagle Pass increased 18.9 percent, Progreso rose 14.9 percent, Presidio was up 11.1 percent, McAllen-Hidalgo increased 9.1 percent, Rio Grande rose 9.0 percent, Roma was up 6.6 percent and El Paso marked a 3.7 percent increase. However, Brownsville decreased 10.2 percent, Del Rio dipped 3.8 percent and Laredo slid 1.2 percent. YTD total northbound pedestrian crossings into Texas were down 1.1 percent. El Paso, accounting for 43.9 percent of all northbound pedestrian crossings in October, was up 5.8 percent YTD. Laredo, with 21.6 percent of all northbound crossings, was down 4.7 percent and Brownsville, with 17.8 percent of all northbound pedestrian crossings, had a 6.4 percent decrease in crossings YTD.

Southbound vehicle bridge crossings into Mexico increased 1.9 percent in October from September's figures. Pharr increased 17.2 percent, El Paso was up 11.2 percent, Roma rose 10.3 percent, Eagle Pass increased 8.4 percent, Rio Grande was up 7.0 percent, Laredo rose 5.1 percent, Progreso marked a 2.6 percent increase, Del Rio was up 2.4 percent, McAllen-Hidalgo rose 1.3 percent and Harlingen rose slightly at 0.3 percent. However, Brownsville fell 14.5 percent. YTD total southbound vehicle bridge crossings were

up 4.8 percent. Laredo, with 25.4 percent of all southbound traffic in October, was up 4.7 percent YTD. Brownsville, with 17.7 percent of all southbound vehicle bridge crossings, had an 6.3 percent increase YTD. McAllen-Hidalgo, with 15.3 percent of all southbound vehicle crossings, experienced an 7.0 percent increase YTD. El Paso, accounting for 16.6 percent of all southbound vehicle crossings had a 6.8 percent increase YTD.

Northbound vehicle bridge crossings into Texas for October were up 2.5 percent since September. El Paso was up 9.4 percent, Rio Grande rose 5.2 percent, Eagle Pass increased 4.9 percent, Laredo was up 2.4 percent, and Presidio marked a 1.8 percent increase. However, Del Rio registered a 5.9 percent decrease, Harlingen fell 3.6 percent, Progreso slid 1.7 percent, McAllen-Hidalgo reported

a 1.6 percent decrease, Brownsville decreased 0.8 percent and Roma fell 0.7 percent. YTD northbound vehicle bridge crossings into Texas were up 3.2 percent. El Paso, with 25.7 percent of all crossings in October was up 2.9 percent YTD. Laredo, with 21.4 percent of all crossings, was down 1.7 percent and Brownsville with 17.7 percent of all crossings, was up 8.7 percent YTD.

Southbound truck shipments into Mexico were up 11.3 percent in October. Pharr increased 70.1 percent, Rio Grande rose 32.1 percent, Roma was up 18.1 percent, Eagle Pass gained 15.3 percent, Del Rio registered a 15.0 percent increase, Laredo rose 14.9 and Brownsville and Progreso increased 3.9 percent. However, McAllen fell 43.6 percent. Harlingen posted a 5.6 percent decrease. YTD, total southbound truck traffic had an increase of 18.7 percent.

Laredo, with 53.2 percent of all southbound shipments in October, experienced a 26.4 percent increase YTD. Brownsville, with 17.9 percent of all southbound shipments, had a 15.7 percent increase YTD. McAllen-Hidalgo with 4.3 percent of all truck traffic, registered a decrease of 15.9 percent and Pharr, with 11.0 percent of all truck crossings, rose 93.4 percent.

Northbound truck shipments into Texas increased 4.4 percent from September's shipments. Rio Grande increased 54.7 percent, Roma had an increase of 22.1 percent, Del Rio rose 18.3 percent, Pharr was up 12.5 percent, Eagle Pass rose 8.5 percent, Laredo was up 1.7 percent and Brownsville had a slight increase of 0.8 percent. However, Progreso showed a 33.5 percent decrease and Falcon

dipped 20.0 percent. YTD northbound truck shipments were up 5.1 percent. Laredo, accounting for 62.5 percent of all northbound truck traffic in October had a 1.7 percent increase YTD. Pharr, with 14.4 percent of shipments, experienced a 139.4 percent increase YTD.



Southbound rail shipments into Mexico increased 11.2 percent in October. El Paso was up 47.8 percent, Laredo rose 22.3 percent, and Brownsville had a slight increase of 3.8 percent. However, Eagle Pass was down 12.4 percent. YTD, total southbound rail shipments into Mexico from Texas were up 17.1 percent. Laredo, which accounts for 66.2 percent of all southbound rail shipments in October was up 15.2 percent. Eagle Pass, accounting for 22.0 percent of all southbound rail shipments, increased 33.3 percent. Brownsville, with 9.4 percent of all southbound rail shipments in October, rose 23.2 percent YTD.




Import Shipments by Rail into Texas —Number of Rail Cars

Northbound rail shipments into Texas increased 11.1 percent in October. Laredo registered a 25.9 percent increase and Brownsville rose 0.9 percent. However, El Paso declined 40.0 percent and Eagle pass posted a decrease of 13.6 percent. YTD, total northbound rail shipments into Texas from Mexico were down 0.0 percent. Laredo, which accounts for 68.7 percent of all northbound rail shipments in October was up 10.5 percent. Eagle Pass, accounting for 23.6 percent of all northbound rail shipments in October, increased 0.9 percent and Brownsville, with 7.0 percent of all northbound rail shipments, decreased 43.3 percent YTD.

Revenues (in U.S. Dollars) Collected by U.S. Customs District of Laredo



Total U.S. Customs revenues for the former District of Laredo increased 4.6 percent from September's figures. Rio Grande increased 26.6 percent, McAllen-Hidalgo rose 25.1 percent, Del Rio gained 22.8 percent and Laredo was up 18.1 percent. However, Eagle Pass fell 62.7 percent, Roma declined 41.8 percent, Brownsville fell 11.9 percent and Progreso registered a 8.7 percent decrease. YTD revenue figures were up 7.9 percent compared to







Tourist Visas YTD October 96-97







Residential Phones % Change October 96-97











The Port of Corpus Christi had a 21.1 percent decrease in outbound cargo tonnage in October. Petroleum, which is 80.3 percent of total outbound cargo for October, decreased 24.9 percent compared to September. Dry bulk increased 72.2 percent, Chemicals fell 27.0 percent and Bulk Grain decreased 27.2 percent. YTD, total outbound cargo tonnage was up 8.1 percent.
