- Southbound pedestrian crossings into Mexico were up 29.5 percent. El Paso was up 74.0 percent, McAllen-Hidalgo rose 15.7 percent, Laredo increased 13.2 percent and Brownsville was up 1.2 percent.
- . Northbound pedestrian crossings into Texas were down 1.6 percent. Brownsville was down 8.2 percent, McAllen-Hidalgo fell 9.8 percent and Laredo decreased 6.2 percent. However, El Paso increased 6.3 percent.
- . Southbound vehicle bridge crossings were up 5.5 percent. El Paso was up 9.5 percent, McAllen-Hidalgo rose 8.8 percent, Brownsville increased 6.5 percent and Laredo was up 5.2 percent.
- Northbound vehicle bridge crossings into Texas were up 2.7 percent with Brownsville increasing 7.4 percent and El Paso gaining 1.4 percent. However, Laredo was down 2.5 percent and McAllen-Hidalgo fell 1.4 percent YTD.
- Southbound truck shipments into Mexico were up 16.4 percent. Laredo increased 24.1 percent and Brownsville rose 12.2 percent while McAllen-Hidalgo decreased 15.6 percent.
- Northbound truck shipments into Texas were up 3.9 percent with Eagle Pass increasing 16.8 percent, Laredo posted a 0.4 percent decrease and Brownsville gained 3.7 percent YTD.
- . Southbound shipments by rail were up 18.7 percent.
- . Northbound shipments by rail were down 1.0 percent.
- Revenues collected by U.S. Customs were up 6.6 percent YTD. Revenues collected by U.S. Bridge operators were up 8.1 percent.
- Building permits issued were down 7.2 percent. Harlingen decreased by 16.3 percent, El Paso declined 11.6 percent and Laredo was down 2.0 percent.
- Building permit values were up with aYTD increase of 28.2 percent. Brownsville increased 82.5 percent, McAllen was up 41.4 percent, Laredo gained 39.5 percent and Harlingen reported a 31.1 percent increase.
- Total employment was up 6.5 percent (26,216 jobs gained) YTD. The average unemployment rate in August 1997 was 11.1 percent, down from the 13.3 percent in August 1996.

Public Law 104-88 and House Bill 1487, Freight Forwarding Seminar Sponsored by the Texas Center at Texas A&M International University

Did you know that under federal and state Law, freight forwarders have to register with the government? Under the ICC Termination Act, a **freight forwarder** is considered a "**carrier**." Under Public Law 104-88, the definition of a carrier is "(3) *Carrier - The term 'carrier' means a motor carrier, a water carrier, and a freight forwarder*." If one is considered a freight forwarder, one needs operating authority.

Did you also know that under federal law if you receive, store, break bulk, warehouse and use interstate or foreign motor carriers or a drayage motor carrier, you may be considered a freight forwarder. The Texas Center at Texas A&M International University recently held a seminar covering the ICC Termination Act and House Bill 1487 on October 29th that provided information on how freight forwarders can register at both the state and federal level.

The seminar was opened by Dr. Larry Boyd, Provost of Texas A&M International University and Dr. Khosrow Fatemi, Dean of the College of Business Administration. Dr. James R. Giermanski, Director of Transportation & Logistics, Center for the Study of Western Hemispheric Trade, Texas A&M International University started the seminar with an overview and background of freight forwarding regulations. He then talked about current federal and state laws (Public Law 104-88 and House Bill 1487) concerning registration of freight forwarders. Dr. Giermanski ended his presentation with a discussion of liability for freight forwarders, particularly with respect to potential Carmack implications.

The next speaker was Liborio Canales, Attorney-at-Law, on the Carmack Amendment. He was followed by Flavio Munoz de Leon, Attorney-at-Law from Monterrey, covering possible scenarios in U.S.-Mexican Freight Movement. Liborio Canales finished up his segment with Federal/State Jurisdiction and Enforcement/Rights & Remedies.

The next portion of the seminar was covered by Nat Jackson, U.S. Department of Transportation, Office of Motor Carriers, who explained the federal registration process. Each participant was provided a booklet with federal registration material inside. Mr. Jackson went step-by-step through the federal registration which benefitted the freight forwarders in attendance.


The final speakers came from the Texas Department of Licensing and Regulation. Henry Molina, Deputy Executive Director and Investigator Bob Roda explained the state registration process. They were accompanied by State Representative Henry Cuellar, D-Laredo, the sponsor of House Bill 1487. Mr. Molina passed out state registration material during his presentation and attempted to "clear the waters" in a lot of the gray areas of the bill. An example discussed at the seminar is where the state bill reads under Section 9 Qualifications (b) "The department may refuse to grant acertificate of registration to a person, other than an individual, or may suspend or revoke the person's certificate if: (2) the person owes delinquent taxes to any local, state, or federal taxing entity." To an average reader of the law, this appears that if one owes back Webb County taxes, one may be refused a registration certificate. Representative Cuellar and Bob Roda assured the audience that the State of Texas does not have any intention to shut down businesses. The Texas Department of Licensing and Regulation officials said they would work with freight forwarders who might be delinquent on back taxes in order to facilitate state registration as freight forwarders.

Southbound pedestrian bridge crossings into Mexico for August were up 2.8 percent compared to July. Harlingen increased 20.5 percent, Eagle Pass was up 14.5 percent, El Paso gained 8.5 percent, Roma rose 7.7 percent, Del Rio grew 4.7 percent and McAllen-Hidalgo posted an increase of 3.5 percent. However, Rio Grande fell 14.3 percent, Progreso declined 13.7 percent, Laredo was down 3.3 percent and Brownsville dipped 0.4 percent. YTD, total southbound pedestrian crossings into Texas were up 29.5 percent. El Paso southbound pedestrian crossings, which make up 45.1 percent of all crossings in August, were up 74.0 percent. Laredo, accounting for 22.0 percent of all crossings, was up 13.2 percent and Brownsville was up 1.2 percent with 18.0 percent of all crossings YTD.





Northbound pedestrian crossings into Texas were down 3.8 percent in August. Progreso decreased 24.1 percent, Brownsville fell 16.0, Eagle Pass declined 5.4 percent, Laredo fell 4.2 percent and Del Rio dipped 1.6 percent. However, Rio Grande increased 16.0 percent, Presidio rose 12.5 percent, El Paso was up 4.6 percent, Roma grew 3.9 percent and McAllen-Hidalgo posted a slight increase of 0.2 percent. YTD total northbound pedestrian crossings into Texas were down 1.6 percent. El Paso, accounting for 43.4 percent of all northbound pedestrian crossings in August, was up 6.3 percent YTD. Laredo, with 21.2 percent of all northbound crossings, was down 6.2 percent and Brownsville, with 19.2 percent of all northbound pedestrian crossings, had an 8.2 percent decrease in crossings YTD.

Southbound vehicle bridge crossings into Mexico increased 1.4 percent in August from July's figures. Rio Grande increased 5.0 percent, McAllen-Hidalgo was up 4.7 percent, Laredo rose 3.1 percent, Roma increased 2.8 percent, Del Rio gained 1.5 percent, Harlingen posted a 1.1 percent increase and El Paso rose slightly at 0.1 percent. However, Pharr decreased 2.8 percent, Progreso fell 2.0 percent and Brownsville had a 0.7 percent decline. YTD total southbound vehicle bridge crossings were up 5.5 percent. Laredo,

with 24.7 percent of all southbound traffic in August, was up 5.2 percent YTD. Brownsville, with 18.9 percent of all southbound vehicle bridge crossings, had a 6.5 percent increase YTD. McAllen-Hidalgo, with 16.0 percent of all southbound vehicle crossings, experienced an 8.8 percent increase YTD. El Paso, accounting for 15.6 percent of all southbound vehicle crossings had a 9.5 percent increase YTD.

Northbound vehicle bridge crossings into Texas for August were up 5.0 percent since July. El Paso was up 17.2 percent, Presidio gained 10.8 percent, Roma increased 3.4 percent and Rio Grande rose 3.3 percent. McAllen-Hidalgo was up 2.7 percent, Laredo gained 2.1 percent, Brownsville rose 1.4 percent and Eagle Pass reported a 1.1 percent increase. However, Progreso posted a 2.8 percent decrease, Del Rio declined 2.5 percent and Harlingen

remained unchanged for the month. YTD northbound vehicle bridge crossings into Texas were up 2.7 percent. El Paso, with 24.3 percent of all crossings in August, was up 1.4 percent YTD. Laredo, with 20.5 percent of all crossings, was down 2.5 percent and Brownsville with 18.2 percent of all crossings, was up 7.4 percent YTD.

Southbound truck shipments into Mexico were down 1.0 percent in August. Rio Grande decreased 15.8 percent, Eagle Pass fell 14.5 percent, Roma declined 10.5 percent, Pharr was down 4.4 percent, McAllen-Hidalgo and Brownsville registered a 2.8 percent decline and Laredo dipped 0.9 percent. However, Progreso posted an 84.0 percent increase, Del Rio rose 19.3 percent and Harlingen was up 8.7 percent. YTD, total southbound truck traffic had an increase of

16.4 percent. Laredo, with 51.5 percent of all southbound shipments in August, experienced a 24.1 percent increase YTD. Brownsville, with 18.6 percent of all southbound shipments, had a 12.2 percent increase YTD. McAllen-Hidalgo with 8.5 percent of all truck traffic, registered a decrease of 15.6 percent and Pharr, with 7.6 percent of all truck crossings, rose 94.6 percent.

Northbound truck shipments into Texas decreased 11.8 percent from July's shipments. Rio Grande decreased 33.3 percent, Laredo had a decline of 18.8 percent, Roma fell 8.2 percent and Pharr slipped 5.8 percent. However, Falcon showed a 144.4 percent increase, Eagle Pass was up 8.3 percent, Del Rio rose 7.1 percent,


Brownsville increased 2.9 percent and Progreso gained 2.3 percent. YTD northbound truck shipments were up 3.9 percent. Laredo, accounting for 55.5 percent of all northbound truck traffic in August, had a 0.4 percent decrease YTD. Pharr, with 16.6 percent of shipments, experienced a 227.0 percent increase YTD.

Southbound rail shipments into Mexico decreased 8.9 percent in August. El Paso declined 23.4 percent, Laredo was down 11.6 percent, Eagle Pass fell 3.1 percent and Brownsville decreased 0.9 percent. YTD, total southbound rail shipments into Mexico from Texas were up 18.7 percent. Laredo, which accounts for 61.6 percent of all southbound rail shipments in August, was up 16.9 percent. Eagle Pass, accounting for 25.6 percent of all southbound rail shipments, increased 34.0 percent. Brownsville, with 10.4 percent of all southbound rail shipments in August, rose 28.8 percent YTD.



Export Rail YTD % Change 96-97





% Share Revenues August 1997





Tourist Visas YTD August 96-97









Passenger Arrivals % Change YTD 96-97








