Note from the Director

Indicators of border business activity for the month of the were down. Twelve monthly indicators were down while eleven indicators were up when compared to May. In addition, for the year-to-date (YTD) figures, fifteen indicators were up and eight were down. Selected YTD comparisons to 1996 reported by border cities include the following:

- Southbound pedestrian crossings into Mexico were up 29.7 percent. El Paso was up 80.7 percent, McAllen-Hidalgo rose 14.0 percent, Laredo increased 11.5 percent while Brownsville was down 0.1 percent.
- Northbound pedestrian crossings intoTexas were down 2.4 percent. Brownsville was down 12.3 percent, Laredo decreased 7.9 percent and McAllen-Hidalgo fell 6.7 percent. However, El Paso increased 8.2 percent.
- Southbound vehicle bridge crossings were up 5.4 percent. McAllen-Hidalgo was up 10.6 percent, El Paso rose 9.0 percent, Brownsville increased 6.6 percent and Laredo was up 4.7 percent.
- Northbound vehicle bridge crossings into Texas were up 3.0 percent with Brownsville increasing 9.6 percent and El Paso gaining 0.6 percent. However, McAllen-Hidalgo was down 2.7 percent and Laredo fell 2.5 percent YTD.
- Southbound truck shipments into Mexico were up 15.4 percent. Laredo increased 23.5 percent and Brownsville rose 8.8 percent while McAllen-Hidalgo decreased 17.2 percent.
- Northbound truck shipments into Texas were up 3.8 percent with Eagle Pass increasing 16.1 percent and Laredo posted a 1.1 percent increase YTD. However, Brownsville remained unchanged YTD.
- . Southbound shipments by rail were up 20.8 percent.
- . Northbound shipments by rail were down 2.4 percent.
- . Revenues collected by U.S. Customs were up 5.3 percent YTD. Revenues collected by U.S. Bridge operators were up 7.6 percent.
- Building permits issued were down 24.3 percent. Harlingen decreased by 31.9 percent, El Paso declined 28.8 percent and Laredo was down 18.9 percent.
- Building permit values were up with aYTD increase of 12.2 percent. Brownsville increased 137.1 percent, Laredo up 29.8 percent, Harlingen 10.5 was up percent and Eagle Pass reported a 5.5 percent increase.
- Total employment was up 3.4 percent (14,161 jobs gained) YTD. The average unemployment rate in June 1997 was 12.4 percent, down from the 13.8 percent in June 1996.



Southbound pedestrian bridge crossings into Mexico for June were down 10.4 percent compared to May. Rio Grande decreased 29.9 percent, Del Rio was down 25.9 percent, Roma fell 22.7 percent, El Paso declined 13.3 percent, Eagle Pass dipped 12.6 percent, McAllen-Hidalgo posted a decrease of 9.0 percent, Brownsville decreased 8.3 percent, Progreso slid 6.9 percent, Laredo dipped 5.9 percent and Harlingen fell 2.0 percent. YTD, total southbound pedestrian crossings into Texas were up 29.7 percent. El Paso southbound pedestrian crossings, which make up 44.3 percent of all crossings in June, were up 80.7 percent. Laredo, accounting for 22.6 percent of all crossings, was up 11.5 percent and Brownsville was down 0.1 percent with 17.7 percent of all crossings YTD.

% Share Pedestrians for June 1997





Northbound pedestrian crossings into Texas were down 5.1 percent in June. Presidio decreased 17.9 percent, Rio Grande fell 17.0 percent, Roma was down 14.4 percent, El Paso declined 8.5 percent, Laredo decreased 7.7 percent, McAllen-Hidalgo was down 5.6 percent, Del Rio dipped 2.4 percent and Eagle Pass decreased slightly by 1.1 percent. However, Progreso gained 11.3 percent and Brownsville increased 3.0 percent. YTD total northbound pedestrian crossings into Texas were down 2.4 percent. El Paso, accounting for 41.7 percent of all northbound pedestrian crossings in June, was up 8.2 percent YTD. Laredo, with 20.7 percent of all northbound crossings, was down 7.9 percent and Brownsville, with 19.5 percent of all northbound pedestrian crossings, had a 12.3 percent decrease in crossings YTD.

Southbound vehicle bridge crossings into Mexico decreased 5.8 percent in June from May's figures. El Paso decreased 9.5 percent, Roma was down 8.4 percent, McAllen-Hidalgo and Progreso fell 7.9 percent, Eagle Pass decreased 7.6 percent, Rio Grande declined 7.5 percent, Brownsville posted a 5.8 percent decrease, Del Rio dipped 4.7 percent, Harlingen fell 3.2 percent and Laredo was down 2.3 percent. However, Pharr increased 3.9 percent. YTD total southbound vehicle bridge crossings were up 5.4 percent. Laredo,

with 24.8 percent of all southbound traffic in June, was up 4.7 percent YTD. Brownsville, with 18.4 percent of all southbound vehicle bridge crossings, had a 6.6 percent increase YTD. El Paso, accounting for 15.7 percent of all southbound vehicle crossings had a 9.0 percent increase YTD. McAllen-Hidalgo, with 15.7 percent of all southbound vehicle crossings, experienced a 10.6 percent increase YTD.

Northbound vehicle bridge crossings into Texas for June were down 4.5 percent since May. Rio Grande was down 7.4 percent, Progreso fell 6.6 percent, El Paso decreased 6.3 percent, Brownsville declined 6.0 percent, Eagle Pass and Roma slid 5.9 percent, McAllen-Hidalgo posted a 5.5 percent decrease, Presidio decreased 2.3 percent, Harlingen was down 2.2 percent and Laredo decreased slightly by 1.4 percent. However, Del Rio increased 3.8 percent. YTD northbound vehicle bridge crossings into Texas were up 3.0 percent. El Paso, with 23.4 percent of all crossings in June, was up 0.6 percent YTD. Laredo, with 21.0 percent of all crossings, was down 2.5 percent and Brownsville with 17.6 percent of all crossings, was up 9.6 percent YTD.

Southbound truck shipments into Mexico were down 1.2 percent in June. Progreso was down 42.9 percent, Rio Grande decreased 27.9 percent, Eagle Pass fell 13.8 percent, Del Rio registered an 8.4 percent decrease, Roma was down 5.8 percent and McAllen-Hidalgo decreased 4.8 percent. However, Harlingen posted an 11.2 percent increase, Brownsville rose 1.6 percent, Pharr was up 1.5 percent and Laredo gained 1.0 percent. YTD, total southbound

truck traffic had an increase of 15.4 percent. Laredo, with 52.3 percent of all southbound shipments in June, experienced a 23.5 percent increase YTD. Brownsville, with 18.2 percent of all southbound shipments, had an 8.8 percent increase YTD. McAllen-Hidalgo with 9.2 percent of all truck traffic, registered a decrease of 17.2 percent and Pharr, with 8.0 percent of all truck crossings, rose 97.2 percent.

Northbound truck shipments into Texas increased 0.9 percent from May's shipments. Progreso had an increase of 33.8 percent, Brownsville posted an increase of 8.9 percent and Laredo rose 2.9 percent. However, Rio Grande was down 47.6 percent, Falcon dipped 28.6 percent, Del Rio decreased 7.5 percent, Roma declined 3.2 percent, Pharr fell 2.4 percent and Eagle Pass slid 1.1 percent. YTD northbound truck shipments were up 3.8 percent. Laredo, accounting for 59.7 percent of all northbound truck traffic in June, had a 1.1 percent increase YTD. Pharr, with 16.6 percent of shipments, experienced a 217.6 percent increase YTD.

Southbound rail shipments into Mexico decreased 14.3 percent in June. Brownsville decreased 51.7 percent, El Paso was down 13.0 percent and Laredo fell 12.6 percent. However, Eagle Pass increased 27.2 percent. YTD, total southbound rail shipments into Mexico from Texas were up 20.8 percent. Laredo, which accounts for 63.3 percent of all southbound rail shipments in June, was up 17.2 percent. Brownsville, accounting for 11.3 percent of all southbound rail shipments, increased 43.6 percent. Eagle Pass, with 22.8 percent of all southbound rail shipments in June, rose 37.0 percent YTD.



However, El Paso fell 31.9 percent and Eagle Pass declined 3.9 percent. YTD, total northbound rail shipments into Texas from Mexico were down 2.4 percent. Laredo, which accounts for 66.2 percent of all northbound rail shipments in June, was up 7.2 percent. Eagle Pass, accounting for 24.8 percent of all northbound rail shipments, decreased 49.3 percent.

Import Rail YTD % Change 96-97





Total U.S. Customs revenues for the former District of Laredo decreased 9.3 percent. Progreso decreased 94.6 percent, McAllen-Hidalgo was down 53.6 percent, Rio Grande fell 42.6 percent and Del Rio dipped 15.9 percent. Laredo, accounting for 66.6 percent of total District revenues, was up 11.9 percent YTD and McAllen-Hidalgo with 15.5 percent of total revenues, was down 14.1 percent YTD. Eagle Pass with 7.3 percent of all revenues in June, increased 12.0 percent YTD. Brownsville, with 8.1 percent of total revenues in June, decreased 3.6 percent.





Total Revenues Collected YTD 96-97









Hotel Occupancy Percentage June 96-97



Residential Phones % Change June 96-97









% Share June 1997 Inbound Cargo





Dry bulk fell 22.6 percent, Chemicals fell 100.0 percent and Bulk Grain rose 70.9 percent. YTD, total outbound cargo tonnage was up 3.0 percent.
