#### **Note from the Director**

Indicators of border business activity for the month of November demonstrated an increase of eleven indicators while eleven indicators decreased. In addition, year-to-date (YTD) figures, ten indicators were up and twelve decreased. Selected 2001 YTD comparisons to 2000 reported by border cities include the following:

- Southbound pedestrian crossings into Mexico were down 2.7 percent. Laredo decreased 3.0 percent, Rio Grande jumped 2.9 percent, McAllen registered an increase of 3.1 percent and El Paso rose 2.1 percent.
- Northbound pedestrian crossings into Texas were up 3.3 percent. Laredo fell 3.1 percent. El Paso went up 4.6 percent. McAllen marked an increase of 21.2 percent.
- Southbound vehicle crossings were down 2.3 percent. Brownsville fell 4.3 percent, and Eagle Pass increased 3.4 percent. El Paso went down 7.1 percent and Pharr decreased 4.0 percent. Laredo went down 1.6 percent. McAllen decreased 0.9 percent.
- Northbound vehicle crossings were down 3.1 percent. Eagle Pass rose 0.5 percent. Roma increased 0.7 percent, El Paso went down 6.1 percent, Brownsville lost 3.2 percent and Pharr increased 3.0 percent.
- Southbound truck crossings into Mexico were down 3.6 percent. Eagle Pass went down 15.6 percent. Pharr increased 0.4 percent, and Laredo fell 0.5 percent. Del Rio was down 0.6 percent. Progreso gained 4.8 and Rio Grande grew 1.7 percent.
- Northbound truck crossings into Texas went down 6.4 percent, Pharr fell 2.0 percent and Eagle Pass posted an 8.4 percent decrease. Brownsville decreased 16.8 percent, Laredo fell 6.2 percent, Del Rio marked a drop of 3.5 percent. Rio Grande had a gain of 8.6 percent. Progreso went up 63.1 percent.
- Southbound shipments by rail were up 1.9 percent.
- Northbound shipments by rail were up 4.4 percent.
- Revenues collected by U.S. Customs went down 10.3 percent.
- Revenues collected by U.S. bridge operators were up 1.2 percent.
- Total building permits issued were up 4.7 percent. Laredo rose 14.9 percent, Eagle Pass gained 4.4 percent, while McAllen-Hidalgo dropped 8.4 percent, and Brownsville registered a decrease of 4.0 percent. El Paso showed an 8.2 percent increase.
- Total building permit values increased 11.5 percent. Laredo increased 20.5 percent, and Brownsville fell 18.6 percent. McAllen increased 32.6 percent. El Paso was up 12.4 percent, and Eagle Pass jumped 82.7 percent.
- Total employment was up 1.0 percent, with 4,301 jobs gained. The average unemployment rate for the border in November 2001 was 8.1 percent.



# U.S.-Mexico Trade Will Register a Decrease as Year Ends

In the November issue of the *BBI*, the effects of the U.S. economic downturn on U.S.-Mexico trade was exhibited in a set of year-to-date figures comparing 2000 and 2001. An update of those trade figures showed total U.S.-Mexico trade experienced a 5.4 percent decrease from \$228.6 billion (Nov. 2000 YTD) to \$216.3 billion in Nov 2001 year-to-date. U.S. exports to Mexico were down 8.4 percent year-to-date and U.S. imports from Mexico were down 2.9 percent for the same period (See Chart 1A). Charts 1B through 3 demonstrate monthly 2001 figures for total trade, U.S. exports and U.S. imports.


Chart 4 shows the percent change between November 2000 and 2001 for U.S. exports (-1.6%), U.S. imports (-1.0%) and total trade (-2.6%). U.S.-Mexico trade will register a loss at year's end for the first time in quite a few years. This drop will be due to the slowing of both countries' interdependent economies. Although the event of 9/11 may have had some effect, its lingering effect will be on the daily operations of trade because of the increased emphasis on insuring national security at all points of entry. —B. G. Garcia

#### Chart 1A U.S.-Mexico Trade November 2000 YTD vs. November 2001 YTD







Southbound pedestrian crossings into Mexico for November were down 1.1 percent. Rio Grande decreased 17.0 percent, Brownsville gained 3.7 percent, Eagle Pass fell 3.5 percent, El Paso decreased 9.8 percent, and Laredo went down 1.4 percent. Progreso gained 39.1 percent, and McAllen-Hidalgo went up 8.7 percent. Del Rio decreased 58.4 percent. YTD southbound pedestrian crossings into Mexico declined 2.7 percent. El Paso's southbound pedestrian crossings, which made up 28.1 percent of all crossings, increased 2.1 percent YTD. Laredo, accounting for 21.1 percent of total crossings, fell 3.0 percent YTD. Brownsville, with a 14.3 percent share, increased 3.8 percent YTD. Progreso, with 6.3 percent share, declined 0.6 percent. Del Rio, with 0.3 percent, increased 15.8 percent YTD.

#### % Share Pedestrians for November 2001





Progreso increased 38.7 percent, Brownsville was up 4.1 percent, El Paso fell 11.9 pecent, and Laredo gained 0.04 percent. YTD northbound pedestrian crossings into Texas were up 3.3 percent. El Paso, accounting for 37.8 percent of northbound crossings, was up 4.6 percent YTD. Laredo, with 23.9 percent of all northbound crossings, was down 3.1 percent YTD. Brownsville, with 16.7 percent of all northbound pedestrian crossings, increased 3.0 percent over the previous year.

Eagle Pass was up 11.0 percent, Del Rio rose 7.8 percent, Rio Grande gained 10.6 percent, McAllen-Hidalgo increased 3.8 percent, and Brownsville went up 3.9 percent. Harlingen gained 7.7 percent, and Laredo was up 2.2 percent. YTD southbound vehicle bridge crossings were down 2.3 percent. Laredo, with 23.1 percent of all southbound traffic, was down 1.6 percent

YTD. Brownsville, with 19.4 percent of all southbound vehicle bridge crossings, had a 4.3 percent decrease YTD. El Paso, accounting for 14.1 percent of all southbound vehicle crossings, fell 7.1 percent YTD. McAllen-Hidalgo, with 15.6 percent of all southbound vehicle crossings, experienced a 0.9 percent decrease YTD.

Laredo was down 4.4 percent and Brownsville lost 6.2 percent. YTD southbound truck crossings were down 3.6 percent. Laredo, with 64.2 percent of all southbound

crossings, experienced a 0.5 percent decrease YTD. Brownsville, with a 10.0 percent of all southbound crossings, had a 7.8 percent decrease YTD. Pharr, with 11.9 percent, registered an increase of 0.4 percent YTD. Eagle Pass, with 4.3 percent of all truck crossings, fell 15.6 percent YTD.

accounting for 62.7 percent of all northbound truck crossings, had a 6.2 percent decrease YTD. Pharr, with 16.5 percent of all crossings, experienced a 2.0 percent decline YTD. Brownsville, with 11.3 percent of all northbound truck crossings, experienced a 16.8 percent decrease YTD.



Southbound rail shipments into Mexico increased 5.3 percent in November. Brownsville rose 31.7 percent, while Laredo increased 2.4 percent. Eagle Pass fell 0.3 percent. YTD southbound rail shipments into Mexico from Texas were up 1.9 percent. Laredo which accounted for 59.7 percent of all southbound rail shipments, was down 1.0 percent YTD. Eagle Pass, accounting for 28.0 percent of all southbound rail shipments, increased 8.8 percent YTD. Brownsville, with 12.3 percent of all southbound rail shipments, showed an increase of 1.4 percent YTD.





Northbound rail shipments into Texas decreased 18.0 percent in November. Laredo fell 13.0 percent, Brownsville declined 76.7 percent, and Eagle Pass lost 21.3 percent. YTD total northbound shipments into Texas from Mexico were up 4.4 percent. Laredo, which accounted for 78.4 percent of all northbound rail shipments, was up 11.7 percent YTD. Eagle Pass, accounting for 14.8 percent of all northbound rail shipments, fell 25.9 percent YTD. Brownsville, with 6.8 percent of all northbound rail shipments, increased 21.8 percent YTD.















#### % Share November 2001 Inbound Cargo







The Port of Brownsville had a decrease of 10.4 percent total tonnage in November over the previous month. Break Bulk, which accounted for 53.3 percent of total tonnage decreased 14.7 percent from October. Liquid, 0.8 percent share of November's total tonnage, fell 34.1 percent. Petroleum, which made up 45.6 percent of the total cargo for November dropped 4.5 percent. YTD figures showed a 15.5 percent increase in total cargo tonnage. Break Bulk tonnage, with 51.3 percent of total tonnage, fell 1.8 percent. Petroleum, with 45.4 percent of total tonnage, increased 51.6 percent. Liquid, with 1.6 percent of total tonnage, fell 7.2 percent.
