Indicators of border business activity for the month of March demonstrated an increase of nineteen indicators while three indicators decreased. In addition, the year to date (YTD) figures, eight indicators were up and fourteen decreased. Selected 2002 YTD comparisons to 2001 reported by border cities include the following:

- Southbound pedestrian crossings into Mexico were down 0.2 percent. Laredo decreased 0.3 percent, Rio Grande fell 66.7 percent, McAllen registered a decrease of 5.4 percent and El Paso rose 4.9 percent.
- Northbound pedestrian crossings into Texas were up 4.9 percent. Laredo fell 0.5 percent. El Paso went up 15.4 percent. McAllen marked a decrease of 1.8 percent.
- Southbound vehicle crossings were down 1.4 percent. Brownsville fell 3.2 percent, and Eagle Pass increased 5.3 percent. El Paso went down 17.9 percent and Pharr decreased 1.0 percent. Laredo went down 0.3 percent. McAllen increased 3.1 percent.
- Northbound vehicle crossings were down 1.7 percent. Eagle Pass rose 5.2 percent.
 Roma increased 2.9 percent, El Paso went down 11.3 percent, Brownsville gained 0.2 percent and Pharr decreased 1.5 percent.
- Southbound truck crossings into Mexico fell 1.2 percent. Eagle Pass went down 16.8 percent. Pharr increased 2.7 percent, and Laredo decreased 0.2 percent. Del Rio was up 30.5 percent. Progreso lost 16.1 and Rio Grande decreased 13.5 percent.
- Northbound truck crossings into Texas went up 2.0 percent, Pharr rose 3.7 percent and Eagle Pass posted an 18.7 percent decrease. Brownsville decreased 0.6 percent, Laredo climbed 1.3 percent, Del Rio increased 24.7 percent. Rio Grande had a loss of 14.5 percent. Progreso went up 35.9 percent.
- Southbound shipments by rail were up 0.5 percent.
- Northbound shipments by rail were down 6.6 percent.
- Revenues collected by U.S. Customs went down 6.1 percent.
- Revenues collected by U.S. bridge operators were down 0.3 percent.
- Total building permits issued were down 7.0 percent. Laredo fell 40.5 percent, Eagle Pass gained 25.6 percent, while McAllen rose 14.1 percent, and Brownsville registered an increase of 12.6 percent. El Paso showed a 6.1 percent increase.
- Total building permit values decreased 4.6 percent. Laredo decreased 9.5 percent, and Brownsville gained 4.8 percent. McAllen declined 52.6 percent. El Paso was up 14.3 percent, and Eagle Pass jumped 260.7 percent.
- Total employment was down 0.4 percent, with 1,748 jobs lost. The average unemployment rate for the border in March 2002 was 8.4 percent.

U.S.-Mexico Trade Down Despite March Gains Over February

U.S.-Mexico trade figures continue down in March 2002 year-to-date compared to same period in 2001. The total U.S.- Mexico trade dollar value of \$53.7 billion, down 10.4 percent for March 2002 YTD. In 2001, total trade had been \$59.9 billion (See Chart 1A).


Chart 1B, 2 and 3 exhibit respectively the current trends for Total Trade, U.S. exports to Mexico and U.S. import from Mexico. March 2002 recorded increases over the month of February 2002 in all three. Yet compared to the same period last year, March 2001, all three were down. U.S. exports to Mexico were down 15.7 percent or \$22.6 billion for March 2002 YTD. U.S. imports from Mexico were down 6.0 percent or \$31.1 billion for the same period.

Chart 4 shows the percent change between January throughMarch 2001 vs. January through March 2002 for U.S. exports (Jan. -11.5 % Feb. -18.0% and Mar. 17.4%), U.S. imports (Jan. -7.4%, Feb. -2.9% and Mar. -7.5%) and total trade (Jan. -9.2, Feb. -9.9% and Mar -11.8%). In the next issue, individual port data will be reviewed. —B. G. Garcia









Southbound pedestrian crossings into Mexico for March were up 20.6 percent. Rio Grande declined 15.3 percent, Brownsville gained 39.2 percent, Eagle Pass went up 16.6 percent, El Paso was up 17.7 percent, and Laredo rose 22.9 percent. Progreso gained 10.8 percent, and McAllen-Hidalgo went up 20.6 percent. Del Rio jumped 109.3 percent. YTD southbound pedestrian crossings into Mexico declined 0.2 percent. El Paso's southbound pedestrian crossings, which made up 26.5 percent of all crossings, increased 4.9 percent YTD. Laredo, accounting for 19.7 percent of total crossings, gained 0.3 percent YTD. Brownsville, with a 13.3 percent share, decreased 6.1 percent YTD. Progreso, with 9.7 percent share, lost 2.0 percent. Del Rio, with 0.3 percent, increased 10.2 percent YTD.

% Share Pedestrians for March 2002





Northbound pedestrian crossings into Texas were up 23.2 percent in March. Progreso increased 10.5 percent, Brownsville was up 36.7 percent, El Paso rose 21.5 percent, and Laredo fell 23.7 percent. YTD northbound pedestrian crossings into Texas were up 4.7 percent. El Paso, accounting for 38.2 percent of northbound crossings, was up 15.4 percent YTD. Laredo, with 22.6 percent of all northbound crossings, was up 0.5 percent YTD. Brownsville, with 15.5 percent of all northbound pedestrian crossings, decreased 2.8 percent over the previous year.

Eagle Pass was up 17.4 percent, Del Rio gained 18.4 percent, Rio Grande increased 18.3 percent, McAllen-Hidalgo went up 13.3 percent, and Brownsville climbed 8.6 percent. Harlingen rose 26.5 percent, and Laredo was up 14.2 percent. YTD southbound vehicle bridge crossings were down 1.4 percent. Laredo, with 21.9 percent of all southbound traffic, was down 0.3 percent

YTD. Brownsville, with 19.5 percent of all southbound vehicle bridge crossings, had a 3.2 percent decrease YTD. El Paso, accounting for 12.1 percent of all southbound vehicle crossings, fell 17.9 percent YTD. McAllen-Hidalgo, with 16.3 percent of all southbound vehicle crossings, experienced a 3.1 percent increase YTD.

Truck crossings into Mexico were up 3.0 percent in March. Harlingen increased 11.0 percent, Del Rio decreased 37.3 percent, and Pharr gained 15.2 percent. Laredo was up 3.0 percent and Brownsville gained 9.1 percent. YTD southbound truck crossings were down 1.2 percent. Laredo, with 64.2 percent of all southbound crossings,

experienced a 0.2 percent decrease YTD. Brownsville, with 9.7 percent of all southbound crossings, had a 0.9 percent decline YTD. Pharr, with 12.7 percent, registered a gain of 2.7 percent YTD. Eagle Pass, with 3.7 percent of all truck crossings, fell 16.8 percent YTD.

YTD northbound truck crossings were up 2.0 percent. Laredo, accounting for

47.1 percent of all northbound truck crossings, had a 1.3 percent increase YTD. Pharr, with 13.2 percent of all crossings, experienced a 3.7 percent increase YTD. Brownsville, with 8.4 percent of all northbound truck crossings, experienced a 0.6 percent decrease YTD.



Southbound rail shipments into Mexico gained 22.7 percent in March. Brownsville rose 25.4 percent, and Laredo increased 16.9 percent. Eagle Pass rose 33.1 percent. YTD southbound rail shipments into Mexico from Texas were up 0.5 percent. Laredo which accounted for 56.2 percentof all southbound rail shipments, was down 4.5 percent YTD. Eagle Pass, accounting for 27.9 percent of all southbound rail shipments, increased 6.3 percent YTD. Brownsville, with 15.9 percent of all southbound rail shipments, showed an increase of 10.3 percent YTD.

Export Rail YTD % Change 01-02





Northbound rail shipments into Texas increased 26.7 percent in March. Laredo gained 27.2 percent, Brownsville increased 78.2 percent, and Eagle Pass climbed 13.0 percent. YTD total northbound shipments into Texas from Mexico were down 6.6 percent. Laredo, which accounted for 83.5 percent of all northbound rail shipments, was up 0.3 percent YTD. Eagle Pass, accounting for 13.2 percent of all northbound rail shipments, fell 26.9 percent YTD. Brownsville, with 3.3 percent of all northbound rail shipments, decreased 42.5 percent YTD.







YTD AVG March 01-02







% Unemployed March 01-02







Passenger Arrivals % Change YTD 01-02







% Share March 2002 Inbound Cargo






