Note from the Director

Indicators of border business activity for the month of August were up moderately. Eleven monthly indicators were up and ten were down when compared to July. In addition, for the year-to-date (YTD), seventeen indicators were up and four were down. Selected YTD figures reported by border cities include the following.

- Southbound pedestrian crossings into Mexico were up 11.5 percent. Brownsville was up 14.5 percent, Laredo was up 10.0 percent, McAllen-Hidalgo was up 8.5 percent as was El Paso.
- Northbound pedestrian crossings into Texas were up 9.5 percent. McAllen-Hidalgo was up 16.9 percent, El Paso increased 18 percent, Brownsville increased 8.7 percent, but Laredo was down 2.1 percent.
- Southbound vehicle bridge crossings were up 8.3 percent. Laredo was up 17.3 percent, McAllen-Hidalgo was up 1.6 percent, and Brownsville increased 3.3 percent. However, El Paso dipped 0.7 percent.
- Northbound vehicle bridge crossings into Texas were up 3.8 percent with Brownsville up 11.4 percent, El Paso up 2.5 percent, and McAllen-Hidalgo 0.9 percent. Laredo increased 0.7 percent while Eagle Pass decreased 0.9 percent.
- Southbound truck shipments into Mexico were up 16.0 percent. Laredo had a 20.8 percent increase, Brownsville was up 6.8 percent and McAllen-Hidalgo increased 3.7 percent.
- Northbound truck shipments into Texas were up 13.3 percent. Laredo had a 29.5 percent increase. However, McAllen-Hidalgo registered a 24.2 percent decrease and Brownsville slid as well 1.4 percent.
- Revenues collected by U.S. Customs were up 6.7 percent and revenues collected by U.S. Bridge operators were up 14.5 percent.
- Building permits issued were up 19.8 percent. El Paso increased by 23.0 percent and Laredo was up 6.5 percent.
- Building permit values were up with a YTD increase of 10.4 percent. El Paso increased 19.0 percent. McAllen was up 10.8 percent, but Laredo reported a 15.6 percent decrease.
- Total employment was down by 2.3 percent (9,279 jobs lost) YTD. The average unemployment rate in August 1996 was 13.3 percent, up from the 11.3 percent in August 1995.

Due to incomplete data, El Paso rail data for north and south bound have not been included for this issue.



Southbound pedestrian bridge crossings into Mexico for August were up 0.8 percent compared to July. Del Rio was up 12.9 percent, El Paso was up 9.4 percent, McAllen-Hidalgo increased 7.0 percent, Eagle Pass increased 5.3 percent, and Roma posted an increase of 3.4 percent. However, Harlingen decreased 19.7 percent, Progreso was down 17.8 percent, Rio Grande decreased 8.9 percent, Laredo was down 5.0 percent and Brownsville dipped 3.9 percent. YTD total southbound pedestrian bridge crossings were up 11.5 percent. El Paso southbound pedestrian crossings, 37.5 percent of all crossings, were up 8.5 percent. Laredo, accounting for 24.0 percent of all crossings, was up 10.0 percent YTD. Brownsville was up 14.5 percent with 22.0 percent of all crossings in the month of August.





Northbound pedestrian crossings into Texas were down 1.1 percent in August. Progreso decreased 20.7 percent, Rio Grande decreased 10.4 percent, Brownsville fell 8.5 percent and Laredo dipped 4.6 percent. However, Del Rio increased 27.2 percent, Presidio increased 22.4 percent, Eagle Pass increased 5.7 percent, El Paso was up 5.2 percent, Roma grew 4.5 percent and McAllen-Hidalgo increased 2.0 percent. YTD total northbound pedestrian crossings into Texas were up 9.5 percent. El Paso, accounting for 42.7 percent of all northbound pedestrian crossings, was up 18.0 percent YTD. Brownsville, with 19.2 percent of all northbound crossings, was up 8.7 percent. However, Laredo, with 21.4 percent of all northbound pedestrian crossings, had a 2.1 percent decrease in crossings YTD.

Southbound vehicle bridge crossings into Mexico increased 1.5 percent in August from July's figures. El Paso increased 6.9 percent, Laredo registered an increase of 5.2 percent, Eagle Pass increased 0.8 percent, Del Rio was up 0.7 percent, Rio Grande increased 0.4 percent and Brownsville was up slightly at 0.1 percent. However, Harlingen registered a decrease of 12.2 percent, Progreso declined 9.9 percent, Pharr fell 5.2 percent, Roma dipped 2.9 percent and McAllen-Hidalgo slid 0.7 percent. YTD total

southbound vehicle bridge crossings were up 8.3 percent. Laredo, with 24.7 percent of all traffic, was up 17.3 percent YTD. McAllen-Hidalgo, with 16.0 percent of all southbound vehicle bridge crossings, had a 1.6 percent increase YTD. Brownsville, accounting for 18.9 percent of all southbound vehicle crossings had a 3.3 percent increase YTD. However, El Paso, with 15.4 percent of all southbound vehicle crossings, experienced a 0.7 percent decrease YTD.

Northbound vehicle bridge crossings into Texas for August were down 2.6 percent since July. Brownsville was down 13.0 percent, Harlingen registered a decrease of 12.9 percent, Progreso was down 8.1 percent, Roma decreased 2.6 percent, Rio Grande decreased 2.4 percent, Laredo fell 2.2 percent, McAllen-Hidalgo posted a 1.9 percent decrease and Del Rio decreased 1.5 percent. However, Presidio rose 18.1 percent, El Paso increased 3.6 percent and Eagle Pass was up 2.7 percent. YTD northbound vehicle bridge crossings into Texas were up 3.8 percent. El Paso, with 23.4 percent of all crossings, was up 2.5 percent. Laredo with 21.7 percent of all northbound vehicle bridge crossings, was up slightly by 0.7 percent YTD. Brownsville, with 17.6 percent of all crossings, was up 11.4 percent YTD. McAllen-Hidalgo, with 14.1 percent of all crossings, was up 0.9 percent.

Southbound truck shipments into Mexico remained even in August. Del Rio was up 27.5 percent, Brownsville increased 6.4 percent, Roma increased 3.8 percent, Laredo was up 3.0 percent and McAllen-Hidalgo increased slightly by 0.5 percent. However, Eagle Pass was down 36.5 percent, and Progreso decreased 25.6 percent, Harlingen decreased 16.3 percent, Rio Grande declined 11.6 percent and Pharr fell 2.1 percent. YTD, total truck traffic had an increase of 16.0 percent. Laredo, with 49.6 percent of all southbound shipments, experienced a 20.8 percent increase YTD. Brownsville, with 18.8 percent of all southbound shipments, had a 6.8 percent increase YTD. McAllen-Hidalgo with 11.5 percent of all truck traffic, registered a slight increase of 3.7 percent.

Northbound truck shipments into Texas increased 2.9 percent from July's shipments. Northbound shipments through Rio Grande gained 10.2 percent, Roma increased 9.4 percent, Eagle Pass increased 8.4 percent, Del Rio was up 6.7 percent, Brownsville rose by 5.4 percent and Laredo increased 2.9 percent. However, Progreso decreased 21.1 percent and McAllen-Hidalgo was down 4.0 per-

cent. YTD, northbound truck shipments were up 13.3 percent. Laredo, accounting for 66.4 percent of all northbound truck traffic, had a 29.5 percent increase YTD. Brownsville, with 14.5 percent of shipments, experienced a 1.4 percent decrease YTD. McAllen-Hidalgo, with 8.6 percent of all northbound truck shipments into Texas, had a 24.2 percent decrease YTD.


Export Shipments by Rail into Mexico —Number of Rail Cars

Southbound rail shipments into Mexico increased 7.2 percent in August. It must be noted that this does not include El Paso data. Eagle Pass had a 34.2 percent increase over July's shipments. Brownsville rose by 3.9 percent and Laredo rose slightly by 0.7 percent. YTD total southbound rail shipments into Mexico during the month of August were up 30.6 percent. Laredo, with 63.7 percent of all southbound rail shipments, was up 23.4 percent YTD. Eagle Pass, with 22.6 percent of all southbound shipments, increased 88.5 percent YTD. Brownsville, with 13.7 percent of all southbound rail shipments, was up 19.8 percent YTD.

Export Rail YTD % Change 95-96





Northbound rail shipments into Texas increased 9.5 percent in August. El Paso data is not currently available. Brownsville was up 29.2 percent, Laredo increased 7.7 percent and Eagle Pass gained 3.8 percent. YTD total northbound rail shipments into Texas were up 43.8 percent. Laredo, with 64.9 percent of all shipments during the month of August was up 55.7 percent YTD. Eagle Pass, accounting for 20.6 percent of all northbound rail shipments, was up 5.8 percent YTD, and Brownsville was up 58.2 percent YTD with a 14.5 percent share of all shipments in August.







% Share Revenues August 1996





Tourist Visas YTD August 95-96







Residential Phones % Change August 95-96







Air Passenger Service Activities —Selected Border Cities



Passenger Arrivals % Change YTD 95-96







% Share August 1996 Inbound Cargo





YTD, total outbound cargo tonnage was up 12.5 percent.
