Hopefully this will translate into improved angler success in coming years. Changes like this make fisheries managers look like heroes when in truth and in fact these benefits are entirely out of our control. We might as well enjoy the accolades because sooner or later something else will inevitably crop up that will consume your time and you will ultimately be blamed for. These ups and downs are all a part of the challenges faced by natural resource professionals operating in a world with diverse user groups some of whom can be quite demanding. We do what we do because that is where our passion lies. It's nice to live comfortably, but it's never been about the money!

If you are a younger professional or you've been watching the Chapter function from the sidelines there are many opportunities for involvement in TCAFS. As our Chapter reaches the ripe old age of 40, you can help shape its course and perhaps contribute to its legacy. 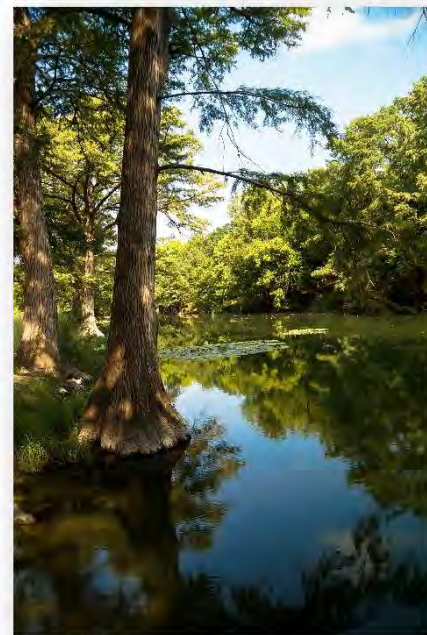
Registration:

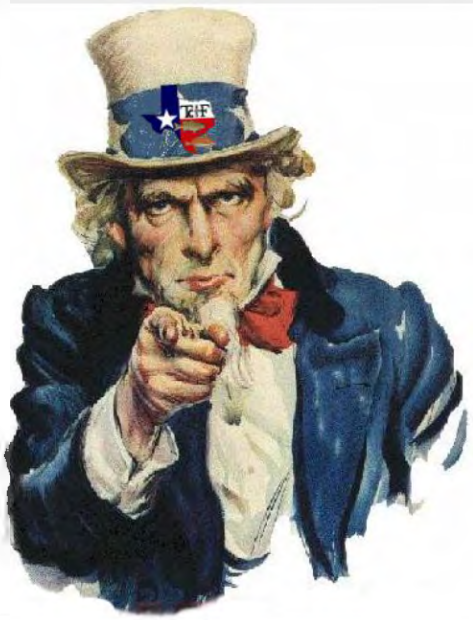
Ask for the Texas Chapter American Fisheries Society Rate

Texas Chapter AFS Business Meeting Minutes

November 17, 2015

Call to Order: President Kevin Storey called the meeting to order at 10:02AM.

Members Present: Kevin Storey (President), Dave Buzan (President-Elect), Michael Homer Jr. (Secretary/Treasurer), Michele Nations (Historian/Awards Committee), Allison Pease (Editorial), Lynn Wright (Continuing Education), Joe Beach (Student Outreach), Aaron Urbanczyk (TX Tech Subunit President)

Approval of Previous Business Meeting Minutes: Kevin asked about approval of the August EXCOM Meeting Minutes published in the October 2015 newsletter. Dave Buzan gave a motion to accept the Minutes, which was seconded by Mike Homer. Kevin asked for a vote to which all Members present voted for with none against. Motion was passed and Minutes were approved.

President's Report (Kevin Storey): Kevin reported that various deadlines for the 2016 Annual Meeting in Kerrville were approaching quickly. Kevin noted that Michele Nations is working with charter members and has developed and ordered commemorative pins for the 40th anniversary of TCAFS. Kevin requested that members present encourage other members to assist with finding donations for auction and raffles.

President-Elect's Report (Dave Buzan): Dave reiterated that Jake Norman and Alice Best need help with finding items to auction and for the raffles and that other fundraising ideas are needed. Dave also mentioned that moderators are needed for the meeting sessions; he requested that Aaron Urbanczyk moderate a session. Dave mentioned that the general theme of the upcoming annual meeting will highlight the 40th anniversary of TCAFS and the recognition of the various contributions to fisheries that have been made to fisheries from all career levels of chapter members. Ray Mathews will be the keynote speaker, and he has been preparing for this task since the summer.

Joe Beach posed a question regarding implementing a pay system that would facilitate the Student/ Mentor Luncheon at the 2016 Annual Meeting and suggested the use of Square or PayPal. Dave Buzan would like to speak to the hotel to determine what payment options are available, and he plans to revisit with Joe Beach once he has been in contact with Y.O. Ranch.

SDAFS Officer Update (Craig Bonds): Not present; no report.

Secretary/Treasurer (Michael Homer Jr.): The current balance in the TCAFS checking account was \$17,249.44. The most recent expenses included \$14.88 for shipping Patrick Cooney's TCAFS shirt, and \$150 to the parent society office for chapter insurance. Patsy B. Hollandsworth Family Foundation had made a \$6000 donation, which these funds are currently in the chapter's checking account. Mike Homer encouraged members to encourage others to register for the annual meeting and to make room reservations.

Committee Reports

Awards (Dave Buzan and Michele Nations): Michele has found multiple judges for presentations and awards; however she needs more. She particularly requested help for judging posters.

Continuing Education (Lynn Wright): Two presentations have been confirmed and the presenters are currently developing their talks.

Editorial (Dan Daugherty and Allison Pease): Allison mentioned that the Editorial Committee has uploaded the 2015 Annual Meeting Proceedings to the TCAFS website for viewing. Dan D. is currently working on compiling and reviewing abstracts that are being submitted for the upcoming meeting.

Endowments (Dave Terre): Not present; Mike Homer stated that the most recent Oct 2015 statement balance was \$252,684.11. Dave Buzan was wondering if a goal amount has been established for the chapter's endowment, as well as if scholarships were being funded from principal amounts from the endowment or checking account funds. Mike Homer mentioned he would follow up with Dave Terre to discuss these questions.

History (Michele Nations): Michele has been updating Ray Mathews previously drafted history document by adding new references, more information, and additional photos. Michele has been working on the PowerPoint slideshow for the annual meeting. Michele said she ordered 200 pins for the first members that register for the meeting. She has paid with her personal credit card and requested reimbursement from the chapter. Mike Homer said he will provide the reimbursement once the receipt of the pins has been provided.

Internet (John Taylor and Danny Lewis): Not Present. Michele reported that Danny Lewis has posted the 2015 Annual Meeting Proceedings on the TCAFS website. Danny has worked with Dave Buzan about possibly getting multiple projectors for use at the upcoming annual meeting. Michele also stated that Danny could use additional help with audio/visual duties and requested that anyone interested in volunteering should contact him.

Issues (Niki Ragan and Mark Webb): Not present; no report.

Membership (Debbie Wade): Not present; no report.

Newsletter Editor (Kevin Storey): Kevin has requested that all newsletter submissions be completed by 12/4/2015. Kevin requested that anyone who believes they may have some interesting fisheries-related news or papers submit them to the newsletter.

Nominating (Dan Bennett): Not present. Kevin reported that Dan had found two candidates for president-elect, but one has recently dropped out. Kevin urged that if anyone was interested in running or could nominate a suitable candidate, please notify Dan Bennett.

Pond Management (Greg Binion): Not present: no report.

Publicity/Exhibits (Jake Norman): Not present. Kevin reported that Jake requested help for soliciting donations for the raffles and auction. Dave Buzan mentioned that he will be donating a rifle for the auction; Michele Nations will be donating a painting.

Scholarships (Mike Morgan): Not present; no report.

Student Outreach (Joe Beach): Joe mentioned that TPWD will be offering four internships during summer 2016. Three internships are being supported with funding from the San Antonio Rodeo for students in Bexar County and neighboring counties. The other internship is being supported through the Texas Parks and Wildlife Foundation. Joe mentioned that he has been in contact with faculty from Tarleton State University, and that the department and majors contacting fisheries-relevant courses have changed names. Once the changes are finalized, Joe plans to approach faculty members about potentially starting a student subunit.

The Hutton J.F.B. Program is a paid summer internship and mentoring program for high school juniors and seniors interested in pursuing the disciplines of fisheries science, marine biology, and STEM related fields, and is sponsored by AFS. From the beginning of the program in 2001 to 2015, the program has offered scholarships to 572 Hutton scholars with the help of 270 Mentors in 137 host and financially sponsoring institutions. The mission is to increase diversity within the fisheries professions. The principal goal of the Hutton Program is to stimulate interest in careers in fisheries science and management among groups underrepresented in the fisheries professions, including minorities and women. Selected students known as "Hutton Scholars," are matched and mentored by a fisheries professional to enjoy an 8-week hands-on fisheries science summer experience in a marine and/or freshwater setting.

SEAFWA 2015 fisheries biologist of the year - Brian Van Zee

Brian Van Zee of Waco has been named fisheries biologist of the year by the Southeastern Association of Fish and Wildlife Agencies (SEAFWA).

Van Zee is a fisheries biologist for the Inland Fisheries Division of Texas Parks and Wildlife Department (TPWD) and is headquartered in Waco.

“It gives me great pleasure to present this year’s Fisheries Biologist of the Year Award to Brian Van Zee,” SEAFWA President Bob Ziehmer said. “His contributions to fisheries conservation that began in Texas have led to ripples across the country.”

Van Zee was instrumental in helping TPWD deal with one of the greatest threats Texas fisheries resources have faced, the introduction of invasive zebra mussels to Texas waters.

“Brian developed and fostered more than 40 key partnerships that helped our agency and constituents understand and address this very dynamic and complicated situation,” said TPWD Executive Director Carter Smith, who nominated Van Zee for the award.

Through new relationships with governmental agencies, universities, non-governmental organizations, private industry and the media, Van Zee fostered collaborative information gathering and sharing, training, statewide monitoring, education and awareness, and delivery of two innovative control efforts.

“Brian has been at the forefront of our efforts to contain the rapidly expanding population and to try and keep it from threatening other waters,” Smith said. “Simply put, he has quickly become one of the state’s foremost authorities on how best to contend with this threat to our waters, aquatic habitats, and boating and fishing traditions.”

Van Zee organized innovative treatments on a 30-mile stretch of river and a reservoir marina. He worked with others to develop, fund and execute a public awareness campaign. Because of his efforts, more than 200 people have been trained to inspect boats for the mussels, and boater inspection and statewide monitoring programs have been implemented.

To keep the public informed and engaged in fighting the invasion, he authored more than 50 press releases and gave hundreds of media interviews. Because of his program’s success, Van Zee has given multiple presentations and training courses to different organizations across the country that are also fighting invasive species.

Van Zee is also responsible for coordinating the Texas statewide fish-stocking plan as well as fisheries management and research operations in the central and western portions of Texas. He and his wife Jill have two children, Breeley and Raelynn.

“All of the achievements that were mentioned are the result of not just my efforts but rather those of many great people and team players,” Van Zee said. “I am very blessed to get to work for TPWD and all of the great staff that we have in the agency. That goes for our field staff as well as all of my supervisors and TPWD’s executive

leadership, who trust us and support us in our work. I think the award really says volumes for who we are as an agency.

"I also want to recognize my wife and daughters for always supporting me in my work," he added. "I am truly a lucky man to have such a loving family and I thank God for them and for the blessings that they are."

The Southeastern Association of Fish and Wildlife Agencies (SEAFWA) is an organization whose members are the state agencies with primary responsibility for management and protection of the fish and wildlife resources in 15 states, Puerto Rico and the United States Virgin Islands. Member states are Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, Missouri, North Carolina, Oklahoma, South Carolina, Tennessee, Texas, Virginia, and West Virginia.

Van Zee was TCAFS President in 2010.

History of the TCAFS Skeg and other memorable historical items

The history of the now-famous Chapter Skeg began in 1990 when Bobby Farquhar, then TCAFS President, won it in a raffle at the annual meeting held next to Lake Texoma and used it the next morning to bring the business meeting to order as a sort of gavel. From that moment on it was passed down from Chapter President to President at the business meeting—a tradition that has continued for 15 years. Gene McCarty was the recipient of the skeg from Bobby and so on down the line of presidents over the years. According to Bobby, back in those days the raffle was a "junk raffle" and any little item, like the skeg or some fishing hooks, sinkers, box of earth worms, etc., were what you got. The Chapter has certainly come a long way since then. We now have great raffle and auction items, and not surprisingly, we have a lot more funds for student scholarships these days. The first skeg was actually not from a boat but rather from an old water ski. A skeg is the fin on the bottom of a boat or ski that gives it stability as it moves through the water. A skag is the removable metal piece that fits through the bottom of a sail boat, serving the same purpose as a skeg. The two are often confused.

One other point about the history of the Chapter Skeg is that it has been lost innumerable times in the 15-year tradition. President Katherine Ramos left it on the podium at the Tanglewood Resort in Pottsboro, Texas, at Lake Texoma in 1996, and despite attempts to locate it the skeg was never found. Another one was made by a fisheries technician, Lynn Sloan, at the Lake Texoma field station from the lower unit of an outboard motor. That Skeg lasted a few years until Paul Hammerschmidt could not find it to give to Charlie Munger in 2000. Charlie had a new skeg made in 2001 out of scrap iron left over from a wrecked boat, which was shaped with a grinder. Charlie gave that one to Gordon Linam at the Chapter's Silver Anniversary in San Marcos, Texas, at Aquarena Springs. That skeg has lasted for a few years and was passed from Fran Gelwick to Dave Terre at the last annual meeting in 2005 (see picture). So, it must be said that Chapter presidents are very innovative in getting new ones made. Perhaps that is one reason they are Chapter presidents, because of their innovation. While researching this story, I came across several other historical items of interest in Chapter history.

- Katherine Ramos had the longest presidency in the history of the organization, 18 months, from September 1997 to January 1999, due to a change in the date of the annual meeting.
- Members decided to raffle Bruce Hysmith's shirt at one of the earlier meetings when items were in short supply, which he had to take off at the meeting.
- The Abilene annual meeting in 1988 was the worst attended of the decade, and casino chips were used for the raffle drawing.
- The annual meeting in Austin in 1994 had the most memorable raffle with a "Bait-a-Hole" contest held at Lago Vista on Lake Travis. Joedy Gray, with TPWD (Austin Inland Fisheries Office) was heavily involved in the contest organization. "Bait-a-Hole" was a package of bait that was supposed to attract catfish to a fishing hole. Every time someone would win the bid for it, they would donate it back to the auction again. There were many packages that were bought and sold several times. These inexpensive little items made a lot of money for the scholarship fund.
- Bob Edwards was requested to write a paper for the 1979 annual meeting's Texas Chapter proceedings, which was turned down by the editorial committee because they said it was written at the 12th grade level but was later accepted for publication in the *Transactions of the American Fisheries Society*.

Some really strange things have happened in the Texas Chapter, and I just wanted to pass some of them along to you. More stories came based on you telling me what you experience in the past. Let's share them with the membership.

SARA student Intern job announcement



The San Antonio River Authority (SARA) will be posting a position in January 2016 for a paid intern in its Environmental Sciences Department (ESD). The “Michael Gonzales Memorial Internship”, will be open to all eligible non-graduate student members of the Texas Chapter of the American

Fisheries Society. The Internship was established in 2012 to honor Michael Gonzales, former Deputy Director of Technical Services at the San Antonio River Authority. The internship opportunity is awarded to a highly motivated outstanding undergraduate student of a Texas institute of higher education. This internship is designed to provide an individual interested in Biology, Chemistry, Geology, other Natural or Environmental Science an opportunity to intern with the San Antonio River Authority Environmental Sciences Department in San Antonio, Texas.

Essential Duties and Responsibilities

Assists in the collection and preservation of biological, water and waste water samples

- Assists with the calibration, operation and maintenance of ESD field instruments
- Makes unbiased observations of aquatic and riparian conditions
- Helps review field data forms for completeness

Other Responsibilities

- Intern will be instructed in sample and laboratory QA/QC procedures as well as Data Management practices
- Performs other tasks as assigned

Education, Experience and Skills Required

- Must be an undergraduate at an accredited college or university with a minimum 3.0 grade point average
- Must be a current member of the Texas Chapter of the American Fisheries Society
- Must be well organized and able to manage time efficiently
- Must be competent in Microsoft Word and Excel
- Must be able to communicate clearly and concisely
- Must be able to establish and maintain cooperative working relationships with the general public and fellow employees
- Ability to swim preferred

Working Conditions

Interns are asked to commit to 40 hours per week. Work days are primarily Monday through Thursday (10 hour/ day) but will vary occasionally with weather and “Other Responsibilities”. The internship will be over a 13 week period running from mid-May to mid-August 2016.

Work will be outdoors the majority of the time, sometimes in adverse weather, and the intern may be exposed to such typical hazards of outdoor work as poison ivy, wasps, snakes, and other natural and mechanical hazards. May be exposed to hazardous chemicals and disease causing agents.

Regularly wades into water bodies to gather samples, collect data, measure flows and record information.

Operates potentially hazardous equipment such as electro-shockers, power boats, generators and winches.

Regularly and safely lifts, carries, and handles supplies and equipment weighing at least forty (40) pounds.

Must be able to perform in a small but highly professional team oriented environment.

Must be able to function in a principle based organization that has a culture built on character and SARA Core Values of Stewardship, Integrity, and Excellence.

Requirements

Candidates for this internship must meet the following qualifications:

- Enrolled at an accredited college or university
- Minimum 3.0 grade point average
- Provide transcripts
- Member of the Texas Chapter of the American Fisheries Society

40-Years of memories and commemorative pins to celebrate them

When we had our EXCOM meeting in Kerrville, Michael Homer had a good idea of how to help attendees remember the 40-year anniversary – a commemorative TCAFS 40-year pin. The first 200 people who register for the meeting will receive this special token. It can be proudly worn on your cap, lapel, pocket, or scarf.

Oops! I'd better go turn in my registration and get the early bird rate and a pin!

The Texas Chapter is celebrating 40 years of being a part of the American Fisheries Society, and it has been a great 40 years: from the first organizational meeting in 1975 on the TAMU campus and being accepted by the parent society in 1976 to the present. Those who attend the Kerrville meeting in January will be surrounded by TCAFS and fisheries history. Several of us have been involved in bringing it all together, and we've had a good time reminiscing, looking for photos and asking "Do you remember when . . . ?" At Bruce Hysmith's retirement party, I challenged people to send me photos of equipment that was used in the early days. Today is Tomorrow's Yesterday! Capturing Today for Those Who Come Tomorrow!

Tim's name appeared again in 2001 when he received the Outstanding Fisheries Student award. Gene Wilde was his PhD advisor. In 2004, his dedication to and love for his students and fisheries were made evident when he received the award for Outstanding Fisheries Worker of the Year in Fisheries Education as the youngest person to receive the award in TCAFS history. Tim is following in the footsteps of such renowned education award winners as Clark Hubbs (UT, 1978), Richard Noble (TAMU, 1979), and his predecessor, Bobby Whiteside (SWTSU/TX State, 1981). I believe that is why presenting awards to outstanding fisheries workers and capturing them in our history is so important – I'm capturing footsteps.

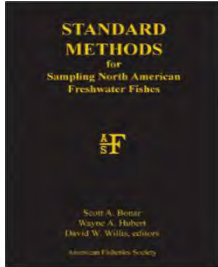

❖ Web-based comparison tool for freshwater fish data



In 2009, “Standard Methods for Sampling North American Freshwater Fishes” (Scott A. Bonar, Wayne A. Hubert, and David W. Willis, editors, ISBN: 978-1-934874-10-3) was published as a reference book to describe standard methods recommended by AFS for assessing and monitoring freshwater fish populations in North America. Authors, reviewers, and sponsors contributing to the book included 284 biologists and managers from 107 agencies, universities, and businesses throughout the United States, Canada, and Mexico. This reference forms the framework of a new web-based tool that allows fisheries workers to upload data they collect using these standard methods and generate individual fish condition, population length-frequency distributions, and catch per unit

effort (CPUE) data. These data can be compared with continent, ecoregion and state data summaries. The web tool was programmed in a PHP-based Drupal framework and was supported by several AFS Sections, agencies, and universities. The system is described in an article in the December 2015 issue of Fisheries Magazine (Vol. 40, No. 12) entitled “A Simple Web-Based Tool to Compare Freshwater Fish Data Collected Using AFS Standard Methods” by Scott A. Bonar, Norman Mercado-Silva, Matt Rahr, Yuta T. Torrey, and Averill Cate, Jr. (pp 580-589). The tool also provides information on ongoing validation studies of standard methods and fisheries scientists can leave comments on specific methods which can be incorporated into future revisions.
