Governor Abbott Appoints Four To Texas Commission On Law Enforcement



Governor Greg Abbott has appointed Conor Harvey and Justin West and reappointed Janna Atkins to the Texas Commission on Law Enforcement (TCOLE) for terms set to expire on August 30, 2029. Additionally, Governor Abbott appointed Justin Berry to the Commission for a term set to expire on August 30, 2027. The Commission establishes and enforces standards to ensure that the people of Texas are served by highly trained and ethical law enforcement, corrections, and telecommunications personnel.



Conor Harvey of Houston is an attorney at Murphy Ball Stratton LLP, where his practice includes civil and white collar litigation and appeals. He is a member of the State Bar of Texas, The Federalist Society, and the bars of the U.S. Court of Appeals for the Fifth Circuit and the U.S. District Courts for the Northern, Southern, and Eastern Districts of Texas. Previously, he clerked for Justice Jimmy Blacklock of the Supreme Court of Texas and served as Chief Law Clerk to Judge Matthew Kacsmaryk of the U.S. District Court for the Northern District of Texas. Harvey received a Bachelor of Public Administration from The University of Texas at San Antonio and a Juris Doctor from the University of Chicago Law School.



Justin West of League City is the constable of Precinct 4 in Galveston County. He is a member of the Combined Law Enforcement Associations of Texas (CLEAT), National Constables and Marshals Association, and the Justices of the Peace and Constables Association of Texas. Additionally, he is a member of the League City Lions Club and a Zone Chair for the Lions Club District. He is a former board member for the Bay Area Council on Drugs & Alcohol and the Refuge for Women Texas Gulf Coast. West received a degree in Information Technology and Security from Western Governors University.



Janna Atkins of Abilene is the criminal justice manager and training coordinator for the West Central Texas Regional Law Enforcement Academy / West Central Texas Council of Governments. She has 38 years of experience as a Texas peace officer working for the Abilene Police Department and the Taylor County Sheriff's Office, 26 of those years has been in the field of law enforcement training. She is a member of the International Association of Chiefs of Police, instructor for the National Safety Council, a Sexual Assault Family Violence Investigators Course instructor for the Texas Municipal Police Association, committee co-chair for Champion for Children, and a former member of the Abilene Police Officers Association. Additionally, she has served as a board member for the Lutheran Women's Missionary League and Vice President of Fundraisers for the Aggie Moms' Club - Abilene Chapter.



Justin Berry of Austin is a senior police officer for the Austin Police Department, with over 16 years of experience. He currently holds a Texas Master Peace Officer License, CIT certification, and Instructor Proficiency certification with TCOLE. He has earned numerous awards, medals, and commendations including the Austin Police Department Honorable Conduct Medal, the Austin Police Department Meritorious Service Medal, CLEAT's Distinguished Spirt of Leadership Award, Austin Cops for Charities Distinguished Civic Leadership Award, a U.S. Senate Certificate of Commendation, a Certificate of Special Congressional Recognition, The 100 Club of Central Texas Outstanding Team of the Year award, and The 100 Club of Central Texas Outstanding Officer of the Year award. SUMMARY OF PROPOSED MODEL POLICIES

Pursuant to Texas Occupations Code §§1701.167, 1701.4522, and 1701.4535 as added by Senate Bill 1445 (88R), the Texas Commission on Law Enforcement (Commission) is proposing model policies regarding Misconduct Allegations, Hiring Procedures, Personnel Files, and the Medical and Psychological Examination of a Licensee. These proposed model policies were developed with input from advisory committees.

The Misconduct Investigation, Hiring Procedures, and Personnel Files Advisory Committee was charged under Texas Occupations Code §§1701.4522 and 1701.4535 with developing model policies establishing procedures applicable to a law enforcement agency investigating alleged misconduct by a license holder employed by the agency, hiring a license holder, and maintaining personnel files with respect to a license holder.

The Examination of a Licensee Advisory Committee was charged under Texas Occupations Code §1701.167 with developing a model policy prescribing standards and procedures for the medical and psychological examination of new licensees, existing licensees, and licensees whose employing agency has reason to believe that a new examination is necessary (fitness-for-duty examination) to ensure the individuals are able to perform the duties for which the license is required.

Each law enforcement agency in Texas will be required to adopt and submit to the Commission these proposed model policies, or a substantively similar policy.

SUMMARY OF PROPOSED TCOLE RULES

37 Tex. Admin. Code § 211.1. Definitions. This proposed amendment would add four definitions and add language to one definition for terms used in the proposed amendment to 37 Tex. Admin. Code § 211.16.

37 Tex. Admin. Code § 211.16. Establishment or Continued Operation of an Appointing Entity. This proposed amendment was developed with input from an advisory committee and would outline the minimum standards for the creation or continued operation of a law enforcement agency.

37 Tex. Admin. Code § 217.9. Refusal by Licensee to Submit to Medical or Psychological Examination. This proposed new rule would outline the process for determining whether a licensee had good cause to refuse to submit to a requested medical or psychological examination following submission of a refusal report from a law enforcement agency to TCOLE.

37 *Tex. Admin. Code § 227.1. Appointing Entity Responsibilities.* This proposed amendment would clarify reporting requirements for school marshal appointing entities by requiring reports to be submitted by an appointing entity to the Commission that a school marshal may no longer be psychologically fit to carry out the duties of a school marshal.

37 Tex. Admin. Code § 227.4. Demonstration of Psychological Fitness. This proposed new rule would outline the requirements and processes for the psychological examination of school marshals.

37 Tex. Admin. Code § 227.6. Fit for Duty Review. This proposed new rule would outline the requirements and processes for the fit for duty review of school marshals.

CHANGES TO THE F5 IN TCLEDDS

In response to Senate Bill 1445 passed by the 88th Texas Legislature, "separation reasons", including "honorable, general, dishonorable", will no longer be collected for separations of a license holder that occur on or after March 1, 2024.

Senate Bill 1445 repealed sections (b) and (c) of Occupations Code §1701.452 (per section 22 of SB 1445), for separations that occur on or after March 1, 2024 (per section 26 of SB 1445).

This means if the separation date is before March 1st, the "separation reason" (honorable, general, dishonorable) will remain on the page, and the process will continue to work as it had previously. The printable version of the F5 will display the "separation reason" selected.

If the separation date is on or after March 1st, the "separation reason" will gray out/prevent a selection and a message will appear that says "TCOLE no longer records separation reasons after 3/1/2024". The printable version of the F5 will also change (see figures below)

The change is dependent on the separation date the agency enters on the F5, not the date the F5 is created.

CHANGES TO THE F5 IN TCLEDDS

Legislatively Mandated Training PEACE OFFICERS

Training Cycle: 09/01/2021 – 08/31/2025 The 1st Training Unit: 09/01/2021 – 08/31/2023 COMPLETED The 2nd Training Unit: 09/01/2023 – 08/31/2025

Licensed Peace Officer:

4-year Training Cycle: (9/1/21-8/31/25):

If you do not have an Intermediate Proficiency Certificate or higher, the following will be required for completion:

- Crisis Intervention Training (#3843 or #1850)
- Cultural Diversity (#3939 or #394)
- De-escalation Techniques (#1849)
- Special Investigative Topics (#3232)

Second 2-year Training Unit: (9/1/23-8/31/25):

A minimum of 40 hours of training to include:

- Legislative Update course (#3188)
- 16 hours of ALERRT training (see next page)
- Finding Wellness Building a Healthier Life (course #4202) in-person or on MyTCOLE 3.0.
- Trauma-Informed Approach to Sexual Assault Investigations (MyTCOLE 3.0 online course #470 or in-person training course #4070), if not completed in the 9/1/21-8/31/23 unit. An equivalent to this course will be #3264 Special Investigator Certification.

Deputy Constables:

In addition to the aforementioned "Licensed Peace Officer" requirements, Civil Process (#3131) must be completed in the 4-year training cycle.

The passage of Senate Bill 1852 requires **all peace officers to attend ALERRT Level 1 training at least once prior to 8/31/2027**. Courses which will satisfy this requirement include #3311, #3313, and train-the-trainer #3315. This new law also requires that every peace officer attain 16 hours of ALERRT training every two years going forward.

Peace officers who have previously completed course #3311, #3313, or #3315 and have at least one of these courses documented one their TCOLE training record do not need to repeat ALERRT Level 1 training; however, they must take at least 16 hours of ALERRT training during this 2-year training unit before 8/31/2025. Courses which will satisfy the 16-hour requirement are included in the approved list below.

Peace officers who do NOT have course #3311, #3313, or #3315 documented on their TCOLE training record are encouraged to complete course #3311 during this current training unit prior to 8/31/2025 as their 16-hour continuing education requirement if at all possible. If not completed during this training unit, they MUST have completed #3311 prior to 8/31/2027 in accordance with Senate Bill 1852.


