# Four Board Members Appointed to Board of Nurse Examiners by Governor Perry

Governor Rick Perry selected four new Board members to fill positions vacated by outgoing Board members: Nancy Boston; Mary Letrice Brown, RN; John Fonteno; and Kenneth Lowrance, MS, RN, CS, FNP-C. Nancy Boston and Kenneth Lowrance began their six-year terms in 1995 and Mary Letrice Brown began her term in 1996. John Fonteno was appointed in 1997 but recently resigned from the Board for health reasons. The new Board members are: Virginia Milam Campbell, a perioperative nurse at Texas Scottish Rite Hospital for Children in Dallas, representing Nursing Practice; Lawrence Canfield, a certified registered nurse anesthetist at Scott & White Hospital in Temple, representing Nursing Practice; Deborah Bell, a consumer member from Abilene; and Phyllis Caves Rawley, a consumer member from El Paso.

### The Role of Board Members

The Board of Nurse Examiners is responsible for promulgating rules and regulations, making disciplinary decisions and setting policies which guide the agency in carrying out the mission of the Board: Protection of the Public. The Board consists of nine members. They volunteer their time to serve the Board, travel to Board meetings, informal disciplinary conferences, and eligibility and disciplinary committees. This service reflects their dedication and commitment to the regulation and safe practice of professional nursing.

## Online Renewal Program to be Launched this Fall

Coming this Fall, Registered Nurses and Advanced Practice Nurses will be able to renew their license via the Internet. Once the program is implemented, notification of the option along with detailed instructions will be included in the renewal packet. The online renewal system will be accessible via the BNE website and will validate the RN's identity and renewal eligibility. If you have complied with all state statutes and BNE rules, the system will accept your online renewals within your 60-day renewal period. Licensees can only renew online during the 60-day period. After completion of the online renewal process, the licensee will be able to

print a confirmation page for validation of payment. This process eliminates the delay imposed in mailing the renewal and provides for the convenience of credit card payment for a small convenience fee. Upon receipt of the renewal information and validation of payment, a renewed license will be mailed within 10 working days. This is a major step toward customer convenience and using automation to streamline agency operations. The Board of Nurse Examiners is continuing to strive to provide all customers access to agency services in the most efficient and expeditious manner.

### Board of Nurse Examiners and Texas Nurses Association Conclude Town Hall Meetings

The BNE and the Texas Nurses Association (TNA) recently conducted four Town Hall Meetings in Corpus Christi (May 7, 2001), Houston (May 10, 2001), Lubbock (May 14, 2001), and Arlington (May 15, 2001). These meetings were held to provide registered nurses an opportunity to speak directly to the Board and TNA about issues and concerns

affecting nursing practice. I represented the Board and Clair Jordan, Executive Director of Texas Nurses Association, represented TNA. We stressed the differences in the roles of the professional association which represents the interests of nurses, and the Board which represent the interests of the public.

More than 180 nurses took time out of their busy schedules to share their experiences and concerns. Several workplace issues were raised, including mandatory overtime, short staffing, salary compression over the career, and a concern that nurses are under appreciated in health care delivery systems. It was clear that the nursing shortage is underscoring these problems since nurses relayed that they are expected to do more patient care with less assistance. Several regulatory issues were discussed.

**Minor Incident Rules**. A participant expressed concern that hospitals are reporting three minor incidents in a year to the Board because they believe that is required. Rule 217.16(d)(4) requires that "the nurse's manager shall report an RN to the Peer Review Committee if three minor incidents involving the RN are documented within a one year period." The Peer Review Committee is then responsible for reviewing the three minor incidents and determining whether a report to the Board is warranted.

**Safe Harbor.** Several participants asked about the safe harbor provisions of the Nursing Practice Act. Based on telephone calls received by the Board office, BNE staff have observed an increase in the incidence of nurses invoking safe harbor but many still do not understand the process. Safe Harbor provides protection for nurses who have been asked to engage in conduct which the nurse in good faith believes would violate the nurse's duty to a patient. Protection for nurses is available only when the nurse's duty is thought to be violated according to the statutory definition:

"Duty to a patient" means conduct, including administrative decisions directly affecting a registered nurse's ability to comply with that duty, required by standards of practice or professional conduct adopted by the Board [Nursing Practice Act, Section 303.005(a).]

Clair Jordan informed participants that TNA has an online continuing education program on Safe Harbor Peer Review which can be found on the TNA web site at <a href="https://www.texasnurses.org">www.texasnurses.org</a>.

**Patient Abandonment.** Several participants raised the question of what constitutes patient abandonment. In today's climate of the nursing shortage and short staffing, some nurses believe that they may not leave their assignment under any circumstance. The Board recognizes that nurses may have to leave their assignment for a variety of legitimate reasons, including personal and family emergencies. "Leaving a nursing assignment without notifying one's appropriate supervisor" is unprofessional conduct according to Rule 217.12(14).

## **Proposed and Adopted Rules**



At the April 2001 meeting of the Board of Nurse Examiners, members voted to propose the repeal of the current version of Rule §219 <u>Advanced Practice Nursing Programs</u> and authorized staff to publish proposed Rule §219 in the *Texas Register*. The proposed rule was in the June 15, 2001 issue of the *Texas Register* with a comment period of 30 days.

# Idaho, Maine & Mississippi Begin Implementation of Compact July 1; Compact Legislation Introduced in Georgia, Illinois, and New Jersey

Effective July 1, 2001, three more states, Idaho, Maine, and Mississippi, begin implementation of the multistate licensure compact. The 13 states where nurses can practice under multistate privilege are: Arkansas, Delaware, Idaho, Iowa, Maine, Maryland, Mississippi, Nebraska, North Carolina, South Dakota, Texas, Utah and Wisconsin. HB 968, Georgia's Compact Bill, was introduced in the Georgia Legislature on March 22, 2001. If enacted, Georgia's Compact Bill will take effect on January 1, 2003. HB 2400, Illinois's Compact Bill, was introduced in the Illinois Legislature on February 23, 2001 and is currently in the Illinois Senate. If enacted, the bill will take effect on January 1, 2002. HB 3302, New Jersey's Compact Bill, was introduced on March 22, 2001. If enacted, the bill will take effect January 1, 2002. Arizona's Compact Bill, SB 1321, was signed by Governor Jane Dee Hull on April 12, 2001 and takes effect July 1, 2002. ## BNE Studies Legislation Enacted By 77th Texas Legislative Session

The Board of Nurse Examiners is currently reviewing legislation enacted during the 77th Texas Legislative Session which concluded May 28, 2001. Governor Rick Perry finished signing/vetoing bills on June 17. Bills impacting registered nurses in Texas will be discussed in detail in the October edition of *RN Update*.

## **Limited Prescriptive Authority and Site Eligibility**

In the April 2001 edition of the *RN Update*, there was an announcement that the BNE would no longer be performing site approvals for advanced practice nurses with limited prescriptive authority (LPA). As a result of this announcement, staff have received numerous requests for information on how to determine site eligibility, especially in medically underserved areas. This article is intended to assist advanced practice nurses in making LPA site eligibility determinations. It is important to note that, although the BNE is no longer performing site approvals, the advanced practice nurse is still responsible for only utilizing limited prescriptive authority in a qualified site.

The Legislature defined the different types of sites at which an advanced practice nurse may utilize limited prescriptive authority in the Medical Practice Act (*Texas Occupations Code*, §§157.052 - 157.054). The definitions for each of these types of sites are also reflected in BNE Rule §222.1. Sites classified as physician's primary practice sites or facility-based sites must meet the requirements as outlined in the definitions. It is important to note that several different types of sites qualify as physician's primary practice sites.

The process for determining eligibility for medically underserved sites can be more confusing and may require additional resources. The advanced practice nurse must first determine how his/her site qualifies as medically underserved (refer to Rule §222.1). The Health Professions Resource Center (a part of the Texas Department of Health) is an important resource for advanced practice nurses in medically underserved areas. This agency can be accessed via the Texas Department of Health's web site at <a href="https://www.tdh.state.tx.us">www.tdh.state.tx.us</a>. They have provided lists of full and partial counties designated as health professions shortage areas (HPSAs) or medically underserved areas (MUAs) that are immediately available on their web site. Their staff can also assist individuals in determining whether their site has been designated as a specific site serving medically underserved populations (MUPs). Many times, the advanced practice nurse needs to know the census tract in which his/her practice is located to determine if the practice site is located in a portion of a county that holds a medically underserved designation. Two web sites that can be utilized to determine the census tract are: <a href="https://www.geocode.com">www.geocode.com</a> and <a href="https://www.geocode.com">www.ffiec.gov</a>.

Another list that may be accessed via the Texas Department of Health's web site is the list of family planning clinics. The list is arranged by county, and the advanced practice nurse only needs to know the zip code of the practice site to utilize the family planning clinic locator to determine if his/her practice site qualifies in this category.

It is **very important** that advanced practice nurses in these settings check the status of their practice sites on a routine basis to determine that the sites still qualify as medically underserved. These designations are subject to change. For example, an advanced practice nurse has been signing prescription drug orders in a site located in County "A", a county that held a designation as a full county HPSA. On January 1, 2001, County "A's" designation as a HPSA was withdrawn. If the practice site meets the criteria for qualification as an eligible site in another category (such as a physician's primary practice site or MUA) then the advanced practice nurse may continue to utilize limited prescriptive authority in that site. If, however, the site does not qualify as eligible in any other manner, then the advanced practice nurse may no longer utilize his/her limited prescriptive authority at that location.

For specific site-based requirements for advanced practice nurses utilizing limited prescriptive authority, refer to Rule §222, relating to advanced practice nurses with limited prescriptive authority. ### **APNAC Reviews Guidelines**

The APN advisory committee (APNAC) met on April 25, 2001 in Austin. The committee began work on their new charge to review the recently revised Rules §§221 and 222 and make recommendations for development of new policies/guidelines necessitated by the rule revisions. Specific discussions focused on the development of guidelines for sponsored practice for a graduate advanced practice nurse who was unsuccessful on his/her first certification examination attempt. The committee meets again on June 27, 2001.

# BNE Investigators Attend Summit

Three staff members from the Department of Enforcement of the Board of Nurse Examiners attended the National Council of State Boards of Nursing Investigators Summit in Chicago, Illinois on June 22-23, 2001. Anthony L. Diggs, Director of Enforcement, served on the planning advisory panel for the Summit, and Cynthia Smith and Jeanne Jacobson attended as well as presented cases on different topics to the group. Approximately one-hundred (100) investigators and fact-finders from numerous states attended.

The purpose of the Summit was to enhance the skills and training of individuals involved in fact finding for Board of Nursing investigators. The topics covered by speakers included patient and elderly abuse and neglect, investigations in community settings, sexual misconduct investigations, and the investigatory implications for alternative discipline for In addition, there were practice cases. numerous networking opportunities for the investigators during the one and one-half day Summit. Cynthia Smith, Investigator for the BNE for thirteen (13) years, presented a discussion on an elderly abuse case. Jeanne Jacobson, Senior Investigator, presented a discussion on a hospice case and the implications of the setting for the investigator.

As more states become members of the multistate compact, the staff of the Department of Enforcement will have more contact with investigators in other states. The Summit was an opportunity to share ideas, strengthen skills, and identify the new challenges the Enforcement staff will encounter through the growth of the multistate compact.



### Q: Can RNs Do "Physicals"?

A: Nurses in a variety of practice settings involving both pediatric and adult clients contact the BNE regarding this very broad question. The Nursing Practice Act(NPA), Section 301.002(2) and Board Rule 217.11(1), (2), and (21) all apply to this question. According to the NPA and Board Rules, the RN may collect data regarding the health status of clients through a variety of mechanisms including history taking and physical assessment. However, the scope of such assessment must always be based on the RN's educational preparation and clinical experience. This data may then be passed on to a physician to apply as he/she deems appropriate in the medical diagnosis and medical management of the patient. RNs are prohibited from engaging in "...Acts of medical diagnosis or prescription of therapeutic or corrective measures" [NPA, §301.002(2)]. RNs with advanced practice authorization through the Board may engage in certain "medical aspects of care" within the advanced specialty and role appropriate to the APN's advanced educational preparation as described in Rule 221.

Not all settings or situations require a medical diagnosis (determined by a physician) as an outcome of a "physical assessment". As with any area of practice, the RN must be knowledgeable regarding additional regulations set forth by other governing entities which may impact the practice of nursing in that setting. When in doubt if an activity is within the scope of the RN, the BNE's "Six Step Decision Making Model for Determining the RN Scope of Practice" is one resource available to aid the RN in making his/her "professional judgment." This information, along with the NPA and Board Rules, is available on the BNE web site.

Denise Parker's license to practice professional nursing in the State of Texas was revoked by the Board of Nurse Examiners on June 6, 1999. Ms. Parker was employed as a Community Health Registered Nurse with a home health agency at the time of the license revocation. Ms. Parker continued to practice as a registered nurse with the home health agency as a Performance Improvement Nurse until February 27, 2001, when the corporate office discovered that her license was revoked. Ms. Parker was terminated from employment on February 27, 2001. The case against Ms. Parker has been referred to the Travis County District Attorney's office.

The case against Ms. Carnes has been referred to the Houston Police Department, Major Offender's Division.

Gigi L. Smeltzer applied for a position as a registered nurse with a hospital in the Dallas/Fort Worth, Texas area. The facility contacted the Board office in an attempt to verify licensure and they were informed that Ms. Smeltzer was not licensed to practice in the State of Texas, therefore Ms. Smeltzer was not hired as a registered nurse. The case against Ms. Smeltzer has been referred to the Dallas County District Attorney's office.



#### TAUQUEER AHMAD

Tauqueer Ahmad was employed as a registered nurse and signed RN after his name while employed with a Home Health Agency in Houston, Texas, during July 1999 and August 1999. The agency hired consultants to audit personnel records. The consultants contacted the Board and they were unable to verify Mr. Ahmad's licensure. Mr. Ahmad was no longer employed with the agency at the time of the audit and he refused to submit verification of licensure. The case against Mr. Ahmad has been referred to the Houston Police Department, Major Offender's Division.
