#### How to Use the Texas Register

Information Available: The 10 sections of the *Texas Register* represent various facets of state government. Documents contained within them include:

Governor - Appointments, executive orders, and proclamations.

Attorney General - summaries of requests for opinions, opinions, and open records decisions.

Secretary of State - opinions based on the election laws.

Texas Ethics Commission - summaries of requests for opinions and opinions.

Emergency Rules- sections adopted by state agencies on an emergency basis.

Proposed Rules - sections proposed for adoption.

Withdrawn Rules - sections withdrawn by state agencies from consideration for adoption, or automatically withdrawn by the Texas Register six months after the proposal publication date.

Adopted Rules - sections adopted following a 30-day public comment period.

Open Meetings - notices of open meetings.

In Addition - miscellaneous information required to be published by statute or provided as a public service.

Specific explanation on the contents of each section can be found on the beginning page of the section. The division also publishes cumulative quarterly and annual indexes to aid in researching material published.

How to Cite: Material published in the Texas Register is referenced by citing the volume in which the document appears, the words "TexReg" and the beginning page number on which that document was published. For example, a document published on page 2402 of Volume 19 (1994) is cited as follows: 19 TexReg 2402.

In order that readers may cite material more easily, page numbers are now written as citations. Example: on page 2 in the lower-left hand corner of the page, would be written "19 TexReg 2 issue date," while on the opposite page, page 3, in the lower right-hand corner, would be written "issue date 19 TexReg 3."

How to Research: The public is invited to research rules and information of interest between 8 a.m. and 5 p.m. weekdays at the Texas Register office, Room 245, James Earl Rudder Building, 1019 Brazos, Austin. Material can be found using Texas Register indexes, the Texas Administrative Code, section numbers, or TRD number.

### Texas Administrative Code

The Texas Administrative Code (TAC) is the official compilation of all final state agency rules published in the Texas Register. Following its effective date, a rule is entered into the Texas Administrative Code. Emergency rules, which may be adopted by an agency on an interim basis, are not codified within the TAC. West Publishing Company, the official publisher of the TAC, releases cumulative supplements to each printed volume of the TAC twice each year.

The TAC volumes are arranged into Titles (using

Arabic numerals) and Parts (using Roman numerals). The Titles are broad subject categories into which the agencies are grouped as a matter of convenience. Each Part represents an individual state agency. The Official TAC also is available on WESTLAW, West's computerized legal research service, in the TX-ADC database.

How to Cite: Under the TAC scheme, each section is designated by a TAC number. For example in the citation 1 TAC §27.15:

1 indicates the title under which the agency appears in the Texas Administrative Code; TAC stands for the Texas Administrative Code; §27.15 is the section number of the rule (27 indicates that the section is under Chapter 27 of Title 1; 15 represents the individual section within the chapter).

How to update: To find out if a rule has changed since the publication of the current supplement to the Texas Administrative Code, please look at the Table of TAC Titles Affected. The table is published cumulatively in the blue-cover quarterly indexes to the Texas Register (January 21, April 15, July 12, and October 11, 1994). In its second issue each month the Texas Register contains a cumulative Table of TAC Titles Affected for the preceding month. If a rule has changed during the time period covered by the table, the rule's TAC number will be printed with one or more Texas Register page numbers, as shown in the following example.

















# RULES

An agency may adopt a new or amended section or repeal an existing section on an emergency basis if it determines that such action is necessary for the public health, safety, or welfare of this state. The section may become effective immediately upon filing with the **Texas Register**, or on a stated date less than 20 days after filing and remaining in effect no more than 120 days. The emergency action is renewable once for no more than 60 additional days.

Chapter 57. Fisheries

Emergency Shrimp Season Closure

• 31 TAC §57.352

The Texas Parks and Wildlife Department adopts on an emergency basis new §57 352, concerning provisions for an early opening of the shrimping season in Gulf (outside) waters of the Texas territorial sea (nine nautical miles) Based on sound biological data, the executive director has determined that migration of small brown shrimp from the bays to the Gulf of Mexico will occur earlier than the

May 15 regulatory closure date. The emergency rule is adopted to adjust the July 15 opening date to July 12, providing for a maximum closure of 60 days.

The purpose of the closed Gulf season is to protect brown shrimp dure; their major period of emigration from the mays to the Gulf of Mexico until they reach a larger, more valuable size before harvest and to prevent waste caused by the discarding of smaller individuals. The executive director found imminent peril to the public welfare which required the closing date be moved forward to Mil 13, 1994. This emergency measure minimulus social and economic hardship in a depressed industry by closing the season two days earlier than scheduled. Early closure is also intended to obtain optimum yield from the shrimp resource.

The new section is adopted on an emergency basis under the authority of the Texas Parks and Wildlife Code, §77 062 In April 1978, the Texas Parks and Wildlife Commission dele-

gated to the executive director the duties and responsibilities of opening and closing the shrimping season under this section

\$57.352 Farly Closure of the Gulf Shrumping Season The 1994 general closed season for shrimp as defined in the Texas Parks and Wildlife Code, \$77.061(a)(1), extends from 30 minutes after sunset May 13, 1994 to 30 minutes after sunset July 12, 1994



# Rules———

Before an agency may permanently adopt a new or amended section or repeal an existing section, a proposal detailing the action must be published in the **Texas Register** at least 30 days before action is taken. The 30-day time period gives interested persons an opportunity to review and make oral or written comments on the section. Also, in the case of substantive action, a public hearing must be granted if requested by at least 25 persons, a governmental subdivision or agency, or an association having at least 25 members.

Part IV. Texas Antiquities Committee

Chapter 41. Practice and Procedure

### • 13 TAC §41.20

The Texas Antiquities Committee (committee) proposes an amendment to §41.20, concerning Archeological Permit Categories The amendment is needed to add other permit categories that allow for greater flexibility in mitigation alternatives designing archeological investigations under antiquities permits issued by the Committee. The current permit categories allow data recovery as the only mitigation option. Experience by the committee staff has demonstrated that other mitigation options, such as site monitoring or historical documentation, are warranted in certain instances to insure that the type of mitigation is appropriate

Dr James E Bruseth, deputy state historic preservation officer, has determined that for the first five-year period the rule is in effect there will be no fiscal implications for state or local government as a result of enforcing or administering the rule

Dr. Bruseth also has determined that for each year of the first five-year period the rule is in effect, the public benefit anticipated as a result of administering the rule will be that more options will be available for state agencies and political subdivisions undertakınd archeological mitigation. The expansion of the number of permit categories allows for the consideration of a range of reasonable mitigation options, as well as possible decreases in construction project costs depending upon the form of archeological mitigation chosen by agencies and political subdivisions in consultation with the committee. There will be no effect on small businesses. There is no anticipated economic cost to persons who are required to comply with the rule as proposed

\$41 20 Archeological Permit Categories Several categories or permits oriented toward specific types of investigation are issued by the Antiquities Committee

- (1) Reconnaissance survey This permit category is [These permits are designed] for the purpose of location, inventory, and assessment of cultural resources of a specific area by conducting archival searches and by searching for sites Reconnaissance is limited to recording site locations, mapping, photographing, controlled surface sampling, and possible site testing A reconnaissance survey does not take the place of an intensive survey and construction clearance cannot be granted relative to this level of research Specific requirements are included in the permit.
- (2) Intensive survey This permit category is for the purpose of an [An] intensive 100% pedestrian survey of a project or permit area. Components of an intensive survey may include, but are not limited to archival research, pedestrian survey, shovel and/or mechanical subsurface probing, inventory, site recordation, and site assessment. Such a survey can be performed in many ways but must, at a minimum, include walking transects no more than 75 feet apart in open terrain and 30 feet apart in dense ground cover. Construction clearance may be granted relative to this level of investigation, if the intensive survey results in negative findings. Specific requirements are included in the permit
- (3) Testing This permit category is for the purpose of [allows] detailed subsurface examination of cultural re-

sources including systematic test excavations of a particular site or area. Testing must be oriented toward sampling a representative portion of a particular site or sites in all environmental contexts and may be conducted to determine if a landmark contains significant materials. Construction clearance may be granted relative to this level of investigation. Specific requirements are included in the permit

- (4) Monitoring [Data Recovery] This permit category is for the purpose of having a professional archeologist or architect on-site to observe construction activities that may or will damage cultural resources, and for them to report findings and impacts to sites to the committee. Monitoring may be conducted during or after other phases of archeological investigation and may not involve the need for a separate permit. However, if monitoring is the only investigation deemed necessary relative to a construction activity, then a monitoring permit will be required. If previously unrecorded and significant archeological deposits are recorded during a monitoring investigation, then construction activities in the immediate area of the find must stop and the principal investigator or other shall notify the Department of Antiquities Protection within 24 hours. Specific requirements of monitoring are included in the permit. [This permit covers full investigation and extensive excavation of a particular archeological sites. Data recovery must be based on a research design approved by the committee Construction clearance may be granted relative to this level of investigation. Specific requirements are included in the permit.]
- (5) Data Recovery [Preservation of rock art] This permit category is for the purpose of full investigation and extensive excavation of particular archeological site or sites. Data recovery must be based on a research design approved by the Committee. Construction clearance may be granted relative to this level of investigation. Specific requirements are included in the permit. [This

permit is issued for purposes of preserving, removing, recording, and copying all manner of rock art. Preservation techniques which involve application of brushes, heat, chemicals, water, chalk, petroleum products, or other preparations to the rock surfaces are prohibited unless specifically authorized by the Antiquities Committee. Specific requirements are included in the permit ]

(6) Alternative Mitigation [Underwater Survey]. When mitigation of an archeological site by data recovery is not appropriate, a permit may be issued for an alternative form of mitigation, as approved by the Committee. Alternative forms of mitigation may include, but not be limited to: monitoring of a proposed construction to record and report the discovery of unanticipated important archeological deposits; conducting archival and historical research to document the significance of the site; capping or burying in place important archeological deposits when appropriate studies have been undertaken to demonstrate that capping or sealing is the most prudent and feasible alternative and that sensors and other types of monitoring will be used by the sponsor to verify that the capping or burying does not disturb the site; and protecting significant remaining portions of a site by donation of the undisturbed area (provided the area equals at least half of the site's original significant deposits) to a nonprofit organization, or a political subdivision of the state, with the demonstrated capability to protect archeological resources. A permit issued for a mitigation alternative may require additional conditions including studies, investigations, or other actions as deemed necessary by the Committee, and will be specified in the terms and conditions of the permit. [Underwater resources include shipwrecks and drowned prehistoric and historic sites. Surveys for these cultural resources are conducted with electronic instrumentation including the proton magnetometer, side scan and subbottom sonar, and radio and radar positioning systems. In some instances divers using scuba gear are used to search for and examine a specific site or structure. Work is conducted under the direct supervision of an underwater archeologist or under a survey technician reporting to an underwater archeologist who is responsible for the quality of the work Data acquired are to be rendered to the committee along with an analysis and report Specific requirements are included in the permit ]

Inspection by divers, coring, or other appropriate means must be used to test the nature of suspected prehistoric or historic sites. In the case of magnetic anomalies, sediment must in many cases be removed to allow identification, approximate dating, and determination of importance of objects and sites found. Any artifacts recovered from the state lands are property of the State of Texas. Extensive recovery during testing is discouraged. Accepted standards for provenience control and archeological data recovery must be maintained. Data must be analyzed and rendered to the committee in a written report. Proper conservation of any artifacts recovered must be carried out. Specific requirements are included in the permit. Under exceptional circumstances, when all preservation alternatives have been exhausted and the public welfare clearly requires destruction of a State Archeological Landmark, the Committee may issue a destruction permit after thorough mitigation has been accomplished. Following any permitted archeological investigation, a clearance letter may be issued by the committee which authorizes destruction of all or part of a cultural resource without an antiquities permit. [Under exceptional circumstances, when all preservation alternatives have been exhausted and the public welfare clearly requires destruction of a State Archeological Landmark, the Antiquities Committee may issue a destruction permit after thorough mitigation has been accomplished Following any permitted archeological investigation, a clearance letter may be issued by the committee which authorizes destruction of all or part of a cultural resource without an antiquities permit ]

(10) Underwater excavations. In order to fulfill justified research objectives, or if damage to significant historic and prehistoric sites cannot be avoided, a full-scale underwater archeological excavation must be carried out under the direct supervision of an underwater archeologist. The intensive investigation and excavation this calls for must include documentary research and, for shipwrecks, detailed magnetometer work. Excavations must be supported by adequate equipment and supplies to insure proper recording, preservation, and the recovery of the maximum amount of data. Thorough analysis and a complete report are

required. Proper antiquities conservation is required for all artifacts, and all specimens recovered are state property. Specific requirements are included in the permit.

(11) Destruction. Under exceptional circumstances, when all preservation alternatives have been exhausted and the public welfare clearly requires destruction of a State Archeological Landmark, the Committee may issue a destruction permit after thorough mitigation has been accomplished. Following any permitted archeological investigation, a clearance letter may be issued by the Committee that authorizes destruction of all or part of a cultural resource without issuing an antiquities permit for destruction.

# Part I. Texas Department of Human Services

Chapter 19. Long-Term Care Nursing Facility Requirements for Licensure and Medicaid Certification

The Texas Department of Human Services (DHS) proposes amendments to §19–1104 and §19-1807, concerning the rehabilitative services system and reimbursement methodology for nursing facilities, in its Long-Term Care Nursing Facility Requirements rule chapter. The purpose of the amendment to §19-1104 is to add a cross-reference to §19-1807. The purpose of the amendment to §19-1807 is to strengthen qualifications for the rehabilitative clinical group. The quality for the rehabilitative clinical group, there must be a documented restorative treatment plan for the resident and documentation of a resident's response to the treatment plan.

Burton F. Raiford, commissioner, has determined that for the first five-year period the proposed amendments will be in effect there will be no fiscal implications for state or local government as a result of enforcing or administering the amendments.



# RULES



# MOPEN MEETINGS

Agencies with statewide jurisdiction must give at least seven days notice before an impending meeting. The Texas Commission on Alcohol and Drug Abuse (TCADA), under the authority of the Health and Safety Code, Title 6, Subtitle B, Chapter 461, gives notice of intent to renew an award with Oxford House, Incorporated for the purpose of administering a revolving loan fund and to provide technical assistance in the establishment of self-run, self-supported housing for recovering substance abusers with funds from the revolving fund. This award may also be used for persons transitioning from the criminal justice system back to the community. The work is for services throughout the State of Texas. The effective period of the award will be September 1, 1994 to August 31, 1995.

Eligible providers are private nonprofit entities.

The purpose and work requirements of the fund are contained in the Public Health Service Act, Title XIX, Part B, Subpart II, §1925:

- (1) The purpose of the fund is to make loans for the costs of establishing programs for the provision of housing in which individuals recovering from alcohol or drug abuse may reside in groups of not less than six individuals. The fund is established directly by the State or through the provision of a grant or contract to a nonprofit private entity.
- (2) The programs are carried out in accordance with guidelines issued under subsection (b).
- (3) Not less than \$100,000 is available for the fund.
- (4) Loans made from the revolving fund do not exceed \$4,000 and each such loan is repaid to the revolving fund by the residents of the housing involved not later than two years after the date on which the loan is made.
- (5) Each such loan is repaid by such residents through monthly installments, and a reasonable penalty is assessed for each failure to pay such periodic installments by the date specified in the loan agreement involved.
- (6) Such loans are made only to nonprofit private entities agreeing that, in the operation of the program established pursuant to the loan.
- (A) the use of alcohol or any illegal drug in the housing provided by the program will be prohibited;
- (B) any residents of the housing who violates such prohibition will be expelled from the housing;
- (C) the costs of the housing, including fees for rent and utilities, will be paid by the residents of the housing; and

(D) the residents of the housing will, through a majority vote of the residents, otherwise establish policies governing residence in the housing, including the manner in which applications for residence in the housing are approved.

The amount of funding TCADA currently provides for technical assistance in the establishment for these homes is \$60,000 annually. Wagner-Peyser Funding Allocation for Employment Service Activities

The Wagner-Peyser Act, establishes a formula for distributing funds to states for employment service activities. With this formula, Texas will receive \$52,928,323 for Program Year 1994, beginning July 1, 1994 and ending June 30, 1995. Ninety percent of this amount must be used for basic labor exchange services under \$501, subsection 7(a); 10% will be reserved for use at the Governor's discretion within legislatively designated parameters under subsection 7(b).

Texas Labor Code, Title 4, Subtitle A (formerly Texas Civil Statutes, Article 5221b), designates the Texas Employment Commission (TEC) as the state agency to administer activities funded by the Wagner-Peyser Act. The state herein presents the method and schedule proposed for distributing substate resources under §501, subsection 7(a).

Staff positions will be distributed to TEC administrative regions throughout the state according to the following formula each region will be held at an 80% hold harmless level, and the distribution will be based upon each region's

accomplishment of individual and transaction placements and new and renewal applications.

These funds will be available to support staff and nonpersonal services (rent, utilities, equipment, supplies, etc.) effective July 1, 1994. Actual disbursement of these funds will be made from the TEC State Office in accordance with the federally approved cost accounting system and state procurement guidelines

The respective TEC regional directors have the discretion for hiring and assignment of specific individuals and for purchases and contracts for nonpersonal services within federal and state guidelines, however, these funds may not be applied to functions other than labor exchange services.

Comments in regard to the substate distribution of the Wagner-Peyser funds should be submitted in writing to Sunya Alexander, Division Director for Employment Service, TEC Building, 15th Street and Congress Avenue, Austin, Texas 78778.

In accordance with 43 TAC §§11 200-11.205, as published in the July 16, 1993, issue of the *Texas Register* (18 TexReg 4649) and in the May 11, 1993, issue of the *Texas Register* (18 TexReg 3034), the Texas Department of Transportation issues this its second annual call for proposed projects for the second cycle of the department's new Statewide Transportation Enhancement Program.

Title 23, United States Code, \$133(d)(2) and \$160(e)(2), and \$1015(d) (2) of the Intermodal Surface Transportation Efficiency Act of 1991 (Public Law 102-240) require that 10% of certain funds apportioned to a state pursuant to Title 23, United States Code, \$104(b)(3) be used for transportation enhancement activities. The Texas Transportation Commission will use those funds in a statewide competitive program that enhances the intermodal transportation systems and facilities within the state for the enjoyment of the users of those systems

Transportation enhancement activities are defined in §101(a) of Title 23. United States Code. That provision defines transportation enhancement activities as.

- (1) provision of facilities for pedestrians and bicycles.
- (2) acquisition of scenic easements and scenic or historic sites,
- (3) scenic or historic highway programs,
- (4) landscaping and other scenic beautification,
- (5) historic preservation,

- (6) rehabilitation and operation of historic transportation buildings, structures or facilities (including historic railroad facilities and canals),
- (7) preservation of abandoned railway corridors (including the conversion and use thereof for pedestrian or bicycle trails);
- (8) control and removal of outdoor advertising;
- (9) archaeological planning and research; and
- (10) mitigation of water pollution due to highway runoff.

To nominate a project, the eligible nominating entity must file its nomination, in the form prescribed by the department, with the district engineer of the district office responsible for the area in which the proposed enhancement project will be implemented. The address and telephone number of the district offices may be obtained by contacting the Environmental Affairs Division at (512) 416-2646. Nominations must be received by the department no later than 90 days after the publication date of this call for projects.
