#### How to Use the Texas Register

Information Available: The 10 sections of the *Texas Register* represent various facets of state government. Documents contained within them include:

Governor - Appointments, executive orders, and proclamations.

Attorney General - summaries of requests for opinions, opinions, and open records decisions.

Secretary of State - opinions based on the election laws

Texas Ethics Commission - summaries of requests for opinions and opinions.

Emergency Sections - sections adopted by state agencies on an emergency basis.

**Proposed Sections** - sections proposed for adoption.

Withdrawn Sections - sections withdrawn by state agencies from consideration for adoption, or automatically withdrawn by the Texas Register six months after the proposal publication date.

Adopted Sections - sections adopted following a 30-day public comment period.

Open Meetings - notices of open meetings.

In Addition - miscellaneous information required to be published by statute or provided as a public service.

Specific explanation on the contents of each section can be found on the beginning page of the section. The division also publishes cumulative quarterly and annual indexes to aid in researching material published.

How to Cite: Material published in the *Texas Register* is referenced by citing the volume in which the document appears, the words "TexReg" and the beginning page number on which that document was published. For example, a document published on page 2402 of Volume 18 (1993) is cited as follows: 18 TexReg 2402.

In order that readers may cite material more easily, page numbers are now written as citations. Example: on page 2 in the lower-left hand corner of the page, would be written "18 TexReg 2 issue date," while on the opposite page, page 3, in the lower right-hand corner, would be written "issue date 18 TexReg 3."

How to Research: The public is invited to research rules and information of interest between 8 a.m. and 5 p.m. weekdays at the *Texas Register* office, Room 245, James Earl Rudder Building, 1019 Brazos, Austin. Material can be found using *Texas Register* indexes, the *Texas Administrative Code*, section numbers, or TRD number.

#### Texas Administrative Code

The Texas Administrative Code (TAC) is the official compilation of all final state agency rules published in the Texas Register. Following its effective date, a rule is entered into the Texas Administrative Code. Emergency rules, which may be adopted by an agency on an interim basis, are not codified within the TAC. West Publishing Company, the official publisher of the TAC, releases cumulative supplements to each printed volume of the TAC twice each year.

The TAC volumes are arranged into Titles (using Arabic numerals) and Parts (using Roman numerals).

The Titles are broad subject categories into which the agencies are grouped as a matter of convenience. Each Part represents an individual state agency. The *Official TAC* also is available on WESTLAW, West's computerized legal research service, in the TX-ADC database.

How to Cite: Under the TAC scheme, each section is designated by a TAC number. For example in the citation 1 TAC §27.15:

1 indicates the title under which the agency appears in the *Texas Administrative Code*; *TAC* stands for the *Texas Administrative Code*; §27.15 is the section number of the rule (27 indicates that the section is under Chapter 27 of Title 1; 15 represents the individual section within the chapter).

How to update: To find out if a rule has changed since the publication of the current supplement to the Texas Administrative Code, please look at the Table of TAC Titles Affected. The table is published cumulatively in the blue-cover quarterly indexes to the Texas Register (January 22, April 16, July 13, and October 12, 1993). In its second issue each month the Texas Register contains a cumulative Table of TAC Titles Affected for the preceding month. If a rule has changed during the time period covered by the table, the rule's TAC number will be printed with one or more Texas Register page numbers, as shown in the following example.

## **Proposed Sections**

Before an agency may permanently adopt a new or amended section, or repeal an existing section, a proposal detailing the action must be published in the *Texas Register* at least 30 days before any action may be taken. The 30-day time period gives interested persons an opportunity to review and make oral or written comments on the section. Also, in the case of substantive sections, a public hearing must be granted if requested by at least 25 persons, a governmental subdivision or agency, or an association having at least 25 members.

Symbology in proposed amendments. New language added to an existing section is indicated by the use of **bold text**. [Brackets] indicate deletion of existing material within a section.

#### TITLE 31. NATURAL RE-SOURCES AND CON-SERVATION

Part II. Texas Parks and Wildlife Department

Chapter 65. Wildlife

Subchapter A. Statewide Hunting and Fishing

• 31 TAC §§65.3, 65.9, 65.13, 65.26, 65.27, 65.31, 65.40, 65. 54, 65.62, 65.72, 65.78

The Texas Parks and Wildlife Department proposes amendments to §§65.3, 65.9, 65.13, 65.26, 65.27, 65.31, 65.40, 65.54, 65.62, 65.72, and 65.78, concerning statewide hunting and fishing regulations.

It should be noted that §65.30, White-tailed Deer Herd Management Tag, expires February 28, 1993. Text complementing §65.30 is proposed for deletion.

The proposed amendments allow the department to adjust seasons, bag limits, means, and methods of taking wildlife resources in consideration of the species' population.

The proposed amendments are in compliance with the Texas Parks and Wildlife Code, Chapter 61, and represent required findings of fact. These findings are based upon scientific studies and surveys which track trends in relative abundance of the different fish and wildlife species. The rules as proposed are designed to prevent depletion or waste of wildlife resources. The amendments that differ from the existing 1992-1993 Statewide Hunting and Fishing Proclamation are summarized by sections.

Section 65.3. Definitions: designate approximately 76 small lakes, as Designated Urban Lakes which permits special restrictive regulations to be placed upon these lakes under §65.72; delete certified wildlife biologist, deer herd management tag, designated agent, designated harvester, and eligible landowner from definitions listing. These definitions are associated with §65.30 (white-tailed deer herd management tag) which expires February 28, 1993; add small lakes that are below the Coastal Water Boundary to listing that exempts these lakes from the Coastal Water Boundary rules; add definition of chumming; change wildlife management plan definition to deer management plan.

Section 65.13. Firearms: delete Angelina County from list where only shotguns may be

used to take turkey during the spring gobbler season, as this county no longer has a spring gobbler season.

Section 65.26. Wildlife Management Plan: change name to Deer Management Plan to more closely identify the section's purpose. Rewrite text to clarify what information is required to be included in the deer management plan.

Section 65.31. Antierless Mule Deer and White-tailed Deer Permits: amend this section to conform with proposed amendments in §65.40.

Section 65.40. Deer, White-tailed and Mule Deer: §65.40(1) is being rewritten due to a proposed more conservative approach to white-tailed deer harvest in several areas of the state and a proposed bag limit increase for 14 south Texas counties. The white-tailed deer general open season text, due to its complexity, is being presented in block form. The block form permits the reader to compare new and old text and determine how a county's deer bag limit relative to other counties is proposed to be changed. Itemized are the major changes: adjust downward the whitetailed deer bag limits. The proposed amendments, incorporated into the text, provide a more conservative harvest strategy to the counties of East Texas, parts of the Post Oak-north Edwards Plateau, and Oak Prairie vegetative areas of the state. This more conservative harvest approach is due to a recognized decline in the deer population; open the white-tailed deer season statewide the second week in November rather than the first week in November; close the white-tailed deer season in south Texas the third Sunday in January rather than the second Sunday in January in 14 of 27 south Texas counties which provides a season that is one week longer; increase the bag limit for deer in 14 of 27 south Texas counties by one deer which means a total of five white-tailed deer and no more than three bucks may be taken; adjust the late antierless only season to conform to 14 days in length in those counties having a one-week extended season while those south Texas counties having no extended season will have a 16-day late antierless only season; and change archery-only deer seasons back to the month of October and archery bag limits will conform to the general season bag limits. The paragraphs previously listed within §65.40 additionally have an optional effective date of September 1, 1993 or September 1, 1994. This option permits public comments on the effective date. Implementation of the effective date is to be carefully considered because landowners and hunters traditionally make contractual and vacation arrangements a year ahead.

Section 65.54. Prairie Chicken: Open Seasons, Bag, and Possession Limits: delete the permit requirement to take prairie chicken as this information can be gained by using hunter harvest surveys.

Section 65.62. Turkey: permit the hunter a choice of taking up to three turkeys either during the fall or spring seasons. This bag limit change applies only to areas where the Rio Grande turkey sub-species is located. The annual bag limit remains the same at three turkeys per license year; change south Texas turkey season dates to conform with white-tailed deer season dates; change archery-only season dates back to the month of October to conform with deer archery season.

Section 65.72. Fish: require juglines to have a 30-day gear tag, juglines used for commercial purposes must have a orange colored floating device, and non-commercial juglines must have a white colored floating device one gal-Ion in size; designate approximately 76 small lakes as Designated Urban Lakes and place restrictive fishing regulations upon these lakes so as to more equitably distribute fishing opportunities for youth, by prohibiting trotlines, juglines, throwlines, and reduce catfish bag limit from 25 per day to three per day and increase minimum length limit from nine to 12 inches; change Lake Conroe black bass regulations from statewide five per day and 14 minimum length limit to five per day and minimum length limit of 16 inches; change Lakes: Bridgeport, Weatherford, Georgetown, Tyler State Park, Striker, and Caddo from statewide five per day and minimum length limit of 14 inches on largemouth bass to three per day with a protected 14-16 inch slot limit; add Lakes Bastrop and Walter E. Long (Decker) to the list of lakes that have a protected 14-21 inch slot length limit on largemouth bass; provide Gibbons Creek Reservoir with a catch-and-release fishery for largemouth bass rather than the current 14-21 inch protected slot length limit; add to the special regulation for the protected 14-21 inch slot length limits that only one largemouth bass over 21 inches may be retained per day; remove Caddo Lake from special crappie exception of 50 per day and no minimum length limit to 25 per day and a minimum length limit of 10 inches; prohibit "chumming" in Lake Texoma as chumming alters fish behavior and concentrates feeding activity. This activity may be detrimentally affecting the abundance of large striped bass in Lake Texoma by increasing the vulnerability of large fish to harvest; place Lost Maples State Park into category of a catch-and-release only fishery; place the following water bodies into the exceptions listing for Coastal Water Boundary

definition: Galveston County Reservoir, Galveston State Parks ponds 1-7, Lake Nassau, Fort Brown Resaca, Resaca de la Guerra, Resaca de la Palma, Resaca de los Cuates, Resaca de los Fresnos, Resaca Ranch Viejo, and Town Resaca. By placing these lakes into the exceptions listing, these lakes may be fished without a saltwater stamp and will reduce confusion among the public, controlling authorities, and clarify enforcement; delete text "500 acres or less" in regulation that applies special regulations to reservoirs lying totally within the boundaries of state parks. Elimination of size restriction will allow state park lakes exceeding 500 acres to be covered by this regulation of prohibiting trotline use; add text "and its tributaries" to regulation exceptions relating to Lakes Somerville and Palestine. Regulations on Lakes Somerville and Palestine and some creeks allow for a 12-inch white bass (there are some creeks feeding into these lakes that are not named and therefore have a 10-inch length limit for white bass); add text "bag, possession, and length limits apply to all waters within the Corps of Engineers Lands on Cooper Lake; upstream from State Highway 19/154 and down stream from FM 71." Within the boundaries of the Corps of Engineers lands, several old stock tanks remain. These are well known fishing holes. This proposed regulation change is to make limits uniform for anglers and reduce law enforcement confusion within the area known as Cooper Lake; place a bag, possession, and minimum length limit on saugeye of three per day, six in possession, and 18-inch minimum length limit. This hybrid fish (Sauger X Walleye) is being experimentally introduced to increase angling opportunities in urban areas and small impoundments. This fish also serves as a biological control on abundant small crappie; provide Lakes E. V. Spence and Fort Phantom Hill with an experimental blue catfish bag limit of five per day and a minimum length limit of 18 inches. The proposed experimental regulation should increase weight of blue catfish harvested by anglers. Protecting blue catfish from harvest until they reach 18 inches should help to maintain or increase reproduction in these reservoirs; increase daily bag and possession limit of red drum from three to four per day and possession limit from six to eight. Staff data indicates that coastal populations of red drum have made significant recoveries from previous natural disasters and overfishing. Staff monitoring data reveal that spawning success, relative abundance of sub-adults, as well as escapement of red drum to the Gulf spawning stocks have all increased. This moderate liberalization is justified to increase recreational opportunities without jeopardizing long-term health of red drum fisheries; increase minimum size limit of king mackerel from 14 to 23 inches total length. The 23-inch minimum size limit corresponds to the regulation implemented by the federal government in the Exclusive Economic Zone (EEZ). The proposal would ensure consistency in regulation enforcement. Staff data indicate no adverse impacts would occur since less than 1.0% of king mackerel retained by Texas anglers are below 23 inches; delete king mackerel bag limit exception that licensed chartered vessels currently have. The bag limit exception is: two king mackerel per person-per day for all persons on board or three per person-per day exclusive of captain and crew, whichever is greater. Deletion of this exception will allow Texas regulations to correspond to those regulations implemented by the federal government in the EEZ. Staff analysis reveals no adverse overall impacts would occur; permit the retention of freshwater catfish taken by trotline below the Coastal Waters Boundary. Almost all coastal counties have freshwater below the proclamation defined Coastal Waters Boundary. At present there are no provisions for retaining catfish taken by trotline below the Coastal Waters Boundary. Currently persons trotlining above the boundary may retain freshwater catfish while those fishing below the boundary (usually defined by a bridge) may not, retain catfish caught on a trotline; clarify text that adds sharks to those game species that may be taken by sail line; delete special note about when the minimum length limit of 24 inches for flathead catfish becomes effective; delete special note about when all netting of freshwater fish becomes effective; remove the phrase "smallmouth bass" from the statewide listing. Removal will clarify regulation wording to make limits apply to the targeted species as intended. The listed reservoirs do not have smallmouth bass or smallmouth will be regulated separately; place Lake Texoma into bass category of Bass: largemouth and smallmouth, spotted and Guadalupe bass, their hybrids, and subspecies." Lake Texoma belongs under this category to make regulation conform to those existing in Oklahoma.

Section 65.78. Crabs: prohibit the tending of crab traps during the period of 30 minutes after sunset to 30 minutes before sunrise. The restriction should reduce the theft of crabs and crab traps. The proposal was recommended by the Texas Blue Crab Fishery Management Plan adopted by the Commission, January 1992; require 2 3/8-inch escape vents in crab traps. Escape vents are expected to reduce the sub-legal catch of crabs, reduce culling time, and reduce cannibalism. The proposal was recommended by the Texas Blue Crab Fishery Management Plan adopted by the Commission, January 1992.

Robin Riechers, staff economist, has determined that for the first five-year period the sections are in effect there will be fiscal implications for state and local government and small businesses as a result of enforcing or administering the sections.

The proposed amendments generally restrict to an additional degree the bag, possession, and size limits for the selected species of fish and wildlife. The restrictions are designed to reduce the vulnerability of the species to take, stem the population decline, prevent overharvest of the species, and more equitably distribute harvest of the wildlife resource. The proposed amendments also change seasons to reflect comments from the public.

Sections 65.3 and 65.72. Designation of 76 urban lakes makes the regulations on those lakes more restrictive to more equitably distribute fishing opportunities. There should be minimal cost to state and local governments as a result of enforcing or administering this rule and the revenue losses or gains to state or local governments should be negligible.

All sections proposed. Many rules can be classified as more restrictive in nature. These include rules which increase the minimum length limits, restriction on bag limits, protected slot length limits, and rules which make certain lakes catch and release only. These rules are designed to prevent overharvest, maintain viable wildlife and fisheries populations, and insure equitable distribution of harvest. There should be minimal cost to state and local government as a result of enforcing or administering this rule and the revenue losses or gains to state or local governments should be negligible.

Sections 65.3 and 65.72. Clarifications to definitions and rules are made in order to reduce confusion and ensure enforceability and compliance with the rules. This also includes standardization with rules in the EEZ for King Mackerel in order to reduce confusion and to create uniformity of rules in the EEZ and in Texas waters. There should be minimal cost to state and local governments as a result of enforcing or administering this rule and the revenue losses or gains to state or local governments should be negligible.

Section 65.78. Rules affecting the crab fishery include time restrictions on the tending of crab traps and mandatory escape vents for crab traps. There should be minimal cost to state and local governments as a result of enforcing or administering this rule and the revenue losses or gains to state or local governments should be negligible. There are potential economic costs associated with small businesses as a result of compliance with these rules.

Section 65.72. Liberalizations of rules on red drum, on the catching of freshwater species below the Coastal Waters Boundary, and in any other bag and size limits may provide more recreational opportunity. There should be minimal cost to state and local governments as a result of enforcing or administering this rule and the revenue losses or gains to state or local governments should be negli-

Section 65.72. Experimental regulations permit for the species saugeye and catfish on lakes E. V. Spence and Fort Phanton Hill the department to regulate the age of species retained and improve population structure of wildlife resources. There should be minimal cost to state and local governments as a result of enforcing or administering this rule and the revenue losses or gains to state or local governments should be negligible.

Section 65.40. Some benefits anticipated as a result of enforcing the rules as proposed will permit hunters to take an additional deer in south Texas and to hunt one week longer in south Texas. The reduction by one week in the deer season length for the rest of the state will benefit those hunters and landowners who have commented to the department that the deer season is too long.

In general, fiscal implications to small businesses may be reduced sales of gear, supplies, etc., to persons as a result of the amended rules. Small businesses or persons who are forced to comply to changes in regulations may also be negatively impacted. Expenditures in certain locales may be

increased or decreased due to the restrictions upon the targeted species.

Mr. Riechers also has determined that for each year of the first five years the sections are in effect the public benefit anticipated as a result of enforcing the sections will be to permit appropriate take of wildlife resources consistent to maintain viable populations.

Those rules which are designed to be more restrictive, will ensure long-term viability of the resource, and thus will accrue public benefits in the future. Rules which clarity or liberalize provide opportunities for immediate public gains through reduced confusion and greater recreational opportunities through increased take of the resource or satisfaction among users of the resource.

It is anticipated there will be fiscal implications to persons who are required to comply with the rules as proposed. Persons who depend upon the expenditures of others that exercise their recreational privileges may find reduced income as a result of the rules. Fiscal implications also concern those hunters who have season hunting leases and will be denied one week of hunting. Fiscal implications may impact hunters and landowners who have already applied for leave from work and landowners who have contracted hunts for the first week in November. Other fiscal implications may affect those businesses that gain a large part of their annual income just from the deer season.

The department has filed a local employment impact statement with the Texas Employment Commission in compliance with the Administrative Procedure and Texas Register Act, §4A, and of this date has not received a reply.

The amendments are proposed under the Texas Parks and Wildlife Code, Chapter 61, Uniform Wildlife Regulatory Act (Wildlife Conservation Act of 1983), which provides the Texas Parks and Wildlife Commission with authority to establish wildlife resource regulations for this state.

§65.3. Definitions. The following words and terms, when used in this subchapter, shall have the following meanings, unless the context clearly indicates otherwise.

[Certified wildlife biologist-A person who has been certified as a wildlife biologist by The Wildlife Society, or who:

[(A) has fulfilled the scholastic requirements of an accredited university or college for the B. S. degree (or advanced degree) with major course work in wildlife science or wildlife management; and

• [(B) has not less than five years of post-graduate experience in research or wildlife management associated with white-tailed deer or mule deer within the past 10 years.]

Chumming-To deposit into the water any fish, parts of fish, or other substances containing fish or fish parts that are not attached to a hook and line and used to attract fish or stimulate fish feeding activity.

Coastal waters boundary-For purposes of Texas Parks and Wildlife Code. Chapters 61 and 66, all public waters east and south of the following boundary are considered coastal waters: Beginning at the International Toll Bridge in Brownsville, thence northward along U.S. Highway 77 to the junction of Paredes Lines Road (FM Road 1847) in Brownsville, thence northward along FM Road 1847 to the junction of FM Road 106 east of Rio Hondo, thence westward along FM Road 106 to the junction of FM Road 508 in Rio Hondo, thence northward along FM Road 508 to the junction of FM Road 1420, thence northward along FM Road 1420 to the junction of State Highway 186 east of Raymondville, thence westward along State Highway 186 to the junction of U.S. Highway 77 near Raymondville, thence northward along U.S. Highway 77 to the junction of FM Road 774 in Refugio, thence eastward along FM Road 774 to the junction of State Highway 35 south of Tivoli, thence northward along State Highway 35 to the junction of State Highway 185 between Bloomington and Seadrift, thence northwestward along State Highway 185 to the junction of FM Road 616 in Bloomington, thence northeastward along FM Road 616 to the junction of State Highway 35 east of Blessing, thence southward along State Highway 35 to the junction of FM Road 521 north of Palacios. thence northeastward along FM Road 521 to the junction of State Highway 36 south of Brazoria, thence northward along State Highway 36 to the junction of State Highway 332 in Brazoria, thence eastward along State Highway 332 to the junction of FM Road 2004 in Lake Jackson, thence northeastward along FM Road 2004 to the junction of Interstate Highway 45 between Dickinson and La Marque, thence northwestward along Interstate Highway 45 to the junction of Interstate Highway 610 in Houston, thence east and northward along Interstate Highway 610 to the junction of Interstate Highway 10 in Houston, thence eastward along Interstate Highway 10 to the junction of State Highway 73 in Winnie, thènce eastward along State Highway 73 to the junction of U.S. Highway 287 in Port Arthur, thence northwestward along U.S. Highway 287 to the junction of Interstate Highway 10 in Beaumont, thence eastward along Interstate Highway 10 to the Louisiana State Line. Deer Management Plan-A written document provided to the landowner or agent and approved by a department biologist after an investigation is completed on a tract of land.

[Deer Herd Management Tag-A tag that permits antlerless white-tailed deer to be taken under a wildlife management plan without becoming a part of the daily bag limit.

[Designated agent-A person who is named in the application for deer herd management tags by the landowner to act on behalf of the landowner for purposes of the wildlife management plan, including acting as a designated harvester.]

Designated urban lakes-For purposes of the Texas Parks and Wildlife Code, Chapters 61 and 66, the following public waters, listed by county and location, are considered designated urban lakes: Bell-Sammon's Park Lake; Bexar-Espada; Hi-Lions; Live Oak City; Millers Pond; San Antonio River; Blanco-Blanco State Park Number 5; Five Mile Dam; Bowie-Spring Lake Park; Brazos-Cy Miller Pond; Gabbards Park; Cameron-Dixieland; Fort Brown Resaca; Harlingen City Lake; Harlingen Sports Complex; Collin-Bethany Park A; Bethany Park B; Bethany Park C; Bob Woodruff; Shawnee Park; Towne; Dallas-Kid Springs Park; Lakeside (Duncanville); Mesquite City Lake; Northwest Park Pond; (Irving)-O'Bannon (Garland); Palos Verdes: Samuel Farm Pond A: Samuel Farm Pond Number 1; Samuel Farm Pond Number 4; Samuel Farm Pond Number 5; Denton-Flower Mound Rheudasil; North Lake Park (Denton); South Lake Park (Denton); Fort Bend-Missouri City; Missouri City Community Park Lake; Gillespie-LBJ State Grayson-Pickens; Park; Waterloo; Gregg-Teague Park Lake; Harris-Bane Park; Eisenhower City Park; Forest Lake; Hermann Park; Tom Bass 1; Lubbock- Canyon Lake Project 1; Maxey Park; Montgomery-Albert Sallas County Park; Orange-Cairborne West Park; Potter-Medical Center North; Medical

[Designated harvester-A person who is named in the application for deer herd management tags by the landowner or designated agent to take and tag antlerless white-tailed deer with a deer herd management tag on the property specified in the wildlift management plan.

[Eligible landowner-A landowner who has placed a specific tract of land under a department approved wildlife management plan and the plan for the property specifies that 40 or more antlerless white-tailed deer shall be taken.

[Wildlife management plan-A written document provided to the landowner or agent and approved by a department biologist after an investigation is completed on a tract of land.]

§65.9. Open Seasons: General Rules.

#### (a)-(h) (No change.)

(i) Every game bird or game animal wounded by hunting and reduced to possession by the hunter must be killed immediately and [except as provided in \$65.3 of this title (see definition of deer herd management tag)] become a part of the daily bag limit.

#### (j)-(l) (No change.)

(m) A person may give, leave, receive, or possess any species of legally taken wildlife resource, or a part of the resource, that is required to have a tag or permit attached [, except for white-tailed deer tagged with a herd management tag,] or is protected by a bag or possession limit, if the carcass or a part of a carcass is tagged with a hunter's document by the person who killed or caught the wildlife resource. The hunter's document that shall accompany the carcass or a part of the carcass until reaching final destination and the document must contain the following information:

(1) -(5) (No change.)

§65.13. Firearms.

(a) It is lawful to shoot game animals and game birds with a rifle, shotgun,

or other legal firearm including muzzleloading weapons, except it is unlawful to shoot:

#### (1)-(2) (No change.)

(3) turkey gobblers during spring gobbler seasons in [Angelina.] Houston, Jasper, Newton, Polk, Trinity, and Tyler Counties with any firearm other than a shotgun.

(b)-(d) (No change.)

#### §65.26. Deer [Wildlife] Management Plan.

- (a) A deer management plan (see §65.3 of this title (relating to Definitions) ) shall include:
- (1) measurements of density, production, and sex composition of the deer population present on the property;
- (2) measurements of the number, sex, and, where possible, age of the deer harvested from the property;
- (3) evaluation and appraisal of habitats determined by Texas Parks and Wildlife Department to be of significance to white-tailed deer;
- (4) the number of hunters on the property, the number of days that they hunted, and the dates that they harvest deer; and
- (5) descriptions of land management practices occurring on the property.
- (b) A deer management plan shall:
- (1) specify the number of antlerless deer to be harvested from a given tract of land;
- (2) require each antlerless deer taken to be tagged with any permit or deer herd management tag issued under this section; and
- (3) no permit or deer herd management tag is valid unless it has been issued, used, and possessed in accordance with this section and §65. 31 of this title (relating to Antlerless Mule Deer Permits).

[A wildlife management plan (see §65.3 of this title relating to Definitions)) shall:

- [(1) specify the number of antierless deer to be harvested from a given tract of land and an equal number of permits or deer herd management tags may be issued to the owner or authorized agent of the tract;
- [(2) require each antierless deer taken to be tagged with the permit or deer herd management tag required by this section: and

[(3) no permit or deer herd management tag is valid unless it has been issued, used, and possessed in accordance with this section and \$65.30 of this title (relating to White-tailed Deer Herd Management Tag) and \$65.31 of this title (relating to Antlerless Mule Deer Permits and White-tailed Deer Permits and Tags).]

§65.27. Permits.

- (a) No person may hunt antieriess mule deer, pronghorn antelope, elk, or antieriess white-tailed deer in areas where permits [or deer herd management tags] are prescribed unless he first procures a valid permit [or deer herd management tag] issued by the landowner.
- (b) It is unlawful to use an antierless mule deer, antelope, elk, or antierless white-tailed deer permit [or white-tailed deer herd management tag] on more than one antierless mule deer, antelope, elk, or antierless white-tailed deer.
  - (c) (No change.)
- (d) No permit [or deer herd management tag] is valid unless it has been issued, used, and possessed strictly in accordance with this section; §65.29 of this title (relating to Antelope Permits), [§65.30 of this title (relating to White-tailed Deer Herd Management Tag),] §65.31 of this title (relating to Antlerless Mule Deer Permits and White-tailed Deer Permits and White-tailed Deer Permits [and Tags]); and §65.33 of this title (relating to Elk Permits).
- [(e) It is unlawful for any person other than a person named as a designated harvester to use a deer herd management tag for tagging deer.]

§65.31. Antlerless Mule Deer and White-tailed Deer Permits.

#### (a)-(d) (No change.)

(e) It is unlawful for a person to possess an antierless mule deer or white-tailed deer, [except as provided in §65.30 of this title (relating to White-tailed Deer Herd Management Tag),] unless the person has been issued an antierless mule deer or white-tailed deer hunting permit on which appear:

#### (1)-(3) (No change.)

- (f) It is unlawful for a hunter to use an antierless mule deer or white-tailed deer hunting permit [or a designated harvester to use a white-tailed deer herd management tag] on a tract of land other than the designated tract for which the permit or tag was issued.
- (g) The permit [or white-tailed deer herd management tag] must be attached to each antierless mule deer or white-tailed deer taken, and shall remain attached until



the deer has reached its final destination as defined in the Texas Parks and Wildlife Code, §42. 001(4).

(h)-(i) (No change.)

- §65.40. Deer: White-tailed and Mule Deer. No person, [other than the designated harvester acting under the authority of a white-tailed deer herd management tag (see §65.30 of this title (relating to White-tailed Deer Herd Management Tag),] may take more than the aggregate total of six [five] deer per license year; of which no more than two may be mule deer, only one of which may be a buck mule deer; no more than three [two] white-tailed buck deer, or no more than six [five] antlerless deer, both species combined.
- (1) White-tailed deer: general open seasons, bag, and possession limits shall be as follows.
- (A) In Bandera, Bexar. Blanco, Brewster. Brown. Calhoun, Coke, Coleman, Comal, Concho, Crockett, Culberson, Edwards, Gillespie, Glasscock, Hays, Irion, Jeff Davis, Kendall, Kerr, Kimble, Kinney (only north of U.S. Highway 90), Lampasas, Llano, McCulloch, Mason, Medina (only north of U.S. Highway 90), Menard, Mills, Mitchell, Nolan, Pecos, Presidio, Reagan, Real, Reeves, Runnels, San Saba, Schleicher, Sterling, Sutton, Terrell, Tom Green, Travis, Upton (south of U.S. Highway 67 and east of state highway 349), Uvalde (only north of U.S. Highway 90), and Val Verde Counties, there is an open season for white-tailed deer.
- (i) Open season: second Saturday in November through the first Sunday in January. This clause becomes effective September 1, 1994.
- (ii) Bag limit: four white-tailed deer, no more than two bucks.
- (iii) Antlerless whitetailed deer may be taken without an antlerless deer permit required by §65.27 of this title (relating to Permits) and §65.31 of this title (relating to Antlerless Mule Deer and White-tailed Deer Permits).
- (B) In Aransas, Atascosa, Bee, Cameron, Hidalgo, Kinney (only south of U.S. Highway 90), Live Oak, Medina (only south of U.S. Highway 90), Nueces, Refugio, San Patricio, Starr, Uvalde (only south of U.S. Highway 90), and Willacy Counties, there is an open season for white-tailed deer.
- (i) Open season: second Saturday in November through the second Sunday in January.

- (ii) Bag limit: four white-tailed deer, no more than two bucks.
- (iii) Antlerless whitetailed deer may be taken without an antlerless deer permit required by §65.27 of this title (relating to Permits) and §65.31 of this title (relating to Antlerless Mule Deer and White-tailed Deer Permits).
- (iv) Special (South Texas) late season: in the counties listed in this subparagraph there is a special late antierless only white-tailed deer season.
- (I) Open season: January 15, 1994-January 30, 1994.
- (II) Bag limit: four antierless white-tailed deer only. Antierless white-tailed deer may be taken without an antierless permit in compliance with clause (iii) of this subparagraph. The bag limit is not in addition to the general or archery only season bag limits.
- (C) In Brooks, Dimmit, Duval, Frio, Jim Hogg, Jim Wells, Kenedy, Kleberg, LaSalle, McMullen, Maverick, Webb, Zapata, and Zavala Counties, there is an open season for white-tailed deer.
- (i) Open season: second Saturday in November through the third Sunday in January. This clause becomes effective September 1, 1994.
- (ii) Bag limit: five whitetailed deer, no more than three bucks. This clause becomes effective September 1, 1994.
- (iii) Antlerless whitetailed deer may be taken without an antlerless deer permit required by §65.27 of this title (relating to Permits) and §65.31 of this title (relating to Antlerless Mule Deer and White-tailed Deer Permits).
- (iv) Special (South Texas) late season: in the counties listed in this subparagraph there is a special late antlerless only white-tailed deer season.
- (I) Open season: January 17-30, 1994.
- antlerless white-tailed deer only.
  Antlerless white-tailed deer may be taken without an antlerless deer permit in compliance with clause (iii) of this subparagraph. The bag limit is not in addition to the general or archery only

season bag limits. This subclause becomes effective September 1, 1994.

- (D) No person may take or possess more than one white-tailed buck deer per license year from counties, in the aggregate, listed within this subparagraph.
- (i) In Angelina, Bell, Bosque, Brazoria, Callahan, Comanche, Corvell, Eastland, Erath, Fort Bend, Goliad (south of U.S. Highway 59), Hamilton, Hardin, Howard, Jackson (south of U.S. Highway 59), Jasper, Liberty, Matagorda, McLennan (west of Brazos River and IH-35), Newton, Palo Pinto, Polk, Shackelford, Stephens, Taylor, Throckmorton, Trinity, Tyler, Victoria (south of U.S. Highway 59), Wharton (south of U.S. Highway 59), and Williamson Counties, there is an open season for white-tailed deer.
- (I) Open season: second Saturday in November through the first Sunday in January. This subclause becomes effective September 1, 1994.
- (II) Bag limit: three deer, no more than one buck.
- (III) Antlerless white-tailed deer may be taken without an antierless deer permit required by §65.27 of this title (relating to Permits) and §65.31 of this title (relating to Antlerless Mule Deer and White-tailed Deer Permits).
- (ii) In Colorado (south of the Colorado River), Goliad (north of U.S. Highway 59), Gonzales, Fisher (west of State Highway 70), Guadalupe (south of IH-10 and east of State Highway 123), Hemphill, Hood, Jack, Jackson (north of U.S. Highway 59), Karnes, Kent (south of U.S. Highway 180), Lavaca (south of U.S. Highway 90A and east of U.S. Highway 77), Nacogdoches, Panola, Parker (west of FM 51 and State Highway 171), Rusk, Sabine, San Augustine, Scurry, Shelby, Somervell, Victoria (north of U.S. Highway 59), Wharton (north of U.S. Highway 59), Wheeler, Wilson, and Young Counties, there is an open season for white-tailed deer.
- (I) Open season: second Saturday in November through the first Sunday in January. This subclause becomes effective September 1, 1994.
- (II) Bag limit: three deer, no more than one buck.
- may be taken only during the first six

- days of the general season. Anterless white-tailed deer may be taken without an antierless deer permit required by \$65.27 of this title (relating to Permits) and \$65.31 of this title (relating to Antierless Mule Deer and White-tailed Deer Permits), except antierless deer may be taken only by antierless permits authorized by \$65.26 of this title (relating to Deer Management Plan).
- (iii) In Archer, Baylor, Bowie, Cass, Clay, Cooke, Denton, Harrison, Hill, Johnson, McClennan (east of Brazos River and IH-35), Marion, Montague, Morris, Parker (east of FM 51 and State Highway 171), Red River, Tarrant, and Wise Counties, there is an open season for white-tailed deer.
- (I) Open season: second Saturday in November through the first Sunday in January. This subclause becomes effective September 1, 1994.
- (II) Bag limit: three deer, no more than one buck.
- (III) Antlerless deer may be taken only during the first two days of the general season. Antlerless white-tailed deer may be taken without an antlerless deer permit required by \$65.27 of this title (relating to Permits) and \$65.31 of this title (relating to Antlerless Mule Deer and White-tailed Deer Permits), except antlerless deer may be taken only by antlerless permits authorized by \$65.26 of this title (relating to Deer Management Plan).
- (iv) In Anderson, Armstrong, Austin, Bastrop, Borden, Brazos, Briscoe, Burleson, Caldwell, Camp, Carson, Chambers, Cherokee, Collingsworth, Colorado Childress, (north of the Colorado River), Cottle, Crane, Crosby, Delta, DeWitt, Dickens, Donley, Ellis, Ector, Falls, Fannin, Fayette, Floyd, Foard, Fisher (east of State Highway 70), Franklin, Freestone, Garza, Gray, Guadalupe (north of IH-10 and west of State Highway 123), Gregg. Grimes, Hall, Harris, Hardeman, Haskell, Hopkins, Houston, Hutchinson, Jefferson, Jones, Kent (north of U.S. Highway 180), King, Knox, Lamar, Lavaca (north of U.S. Highway 90A and west of U.S. Highway 77), Lee, Leon, Limestone, Lipscomb, Loving, Madison, Midland, Milam, Montgomery, Motley, Navarro, Ochiltree, Orange, Randall, Rains, Roberts, Robertson, San Jacinto, Smith, Stonewall, Swisher, Titus, Upshur, Upton (north of U.S. Highway 67 and west of state highway 349), Van Zandt, Walker, Waller, Ward, Washington, Wichita, Wilbarger, Wood Counties, there is an open season for buck white-

- tailed deer only, except that antierless deer may be taken only by the antierless permit authorized by a Deer Management Plan (see §65.26 of this title (relating to Deer Management Plan)).
- (I) Open season: second Saturday in November through the first Sunday in January. This subclause becomes effective September 1, 1994.
- (II) Bag limit: three deer, no more than one buck.
- (III) Antierless deer may be taken only by antierless permits authorized by §65.26 of this title (relating to Deer Management Plan).
- (v) In Hartley, Oldham, and Potter, there is an open season for buck white-tailed deer only, except that antierless deer may be taken only by the antierless permit authorized by a Deer Management Plan (see §65.26 of this title (relating to Deer Management Plan)).
- (I) Open season: Saturday before Thanksgiving for 16 consecutive days.
- (II) Bag limit: three deer, no more than one buck.
- (III) Antlerless deer may be taken only by antlerless permits authorized by §65.26 of this title (relating to Wildlife Management Plan).
- (vi) In Hunt County, there is an open season for buck white-tailed deer only, except that antierless deer may be taken only by the antierless permit authorized by a Deer Management Plan (see §65.26 of this title (relating to Deer Management Plan)).
- (I) Open season: second Saturday in November for nine consecutive days. This subclause becomes effective September 1, 1994.
- (II) Bag limit: three deer, no more than one buck.
- (III) Antierless deer may be taken only by antierless permits authorized by \$65.26 of this title (relating to Deer Management Plan).
- (vii) In Henderson County, there is an open season for buck whitetailed deer only, except that antierless deer may be taken only by the antierless permit authorized by a Deer Management Plan.

- (I) Open season: second Saturday in November through the first Sunday in January. This subclause becomes effective September 1, 1994.
- (II) Bag limit: three white-tailed deer, no more than one buck and no more than two antierless deer, antierless deer by permit only.

Robertson County to its confluence with the Brazos River:

- [(-e-) The Neches River from State Highway 294 in Cherokee County to U. S. Highway 69 in Jasper County and from FM Road 1013 in Jasper County to IH-10 in Jefferson County;
- [(-f-) The Sabine River from Lake Tawakoni Dam to U.S. Highway 80 in Van Zandt County and from State Highway 63 in Newton County to Sabine Lake:

- [(-g-) The San Antonio River and Coleto Creek (exclusive of Coleto Creek Reservoir) in Goliad and Victoria Counties;
- [(-h-) The San Bernard River between Austin and Colorado Counties: and
- [(-i-) Yegua Creek from Somerville Dam to its confluence with the Brazos River.

It is unlawful to take game fish on any gear except pole and line or rod and reel, except channel, blue, and flathead catfish may be taken by trotline, and [that] red drum, sharks, and spotted seatrout may be taken by sail line. Cast nets not exceeding 14 feet in diameter and 20-foot minnow seines may be used for taking bait. Dip nets and gaffs may be used only in aiding to land fish caught on other legal devices except that gaffs may not be used to land fish below the minimum or above the maximum size limits.





## Adopted Sections

An agency may take final action on a section 30 days after a proposal has been published in the *Texas Register*. The section becomes effective 20 days after the agency files the correct document with the *Texas Register*, unless a later date is specified or unless a federal statute or regulation requires implementation of the action on shorter notice.

#### TITLE 37. PUBLIC SAFETY AND CORREC-TIONS

Part I. Texas Department of Public Safety

Chapter 1. Organization and Administration

Personnel and Employment Policies

• 37 TAC §§1.22, 1.23, 1.32, 1.34, 1.36

The Texas Department of Public Safety adopts amendments to §§1.22, 1.23, 1.32, 1.34, 1.36, concerning personnel and employment policies. Section 1.32 was adopted with changes to the proposed text as published in the January 8, 1993, issue of the Texas Register (18 TexReg 154). Sections 1.22, 1.23, 1.34, 1.36 are adopted without changes and will not be republished.

The adoption of these sections will ensure that applicants for positions with the department will be screened on the basis of jobrelated requirements in compliance with the Americans with Disabilities Act. The last statement in §1.32(b)(9) was published incorrectly in the *Texas Register* which is now rewritten for clarification purposes.

Adoption of these amendments comply with the provisions of the Americans with Disabilities Act. Language is added and deleted in §§1.22, 1.23, 1.32, and 1.34 to revise the screening and basic requirements for certain positions in order that medical and physical requirements are related to the performance of essential job functions. Section 1.36 is amended by changing the word handicap to disability.

No comments were received regarding adoption of these amendments.

The amendments are adopted under the Texas Government Code, §411.006(4) and §411.004(3), which provides the director with the authority to adopt rules necessary for the control of the department, subject to the Public Safety Commission's approval.

§1.32. Basic Requirements for Employment as Trooper.

(a) Application requirements.

(1)-(8) (No change.)

(9) All applicants for a position with the department must pass a physical

examination and the physical demands work Texas Department of Public Safety Page 7 of 14 Chapter 1. Organization and Administration sample tests prior to probationary appointment. The physical demands work sample tests will be conducted by the Department of Public Safety personnel. The physical examination will be made by a physician designated by the department after a conditional job offer has been made.

#### (10)-(11) (No change.)

- (b) Medical-physical standards. Applicants must conform to the following medical-physical standards.
- (1) Weight. Not less than two pounds per inch of height nor more than three pounds per inch of height for males and not less than 1 3/4 pounds per inch of height nor more than 2 1/2 pounds per inch of height for females and according to body build.

#### (2) Vision.

- (A) Visual acuity. Maximum uncorrected visual acuity of 20/200 and correctable or corrected as follows:
- (i) 20/30 thru 20/40-correctable to 20/30 in each eye and binocularly;
- (ii) in excess of 20/40 thru 20/100-must be corrected to 20/30 in each eye and binocularly by means of eyeglasses or contact lenses;
- (iii) in excess of 20/100 thru 20/200-must be corrected to 20/30 in each eye and binocularly by contact lenses and a statement from an ophthalmologist that no ocular disease exists.
- (B) Field of vision. Horizontal 60-85 degrees temporally from a central fixation point.
- (C) Muscular imbalance. Zero vertical deviation. Horizontal-5 prism diopters exophoria at 20 feet, 10 prism diopters esophoria at 20 feet.
- (D) Other visual factors. Applicants will be rejected for color deficiencies as determined by Department of Public Safety testing, chronic inflammation of the eye or adnexa, or permanent abnormalities

of either eye (including cataracts, corneal opacities, paralysis of ocular muscles, etc.). Loss of either eye will reject.

- (3) Ears. Normal hearing with or without a hearing aid for each ear is required.
- (4) Heart. The action of the heart must be uniform, free, and steady, its rhythm regular, and the heart and vascular system free from organic changes. Organic heart disease will disqualify.
- Circulation. Blood pressure-systolic maximum, 139; diastolic, 89; pulse pressure, 45. A slight variation from these figures may be permissible subject to the discretion of the examining physician. Hypertension that is controlled by medication to within the limits set forth herein is acceptable. The applicant must furnish a medical statement describing the medication and any warnings or cautions for proper safeguards against physical conditioning techniques with a statement furnished by a physician. It is also very important that the training academy and DPS physical training officer know when a trainee is taking medication. A marked tendency to the formation of varicose veins must reject.
- (6) Respiration. Must be full, easy, and regular; the respiratory murmur must be clear and distinct over both lungs, and no disease of the respiratory organs must be present.
- (7) Hernia. An actual hernia in any form must reject.
- (8) Genito-Urinary. Applicants must be free from stricture or incontinence of urine. Kidneys or kidney must be healthy and the urine normal.
- (9) Limbs. Both arms and legs, hands, and feet must be present. Must be free from infections of the joints, sprains, stiffness, or other conditions which prevent the proper and easy performance of duty. Great toes must be present in their entirety on both feet. First (index), second (middle), and third (ring) fingers and thumb must be present in their entirety on both hands. The provisions of this paragraph may be waived by the director.
- (10) Brain and nervous system. An applicant who has a history of epilepsy, blackouts, fainting spells, seizures, or con-

vulsions must be seizure free for two years without taking medication.

- (11) Mental and personality. Applicants must be mentally alert and sound of mind and must be possessed of initiative, intelligence, good judgment, good address, and neatness of appearance.
- (12) Physical agility tests. Applicants for a position with the department must pass the physical agility tests which are set out by the department.
- (13) Diabetes. Applicants with insulin-dependent diabetes will be rejected.

Applicants who have a history of diabetes, but whose diabetes is controlled by diet alone or diet and oral hypoglycemic agents, will be considered on a case-by-case basis.

(14) Questions. In all instances where a question may arise as to whether an applicant meets the medical-physical standards, the director or his designee shall make the final determination as to whether an applicant is physically qualified for acceptance as a trooper.

### **Open Meetings**

Agencies with statewide jurisdiction must give at least seven days notice before an impending meeting. Institutions of higher education or political subdivisions covering all or part of four or more counties (regional agencies) must post notice at least 72 hours prior to a scheduled meeting time. Some notices may be received too late to be published before the meeting is held, but all notices are published in the *Texas Register*.

**Emergency meetings and agendas.** Any of the governmental entities named above must have notice of an emergency meeting, an emergency revision to an agenda, and the reason for such emergency posted for at least two hours before the meeting is convened. Emergency meeting notices filed by all governmental agencies will be published.



## Questions Concerning Integrated Resource Planning

The Public Utility Commission of Texas requests interested persons to comment on whether the commission should adopt rules requiring electric utilities to adopt integrated resource plans. On January 26, 1992, the commission considered whether to publish a rule prepared by the commission staff that would have required electric utilities to file integrated resource plans. Should the commission require electric utilities to file integrated resource plans?

Should the commission change its procedures related to resource planning to consolidate existing avoided cost, NOI proceedings, and energy efficiency and load forecast filings into a more rational scheme? If so, should the commission require that utilities seek NOI approval in conjunction with the approval of a resource plan?

Should the commission require utilities to permit the public to participate in the resource planning process? Is the participation process set forth in the staff's proposed rule appropriate? Should the commission require periodic approval of utilities' integrated resource plans?

Should the commission monitor utilities' implementation of resource plans? Does the proposal give utilities sufficient flexibility or should the rules be more prescriptive?

Should the commission prescribe the criteria for selecting resources in the resource planning process? Are the selection criteria in the staff's proposed rule appropriate?

Should the commission require utilities to consider environmental externalities in assessing resources? Are the selection criteria in the staff's proposed rule related to environmental externalities appropriate?

Should the commission use the committed-unit-basis methodology for calculating avoided costs as the primary basis for comparing purchased power arrangements with other resource options?

Should the commission treat all units that a utility has under construction as avoidable units that are subject to being replaced by power supplied by qualifying facilities?

Should the commission assess the historical performance of a utility's demand-side management programs as a part of the approval of a resource plan?

Are the filing requirements for an integrated resource plan, as set out in the staff's proposed rule, appropriate? Please indicate which requirements are too burdensome or too general.

Do you agree with the staff proposal insofar as it specifies the utilities that are required to file an integrated resource plan or a load forecast or make no filing?

Will the time required for processing a resource plan application, a solicitation, and a certificate of convenience and necessity permit utilities to carry out a practical and economical resource acquisition?

#### Request for Proposal
