How To Cite: Material published in the *Texas Register* is referenced by citing the volume in which a document appears, the words "TexReg," and the beginning page number on which that document was published. For example, a document published on page 2402 of Volume 6 (1981) is cited as follows: 6 TexReg 2402.

In order that readers may cite material more easily page numbers are now written as citations. Example: on page 2 in the lower left-hand corner of the page, would be written: "13 TexReg 2 issue date," while on the opposite page, page 3, in the lower right-hand corner, would be written "issue date 13 TexReg 3."

How To Research: The public is invited to research rules and information; of interest between 8 a.m. and 5 p.m. weekdays at the Texas Register office, 503E Sam Houston Building, Austin. Material can be found using Texas Register indexes, the Texas Administrative Code, sections number, or TRD number.

Texas Administrative Code

The Texas Administrative Code (TAC) is the approved, collected volumes of Texas administrative rules.

How To Cite: Under the TAC scheme, each agency section is designated by a TAC number. For example in the citation 1 TAC §27.15:

1 indicates the title under which the agency appears in the *Texas Administrative Code*;

TAC stands for the Texas Administrative Code;

§27.15 is the section number of rule (27 indicates that the section is under Chapter 27 of Title 1; 15 represents the individual section within the chapter).



Attorney General

Description of Attorney General submissions. Under provisions set out in the Texas Constitution, Texas Civil Statutes, Article 4399, and numerous statutes, the attorney general is authorized to write advisory opinions for state and local officials. These advisory opinions are requested by agencies or officials when they are confronted with unique or unusually difficult legal questions. The attorney general also determines, under authority of the Texas Open Records Act, whether information requested for release from governmental agencies maybe held from public disclosure. Requests for opinions, opinions, and open record decisions are summarized for publication in the *Texas Register*.

Opinions

JM-886 (RQ-1252). Request from Kenneth W. Littlefield, Commissioner, Texas Department of Banking, Austin, concerning the constitutionality of Texas Civil Statutes, Article 342-803a, which permits the sale of the assets of a bank without shareholder approval in certain circumstances.

Summary of Opinion. The Texas Banking Code of 1943, Article 342-803a, which permits the banking commissioner to approve the sale of the assets of a banking corporation by its directors in certain situations specified in the statute, is a constitutional exercise the legislature's power to provide for a safe banking system. Shareholders in banking corporations organized under the Banking Code have no right to approve the sale of all, or substantially all, of the assets of the banking corporation, unless they have reserved such a right by means of a corporate by-law. The legislature has, by means of its reserved power to amend the Banking Code, overridden such by-laws in the case of banking corporations operating within the circumstances specified in Texas Civil Article 342-803a. Statutes. 8804527

Open Records Decisions

JM-493 (RQ-1273). Request from Fred S. Brinkley, Jr., Executive Director/Sectretary, Texas Board of Pharmacy, Austin, concerning whether information regarding negotiations about disciplinary action taken by the Texas State Board of Pharmacy against a licensee is available to the public under the Open Records Act, Texas Civil Statutes, Article 6252-17a.

Summary of Decision. Open Records Decision Number 474 (1987) is an accurate statement of the law. The Texas Board of Pharmacy may withhold "investigative files," including documents prepared for internal board use that relate to fact gathering by the board's staff or that assess the validity of complaints pursuant to the Texas Open Records Act, §3(a)(1) of the Texas Civil Statutes, Article 6252-17a, in conjunction with Texas Civil Statutes, Article 4542a-1, §17(q). This confidentiality for "investigative files" does not protect from disclosure correspondence between the board and licensees relating to informal conferences, proposed notice of hearings

and charges, or agreed board orders.

With regard to additional arguments you raise, §3(a)(3), protects from disclosure these latter categories of information only when they are prepared by the board's staff and when withholding the information is necessary to preserve the board's strategy or interest with regard to licensees who have not seen the information. Section 3(a)(8), applies only if the board investigates violations of criminal law and the release of the investigations would unduly interfere with law enforcement.

Section 3(a)(1) of the Open Records Act in conjunction with Texas Civil Statutes, Article 4542a-1, subsection 27A(d), protects from public disclosure records relating to proceedings of the board to investigate reports about pharmacists "impaired" by chemical abuse or mental or physical illness. TRD-8804529

ORD-494(RQ-1263). Request from Allen Beinke, Executive Director, Texas Water Commission, Austin concerning whether federally required reports of releases of certain hazardous substances into the environment are excepted from disclosure under the Texas Open Records Act, Texas Civil Statutes, Article 6252-17a, when the reports indirectly reveal customer list information.

Summary of Decision. Federally required reports provided to the Texas Water Commission about releases of hazardous substances into the environment that indirectly reveal customer identities are not excepted from disclosure under the Texas Open Records Act, §3(a)(10), Texas Civil Statutes, Article 6252-17a, when the governmental agency or private entity seeking confidentiality fails to establish that the customer information is maintained as a trade secret or that its release would cause substantial competitive injury. TRD-8804528

Chapter 3. Tax Administration

Subchapter V. Bingo Regulations and Tax 34 TAC §3.545

The Comptroller of Public Accounts proposes an amendment to §3.545 concerning licenses, fees, and bonds for conduct of bingo and commercial lessor. The amendment amends paragraph (a)(4) to increase the amount of estimated tax liability before a bond is required, and to provide for release, imposition, or reimposition of the bond based on the taxpaying history of the authorized organization. The amendment also repeals the current subsections (e) and (k) which duplicate provisions in the Bingo Enabling Act and reletters other subsections.

Ben Lock, director of the comptroller's economic analysis center, has determined that for the first five-year period the proposed section is in effect there will be no fiscal implications for state or local government or small businesses as a result of enforcing or administering the section.

Mr. Lock also has determined that for each year of the first five years the section is in effect the public benefit anticipated as a result of enforcing the section will be an increase in the amount of estimated tax liability necessary before a bond is required, and provide for release, imposition or reimposition of the bond based on the taxpaying history of the authorized organization. There is no anticipated economic cost to individuals who are required to comply with the sections as proposed.

§3.545. Licenses, Fees, and Bonds for Conduct of Bingo and Commercial Lessor.

(a) Annual license to conduct bingo games.

(1)-(3) (No change.)

(4) Bond or other security. Each application for an annual license to conduct bingo must be accompanied by a bond or other security equal to the applicant's estimated quarterly tax liability. If the amount is estimated to be less than \$1,900 [\$950], no bond or other security will be required, unless the comptroller determines a bond or other security is necessary based on the applicant's history at recordkeeping, reporting, and payment of tax. No new bond will be required upon renewal if the licensee would be eligible to have an existing bond released under subparagraph (D) of this paragraph. If a bond or other form of security is required, no license will be issued until such bond or other security has been posted.

(A)-(C) (No change.)

(D) Release. [A bond must be posted at all times while a license is in effect.] If the licensee ceases to conduct bingo games and relinquishes its license or if the license is revoked by the comptroller for any reason, the comptroller will release any bond or security on his determination that no amounts of tax, penalty, or interest remain due and payable under the Act. If the licensee has filed all required returns, has no outstanding amounts of tax, penalty or interest due and payable under the Act, and has completed seven consecutive quarters without a deficiency determination becoming final the bond or security will be released at the time the licensee next renews its license.

(E) Reinstatement. If a deficiency determination becomes final for a ficensee who has had its bond released or for whom a bond was not required a new bond will be required at the time the licensee next renews its license.

(b)-(d) (No change.)

[(e) Supplemental information. In addition to the application form, the applicant or licensee must submit any supplemental information requested by the comptroller within the time limit set by the comptroller. Failure to timely submit any of the requested supplemental information is grounds for denial of the license sought or revocation of a license held.]

(e)[(f)] License to operate. Each ap-

plicant for a license to operate bingo games must demonstrate that it is organized and operated primarily for purposes other than the operation of bingo activities.

(f)[(g)] Payment of fees. The proper license fee must accompany each application. License fees will not be prorated. The fee and any cash bond must be in the form of cash, cashier's check, money order, or check made payable to the state treasurer. After the filing of the application, fee, and any required bond, the comptroller will promptly investigate the qualifications of the applicant and either:

(1)-(3) (No change.)

(g)[(h)] Notification of election results. No license will be issued until the comptroller receives from the appropriate governing body written notification of the date and results of a legalization election along with a map of the boundaries in which games may be held.

(h)[(i)] Copies of applications. No license or amended license will be issued before a copy of each original application or application for amendment is sent by the applicant to the appropriate governing body of the area in which the games are to be held.

(I)[(j)] Copies of licenses. Upon receipt of any license or amended license issued by the comptroller, the licensee must immediately send a copy to:

(1)-(2) (No change.)

[(k) Display of license. Every license and amendment issued by the Comptroller must be conspicuously displayed on the premises at all times during the conduct of bingo so that it can be easily read by any patron.]

(j)[(1)] Transfer of license. Licenses and renewals issued by the Comptroller may not be transferred or assigned.

(k)[(m)] Amendments.

(1)-(2) (No change.)

(I)[(n)] Notification of changes. Each licensee has a continuing responsibility to promptly notify the comptroller in writing of any changes to information in a filed application, when information filed with the comptroller becomes inaccurate in any way, or when additions or deletions are necessary to reflect changes in circum-

stances of the licensee. Examples of such changes include the name of organizational officers, the amount of rent charged for leased premises, the name of a member responsible for the conduct of games or the name of an individual connected with a commercial lessor that would affect its eligibility to hold a license and, in the case of lessors, the name of a new, authorized organization that intends to lease premises from it for the purpose of conducting bingo.

The Comptroller of Public Accounts proposes an amendment to §3.547, concerning books and records-bingo licensees. The amendment deletes subsection (a)(2)(D), which requires keeping of a daily schedule of prizes. The amendment adds subsection (d) allowing a licensed authorized organization to loan money from its general fund to its bingo account upon written approval by the comptroller. The amendment also adds as subsection (e) language from the existing §3.559, concerning books and records - commercial lessors licensed to conduct bingo.

(b)-(c) (No change.)

- (d) Loans to the bingo account.
- (1) A licensed authorized organization or an organization applying for a license to conduct bingo may loan money to its bingo account from itsgeneral fund if:
- (A) a request is filed with the comptroller which states:
 - (i) the amount of the
 - (ii) the purpose of the

loan; and

loan:

(iii) a repayment schedule for the loan which is 12 months or less; and

- (B) the comptroller approves the loan. Prior to approval the comptroller must find that:
 - (i) the loan is necessary;

and

(ii) the repayment schedule is reasonable.

- (2) The comptroller may consider the organization's financial condition as reflected in all available information including past quarterly reports prior to the approval of the loan request.
- (3) The loan transactions must be reported on the quarterly reports as follows:
- (A) loan proceeds must be reported as interest earned for the quarter in which they are received; and
- (B) loan payments must be reported as expenses for the quarter in which they are paid.
 - (4) Failure to repay the loan,

with proceeds from the bingo account, pursuant to the repayment schedule is a violation of this section and may result in suspension, revocation, or denial of the renewal of an organization's license to conduct bingo.

- (5) The records to document loans from the general fund must show:
- (A) the date and amount of the loan; and
- (B) the dates and amounts of all loan payments.
- (e) Commercial lessors licensed to conduct bingo.
- (1) This subsection applies to authorized charitable organizations which are licensed to conduct bingo and are also licensed to lease their premises to other organizations conducting bingo.
- (2) An organization to which this subsection applies shall deposit in from authorized organizations its bingo checking account all rental payments from authorized organizations conducting bingo at the location of the lessor under a temporary license, an annual license, or a temporary authorization to conduct bingo. A rental payment must be deposited in the bingo checking account not later than the end of the next business day after it is received.
- (3) Rental payments required by this subsection to be deposited in the bingo bank account are not part of gross receipts for purposes of the bingo gross receipts tax. Such rental payments are not considered in computing adjusted gross receipts under §3.555 of this title (relating to Minimum Charitable Distribution). Distributions for charitable purposes of such funds from the bingo checking account will be considered as part of the disbursements toward meeting that minimum charitable distribution requirement under §3.555 of this title (relating to Minimum Charitable Distribution).

The Comptroller of Public Accounts proposes an amendment to §3.549, concerning allow-

able expenditures of receipts from bingo. The amendment amends subsection (a)(2) to limit the amount of compensation which may be paid by a licensee to (i) accountants andor bookkeepers (other than accountants andor bookkeepers licensed by the Texas State Board of Public Accountancy), (ii) security personnel, and (iii) janitorial personnel. The amendment is intended to clearly inform licensees and their employees who are engaged to perform accounting andor bookkeeping, security, and janitorial services pursuant to the Act of terms and restrictions to which they may be subject. The amendment also repeals the present subsections (d) and (e), which duplicate provisions in the Bingo Enabling Act, and reletters other subsections.

The amendment is intended to clarify what is to be considered as "reasonable compensation" which is authorized pursuant to the Bingo Enabling Act, §19(c), to be paid by a licensed organization for services related to bingo. The amendment implements the statement of legislative purpose expressed in the Bingo Enabling Act, §16(a), of discouraging the commercialization of bingo and maximizing the availability of bingo proceeds for charitable purposes.

- (F) security during bingo games, limited as provided in paragraph (2) of this subsection;
- (G) [The portion of lease] lease payments [not treated as a qualifying distribution under §3.555 of this title (relating to Certain Charitable Distributions)];

(H)-(L) (No change.)

- (2) the payment of necessary and reasonable compensation actually incurred and paid in connection with the conduct of bingo for the following personnel and no others:
- (A) the total amount paid to all bookkeepers or [,] accountants, not to exceed \$50 per occasion, provided that the limit imposed by this paragraph shall not apply to certified public accountants or any other individual, partnership or corporation registered with and licensed by the Texas State Board of Public Accountancy; [or]

(B) attorney;

(C)[(B)] cashiers, not to exceed \$50 per cashier per occasion;

(D)[(C)] users, not to exceed \$50 per usher per occasion;

(E)[(D)] the total amount paid to all callers, not to exceed \$50 per occasion;

(F)[(E)] security or guard services, not to exceed \$50 per guard per occasion; and

(G)[(F)] janitorial services, not to exceed \$50 per janitor per occasion.

(H) for an individual employed by any licensed organization to perform more than one of the services listed in paragraph (2)(C), (D), (E), and (F) of this subsection, the total compensation paid to the individual may not exceed \$50 per bingo occasion.

(3) (No change.)

(b) Upon written request by a licensee, the comptroller will issue a ruling on the legality of a proposed expenditure out of bingo reciepts or of a proposed disbursement for charitable purposes. Ruling requests should be addressed to the Regulatory Tax [Bingo Regulation] Division, Comptroller of Public Accounts, Austin, Texas 78774.

- (c) (No change.)
- [(d) No part of the net proceeds, if they are given to any person or organization for charitable purposes, may be used by the donee either:
- [(1) to pay for services or materials supplied in connection with the conduct of bingo by the donor organization; or
- [(2) for any activities which would not be charitable purposes if the donor had conducted the activities.
- [(e) No part of the net proceeds may be used, directly or indirectly, to support or oppose a particular candidate or a slate of candidates for public office, to support or oppose any measure submitted to a vote of the people, or to influence or attempt to influence legislation.]
- (d)[(f)] The license of any authorized organization which does not distribute the required amount of proceeds for charitable purposes during any quarter may be suspended or revoked.
- (e)[(g)] No expenses may be paid out of the petty cash fund, except for emergency expenses validated by proper receipts.
- (f)[(h)] The only expenses that may be paid from the petty cash fund are expenses necessary to continue or complete the operation of a bingo occasion.

§3.562. Unauthorized Prizes.

- (a) Construction. The prohibition contained in this section shall be broadly construed in order to carry out the legislative purpose expressed in House Bill 1043 of prohibiting all door prizes or other prizes in addition to those given for winning individual bingo games.
- (b) Definitions. The following words and terms, when used in this section, shall have the following meanings, unless the context clearly indicates otherwise.
- (1) Person—An individual, partnership, corporation, or other group, however organized, whether or not licensed or required to be licensed under the Bingo Enabling Act.
- (2) Present at a bingo occasion and participating in a bingo occasion—Being present at or participating in any activity at the bingo location during the time when people are gathered for the purpose of playing bingo, including times before, during, between, and after bingo games.

- (3) Prize—Money or anything of value offered or awarded to one or more persons present at a bingo occasion, whether offered or awarded at that occasion or awarded at a different time or place.
- (c) Extra prizes prohibited. No authorized organization, lessor, or other person may offer or award any prize to any person or persons present at a bingo occasion other than the prizes awarded for winning the individual bingo games authorized under the Bingo Enabling Act. This includes any activities while persons are present at a bingo occasion in connection with the offering or awarding of such prizes. Such prohibited activities include, but are not limited to:
 - (1) the handing out of tickets;



The corrections were to subsection (a)(1), where the spelling the word pastime was corrected, subsection (a)(1)(F)(iii), where the word boat was omitted from the proposed version and where the reference to horse-drawn carriages was deleted, and the insertion of subsection (a)(1)(F)(vi), which had also been omitted.





Pat D. Westbrook, executive director of the Texas Commission for the Blind, has announced the availability of Title VII, Part A funds to contract for independent living skills training for legally and totally blind individuals.

Funding Areas. Applications will be considered for facilitics eligible under 34 Federal Regulations 361.63 for independent living skills training.

Objectives. The primary objective of the Independent Living Rehabilitation Program is to enable legally and totally blind persons without vocational potential to live independently with their families and/or in their communities and to avoid institutionalization. This is achieved via the provision of independent living skills training, adaptive aids, and assistance in providing physical restoration. The Commission for the Blind intends to enter into contract with facilities to provide various independent living skills training programs on a fee for services basis to clients determined eligible by the commission. Funds available for this purpose total \$21,494.

Examples of training include: peer counseling groups; recreation groups; braille instruction groups; and other individual or group training which will benefit blind persons with a wide range of disabilities in terms of independence.

Targeted Population. Individuals served under these contracts are persons who are legally or totally blind and who have met the basic requirements for receiving ILR services which are: (1) there is a presence of a severe physical or mental disability, which for the purposes of this contract, is or includes legal or total blindness; (2) the presence of a severe limitation in ability to function independently in the family or the community or to engage work, continue employment; and (3) a reasonable expectation that independent living rehabilitation services will significantly assist the individual to improve his/her ability to function independently in the family or community or to engage or continue in employment.

All clients served under these contracts must be determined to be eligible by the local Texas Commission for the Blind.

Who Is Eligible To Apply. Local public agencies and private non-profit organizations who provide independent living skills training are eligible to apply for contracts. Section 365.12 of the Federal Regulations states: Any agency, organization, or facility awarded a grant by the state unit must assure that severely handicapped individuals are fully involved in policy and program development activities affecting the provision of independent living rehabilitation services. Contracts will be awarded only in those cities or regions where the commission presently has an ILR caseload. The cities or regions are as follows: Houston, Corpus Christi, Tyler, Harlingen, San Antonio, and Odessa.

Application Procedures. Submit to Mr. Bill Agnell, Program Specialist, Texas Commission for the Blind, P.O. Box 12866, Austin, Texas 78711: A narrative no longer than five typed pages which describes: your organization; individuals you now serve; the quality and extent of services to be provided; how proposed services would augment those presently available; and cost per person per hour for proposed training. Also include: qualifications of key personnel; a letter from the executive director or chairman of the board of your organization supporting your request and your proposed plan; you may, as an appendix, supply additional information about your organization and past achievements in serving the disabled in general and the blind in particular.

All Applications Must Be Postmarked No Later Than June 10, 1988. Interested parties are urged to contact Texas Commission for the Blind with related questions prior to drafting proposals, to facilitate the request for proposals process. Method of Payment. Facility will be reimbursed monthly via: monthly submission of voucher with detail listing of services provided; TCB review and approval of submitted material.

Non-Duplication of Services. Fees for services will not be paid to reimburse services provided by staff currently funded through existing grants.

Review Criteria. The criteria used by reviewers to evaluate proposals are as follows. The proposal addresses the explicit purpose of the RFP and has specific, measurable goals. The applicant provides evidence of their professional and organizational familiarity and expertise with the RFP subject matter and their capacity to achieve the objectives of the contract in a timely manner. The facility states that they are free of architectural and communication barriers. The facility agrees to provide services to clients in locations accessible to clients, including residences, if required. The facility's services provide alternatives to institutionalization. The applicant indicates that individuals with severe handicaps are involved in policy and program development decisions.

Weekly Report on the 1988 Allocation of the State Ceiling on Certain Private Activity Bonds

The Tax Reform Act of 1986 (the "Tax Act") imposes a

volume ceiling on the aggregate principal amount of private activity bonds that may be issued within the State of Texas during any calendar year. The state ceiling for Texas, imposed by the Tax Act for calendar year 1988 is \$834,100,000.

State legislation, Senate Bill 1382, Chapter 1092, Acts of the 70th Legislature, (the Act), established the allocation process for the State of Texas. The Act specifies that one-third of the state ceiling is to be made available to qualified mortgage bonds and of that one-third, one-third is available to the Texas Housing Agency. One-fourth of the state ceiling is available to state-voted issues, and the balance of the state ceiling is available for all other issuers of bonds requiring an allocation.

Pursuant to the Act, the aggregate amount for qualified mortgage bond subceiling is \$278,033,300 with \$185,355,500 available to the local housing authorities and \$92,677,800 available to the Texas Housing Agency. The aggregate amount for state-voted issues is \$208,525,000 and the amount for all other bonds requiring an allocation is \$347,541,700.

Generally, the state ceiling is allocated on a first-come, first-served basis, with the Texas Department of Commerce (the department) administering the allocation system.

The Texas Department of Health submitted an adapted amendment which contained an error as submitted by the department in the February 12, 1988, issue of the *Texas Register* (13 TexReg 780).

In §325.133, the last sentence of the opening paragraph

(implied (a)) should read: "Failure to prevent disposal of unauthorized waste shall be deemed a significant threat to public health or the environment and shall be grounds for the department to initiate permit revocation procedures and/or referral to the attorney general for legal relief."


