the words "TexReg," and the beginning page number on which that document was published. For example, a document published on page 2402 of Volume 6 (1981) is cited as follows: 6 TexReg 2402.

In order that readers may cite material more easily, page numbers are now written as citations. Example: page 2 in the lower left-hand corner of this page is written: "7 TexReg 2 issue date," while on the opposite page, in the lower right-hand corner, page 3 is written "issue date 7 TexReg 3."

How To Research: The public is invited to research rules and information of interest between 8 a.m. and 5 p.m. weekdays at the Texas Register Division office, 503E Sam Houston Building, Austin. Material can be found by using Register indexes, the Texas Administrative Code (explained below), rule number, or TRD number.

Texas Administrative Code

TAC stands for the *Texas Administrative Code*; **\$27.15** is the section number of the rule (27 indicates that the rule is under Chapter 27 of Title 1; 15 represents the individual rule within the chapter).

The Governor

As required by Texas Civil Statutes, Article 6252-13a, §6, the *Register* publishes executive orders issued by the Governor of Texas. Appointments made and proclamations issued by the governor are also published. Appointments are published in chronological order.

Additional information on documents submitted for publication by the Governor's Office can be obtained by calling (512) 475-3021.

Brucellosis Proclamation 41-1852

This proclamation shall receive a unique identifying number from the Secretary of State of the State of Texas and shall hereafter be identified by such number.

This proclamation supersedes and takes the place of the proclamation known as Proclamation by the Governor Number 432 as amended January 29, 1982.

This proclamation has the effect of extending, until June 1, 1983, unless sooner revoked or amended, the rules of the Texas Animal Health Commission regarding brucellosis, which were due to expire April 9, 1982.

WHEREAS, the Texas Animal Health Commission has submitted quarterly reports to the governor for the period covering April through December, 1981, including statistical data which indicate progress in terms of an improved brucellosis control and eradication program with greater emphasis on vaccination than on test and slaughter; and

WHEREAS, the Texas Animal Health Commission's data, a compilation of which is attached hereto as Exhibit I, indicate such progress is reflected, in part, by trends in the number of calfhood vaccinations which has increased from 298,444 in 1978, to 839,952 in 1981, and 564,078 for the five-month period of October, 1981, through February, 1982; and by trends in the Market Cattle Identification Rate (MCI) which has decreased from 1.432% in 1978 to 0.969% in 1981; and

WHEREAS, pursuant to Proclamation of the Governor Number 432 as amended January 29, 1982, the Special Committee for Evaluation of the Texas Brucellosis Program has met and issued a report to the governor on the progress of the program, attached hereto as Exhibit II; and

WHEREAS, the Special Committee for Evaluation of the Texas Brucellosis Program has recommended in its report to the governor that the Texas Animal Health Commission should promote vaccination by educating cattlemen and the general public about the economic advantages of calfhood and adult vaccination, and by encouraging the U.S. Department of Agriculture to ease movement restrictions on cattle vaccinated with reduced dose strain 19 vaccine; and

WHEREAS, the Special Committee for Evaluation of the Texas Brucellosis Program has recommended in its report to the governor that research conducted at Texas A&M University's Agricultural Experiment Station should be continued; and

WHEREAS, the Special Committee for Evaluation of the Texas Brucellosis Program has stated that its recommendations were based on a consensus that the elimination of brucellosis and the need for testing and slaughter is a desirable goal but that due to the low vaccination rate currently existing in Texas, it is not practical to eliminate these procedures at this time; and

WHEREAS, pursuant to Proclamation of the Governor Number 432 as amended January 29, 1982, the Texas Animal Health Commission has adopted new recommendations by commission resolution dated March 11, 1982, and attached hereto as Exhibit III; and

WHEREAS, the commission's executive director submitted the commission's resolution and recommendations to the governor on March 15, 1982, as adopted by the commission at its meeting on March 11, 1982; and

WHEREAS, the Texas Animal Health Commission in its March 11, 1982, resolution has certified to the governor that the commission intends to conduct a final hearing by June 9, 1982, for adopting new calfhood vaccination regulations requiring vaccination of all breeding heifer cattle born after January 1, 1982, if being moved into the state or if changing ownership, and, states that it is the commission's objective to continue to place more emphasis on vaccination than on test and slaughter; and

WHEREAS, the Texas Animal Health Commission's March 11, 1982, resolution included a recommendation that brucellosis regulations proclaimed by the governor on January 29, 1982, be continued in effect after April 9, 1982; and

WHEREAS, the Texas Animal Health Commission's March 11, 1982, resolution and recommendations are predicated upon the continued use of the present program of surveillance with testing followed by slaughter of infected animals, and that future commission decisions will be based upon recommended changes that are epide:niologically sound, that are in accord with the national program, and that are adequately funded; and

WHEREAS, there are currently pending proposed federal regulations under the uniform methods and rules that will or should accommodate the goal of continuing to move toward a program which places more emphasis on vaccination than on test and slaughter; and

WHEREAS, there are currently pending federal budget proposals which will have a direct impact on both state and federal brucellosis programs; and

WHEREAS, marked progress has been accomplished and more progress can and should be accomplished in developing a program by moving away from the test and slaughter approach toward a program which emphasizes vaccination and utilizes testing surveillance as a means for monitoring program effectiveness and eliminating infected animals based on confirmatory laboratory testing.

NOW, THEREFORE, I, William P. Clements, Jr., Governor of Texas, under the authority vested in me do hereby proclaim that Proclamation by the Governor Number 432 as amended January 29, 1982, is superseded hereby, and the accompanying regulations are to be continued in effect from April 9, 1982, and will remain in effect, subject to appropriate amendment, until June 1, 1983, at which time they will cease to be in effect. On or before May 1, 1983, appropriate recommendations together with adopted regulations which continue to place greater emphasis on vaccination than on test and slaughter shall be made by the commission to the governor.

Quarterly reports, coinciding with the state fiscal year, including statistical data shall be submitted by the commission to the governor concerning the progress of the program. The quarterly reports shall document the nature of the commission's interactions with the U.S. Department of Agriculture and the U.S. Animal Health Association regarding changes in the federal program to accommodate the Texas position. The quarterly reports shall be accompanied by appropriate written recommendations for amendments to the program. The commission shall publish in the *Texas Register* the quarterly reports and the accompanying recommendations within 10 days after their submission to the governor.

The Texas Animal Health Commission shall hold quarterly public hearings in different locations in the brucellosis control areas or zones during each quarter. In addition to the notice required by law, written notice of these public hearings shall be given to those in the industry, the State Senators and Representatives and other interested parties in the respective zones. The Texas Animal Health Commission shall request newspapers in the zone to carry stories relating to the public hearing and the

subject matter to be covered. The public hearings shall address the progress of the program for the preceding quarter, recommendations for amendment to the regulations and public comments on the program. The Texas Animal Health Commission shall cause a verbatim transcript of each hearing to be made. A summary of the public meeting, together with the verbatim transcript, list of invitees, and copies of news stories, shall be filed with each quarterly report.

In consultation with the governor, the commission shall appoint an evaluation committee which is representative of all interests and persuasions in the Brucellosis Program and this evaluation committee shall conduct hearings between February 1 and March 1, 1983, and issue an evaluation report on the progress of the program's movement toward a program which places greater emphasis on vaccination than on test and slaughter. The report shall be filed with the governor on or before April 1, 1983.

This proclamation is effective April 9, 1982.

(Editor's note: The text of the brucellosis rules of the Texas Animal Health Commission are available for public inspection. The rules may be examined in the offices of the Texas Animal Health Commission, 1015 Sam Houston Building, Austin, and in the Texas Register Division office, 503E Sam Houston Building, Austin.)

An agency may take final action on a rule 30 days after a proposal has been published in the *Register*. The rule becomes effective 20 days after the agency files the correct document with the Texas Register Division, unless a later date is specified or unless a federal statute or regulation requires implementation of the action on shorter notice.

The document, as published in the *Register*, must indicate whether the rule is adopted with or without changes to the proposal. The notice must also include paragraphs which: explain the legal justification for the rule; how the rule with function; contain comments received on the proposal; list parties submitting comments for and against the rule; explain why the agency disagreed with suggested changes; and contain the agency's interpretation of the statute it adopted the action under.

If an agency adopts the rule without any changes to the proposed text, only the preamble of the notice and statement of legal authority will be published. The text of the rule, as appropriate, will be published only if final action is taken with alterations to the proposal. The certification information, following the submission, contains the effective date of the final action, the proposal's publication date, and a telephone number to call for further information.

TITLE 22. EXAMINING BOARDS Part XV. Texas State Board of Pharmacy

Chapter 291. Pharmacies

22 TAC §291.15

The Texas State Board of Pharmacy adopts new §291.15 without changes to the proposed text published in the March 12, 1982, issue of the *Texas Register* (7 TexReg 1019).

This rule is adopted to insure that pharmacists are in compliance with the Texas Pharmacy Act, House Bill 1628, Acts of the 67th Legislature, effective September 1, 1981. This rule identifies proper procedures a pharmacy must follow in order to comply with subsection (a) of §32 of the Act, which references the notification of the theft or significant loss of any controlled substance by a pharmacy.

No comments were received regarding adoption of the new section.

The new section is adopted under House Bill 1628, Acts of the 67th Legislature, 1981. Section 32 of the Act provides the Texas State Board of Pharmacy with the authority to require a pharmacy to report in writing to the board within 10 days of any of the following: permanent closing: change of ownership; change of location; change of pharmacist-in-charge; the theft or significant loss of any controlled substance on discovery of the theft or loss; the notification of theft or loss shall contain a list of all controlled substances stolen or lost; the sale or transfer of all controlled

substances or dangerous drugs on the permanent closing or change of ownership of a pharmacy; any matters and occurrences that the board may require by rule; and out-of-state purchases of controlled substances as determined by the board.

This agency hereby certifies that the rule as adopted has been reviewed by legal counsel and found to be a valid exercise of the agency's legal authority.



TITLE 28. INSURANCE Part I. State Board of Insurance

(Editor's note: Because the State Board of Insurance rules have not yet been published in the Texas Administrative Code (TAC), they do not have designated TAC numbers. For the time being, the rules will continue to be published under their Texas Register Division numbers. However, the rules will be published under the agency's correct TAC title and part.)

General Provisions Insurance Company Insider Trading and Proxy Solicitation Regulation Act

059.21.48

The State Board of Insurance has amended Rule 059.21.48.001 which adopts by reference its amendment of the permanent and general rules and regulations of the State Board of Insurance by adoption of rules of administrative construction and interpretation, insurance company reporting and filing rules, annual statement blanks and supplements, including schedule SIS, supplemental reports, regulations affecting foreign and domestic insurance companies, rules and regulations on proxies, consents, and authorizations of domestic stock insurance companies, rules and regulations governing insurance company insider trading, and provisions for codification. This proposal appeared in the January 1, 1982, issue of the *Texas Register* (7 TexReg 11).

The amendment substantially conforms §6.32 of Part VI of the rule to Securities and Exchange Commission (SEC) Rule 16b-3 which has been amended under authority of §16 of the Securities and Exchange Act of 1934, as amended. Prior to that amendment, §6.32 and SEC Rule 16b-3 were in substantial conformity. Section 6.4 of Part VI specifies that domestic insurers satisfying SEC requirements and provisions respecting insider trading (including the provisions and requirements of SEC Rule 16b-3) will be considered to comply with the provisions and requirements of Rule 059.21.48.001, if the matter regulated is the same or substantially the same, any other provision of Rule 059.21.48.001 to the contrary notwithstanding. Accordingly, this amendment merely updates §6.32 in accordance with the law as specified in §6.4.

No comments were received regarding adoption of the amendments.

The amendments are adopted under authority of Texas Insurance Code, Article 21.48, §3 and §10. Section 10 authorizes the board to make such rules and regulations as may be necessary for the execution of the functions vested in the board by Texas Insurance Code, Article 21.48, §§2-9. Section 3 of Article 21.48 authorizes the board to exempt by rules and regulations, certain insider trading transactions.

.001. Insider Trading and Proxy Solicitation. The State Board of Insurance adopts by reference an amendment as of May 1, 1982, to the attached amendment of the permanent and general rules and regulations of the

State Board of Insurance by adoption of rules of administrative construction and interpretation, insurance company reporting and filing rules, annual statement blanks and supplements, including schedule SIS, supplemental reports, regulations affecting foreign and domestic insurance companies, rules and regulations on proxies, consents, and authorizations of domestic stock insurance companies, rules and regulations governing insurance company insider trading, and provisions for codification.

This agency hereby certifies that the rule as adopted has been reviewed by legal counsel and found to be a valid exercise of the agency's legal authority.




Part II. Texas Parks and Wildlife Department

Chapter 55. Law Enforcement Operation Game Thief Fund

31 TAC §§55.111-55.114

The Operation Game Thief Committee adopts new §§55.111-55.114 concerning the operation game thief fund with changes to the proposed text publish-

ed in the March 12, 1982, issue of the *Texas Register* (7 TexReg 1028).



These sections are adopted to comply with the provisions of House Bill 1421 which was passed by the 67th Legislature. The rules provide for the establishment of a fund derived from donations by individuals and deposited i., a special fund outside the state treasury for the disbursement of rewards to persons furnishing information to the department of persons committing flagrant violations of the Parks and Wildlife Code or a regulation or proclamation adopted under the authority of the Code that applies to the taking, possession, or sale of an animal, bird, reptile, or fish. These rules will provide an additional deterrent to poaching.

No comments were received regarding adoption of the new sections.

These new sections are adopted under the Texas Parks and Wildlife Code, Chapter 12, Subchapter C, which provides the Operation Game Thief Committee with the authority to adopt rules for the implementation and maintenance of the operation game thief fund.

§55.111. Definitions. The following words or terms, when used in this subchapter, shall have the following meanings, unless the context clearly indicates otherwise:

Chairman—Chairman of the Operation Game Thief Committee.

Committee—The Operation Game Thief Committee.

Department—The Texas Parks and Wildlife Department.

Director—The executive director of the Parks and Wildlife Department.

Donation—Something of value, negotiable or convertible, and shall include but not be limited to, currency, stocks, bonds, or property, whether real cr personal.

Eligible applicant—A person making application for a reward for furnishing information to the department which leads to an arrest and conviction of a flagrant violation.

Flagrant violation—Shall be as defined in Texas Parks and Wildlife Code, §12.203.

Information—Specific information of a flagrant violation furnished to the department that leads to the arrest and conviction of the violator.

Operation game thief fund—Monies collected and deposited in a special fund outside the state treasury.

§55.112. Donations and Dishursements.

- (a) The director shall develop procedures for the acceptance, conversion, and deposit of all donations offered by individuals, clubs, or other organizations.
- (b) Conversion of donations of real or personal property into United States currency shall be accomplished by the director or his designee.

- (c) Donations received shall be deposited by the director in interest bearing accounts (operation game thief fund) insured by the Federal Deposit Insurance Corporation.
- (d) Disbursements for rewards shall be approved by the committee. Disbursements for other expenditures directly related to implementation of the program shall be approved by the chairman and may include but not be limited to costs of the WATS line and promotional costs to enhance the fund. All donations may be used for these purposes unless otherwise specifically prohibited by the donor. All disbursements from accounts will be by check signed by the director. The committee will be furnished an annual report detailing all expenditures from the fund.

§55.113. Reporting Violations; Eligibility of Applicant.

- (a) No person other than a person furnishing information to the department that leads to the arrest and conviction of a person for committing a flagrant violation of the Parks and Wildlife Code may be eligible for receiving a reward.
- (b) No person shall be eligible for receiving a reward unless information required in subsection (a) of this section is forwarded to a designated office established by the department for the reporting of such information.
- (c) The designated office defined in subsection (b) of this section shall provide:
 - (1) employees on duty 24 hours a day,
- (2) a toll-free telephone number for use by the public for reporting flagrant violations, and
- (3) assignment of a specific operation game thief report code number for persons reporting a flagrant violation.
- (d) The director shall prescribe the documentation to be furnished to substantiate the information provided.
- (e) Informants shall have the option of furnishing his name, address, and telephone number or requesting only a code number for anonymity which shall be used in lieu of applicant's name in all subsequent transactions with the informant.

§55.114. Rewards: Payment.

- (a) The amount of reward granted to eligible applicants shall be determined on an individual basis by the committee according to the degree of flagrancy of each violation
- (b) In the event two or more eligible applicants furnish information pertaining to a specific flagrant violation, the reward may be divided among the eligible applicants in an amount determined by the committee.

Part X. Texas Water Development Board

Chapter 337. Boat Regulations Boat Sewage Disposal

31 TAC §§337.1-337.8, 337.10-337.16, 337.19, 337.20

The Texas Water Development Board adopts amendments to §§337.1-8, 337.10-337.16, 337.19, and 337.20 concerning boat sewage disposal without changes to the proposed text published in the February 2, 1982, issue of the *Texas Register* (7 TexReg 420).

The amendments bring the rules into conformity with \$312(f) of the Clean Water Act, to simplify procedures for certification of marine sanitation devices, and to provide for annual recertification of boat sewage pump-out facilities. The rules prohibit discharge of boat sewage into 24 designated lakes in the state and set forth guidelines for the certification of boat sewage disposal devices. The rules also establish criteria and certification procedures for boat sewage pump-out facilities.

No comments were received regarding adoption of the amendments.

The rules are adopted under the authority of Texas Water Code, § 26.044, which requires that the board issue rules concerning the disposal of sewage from boats located or operated on inland fresh waters in this state.

31 TAC §§337.17-337.18

The Texas Water Development Board adopts the repeal of §§337.17-337.18 concerning boat sewage disposal without changes to the proposed notice of repeal published in the February 2, 1982, issue of the Texas Register (7 TexReg 420).

The repeals are intended to simplify the rules by eliminating unnecessary language. The repealed rules merely restated the policies contained in Texas Water Code, §26.014, and Texas Parks and Wildlife Code, §31.129.

No comments were received regarding adoption of the repeals.

The repeals are adopted under the authority of Texas Water Code, §26.044, which authorizes the Texas Water Development Board to issue rules concerning the disposal of boat sewage.



Institutions of higher education or political subdivisions covering all or part of four or more counties (regional agencies) must post notice at least 72 hours prior to a scheduled meeting time. Although some notices may be received too late for publication before the meeting is held, all those filed are published in the *Register*. Notices concerning state agencies, colleges, and universities must contain the date, time, and location of the meeting, and an agenda or agenda summary. Published notices concerning county agencies include only the date, time, and location of the meeting. These notices are published alphabetically under the heading "Regional Agencies" according to the date on which they are filed.

Any of the governmental entities named above must have notice of an emergency meeting, or an emergency revision to an agenda, and the reason for such emergency posted for at least two hours before the meeting is convened. Emergency meeting notices filed by all governmental agencies will be published. However, notices of emergency additions or revisions to a regional agency's agenda will not be published since the original agenda for the agency was not published.

All notices are posted on the bulletin board outside the Office of the Secretary of State on the first floor of the East Wing in the State Capitol. These notices may contain more detailed agendas than space allows to be published in the *Register*.



Also at 7 TexReg 1041, in the right column, third paragraph, the sentence relating to subsection (b) should read "Subsection (b) was amended to detail the form and content of all comments submitted to the department in relation to a proposed departmental rule."

At 7 TexReg 1044, in the left column, the second sentence of the seventh paragraph should read "The section provides the charges required for the reproduction of departmental records."

At 7 TexReg 1047, the next-to-last sentence of §1.14(b)(1) should read "Notice of protest being timely filed, the application shall be administered as a contested case as provided for in the Act and Chapter 1 of this title (relating to General Practice and Procedure)."

Comptroller of Public Accounts Public Comment 34 TAC §3.297

Although the time allowed for comments on 34 TAC §3.297 (relating to Carriers) has elapsed, it appears that a written comment sent to the comptroller's department was apparently lost in the mail. If the letter had not been lost, the comments would have been published in the Texas Register when the rule was adopted. For this reason, the comptroller has requested that the comments be accepted as though received timely and that the comments, with the comptroller's response, be published.

Additionally, a comment received from another business was received late. However, since both comments were similar, both comments will be combined and the business acknowledged herein.

Comments against the rule's adoption were submitted by Lone Star Gas Company, Division of Enserch Corporation, and El Paso Natural Gas Company. Comments against the rule were that the proposed rule would attempt to limit the statutory exemption to those licensed and certificated carriers which are common or contract carriers. Such limitation would discriminate against those carriers which are not common or contract carriers. Such a limitation would go beyond Texas Taxation General, Article 20.40(G)(3)(a), and would and is therefore, in direct conflict with the tax statute.

The comptroller's department disagrees with the comments in that it has been the long standing position of the comptroller's department that private carriers are not "licensed and certificated" carriers as that term is used in Texas Taxation General, Article 20.04 (now Texas Tax Code Annotated, Chapter 151, subchapter H.)

The Texas Railroad Commission regulates the pipelines operated by commentors as an extension of their businesses as gas utilities. The Texas Railroad Commission does not permit these companies as private carriers, for the commission does not regulate private carriers per se.

The comptroller's office believes a Texas Railroad Commission permit of a gas utility pipeline is much in the same nature of an airworthiness or inspection certificate required of every aircraft. Such a permit does not make the recipient a "licensed and certificated carrier."


