By executive order, Governor Bill Clements has abolished the Governor's Office of Migrant Affairs (GOMA) and has transferred the agency's responsibilities to the Texas Department of Community Affairs. The order also repeals Governor Dolph Briscoe's 1974 executive order that created GOMA. The agency's functions had included managing job training programs for migrants and serving as a liaison for migrants. Federal funds authorized by the Comprehensive Employment and Training Act were the chief source of financing for the programs. Executive Order WPC-3, which effects the change, appears in the Governor's section of this issue.

# Executive Order WPC-3

Transferring the duties, functions, records, contracts, administrative obligations, and assets of the Governor's Office of Migrant Affairs to the Texas Department of Community Affairs; repealing Executive Order D.B. No. 13; and abolishing the Governor's Office of Migrant Affairs.

WHEREAS, the Texas Department of Community Affairs has installed a streamlined management and audit capability.

WHEREAS, the Texas Department of Community Affairs is the State Prime Sponsor under the Comprehensive Employment Training Act of 1978 and handles federal manpower programs in Texas.

WHEREAS, it is in the best interest of Texas to insure that the maximum amount of federal dollars available under these programs actually reaches the recipients rather than being wasted on excessive administrative costs.

NOW, THEREFORE, I, William P. Clements, Jr., Governor of Texas, under the authority vested in me, do hereby transfer the duties, functions, records, contracts, administrative obligations, and assets of the Governor's Office of Migrant Affairs to the Texas Department of Community Affairs; repeal Executive Order D.B. No. 13; and abolish the Governor's Office of Migrant Affairs.

The Texas Department of Community Affairs is hereby directed to redouble its efforts to assist Texas migrants in breaking the often inhumane migrant cycle and to maximize the impact of programs by further reducing the tremendous administrative costs involved in such programs.

This executive order shall be effective immediately.



Summary of Opinion: Under Arti le 1702h, the County Law Library Fund may be expended only for library purposes and for the needs of judges and litigants. The fund may not be used to buy books owned by the county.

An agency may adopt a proposed rule no earlier than 30 days after publication in the *Register*, except where a federal statute or regulation requires implementation of a rule on shorter notice.

An agency, on request, shall provide a statement of the reasons for and against adoption of a rule. Any interested person may request this statement before adoption or within 30 days afterward. The statement shall include the principal reasons for overruling considerations urged against the agency's decision.

Numbering System—Each rule is designated by a unique 10-digit number which is divided into four units by decimal points. The first unit (three digits) indicates the agency which promulgates the rule. # **Application and Petition Procedures**

# Certificate of Need Application Procedures 315.18.01

Rule 315.18.01.290 provides for the joinder of certificate of need applications considered "potentially competing." Under the rule, the chairman of the commission is given discretion to order joinder. As written, the rule may be interpreted as allowing joinder any number of times during an indefinite period. In order to more explicitly identify those applications subject to joinder, to make joinder mandatory, and to place limits upon joinder, the commission proposes to amend Rule .290 as set forth below.

The adoption of the rule amendment will have no fiscal implication. The source of this determination is the commission staff which has analyzed the proposed amendment.

Public comment is invited and will be accepted until May 4, 1979. Written comment should be addressed to Dan R. McNery, general counsel, Texas Health Facilities Commission, P.O. Box 15023, Austin, Texas 78761. A public hearing is scheduled to receive oral testimony relevant and material to the adoption of these rules. The hearing will be held on April 26, 1979, at 1:30 p.m., at the offices of the commission, 1600 West 38th Street, Suite 305, Jefferson Building, Austin, Texas

This rule is proposed under the authority of Article 4418(h), Texas Revised Civil Statutes.

.290. Joinder—Certificate of Need.

(a) The chairman shall order the joinder of an accepted and dated certificate of need application (hereafter referred to as the first application) with one or more subsequently dated and accepted certificate of need applications (hereafter referred to as subsequent applications) when:

(1) the first and subsequent applications involve similar project descriptions in the same medical service area or overlapping medical service areas; and

(2) the subsequent applications are accepted and dated within 45 days of the acceptance and dating of the

first application.

- (b) The 45-day joinder period begins with the dating and acceptance of the first application. Only during this period of 45 days may applications be joined with the first application. When the first application and subsequent applications are joined under this rule, the commission shall not consider any of the joined applications as a first application for purposes of future joinders. [The chairman, on his own motion or on the motion of any person, may order a certificate of need application joined with another previously accepted and dated certificate of need application when he determines that the applications are potentially competing. The chairman may join certificate of need applications when the subsequent applications are accepted and dated within 45 days of the acceptance and dating of the previous certificate of need application.]
- (c) The chairman, in ordering the joinder, shall reschedule the hearing on the first application [previously accepted application] in order that one hearing may be conducted on all joined applications. By ordering joinder, the applicants are admitted as parties to all joined applications.

(d)-(e) (No change.)

# Rating and Policy Forms

Board Shall Fix Rates 059.05.25

The State Board of Insurance proposes to amend Rule 059.05.25.003, which adopted by reference the Texas General Basis Schedules, as follows:

- (1) adding to the existing rules for land and outside site improvements a new subject of insurance, described as underground utilities located outside the perimeter of any building or structure, with the same fire and extended coverage rates now applicable to land and outside site improvements (see Attachment A):
- (2) eliminating the current rating rule for rent insurance, requiring separate minimum premiums be applied for each peril covered, even though rental coverage is written in the same policy with property damage (see Attachment B);
- (3) adding to existing rating rules for office contents special form a rule to allow cancellation of such form from a policy without having to cancel the entire policy (see Attachment C):
- (4) adding an exception to the rating rules limiting the additional occupant charge to frame or ironclad mini-storage warehouses to a specific maximum charge according to the applicable key rate (see Attachment D);

- (5) adding to the existing rating rules a definition of "per account" as used in connection with the minimum premium applicable to the special extended coverage endorsement (see Attachment E);
- (6) adding rules to govern the writing of Blanket Earnings and Expense Form TxMP-147, previously not available under the Texas Multiperil Program, including applicable rates for such endorsement (see Attachment F);
- (7) adding to the existing rating rules specific rules to allow Section III (crime coverage) or Section IV (boiler and machinery coverage) to be provided under a Texas multiperil policy by a company other than that providing coverage under Section I (property coverage) and/or Section II (liability coverage) (see Attachment G);
- (8) adding rules to govern the writing of the TMP-Removal Permit Form TxMP-60, not previously available under the TMP Program (see Attachment H);
- (9) adding rules to govern the writing of replacement cost coverage on unscheduled household goods and personal effects under Form FRO-465, not previously available under the Farm and Ranch Owners Program (see Attachment I);
- (10) adding rules to govern the writing of an additional extended coverage endorsement under Form HO-366, not previously available under the Homeowners Program (see Attachment J);
- (11) adding to existing rules a specific definition of "fringe" in relation to applying the dwelling key rates (see Attachment K);
- (12) amending the existing minimum premium rules to reflect the minimum premium for additional extended coverage to be \$5 (see Attachment L).

# Texas Education Agency in General

Public Information 226.11.06

The Texas Education Agency has amended Rule 226.11.06.010, concerning the public information program of the agency. The change deletes detailed material from the administrative procedure section of the rule. This material is more appropriately covered in an internal operating procedure of the agency. The policy section of the rule remains unchanged.

This amendment is adopted with no change from the text as proposed.

This amendment is promulgated under the authority of Sections 11.02(a) and 11.52(b), Texas Education Code.

.010. Texas Education Agency Communications Program.

(a) Policy. In administering the state responsibility for the public schools, the Texas Education Agency shall keep the public informed of both the progress and the problems of public school education in Texas in accordance with statutes and regulations established by the agency. The Texas Education Agency shall collect, analyze, interpret, and communicate educational information, impartially and independently. The communications program of the Texas Education Agency shall be directed toward strengthening all lines of communication to and from the public, school personnel, and agency staff. The State Board of Education shall be advised of and consulted on major activities of the Texas Education Agency in its communications program.

(b) Administrative procedure. The Texas Education Agency reports both the progress and the problems in elementary, secondary, adult, and certain areas of early child-hood education, teacher education, and postsecondary education to the people of Texas through the news media, professional journals, and other publications. Each Texas Education Agency staff member has a role in carrying out an external communications program. Divisional and individual responsibilities are as follows:

(1) The Division of Dissemination and Publications has primary responsibility for developing and carrying out a public information program.

(2) Each professional staff member is responsible for cooperation with the Division of Dissemination and Publications in providing accurate information within his or her areas of expertise and in compliance with state and federal open records statutes.



# Legislative Report

The legislative coverage in the Register includes notices on the introduction of bills and committee referrals. The legislative report focuses on proposed bills and resolutions which, if passed, will have a major impact on issues of concern to citizens on a statewide basis. Organized according to content, the coverage includes legislation regarding energy, environment, education, human services (health and welfare), insurance, economic development, taxes, criminal justice, state and local government, elections, constitutional revision, and consumer affairs. Also appearing in this section are notices of committee meetings and bill status lists which indicate the latest action on bills covered in the report.

The Texas House changed the referral of HB 2173, relating to the composition and compensation of the Grayson County Juvenile Court, from the Committee on Intergovernmental Affairs to the Judicial Affairs Committee.

#### **Environment**

A bill to making changes in the Texas Air Control Board (HB 726) was placed on the daily general state calendar on April 3. The bill would require five board members to represent the public interest and allow the board to adopt rules relating to fees for permits and variances.

#### Education

HB 2045, creating a state higher education assistance fund, we referred to the Subcommittee on Revenue Administration on April 2. Similar to other proposals, this fund would be created in the state treasury. The income from the fund's investment would be used for acquiring land with or without permanent improvements or for construction of permanent improvements at state institutions of higher education.

#### **Human Services**

A proposed statutory definition of death (HB 12) was placed on the daily general state calendar on April 3. Death would be defined as the irreversible cessation of spontaneous respiratory and circulatory functions, based on ordinary standards of medical practice. The bill requires a physician to announce the occurrence of death prior to the termination of artificial means of support and provides immunity from liability for physicians.

#### Insurance

Several bills have been introduced to require trucks hauling loose materials to cover their loads. In the Senate Economic Development Committee, SB 84 and SB 342 were referred to subcommittee on April 2.

HB 22, requiring all drivers to carry liability insurance, was considered by an Insurance subcommittee in public hearing on March 28.

#### **Economic Development**

The regulation of offers and sale of securities in Texas is under consideration in both houses. SB 293, passed in the senate on March 29, was reported favorably from the House Financial Institutions Committee without amendments on April 3. HB 807 was read the second time in the house on April 3.

#### Taxes

There are many proposals pending in both houses regarding ad valorem taxation. SB 621, the Property Tax Code, was considered by the Senate Finance Committee in a third public hearing on April 2. HB 503, limiting increases in property ad valorem taxes to 10 percent per year, was reported from an Intergovernmental Affairs subcommittee favorably with amendments on April 2.

The committee report of HJR 102, prohibiting a personal state income tax in Texas, was printed and sent to the Committee on Calendars on March 29.

Two bills (HB 1005 and HB 690) imposing a severance tax on uranium were considered by a Ways and Means subcommittee in public hearing on March 28.

#### Crimimal Justice

Several criminal justice issues are being considered. SB 546, making violation of a prisoner's civil rights a third-degree felony, was passed in the Senate on April 2 and referred to the House Criminal Jurisprudence Committee on April 3. HB 43, changing the definition of sexual contact to include females younger than 10 years, was placed on the daily general state calendar on April 3. HB 244, making parents liable for property damage or personal injury caused by their child, was placed on the daily general state calendar on April 3.

Extending the jurisdiction of the Commission on Jail Standards to all jails rather than just county jails, HB 1111 was referred to an Intergovernmental Affairs subcommittee on April 2. HB 2131 would abolish the Jail Standards Commission and transfer its duties to the Commission on Law Enforcement Officer Standards and Education. HB 2131 was considered by the Security and Sanctions Committee in public hearing on April 2.

#### State and Local Government

Many proposals regarding organization or creation of state agencies are receiving attention in both houses. Concerning regulation of dentists, two bills are under consideration: HB 884 passed to third reading in the house on April 3; and SB 484 was received by the house from the senate on April 3. Creating the Texas 1986 Sesquicentennial Commission, HB 1379 was read a second time in the house on April 3; SB 779 was referred to the House Business and Industry Committee on April 3. HB 1429, changing the name of the Texas Library and Historical Commission to the Texas State Library and Archives Commission, was referred to the Subcommittee on Agencies and Licensing on April 2. SB 681, renewing the Battleship Texas Commission, was referred to the House

Government Organization Committee on April 3. SB 522, creating the Texas Board of Examiners in Social Work, was considered by the Human Resources Committee in public hearing on April 2. HB 39, changing the Texas Adult Probation Commission to the Texas Probation Commission, was placed on the daily general state calendar on April 4.

Other state government issues are addressed by the following bills. SB 977, limiting the rate of growth of state appropriations, was reported favorably from the Finance Committee without amendments on April 3. HB 1125, granting budget execution powers to the governor, was reported from the Ways and Means Committee favorably without amendments on April 2. HB 1290, extending the Railroad Commission's jurisdiction over gas utilities, was considered by a State Affairs subcommittee in public hearing on April 2. HB 1382, requiring state agencies to justify proposed rules and creating the Joint Committee on Administrative Rules Review, was referred to the Subcommittee on State Employees on April 2.

#### Constitutional Revision

The committee report on SJR 28, legalizing bingo for some nonprofit organizations, was printed and sent to the Committee on Calendars on March 30.

#### Consumer Affairs

Two bills requiring warranty of habitability for residential rental units (SB 774 and SB 721) were referred to a Human Resources subcommittee on April 2. This warranty would be implied in every lease or rental agreement of a residential unit. Habitability includes clean and safe conditions; performance of necessary repairs; maintenance of heating and air conditioning appliances, garbage receptacles, locks, and stairways; and extermination of rodents and insects.

### Summary of Administrative Decision 7476

Summary of Decision: Purchases of electricity used for heating, cooling, lighting, operation of office machines, and other administrative uses are subject to sales and use tax unless (1) these electricity purchases flow through the same meter as electricity purchased and used in actual processing operations and (2) the electricity purchases used in the actual processing operations predominate over the electricity purchases used in a taxable manner (comptroller's sales tax Rule .015).

### Summary of Administrative Decision 9525

Summary of Decision: Purchases of steel rods, which had a useful life of less than six months and which were used in the actual manufacturing of cast iron to skim the ladles out of which the molden iron was poured, were exempt from sales and use tax as equipment having a useful life when new of less than six months (Texas Taxation—General Annotated, Article 20.04(E)).

Summary of Decision: The date appearing in the summary of the comptroller's Administrative Decision 10445, should be changed to read August 29, 1977, instead of September 1, 1975.
