

The Texas Register is currently in the process of converting to the numbering system to the Texas Administrative Code (TAC). To aid the reader in this conversion, both the 10-digit Register number and the new TAC number will be listed for agencies whose rules have been published in the TAC. Emergency, proposed, and adopted rules sections of the Register are divided into two classifications: codified and noncodified. Codified rules appear in title number order. Noncodified rules appear in alphabetical order as they have in the past. An "Index of TAC Titles Affected" appears at the end of this issue.

Titles 1, 4, 7, 10, 13, 22, 31, 34, 37, and 43 only of the TAC have now been published. Documents classified in the *Texas Register* to titles not yet published and certain documents affecting titles of the code have been accepted in the non-TAC format and may be renumbered or revised, or both, when initially codified in the TAC.

Under the TAC scheme, each agency rule is designated by a TAC number. For example, in the citation 1 TAC §27.15:

1 is the title (agencies grouped together by subject title which are arranged alphabetically)

TAC is the *Texas Administrative Code* §27.15 is the section number (27 represents the chapter number and 15 represents the individual rule within the chapter)

3185 TAC Titles Affected in This Issue (Conversion Table) 3185 Table of TAC Titles Article 4399; Vernon's Texas Civil Statutes, requires the attorney general to give written opinions to certain public officials. The Texas Open Records Act, Article 6252-17a, Section 7, Vernon's Texas Civil Statutes, requires that a governmental body which receives a request for release of records seek a decision of the attorney general if the governmental body determines that the information may be withheld from public disclosure. Opinions and open records decisions issued under the authority of these two statutes, as well as the request for opinions and decisions, are required to be summarized in the *Texas Register*.

Request from John J. Kavanagh, M.D., commissioner, Texas Department of Mental Health and Mental Retardation, Austin.

Summary of Request:

- (1) Does the Mentally Retarded Persons Act of 1977, Article 5547-300. Vernon's Texas Civil Statutes, or any other statutory, constitutional or common-law, require legally adequate consent for the performance of a comprehensive diagnosis and evaluation?
- (2) With regard to the admission of a person to nonresidential mental retardation services, such as, but not limited to a sheltered workshop program:
- (A) Must a comprehensive diagnosis and evaluation of such person be performed before the person may be admitted to such services?
- (B) Does the Mentally Retarded Persons Act of 1977, Article 5547-300, Vernon's Texas Civil Statutes, or any other statutory, constitutional or common law, require legally adequate consent for admission to such services?
- (C) If you answer the preceding question in the affirmative and if the facility's personnel have determined, based on observation and testing, that an adult proposed client who never been judicially declared incompetent and has no

guardian does not possess the mental capacity to give legally adequate consent for admission to such services.

- (i) Must the mental retardation services be denied to the proposed client?
- (ii) If the mental retardation services must be denied, does the proposed client have a property right protected by the 14th Amendment to the U.S. Constitution similar to the one recognized in Java v. California Department of Human Resources Development, 317 Federal Supplement 875 (District Court of California 1970), affirmed 402 United States 121, 91 Supreme Court 1347, 28 Lawyer's Edition, Supreme Court Reports 2d 6669 If your answer is in the affirmative, to what process is the proposed client entitled and who must provide that process?
- (3) With regard to the discharge of a client from nonresidential mental retardation services, such as, but not limited to, a sheltered workshop program, if the facility's personnel have determined, based on observation and testing, that an adult client who has never been judicially declared incompetent and has no guardian does not possess the mental capacity to give legally adequate consent for the provision of such services:
 - (A) Must the client be discharged from such services?
- (B) If the client must be discharged from such services, does the client have a property right protected by the 14th Amendment to the United States Constitution similar to the one recognized in Java v. California Department of Human Resources Development, 317 Federal Supplement 875 (District Court of California 1970), affirmed 402 United States 121, 91 Supreme Court 1347, 28 Lawyer's Edition, Supreme Court Reports 2d 666? An agency may adopt a proposed rule no earlier than 30 days after publication in the *Register*, and the adoption may go into effect no sooner than 20 days after filing, except where a federal statute or regulation requires implementation of a rule on shorter notice.

Upon request, an agency shall provide a statement of the reasons for and against adoption of a rule. Any interested person may request this statement from the agency before adoption or within 30 days afterward. The statement shall include the principal reasons for overruling objections to the agency's decision.

This section now contains two classifications: codified and noncodified. Agencies whose rules have been published in the *Texas Administrative Code* will appear under the heading "Codified." These rules will list the new TAC number, which will be followed immediately by the *Texas Register* 10-digit number. Agencies whose rules have not been published in the TAC will appear under the heading "Noncodified." The rules under the heading "Codified" will appear first, immediately followed by rules under the heading "Noncodified."



Fraud Disqualification 326.15.73

The Department of Human Resources adopts the following amendments to rules about administrative fraud hearings in the Food Stamp Program. These amendments are required as a result of federal regulations issued by the United States Department of Agriculture (USDA) to be effective June 1, 1980. These amendments clarify when the department should initiate administrative fraud hearings.

These amendments are adopted under the authority of the Human Resources Code, Title 2, pursuant to federal requestion be effective June 1, 1980.

.007. Administrative Fraud Hearings.

(a) An administrative fraud hearing should be initiated by DHR in cases in which DHR has sufficient documentary evidence to substantiate that an individual has committed fraud as defined in department rules. Such cases may include those in which the department believes the facts of the individual case do not warrant civil or criminal prosecution through the appropriate court system. Other cases may be those previously referred for prosecution but for which prosecution was declined by the appropriate legal authority.

Administrative Fraud Disqualification Hearings 326.74.41

The Department of Human Resources adopts the following amendments to rules about administrative fraud hearings. These amendments are required as a result of federal regulations issued by the United States Department of Agriculture (USDA) to be effective June 1, 1980. These amendments clarify when the department should conduct administrative fraud hearings.

These amendments are adopted under the authority of the Human Resources Code, Title 2, pursuant to federal requirements to be effective June 1, 1980.

.002. Requirement for Administrative Fraud Hearing.
(a) (No change.)

(b) An administrative fraud hearing should be initiated by DHR in cases in which DHR has sufficient documentary evidence to substantiate that an individual has committed fraud as defined in department rules. Such cases may include those in which the department believes the facts of the individual case do not warrant civil or criminal prosecution through the appropriate court system. Other cases may be those previously referred for prosecution but for which prosecution was declined by the appropriate legal authority. Fraud hearings will not be conducted if the amount the department suspects has been fraudulently obtained is less than \$35 or if the value of ineligible items that have been purchased with food stamps is under \$35.

The Open Meetings Act (Article 6252-17, Texas Civil Statutes) requires that an agency with statewide jurisdiction have notice posted for at least seven days before the day of a meeting. A political subdivision covering all or part of four or more counties, or an institution of higher education, must have notice posted for at least 72 hours before the scheduled meeting time. Notice of an emergency meeting or an emergency addition or amendment to an agenda must be posted for at least two hours before the meeting is convened. Although some notices may be received and filed too late for publication before the meetings are held, all filed notices will be published in the Register. Each notice published includes an agenda or a summary of the agenda as furnished for publication by the agency and the date and time of filing. Notices are posted on the bulletin board outside the offices of the secretary of state on the first floor in the East Wing of the State Capitol. These notices may contain more detailed agendas than space allows to be published in the Register.

Solar, when uncapitalized refers to specific solar applications i property tax exemptions entirely to the State Tax Board from the comptroller's office. Also, the legislature should require inclusion the Solar tax exemptions information in the appraiser's all and in any appraiser's training. A small appropriamay be required for training appraisers. Furthermore,

the Solar ad valorem tax exemption should be included in the

property inventory checkoff for standard deductions, similar

to the old age or disabled veterans, standard exemptions.

Franchise Tax. The Solar Advisory Committee of TENRAC recommends that the legislature modify and broaden the present franchise tax exemption, if administratively feasible to allow businesses with some Solar involvement, to exempt the part of their taxable capital and assets devoted to Solar sales manufacturing, and installation

Solar Component for Texas Housing Agency. The Solar Advisory Committee of TENRAC recommends the following relating to the Texas Housing Agency

- award qualifying points to Texas Housing Agency applicants using conservation and or Solar. The points would be added as a factor in considering the loan application and would not apply to the applicable interest rate, which would be the same as that for all other Texas Housing Agency loans
- (2) award qualifying points to the applications of builders, developers, and architects using passive or active solar in designs for single and multifamily dwelling, and
- (3) amend the Texas Housing Agency's enabling legislation to allow financing of rehabilitation projects offering qualifying points to solar

Solar Component for Texas Rehabilitation Loan Fund. The Solar Advisory Committee of TENRAC recommends that if funding is made available to the Texas Rehabilitation Loan Fund. qualifying points to applicants using conservation and/or Solar be given. The points would be added as a factor in considering the loan application and would not apply to the applicable interest rate, which would be the same for all applicants.

Texas Industrial Commission. The Solar Advisory Committee of TENRAC recommends that applications for funding under the Texas Industrial Commission's Industrial Development Bond Program be given qualifying points if the proposed design incorporates the use of Solar energy

Texas Veterans Land Program. The Solar Advisory Committee of TENRAC recommends that building loans made under the Texas Veterans Land Program be expanded if administratively feasible to include solar retrofit improvements at existing interest rates.

Federally Guaranteed Retrofit Loans. The Solar Advisory Committee of TENRAC recommends that the council adopt a resolution to be forwarded to the Texas Congressional Delegation seeking expansion of current Federal Housing Authority and Veterans Administration home mortgage programs to include solar retrofits

Increased Energy Development Funds for Solar. The Solar Advisory Committee of TENRAC recommends that greater funding be made available for the Energy Development Fund program to support research development and demonstration of those Solar technologies that are of direct importance to this state. Such funding should include but not be limited to

- (1) informational research.
- (2) comprehensive energy management planning
- (3) monitoring selected Solar projects in the state
- (4) development of solar cooling and dehumidification methods, and industrial applications of solar technologies in cluding small concentrating systems, and
- (5) applications of wind energy generation and passive design of residential and commercial buildings. Significant portions of these funds for research, development, and demonstration should be given to small size firms.

Cost Sharing. The Solar Advisory Committee of TENRAC recommends that the state be encoveraged to support federally funded solar projects in Texas through cost sharing and other cooperative efforts.

Standards for Solar Collectors and Systems. The Solar Advisory Committee of TENRAC recommends that Texas adopt standards for testing solar collectors. The standards to be adopted would be those of the American Society of Heating Refrigerating and Air Conditioning Engineers.

New State Structures. The Solar Advisory Committee of TENRAC recommends that passive and active solar heating, cooling hot water systems and daylighting shall be used on all new state buildings after August 31, 1981, except on those structures where the use of solar is clearly not in the public interest. The method of cost analysis should be life cycle costs.

Public Utility Commission and Railroad Commission of Texas Solar Involvement. The Solar Advisory Committee of TENRAC recommends that the Public Utility Commission of Texas and the Railroad Commission of Texas consider the following—a voluntary program in which the electric and natural gas utility companies participate in financing the purchase and installation of solar hot water heaters. The investment would be attributed to the Reserve for Deferred Taxes in order to relieve it of the return requirement—The effect would be to provide interest free loans for solar hot water installations. The customer would be required to main tain the device once it is installed.

Licensing of Solar Installers. The Solar Advisory Committee of TENRAC recommends that a single statewide license be required for contractors installing solar energy systems for hot water heating air conditioning, and space heating of buildings as well as for solar energy systems used for commercial and industrial purposes. This license should be granted to contractors who have

- 1 completed a course in basic design and installation procedures of solar installation, and
- $\langle 2 \rangle$ -passed a state examination as a master installer of solar systems

We suggest two types of licenses—(a) for contractors installing solar systems having a capacity of not more than 100 square feet of collector surface (including domestic hot water and other solar heat requirements) or (b) for installers qualified to install any size solar installation. This licensing requirement would not apply to passive building construction techniques or owner built systems.

Model Solar Code. The Solar Advisory Committee of TENRAC recommends that TENRAC contact local building officials to urge adoption of the "Document for Code Officials on Solar Heating and Cooling of Buildings" issued by the United States Department of Energy

Architectural Licensing and Renewal. The Solar Advisory Committee of TENRAC recommends that in its licensing examinations and requirements for renewal, the Texas Board of Architectural Examiners should require basic knowledge and understanding of energy conservation and the use of renewable energy sources.

Solar Easement Legislation. The Solar Advisory Committee of TENRAC recommends that the council endorse the establishment of "solar easements," as defined in Senate Bill 494, 66th Legislature. Solar easements are defined as the

Tright to receive solar energy across real property of another person for efficient use of solar energy devices."

Information Transfer. The Solar Advisory Committee of TENRAC recommends that TENRAC with subcontract to appropriate groups where necessary shall continue and expand information transfer programs e.g. data banks workshops, brochures public service announcements and the dissemination of public information from state and federal agencies related to solar and renewable resources Furthermore, the committee recommends that TENRAC with subcontract to the appropriate groups where necessary

- (1) determine the resources of the state to allow engineers architects designers and planners to more adequately design Solar systems
- (2) provide for the gathering of data on a statewide basis of hourly values of direct and total insolation wind speed, and direction at appropriate heights, and other appropriate local climate data, and
- $(3)^{\circ}$ disseminate this data in useful form to concerned parties

Expanded TENRAC Solar Functions. The Solar Advisory Committee of TENRAC recommends that TENRAC be identified as the "lead agency" in programs and policy recommendations for increasing the use of Solar energy in Texas. It is further recommended that the council centralize Solar activities for the administration of the solar programs. Among the responsibilities to be performed by TENRAC are

- (1) information transfer
- (2 research
- (3) policy recommendations, and
- (4) contact with the United States Department of Energy—the Solar Energy Research Institute, and the Southern Solar Energy Center

It is further recommended that TENRAC

- (1) administer centers in various climate regions to serve as central information distribution points for regional specific Solar information. The centers would offer consumer information, free or low cost design consultation and computer modeling services.
- (2) fund and administer design competition for low cost solar home designs. TENRAV should acquire design rights to winning designs which are climate and market sensitive in different climate regions and offer them free to builders who will build and market them. TENRAC should also build high visibility demonstration projects based on winning designs in each climate region.
- (3) offer recognition awards to builders who use Solar principles in site plans and residential and commercial structures.
- (4) conduct hands on solar domestic hot water work ships for homeowners, and
- (5) publish brochures, manuals, and workbooks related to Solar. To accomplish this broadened responsibility, it is recommended that the TENRAC Solar staff be expanded

Additionally the Solar Advisory Committee of TENRAC recommends that TENRAC appoint an advisory committee on solar energy to provide continuing advice to TENRAC technical and policy matters.

Fuel Use Act. The Solar Advisory Committee of TENRAC recommends that the state should seek relief from the Fuel Use Act for hybrid solar systems beyond 1990. Oil and gas firing of boilers should be permitted for industrial heat and

electrical utilities provided that at least 50% of the annual energy supplied is solar and/or wind.

Swimming Pool Heaters. The Solar Advisory Committee of the TENRAC recommends that the state should encourage the use of solar energy for heating swimming pools by phasing out the use of swimming pool heaters using oil and gas

Low Interest Solar Loans. The Schar Advisory Committee of TENRAC recommends, to the extent that the constitution permits, the passage of enabling legislation to permit the sale of state bonds that are tax exempt and thereby establish a fund for low interest loans to be made for residental and commercial applications for Solar energy equipment and components

Western Solar Utilization Network. The Solar Advisory Committee of TENRAC recommends that Texas explore affiliation with the Western Solar Utilization Network.

Wind Test Center. The Solar Advisory Committee of TENRAC recommends that a test center be established for small wind energy conversion systems (less than 100 kw).

Functions would include

- (1) certification of small wind energy conversion systems which are sold in the state. Certification is recommended but not mandatory;
- (2) provide information to the manufacturer that will assist in improving their product; and
 - (3) provide information for consumers regarding permance in long term test situations.

Standards for rating and performance would be developed in conjunction with national standards being developed by American Wind Energy Association and the United States Department of Energy.


Rating. The Solar Advisory Committee of TENRAC recommends that Texas endorse the national consensus method for rating collectors and small wind energy conversion systems, when promulgated, in order to provide better information for consumers




