The *Register* is published under Texas Civil Statutes, Article 6252-13a. Second class postage is paid at Austin, Texas, and additional entry offices.

How To Cite: Material published in the *Texas Register* is referenced by citing the volume in which a document appears, the words "TexReg," and the beginning page number on which that document was published. For example, a document

published on page 2402 of Volume 6 (1981) is cited as follows: 6 TexReg 2402.

In order that readers may cite material more easily, page numbers are now written as citations. Example: page 2 in the lower left-hand corner of this page is written: "7 TexReg 2 issue date," while on the opposite page, in the lower right-hand corner, page 3 is written "issue date 7 TexReg 3"

How To Research. The public is invited to research rules and information of interest between 8 a.m. and 5 p.m. weekdays at the *Texas Register* office, 503E Sam Houston Building, Austin. Material can be found by using *Register* indexes, the *Texas Administrative Code* (explained below), rule number, or TRD number.

Texas Administrative Code

The Texas Administrative Code (TAC) is the approved, collected volumes of Texas administrative rules currently being published by Shepard's/McGraw-Hill, in cooperation with this office.

How To Cite: Under the TAC scheme, each agency rule is designated by a TAC number. For example, in the citation 1 TAC §27.15:

1 indicates the title under which the agency appears in the *Texas Administrative Code* (a listing of all the titles appears below);

TAC stands for the *Texas Administrative Code;* **\$27.15** is the section number of the rule (27 indicates that the rule is under Chapter 27 of Title 1; 15 represents the individual rule within the chapter).



The Secretary of State

Under provisions of the Texas Election Code (Article 1.03), the secretary of state, as chief elections officer, is responsible for maintaining uniformity in the application, operation, and interpretation of the election laws, and for advising the state's election officers in this regard. In carrying out this responsibility, the secretary of state is authorized to issue opinions based on the election laws.

These opinions are summarized for publication in the Register.

Opinions Issued September 1

Election Law Opinion DAD-55. Request from Dorothy Stanley, Port Neches, regarding whether a municipality may combine county precincts for city elections.

Summary. Incorporated cities and towns may combine county precints for city elections (Texas Election Code, Article 2.05). However, the formation of election precincts is a discretionary right which belongs to each municipal governing body

(Texas Election Code, Articles 2.02(c) and 2.05).

Election Law Opinion DAD-56. Request from Judge L. E. Equia, Stafford, regarding whether variations in the manner of writing in a candidate's name determine whether a write-in vote is counted.

Summary. It is not necessary that a writein vote be written in on the ballot exactly as it appears on the list of qualified writein candidates. A vote for a write-in candidate must be counted if it is clear that the voter intended to vote for that candidate.

Under provisions set out in the Texas Constitution, Texas Civil Statutes (Article 4399), and numerous statutes, the attorney general is authorized to write advisory opinions for state and local officials. These advisory opinions are requested by agencies or officials when they are confronted with unique or unusually difficult legal questions. The attorney general also determines, under authority of the Texas Open Records Act, whether information requested for release from governmental agencies may be held from public disclosure.

Requests for opinions, opinions, and open record decisions are summarized for publication in the *Register*.

Opinions

MW-494 (RQ-784). Request from George N. Rodriguez, Jr., El Paso county attorney, El Paso, concerning whether counties must require competitive bids on insurance contracts whose premiums exceed \$5,000.

Summary of Opinion. Texas Civil Statutes, Article 2368a, requires counties to award contracts for the purchase of insurance through the competitive bidding process.

MW-495 (RQ-842). Request from Kenneth E. Graeber, executive director, State Property Tax Board, Austin, and Raymon L. Bynum, commissioner, Texas Education Agency, Austin, concerning calculation of tax rate under the Property Tax Code, §26.04.

Summary of Opinion. The phr so caxable value that is exempt in curre e year" in the Property Tax Code, §26.04(c)(3), refers not only to taxable value lost as a result of the granting of total exemptions, but also that lost to the granting of partial exemptions. The correct method of determining "the amount of taxes imposed in the preceding year on taxable value that is exempt in the current year" is determined by multiplying the amount of the exemption granted in the current year on taxable value taxed in the preceding year by the preceding year's tax rate. The amount of the exemption granted in the current year is determined in one of two ways. If the exemption is a partial exemption or a total exemption, the number used in the calculation is simply the amount granted. If the exemption granted is a percentage exemption granted pursuant to the Texas Constitution, Article VIII, §1-b, then the amount of the exemption granted is equal to that percentage multiplied by the preceding year's market value.

MW-496 (RQ-744). Request from Stan Schlueter, chairman, Committee on Financial Institutions, Texas House of Representatives, Austin, concerning construction of House Bill 1208.

Summary of Opinion. Securities pledged to secure public deposits pursuant to Texas Civil Statutes, Article 2529b-1, may be pledged to the full extent of their market value. They are eligible to be pledged in bearer form with coupons attached, registered as to principal or as to principal and interest, or into fully registered bonds without interest coupons, or in any other form authorized by the governing body of the issuer.

MW-497 (RQ-761). Request from Robert O. Viterna, executive director, Texas Commission on Jail Standards, Austin, concerning accrual of good time credit by jail inmates.

Summary of Opinion. The provisions of the Code of Criminal Procedure, Texas Civil Statutes, Article 43.10, apply to work performed by a misdemeanor convict during his incarceration in the county jail, but only if such labor is used upon public improvements. These provisions do not

apply to convicted felons who are merely in county jail awaiting transfer to the Texas Department of Corrections. The maximum amount of credit which could be given to an inmate with a one-year sentence would be 3/1 of his sentence or eight months. The provisions of Texas Civil Statutes, Article 5118a, do not apply to inmates who are merely awaiting transfer to the Texas Department of Corrections. The sheriff could increase the credit given against a fine beyond the rate of \$15 per day by commuting up to 1/2 of the total fine assessed against a defendant in addition to the credit allowed under Texas Civil Statutes, Article 43.09.

MW-498 (RQ-860). Request from Bob D'illock, comptroller of public accounts, Austin, concerning the effect of appropriations act rider limiting payment of plaintiff's attorney fees in suits against the Department of Corrections.

Summary of Opinion. House Bill 9, Acts of the 67th Legislature, second called session, 1981, Chapter 2, at 8, is not an invalid attempt to amend general law by an appropriations act rider. It applies only to those appropriations made in House Bill 9.

MW-499 (RQ-807). Request from Bill Clayton, speaker of the House of Representatives, Austin, concerning the use of topical ocular pharmaceutical agents by optometrists, and related matters.

Summary of Opinion. The Medical Practice Act of 1981, Texas Civil Statutes, Ar-

ticle 4495b, Subsection 3.06(d)(5), is unconstitutional.

MW-500 (RQ-455). Request from Harvey Davis, executive director, Department of Water Resources, Austin, concerning authority of county to incur indebtedness to finance construction and maintenance of sewage treatment works.

Summary of Opinion. There is no general authority for a Texas county to incur short-term and long-term indebtedness to finance the construction costs of a sewage treatment works, insure adequate operation and maintenance of the works throughout its jurisdiction, or to carry out responsibilities under an area wide water quality plan.

MW-501 (RQ-756). Request from William S Nail, executive director, Texas State Board of Dental Examiners, Austin, concerning constitutionality of Dental Practice Act provision relating to solicitation.

Summary of Opinion. The provision of the Dental Practice Act, Texas Civil Statutes, Article 4548g, which relates to solicitation is constitutional on its face.

MW-502 (RQ-815). Request from Margaret Moore, Travis County attorney, Austin, concerning construction of Texas Civil Statutes, Article 3836(a)(3).

Summary of Opinion. A person claiming an exemption from forced sale for debt under Texas Civil Statutes, Article 3836(a)(3), must elect to exempt, subject to dollar amount limitations, either all passenger cars and light trucks as specified in the statute not held or used for production of income or any two categories of the means of travel specified in the statute whether held or used for production of income or not.

MW-503 (RQ-880). Request from L. Alvis Vandygriff, commissioner, Texas Savings and Loan Department, Austin, concerning whether savings and loan company is an authorized agent to receive tax bill under the Texas Property Tax Code, §31.01.

Summary of Opinion. A state chartered savings and loan association or other mortgage lender is the authorized agent entitled to receive the original tax bill from the taxing unit where the deed of trust places the responsibility for paying taxes on the mortgage lender.

MW-504 (RQ-800). Request from Kenneth H. Ashworth, Coordinating Board, Texas College and University System, Austin, concerning whether independent school district tax funds may be used to support a junior college district.

Summary of Opinion. The board of trustees of an independent school district may not set aside or utilize a portion of the independent school district's maintenance and operation funds derived from ad valorem taxation for the support of a junior college district created pursuant to the Education Code, §130.011(a).

MW-505 (RQ-480). Request from James A. Gray, Burleson County attorney, Caldwell, concerning selection of county depository owned by holding company in which county judge owns stock.

Summary of Opinion. A bank is not disqualified from serving as a county depository where an officer, director, and 1.0% shareholder of the bank is the county judge, so long as the county judge does not participate in the voting on the selection of the county depository and his interest in the bank stock combined with that of any other members of the commissioners court does not exceed 10%. The bank may be disqualified by virtue of the county judge's ownership of 17% of the outstanding capital stock of the bank holding company, depending upon the judge's resulting "beneficial interest" in the bank stock.

MW-506 (RQ-824). Request from Hal H. Hood, Firemen's Pension commissioner, Austin, concerning authority of trustees of a Firemen's Pension and Retirement Fund to make certain investments.

Summary of Opinion. On the basis of the descriptions you have provided, a city Firemen's Relief and Retirement Fund subject to Texas Civil Statutes, Article 6243e, §23A, may not invest its surplus funds in a local partnership and a local corporation. The board of trustees of the Firemen's Relief and Retirement Fund is subject to the Open Meetings Act, Texas Civil Statutes, Article 6252-17, and is required by Texas Civil Statutes, Article 6243e, to keep minutes of its meeting.

MW-507 (RQ-772). Request from Bill M. White, criminal district attorney, San Antonio, concerning who may be licensed under Bail Bondsman Licensing Act, Texas Civil Statutes, Article 2372p-3.

Summary of Opinion. Only corporations and individuals may be licensed to act as bail bondsmen, according to Texas Civil Statutes, Article 2372p-3. A licensed corporate surety may have authorized agents to sign bonds in its behalf, but an individual surety may not do so, according to the Code of Criminal Procedure, Article 17.08. A licensed corporate surety is not prohibited from designating a separate business entity as its agent for executing bail bonds; however, the corporate surety must obtain a separate license on behalf of each individual who ultimately acts as the surety's agent by executing the bail bonds.

MW-508 (RQ-768). Request from Henry Wade, criminal district attorney, Condemnation Section, Dallas, concerning authority of county fire marshal with respect to arson investigation.

Summary of Opinion. The county fire marshal is responsible for arson investigation within unincorporated areas of Dallas County, but not within incorporated areas. If requested by an area city to investigate an arson case within the corporate city limits, the county fire marshal must act in the capacity requested. The county fire marshal is responsible for inspecting, for fire prevention purposes, county facilities within unincorporated areas, and for inspecting private businesses in unincorporated areas as circumscribed by the fourth amendment of the United States Constitution, and by the Texas Constitution, Article 1, §9. The county fire marshal is empowered to order the abatement of fire hazards in unincorporated areas. Area municipalities may enforce their fire codes over county owned facilities within incorporated areas.

MW-509 (RQ-618). Request from Henry Wade, criminal district attorney, Dallas, concerning longevity pay for deputy sheriffs.

Summary of Opinion. Texas Civil Statutes, Article 3912f-7, requires that deputy sheriffs be given "not less than \$5 per month for each year of service in the department," whether or not such service is continuous.

MW-510 (RQ-840). Request from George N. Rodriguez, Jr., El Paso County attorney, concerning alteration of city firemen, policemen, and fire alarm operators pension fund.


Summary of Opinion. Neither division of the firemen, policemen, and fire alarm operators fund established pursuant to Texas Civil Statutes, Article 6243b, may be tanged without a uniform change in the ther division.

TRD-826953

MW-511 (RQ-733). Request from Sam Kelley, consumer credit commissioner, Austin, concerning construction of the Insurance Code, Article 3.53, §8B, regarding refund of unearned insurance premiums on terminated policies.

Summary of Opinion. For credit transactions covered by the consumer credit chapters, subtitle two of the Texas Credit Code, all unearned credit insurance premiums must be refunded except for amounts totaling less than one dollar (Texas Civil Statutes, Articles 5069-3.18(6), 5069-4.02(6), 5069-5.03(6), 5069-6.04(9), 5069-6A.8(10), 5069-7.06(8)). These requirements are unaffected by the 1981 amendment to the Texas Insurance Code, Article 3.53, §8(B).

Emergency Rules

An agency may adopt a new or amended rule, or repeal an existing rule on an emergency basis, if it determines that such action is necessary for the public health, safety, or welfare of this state. The rule may become effective immediately upon filing with the *Texas Register*, or on a stated date less than 20 days after filing for no more than 120 days. The emergency action is renewable once for no more than 60 days.

An agency must submit written reasons, published in the *Register*, for emergency action on a rule. The submission must also include a statement of the legal authority under which the emergency action is promulgated and the text of the emergency adoption. Following each published emergency document is certification information containing the effective and expiration dates of the action and a telephone number from which further information may be obtained.

Symbology in amended rules. New language added to an existing rule is indicated by the use of **bold text**. [Brackets] indicate deletion of existing material within a rule.

TITLE 31. NATURAL RESOURCES AND CONSERVATION

Part II. Texas Parks and Wildlife Department

Chapter 65. Wildlife
Subchapter H. Wildlife Management
Areas Hunting, Fishing, and Trapping

31 TAC §§65.191, 65.194, 65.197, 65.202, 65.207-65.213, 65.217, 65.219

The Texas Parks and Wildlife Commission in a regularly scheduled public hearing on September 2, 1982, adopted on an emergency basis amendments to §§65.191, 65.194, 65.197, 65.202, 65.207-65.213, 65.217, and 65.219 of this title. Sections 65.191-65.224 constitute the Wildlife Mangement Areas Hunting, Fishing, and Trapping Proclamation.

The adopted amendments rename the Choke Canyon area, add a new unit to the Las Palomas area, add the Walter Buck area, delete specific dates for seasons, provide mourning dove hunting on two units of the Las Palomas area, provide a white-winged dove season on one unit of the Las Palomas area, provide limited pheasant hunting on the Granger Unit, and clarity where fishing is permitted on the J. D. Murphree area

The commission finds that imminent peril to the public's wildlife resources requires the adoption of the amendments on an emergency basis.

The amendments are adopted on an emergency basis under the authority of the Texas Parks and Wildlife Code, Chapter 18, Subchapter E.

§65.191. Application. The provisions of this subchapter apply to all of the wildlife resources in the following areas:

- (1)-(3) (No change.)
- (4) James E. Daughtrey [Choke Canyon] Wildlife Management Area in Live Oak and McMullen Counties;
 - (5)-(10) (No change.)
 - (11) Las Palomas Wildlife Management Area: (A)-(F) (No change.)
 - (G) Prieta Unit in Starr County; [and]
 - (H) Voshell Unit in Cameron County; and
 - (I) Penitas Unit in Hidalgo County;
 - (12) (No change)
- (13) Walter Buck Wildlife Management Area in Kimble County.

§65.194. Consent.

- (a) (No change.)
- (b) The department shall charge a permit fee based on the costs to the department in compliance with Texas Parks and Wildlife Code, §81.403(c). Permit holders will be allowed to harvest game in accordance with established daily bag limits on the particular area hunted.
 - (c) The permit fees are:
 - (1)-(6) (No change.)
 - (7) pheasant-\$10;
- (8)[7] mourning doves and/or white-winged doves—\$5.00;
 - (9)[8] waterfowl-\$4 00;
 - (10)[9] predatory animals (feral hogs)—\$10.

§65.197. General Regulations.

- (b) All vehicles shall be restricted to designated roads. Parking will be permitted only in designated areas. [On the Granger Unit, parking is permitted only along roads and in such manner as to not obstruct traffic.]

§65.202. Hunting Permits.

- (c) A special permit is required for the hunting of deer, javelina, feral hogs, turkey, and exotic animals on

- the following wildlife management areas: Gene Howe, Walter Buck, Gus Engeling, James E. Daughtrey, [Choke Canyon,] Matador, Kerr, Black Gap, Sierra Diablo, Chaparral, and the Somerville and Pat Mayse Units of the Eastern Wildlife Management Arca, except during the deer archery only season on Somerville and Pat Mayse Units of the Eastern Wildlife Management Area. A special permit is also required to hunt white-winged doves on the Penitas Unit of the Las Palomas Area, and pheasants on the Granger Unit of the Eastern Wildlife Management Area.
- (d) A regular permit (issued on a first-come first-served basis at the area) is required for the taking of quail, squirrel, and waterfowl on the Genc Howe, James E. Daughtrey, [Choke Canyon,] Matador, Gus Engeling, Black Gap, Chaparral, and J. D. Murphree Areas, and for mourning dove on the Chaparral Area, and the Penitas and Longoria Units of the Las Palomas Area.
 - (e) (No change)
- §65.207. Deer and Exotic Mammals.
 - (a) (No change.)
 - (b) Archery only season—open season.
 - (1) (No change.)
- (2) James E. Daughtrey [Choke Canyon] (special permit): during the month of October [October 1-30, 1981].

- (5) Gene Howe (special permit): during the period from the Saturday nearest October 15 through the third Sunday in January [November 14, 1981, through January 3, 1982].

Part IX. Texas Water Commission Chapter 263. General Rules

31 TAC §263.18, §263.19

The amendment also provides for a minimum fee to be charged if a hearing is cancelled without reasonable notice to the reporter.

The amendment to §263.19 provides for the commission to receive the original and one copy of a transcript and for the sale of additional copies.

These amendments are adopted on an emergency basis in order to conform the rules to a reporting services contract which is effective on September 1, 1982.

§263 18. Proceedings [Hearings] A hearings reporter shall be provided by the commission to transcribe a proceeding upon the timely written request of any party. When a reporter is provided at the request of a party, the party requesting the transcript shall pay all costs associated therewith, or the commission may assess the costs to one or more of the parties to the proceeding. When a hearing is cancelled, a minimum reporting fee, as determined by the commission, may be charged to the party responsible for the cancellation unless reasonable notice has been given to the reporter. If the commission is unable to provide a reporter, a party may furnish a reporter, at that party's expense, who may be appointed by the commission as the official reporter for the proceeding. All other hearings will be electronically recorded. [An agency hearings reporter may be provided by the commission to report a hearing or conference. A party to a proceeding may request in writing that the commission provide an agency hearings reporter. When an agency reporter is provided at the request of a party, the commission may assess the cost among the parties to the proceeding. If the commission does not provide an agency reporter, a party may furnish a reporter who may be appointed by the commission as the official reporter for the proceeding. All other hearings will be electronically recorded.]

§263.19. Transcription of Proceedings [Hearings].

(a) Upon being requested by a party to transcribe a proceeding, the hearings reporter shall provide the original and one copy of the transcript free of charge to the commission within the time period requested by the party. Copies of the transcript may be sold by the reporter, but the commission shall not be precluded from complying with the provisions of the Open Records Act, Texas Civil Statutes, Article 6252-17A. A party may file a motion to offer corrections to a transcript after the transcript is filed in a proceeding. The presiding officer will include the motion in the record and may order any of the corrections made. [Upon being requested by the commission or by a party to transcribe a hearing or conference, the hearings reporter shall provide the original

transcript free of charge to the commission within a reasonable period of time after the close of the hearing or receipt of the written request. Copies of the transcript may be sold by the agency reporter at a rate to be determined by the commission. A party may file a motion to offer corrections to a transcript after the transcript is filed in a proceeding. The presiding officer will include the motion in the record and may order any of the corrections made.]



Withdrawn Rules
