ANNUAL MEETING MINUTES

Texas Chapter American Fisheries Society Annual Meeting, January 25, 2000 in Bossier City, Louisiana.

- The meeting was called to order by president Paul Hammerschmidt.
- A motion to approve the minutes of the last meeting as printed in the Newsletter was made by John Prentice and seconded by Brian Van Zee.
- The secretary/treasurer reported that as of December 31, 1999 the Chapter had combined investment and checking account assets of \$41,102.00 (10,002 in checking and 31,100 in investments). The total expenses for 1999 were \$11,448.45 with an income of \$12,659.69. Debbie Wade also informed the membership that a portion of the investment capital had been placed in a growth fund.

Expenses for the annual meeting were \$10,633.53. Income was \$10.628.85, which breaks down as:

- Motion to accept the treasurer's report was made and seconded. The motion carried.
- The newsletter is currently sent out quarterly with approximately half the issues being sent out electronically.
- Committee reports:

Stocks at Risk – Bob Edwards:

- The Devils River minnow (*Dionda diaboli*) is now listed as a federally threatened species. A cooperative team, Devils River Minnow Conservation Team, consisting of government agencies, private landowners and other stakeholders was formed to gather information on the minnow.
- The speckled chub has been split into different species assemblages. This affects Texas fish by placing the four-

- barbeled form of speckled chub in the Panhandle region into a separate species, *Macrhybopsis tetranemus* while elsewhere in the state the populations remain *M. aestivalis*.
- Grass carp are to be introduced into the lowermost Rio Grande to control hydrilla and water hyacinths. The impact on native fauna is unknown.
- The slenderhead darter's (*Percina phoxocephala*) distribution has been extended to Texas.
- Pure Guadalupe Bass continue to be stocked into the upper Guadalupe River. Preliminary results suggest that these stocked individuals may be migrating downstream forcing the hybrid individuals upstream.
- As a part of the ecological studies of the Devils River Minnow a new *Gambusia* was located in San Felipe Creek in Del Rio. This species is a member of the *Gambusia nobilis* species group and appears most closely related to *Gambusia krumholtzi*, a species found several hundred kilometers downstream in a very limited area in Mexico. Two members of the committee are currently describing the new species. Its distribution and abundance suggests that the species is a likely candidate for federal and state protection.
- A Conservation Agreement has been signed for the Pecos pupfish, *Cyprinodon pecosensis*. Encouraging first steps in this agreement have been amended regulations concerning non-native bait minnows in west Texas and New Mexico and the TPWD Landowner Incentive Program which is currently establishing off-channel refugia for the Pecos pupfish in Texas.

Publicity and Exhibits – Bobby Miller:

- Special thanks to the Bidders and to those who contributed to the auction raffle.
- The committee members were thanked for collecting and bringing all of the items to the meeting.
- All of the Auction items were paid for during the banquet.

Nominating Committee – John Moczygemba:

- The mail-in-ballots were very successful.
- Gordon Linam was announced as the next presidentelect.

Membership – Kevin Pope:

- Reminder to pay dues if you haven't.

Continuing Education – Bruce Hysmith:

- Three classes were held as part of the annual meeting this year. Attendance were as follows: Hydro acoustics 100 participants, Exotic Species 40, Electrophoresis 64.
- Suggestions for Continuing Education topics can be sent to Bruce Hysmith.

Issues - Perry Trial:

- Concerns about the unregulated harvest of Mollusks on the coast.
- Concerns about the impact of grass carp in the lower Rio Grande.

The Endowments committee presented three scholarships in the name of TCAFS. They went to Calub Shavlik, a graduate student at Texas Tech University; Mandy Cunningham, an undergraduate at Texas Tech University; and to Laurianne Lancaster a graduate student at Sam Houston State University.

MARCH EXCOM MINUTES

The first TCAFS ExCom meeting for 2000 was held March 28, 2000 at the TPWD Waco Regional Office. Charlie Munger, Gordon Linam, Aaron Barkoh, John Prentice, and Deborah Wade were present. The meeting was called to order at 1:00 p.m. by Charlie Munger, President.

- Debbie presented the treasurer's report: the TCAFS currently has \$47,350.46 total funds available. This is a net increase in both investments and checking from the March 1999 combined statement of \$11,388.46. This increase is the result of wise investments and the move of some funds to a higher risk account. Expenses for the 2000 meeting totaled \$10,633.53 with income being \$10,628.85 for a net loss of \$4.68 between the three chapters.
- John Prentice made the motion to accept the treasurer's report and Aaron Barkoh seconded it. The motion passed.
- Gordon Linam has begun planning the 2001 meeting, which will be held in Central Texas. This will be the 25th Anniversary meeting of the TCAFS. A possible topic for the panel discussion is "Value of the Environment".
- Committee Reports:

Newsletter- Submission deadline for the spring issue of the newsletter is April 5. More importantly Brian believes that he has resolved the email distribution problems that occurred during the fall of 1999.

Awards- John Prentice has put together a committee consisting of Danny Lewis, Fran Gelwick, Dave Buckmeier, Tom Wagner, Joe Warren, and Ray Drenner. The committee's first task is to determine who won the Best Presentation awards from the 2000 annual meeting. The second area of concern is attempting to raise awareness of the fishery workers awards and increase the number of nominations from the membership. The final project for the awards committee is to update the Procedures Manual to include the Outstanding Student Award.

Editorial- Aaron Barkoh has taken over as chair of the Editorial Committee that consists of Joe Fries, Larry McKeron, and Dave Buckmeir. They are getting ready to begin the editorial process for the 2000 proceedings.

Continuing Education- Bruce Hysmith as always is seeking suggestions for Continuing Education classes for the 2001 meeting. If you have any please contact him or a member of the ExCom committee with your ideas.

Nominating- John Moczygemba reported that mail out ballots were an outstanding success with a greater membership response than ever before.

Publicity/Exhibits- Bobby Miller is seeking committee members from all over the state to help with this committee. Student Outreach - The Student Outreach Committee is currently vacant, Larry Hysmith was suggested as a possible committee Chairman.

- It was moved that the Student Scholarships be increased in value to \$750.00. The Motion was seconded and passed unanimously.
- Tentative dates have been set for the Ex-Com meetings for the rest of this year: June 20th, September 19th, and November 28th. All of the meetings will be held in Waco at 1:00 p.m.
- A motion was made to adjourn and it was seconded. The meeting was adjourned at 3:30pm.

At the 2000 Texas Chapter annual business meeting in Bossier City, the Awards Committee introduced a new award for Outstanding Fisheries Student. This award is added to include students and to compliment the six categories which have been utilized previously: Administration, Culture, Education, Management, Research and Technical Support. Award criteria are listed below to familiarize our membership

and encourage nominations. Any member having experience with students is encouraged to participate in nominations. On a general note, nominations for any of the Texas Chapter awards are always encouraged, so be aware and make the effort when you find someone deserving.

Award criteria: Outstanding Fisheries Student

- Only Texas Chapter AFS members in good standing can make nominations. All members who have knowledge of student performance or activities are encouraged to make nominations for this award.
- The nominee must be a member in good standing and must be enrolled in, or recently graduated from, a Texas College or University since the last Texas Chapter AFS annual meeting.
- 3. Students can be nominated at any time during their tenure for work spanning single or multiple years, but no later than 12 months after graduation.
- 4. Notable accomplishments by the nominee should include one or more of the following:

Student research which adds to the understanding, or solution, of a fisheries-related problem. Research can be basic or applied in nature, can involve nongame or game species, and need not be conducted in the State of Texas.

Dissemination of research results in, in order of importance, a peer-reviewed publication, thesis or dissertation, non-refereed publication, or an oral presentation.

Involvement in professional organizations including participation in committees, organizing or moderating a technical session at a professional meeting, or serving in a peer-elected office.

Academic excellence.

Merit-based scholarships or grants.

- 5. Honorable mention may be awarded, for recent graduates only (those who have graduated within 12 months after the last Texas Chapter AFS annual meeting), if more than one nominee is considered Outstanding by the Awards Committee members.
- 6. The award will not be made in any year for which no appropriate candidates are nominated.

This award and these criteria are official as of the January 2000 business meeting. Criteria are being included in the Texas Chapter Procedures Manual for future reference. It all starts with a nomination from you. Thanks!

Every year in Texas Chapter AFS history there are few nominations for the various awards that can be offered. There are various reasons this can happen, but lack of qualified members is likely not among those reasons. One reason is putting off the consideration until the next annual meeting approaches and the awards committee begins to put reminder articles in the newsletter. Well guess what, here is the first newsletter of the year and you are getting the first request. In addition you will see an article in each newsletter to follow. Check out the award criteria below (and remember there is a new award for students also listed) and keep the thought of nominating someone on your mind. It takes only a little effort to write out your explanation of criteria for why this person should be awarded, but it is worth the effort! Also, the deadline for submission is far enough away at this time that there is no time crunch. We are not even going to talk about a deadline for awhile, but you know it will be next winter sometime. There is a form for nominations below to help you in your considerations.

Each year nominations are solicited for Outstanding Fisheries Worker of the Year in seven (7) categories: Administration, Culture, Education, Management, Research, Technical Support, and Fisheries Student.

One award may be made per category. The nominee must be a member in good standing of the Chapter. The award is based on fisheries-related work accomplished in Texas (except student related work, see student criteria below) and can span more than one year. Criteria for the awards follow the "nomination form" below. Please, be thorough and concise in your description of qualifications!

Additionally, an award for Special Recognition in Fisheries Work can be made, when warranted. This award can recognize the efforts of individuals who do not belong to the Chapter, or whose efforts do not readily fall within one of the formal categories above. Criteria for the awards follow the "nomination form" below. <u>Please</u>, be thorough and concise in your description of qualifications!

AWARD CRITERIA

Administration

- Development of innovative management programs, research activities, or facilities that significantly affect fisheries management and conservation on a regional or statewide level.
- Leadership in implementation of regulations or management programs that address regional or statewide fisheries issues.
- 3) Development of new sources of funding for fisheries programs.
- 4) Leadership in the development of public outreach or recognition/award programs.
- Significant and effective promotion of fisheries management and conservation activities on a regional or statewide level.

Culture

- 1) Development of techniques that produce fish more safely, more efficiently, or more economically.
- Development of methods that produce species not formerly cultured.
- 3) Development of procedures that produce more fish.
- 4) Participation in the development of equipment that benefited fish culture.
- 5) Promotion of fish culture.
- 6) Participation in the production of a record number of fish (may be station- or species-specific).

Education

- Development of an innovative approach to fisheries education as illustrated through development of a new or revised course or curriculum.
- 2) Publication of a journal article, extension publication, book, or book chapter that contributed significantly to fisheries education.
- 3) Contribution of notable service in public education programs.
- 4) Development of educational media (software, videotape, slide-tape, etc.) that contributed significantly to fisheries education.
- 5) Outstanding contributions to the profession through service as an officer or other leader of an educational organization ((e.g., the Education Section of the American Fisheries Society).

Management

 Development of management plans or strategies or implementation of management practices (reservoir or pond management plans, pre-impoundment work, habitat work, development of urban fisheries). This would include private water work.

- Education of the public in areas of fishing or fisheries management (conducting fishing clinics, educational programs, contact with various media, development of brochures, newsletters, bulletin boards, fliers, popular articles, etc.).
- 3) Coordination with different agencies (cities, counties, or federal government) or reservoir controlling authorities to develop or implement management strategies.
- 4) Participation in professional scientific organizations in the fisheries field to include offices held, committees served on, or other activities accomplished for the organization.

Research

- 1) Research contribution should add to the understanding of a biological problem or to solving a resource problem.
- Research contribution can be basic, applied, or a combination.
- 3) Research contribution should have been disseminated, in order of importance, in a peer-reviewed journal, non-peer reviewed publication, or an oral presentation.
- 4) Participation in professional and public organizations in the fisheries research field that comment on, advise, or review research activities.
- 5) In order of importance, the nominee's role in a research project should be directing the project or program, establishing the project or program, analyzing data, or conceiving the project or program.

Technical Support

- 1) Development of new or improved design and/or construction of equipment used in field sampling, culture, lab analyses, etc.
- 2) Participation in some outstanding or unique management, research or culture activities which aided the fisheries profession.
- 3) Participation in education programs for fisheries workers or the public.
- 4) Accomplishments resulting in new or improved techniques or efficiency.

Fisheries Student

- Only Texas Chapter AFS members in good standing can make nominations. All members who have knowledge of student performance or activities are encouraged to make nominations for this award.
- 2) The nominee must be a member in good standing and must be enrolled in, or recently graduated from, a Texas College or University since the last Texas Chapter AFS annual meeting.
- 3) Students can be nominated at any time during their tenure for work spanning single or multiple years, but no later than 12 months after graduation.

4) Notable accomplishments by the nominee should include one or more of the following:

Student research which adds to the understanding, or solution, of a fisheries-related problem. Research can be basic or applied in nature, can involve nongame or game species, and need not be conducted in the State of Texas.

Dissemination of research results, in order of importance, a peer-reviewed publication, thesis or dissertation, non-refereed publication, or an oral presentation.

Publicity/Exhibits Committee – Chair, Bobby Miller, (281) 474-2811, bobby.miller@tpwd.state.tx.us




