### President's Message

I hope that each of you are enjoying the summer so far and are already making plans to attend the Annual Chapter meeting scheduled for Junction in January 2002. Gene Wilde reports the meeting is already shaping up to be a great one. I have attended several meetings at the Texas Tech facility in Junction which Gene has reserved for our Chapter meeting. It is a very nice facility and a great location choice for the 2002 meeting. In addition to the nice building facilities, the South Llano River runs along the property providing not only recreational opportunities but also an outdoor classroom for some continuing education possibilities that Bruce Hysmith is considering.

I am very pleased and excited to announce that Ray Mathews, Jr. has produced the first draft of our Texas Chapter's history. These were distributed at the last Executive Committee meeting. We are looking for interested reviewers (who have some history behind them) to take a look at this draft. If you are interested in getting a copy please contact one of the Executive

Committee members or Committee Chairs listed within this newsletter. Ray is also still interested in obtaining photographs from past Chapter meetings and activities for the archives.

On another note, Kevin Pope (Membership Committee Chair) provided some very interesting facts concerning the Chapter's membership at our last Executive Committee meeting. Presently the chapter has 216 members, of which only 22 are students. The paucity of student members was a very big surprise to me and encourages a renewed emphasis on reaching out to fishery students. Kevin and I are going to draft a letter to the respective departments of every Texas university which has fishery and/or environmental studies in order to re-introduce the Texas Chapter to them as well as outline the benefits of joining. Larry Hysmith (Student Outreach Chair) is also planning some new activities for the Chapter meeting which hopefully will attract more students. Another surprise from the Membership Committee research is the high membership turnover. Our total membership numbers have remained relatively stable over the last few years; however, the individuals comprising those numbers change considerably. For example, 73 individuals who were members during 2000 did not renew their membership in 2001; however, 64 new members came on board to replace them. The Executive Committee will be looking at ways to retain membership and to decrease this high turnover rate.

## TCAFS ExCom Meeting Debbie Wade

The second TCAFS ExCom meeting for 2001 was held July 16, 2001 at the TPWD District Inland Fisheries Office in Abilene. A special thanks goes to the Inland Fisheries District 1-B crew for fixing lunch. The fish was great. Special thanks goes to Galen Jons for modeling hats. In attendance were Gordon Linam, Gene Wilde, Kevin Pope, Robert Mauk, John Mocyzgemba, Bruce Hysmith, Larry Hysmith, Aaron Barkoh, and Deborah Wade.

- The meeting was called to order at 1:00 p.m. by president Gordon Linam.
- Secretary/Treasurer—reported current combined balance as of June 30, 2001 is \$27,728.95 with \$7,117.00 in checking and \$20,611.95 in investments. The market is still going down and the investment councilors for this account continue to advise waiting things out predicting the market will get better in a few months. Of course I also hear this about my 401K, which also is looking somewhat anemic.
- **President-elect** Gene Wilde presented an update on the 2002 meeting that will be held January 20-22, 2002 at the Texas Tech University Campus in Junction, Texas.
- **TTU Student Chapter** their second fish fry fundraiser was successful despite some minor problems. Activity is suspended until the beginning of the fall semester.
- **Newsletter** Robert Mauk stated that 191 copies of the newsletter were e-mailed to the membership and others and 139 were mailed in April.
- Awards— Danny Lewis sent a report. The TCAFS webpage has been updated with the award information so that it is even easier for members to nominate individuals for recognition within TCAFS. The committee has developed a new award for the membership's consideration, that of poster presentation which will be judged at the annual meeting each year.
- Continuing Education—Bruce Hysmith began by saying that he was seeking topics for this year's meeting. Topics suggested by the ExCom included: stream discharge measurements, stream accessibility issues, fish disease especially the LMBV and issues relating to golden and other toxic algae blooms.
- Editorial— Aaron Barkoh has mailed all of the proceedings to members and university libraries. He has sent out a call for manuscripts and updated abstracts for the proceedings, which will go to the reviewers in early August.
- Membership—Kevin Pope distributed a list of current and last year's members. Presently we have 216 members with 64 new members. We lost 73 members from last year. We currently have 22 student members down from 30 last year.

We need to urge our co-workers to join and participate in TCAFS

- **Nominating** John Mocyzemba, the mailout system is working well and will be continued.
- **Publicity and Exhibits**—Cody Winfry asked if the chapter wished to have caps made for the next meeting. The ExCom agreed that this was a good idea and several caps were examined to determine the style most likely to be chosen by the membership.
- Student Outreach—Larry Hysmith is very excited about this position and had several suggestions for activities at the upcoming meeting in an attempt to encourage more participation on the part of both students and professionals. Among the suggestions were a college quiz bowl and photo contest (open to all members) look for further information in the newsletter.
- Ad Hoc Committee: Archives—have been completed and are in the process of being reviewed. Volumes 8, 10, 14 and 15 of the proceedings could not be located. If anyone has a copy of these please contact a member of the ExCom so that we can add a copy of each to the archives.
- Endowments, Internet, Issues, Pond Management– no reports.

#### Old Business:

- Gordon has made a list of everyone receiving courtesy copies of the newsletter and requested that it be reviewed to see if some can be deleted and if others need to be added to the list.
- The chapter needs to look at having a focused membership drive targeting members who did not attend the last meeting, under-represented areas of the state, and universities.

### • New Business:

- Gordon submitted the paperwork for Chapter of the Year Award to both the parent organization and to the Southern Division AFS.
- The next ExCom meeting will be held in Abilene at the TPWD District Inland Fisheries Office in October.

This year, for the very first time, you may nominate someone online, by going to the Texas Chapter website (<a href="http://www.sdafs.org/tcafs">http://www.sdafs.org/tcafs</a>) and clicking the "Awards" link. A list of criteria for each award may be found there as well.

Each year nominations are solicited for Special Recognition and Outstanding Fisheries Worker of the Year in seven (7) categories: Administration, Culture, Education, Management, Research, Technical Support, and Fisheries Student.

### **AWARD CRITERIA**

### Outstanding Fisheries Worker of the Year

- Nominations can be made only by members in good standing.
- The recipient must be a member in good standing.
- The award is based on fisheries-related work accomplished in Texas and can span more than one year.
- The worker may not be on the Awards Committee.

### Special Recognition in Fisheries Work

- Nominations can be made only by members in good standing.
- The recipient may or may not be a member.
- The recipient may be an individual or an organization.

- Recognition should be based on fisheries-related work done in the State of Texas, but can span more than one year.
- Work may, but does not have to, fit into the 7 categories listed above.

# CARA PASSES U.S. HOUSE COMMITTEE

The bipartisan Conservation and Reinvestment Act (CARA, H.R. 701) introduced by Congressmen Young (R-Alaska), Hansen (R-Utah), and Tauzin (R-Louisiana) passed a major milestone when the House Resources Committee voted 29-12 to report the bill to the full U.S. House of Representatives. Last session, CARA passed the House and a Senate committee, but never made it out of the full Senate. CARA would use federal oil and gas receipts to fund land conservation, wildlife and recreation programs, as well as "impact aid" for coastal states. The bill would provide an estimated \$130 million per year in new federal matching dollars for Texas, benefiting coastal areas, state and local parks, wildlife, historic sites, educational efforts and private landowners. The new version of CARA includes stronger property rights protections. The bill mandates that each federal land acquisition be a federal budget line item, so that members of Congress may object to any land purchase in their districts. CARA also fully funds the Payment In-Lieu of Taxes (PILT) program that helps local communities offset lost property taxes after land is acquired by the government. H.R. 701 prohibits the federal government from using adverse condemnation to acquire new lands. CARA funds will not be used to acquire property unless the owner willingly agrees to sell or if the acquisition receives express Congressional approval. Some conservationists support the bill, but many have opposed it, expressing concern that the bill inadequately constrains the use of royalty receipts to be devoted to conservation purposes, and creates an incentive for other states to support coastal drilling off Alaska. A vote is expected after the August recess.

### **Water Planning in Texas**

In June 1997, Governor George W. Bush signed into law Senate Bill 1 (SB 1), comprehensive water legislation enacted by the 75th Texas Legislature. This comprehensive water legislation was an outgrowth of increased awareness of the vulnerability of Texas to drought and to the limits of existing water supplies to meet increasing demands as population grows. The state's population is expected to increase from its current level of about 19 million to more than 39 million people by the year 2050. SB 1 designated the Texas Water Development Board (TWDB) as the lead state agency for coordinating the regional water planning process and developing a comprehensive state water plan. To accomplish these tasks, the TWDB developed planning guidance documents to govern how regional water plans were to be developed, delineated sixteen planning areas, and designated planning group representatives. The regional water planning groups (RWPG) were charged with the task of determining how future water needs in their respective regions might be met. The preparation and adoption of the plans are now complete. Each regional water plan includes information about water supplies and demand, water quality problems affecting water supply, and social and economic characteristics of the region. The plans also identify water supply threats to agriculture and natural resources. Information concerning current preparations for drought and the status of other water plans in the region are also reviewed. These planning efforts have culminated in the proposal of a number of new major reservoirs and major water conveyances (see figures). ### PROPOSED MAJOR RESERVOIRS (greater than 5,000 acre-feet of storage capacity recommended to meet specific needs)




#### PROPOSED MAJOR CONVEYANCES




