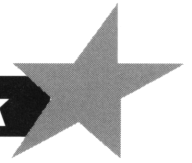

## Hard hats, vests, safety gear: wear 'em

Safety — it's the most important thing to think about as the workday begins. It's no less important to remember as the workday continues, especially for TxDOT people who do their jobs in high-danger environments.

A recent incident southeast of Dallas on Interstate 35 East, detailed on page 12, reminds us of the importance of safety precautions.

Please help us make the 123 Safe Days of Summer campaign a success. Each year between May and August, work-zone accidents and injuries increase significantly.

All safety rules and procedures applying to regular employees also apply to summer hires, temporaries, project employees, and anyone else who works for the department. Each supervisor is responsible for ensuring a safety orientation is provided.

Remember, highway crews work in one of the most dangerous professions anywhere. Roadway work involves a partnership between the traveling public and TxDOT employees. Unfortunately we have no control over the public's driving habits, alertness or attitudes.

Supervisors should focus summer safety meetings on high-exposure areas, accident prevention, and past summer accidents and injuries. Each morning, construction supervisors, maintenance supervisors and crew leaders should conduct a brief safety review of the activities planned for that day. This meeting establishes the game plan for reducing accidents or injuries.

If a hard hat, reflective vest or protective shoes are supposed to be worn on the job, wear them. Not because it's policy — although it is — but because we want everyone to come back safely from their TxDOT workday.

The contractor injured so severely in the recent work-zone incident near Dallas must be grateful he wore the hardhat required. He was thrown with such force his hardhat broke when he hit a dump truck. The safety equipment did its job and probably saved him from more severe injury. Keep in mind, the equipment can't work if it isn't worn as directed.

The unexpected often happens when we let down our guard. Remember the importance of making safety a habit throughout the year. ★

# Stotzer, Barnhart join Hall of Honor

Raymond Stotzer and Ray Barnhart, two of the transportation industry's most prominent contributors, were inducted April 19 into the Texas Transportation Hall of Honor during ceremonies at TxDOT's main office in Austin.

Stotzer served as engineer-director for TxDOT and Barnhart is both a former commissioner and former administrator of the Federal Highway Administration (FHWA).

"The Hall of Honor is intended to recognize that small group of people whose vision and exceptional leadership made possible the outstanding transportation system we have today," said Dennis Christiansen, deputy director of the Texas Transportation Institute (TTI).

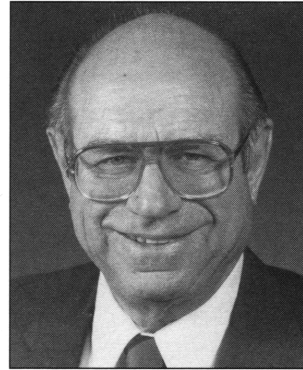
Noting the institute established the hall in 2000, Christiansen said, "We are proud and thankful to recognize these great leaders for what they've given the people of Texas and the nation."

Stotzer's service to TxDOT

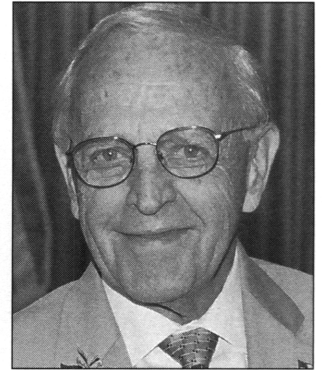
spanned more than 40 years. He began as an entry-level engineer in 1947 and became district engineer in 1968, serving in that position for both the Pharr and San Antonio districts. He led the development and construction of the Queen Isabella Causeway, and he addressed congestion in San Antonio by improving major free-ways.

Colleagues note Stotzer was willing to take risks to pursue innovative ideas in areas such as organizational structure, highway design, and right-of-way acquisition.

He was named distinguished alumnus of the College of Engineering at Texas A&M University and Citizen of the Year by the North San Antonio Chamber of Commerce. He also

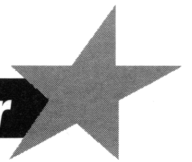

received the TTI Luther DeBerry Award in recognition of his outstanding contributions in the field of transportation. He became the state highway engineer-director in 1986 and served in that position until his death in October 1989.

Barnhart, administrator of the FHWA from 1981 to 1987, earned praise from associates for his leadership, easy manner, and communication skills. His tenure was marked

The last Olds came off the assembly line in Lansing, Mich., in late April. That marked the end of America's oldest motor-vehicle brand name, one that endured more than a century. But circumstances change, no matter how good your brand name.

At TxDOT, one of our older brand names is *Transportation News*. In one format or another, the department has been providing its employees news under that name

since the 1940s. We're not about to give up that identifier, but effective with this issue, we are changing.

From now on, *Transportation News* will be published four times a year instead of monthly. We can explain this change in two words — the Internet.

The ease with which we can compile and disseminate information online makes a newsletter on paper seem just about as quaint as an Oldsmobile Rocket 88, or the older song, "In My Merry Oldsmobile."

For years, TxDOT employees have had to wait a month, sometimes more, to read what's going on in the department.

To remedy that, soon we will launch TxDOT News Service —

TNS for short. It will appear on the Public Information Office's intranet site, right along with TNews Online and other PIO publications.

TNS will be similar to the Associated Press or CNN, though we will post TxDOT news only when it becomes available, not on any regular schedule. If you don't have access to a computer at work, others in your district, division or office will share the news with you by printing it out and posting or circulating copies.


In making this change, we expect to spare some trees by using less paper and save the department money in printing and postage costs

# TORNADO

## Bridges offer no place to hide

**The sight of a tornado suddenly appearing from thick dark storm clouds and descending to the ground is one of the most fearsome things imaginable.**

**Survival depends on finding the best possible shelter, a refuge that has a good chance of being intact after the storm has gone.**

Because a tornado can cause damage or destruction any place, a highway bridge is the worst place to seek shelter. A vehicle is the second-worst place.

"Most people don't think about the wind and potentially deadly debris that will come under that bridge later," says J.B. Hutchison, Paris District director of maintenance. He adds, "They know the rain and hail can't fall on you while you're under the bridge, but they're not thinking about the fact that if you're within a quarter-mile of a tornado you're not safe."

According to the National Weather Service (NWS), the winds from a tornado can pull a person from beneath a bridge. Beyond that, the shrapnel-like debris carried by winds that could reach speeds of more than 300 mph is extremely dangerous.

Nancy Smith, Lufkin District bridge engineer, says she thinks the idea of bridges as tornado shelters started with film footage of two tornado chasers.

"I still see the footage sometimes, but when I hear about places to take shelter on the Weather Channel they usually warn against using a bridge as a shelter," she says.

TxDOT's district bridge engineers and maintenance directors do not recall ever hearing of injury or death resulting from people seeking shelter under bridges in Texas.

"Of course, it never hurts to remind everyone about the danger," says Hutchison.

The NWS also cautions that vehicles provide no protection from a tornado. The weather service advises those facing a tornado to escape its path. If that's impossible, abandon the vehicle and get as far away from the roadway as possible. In the fierce winds of a tornado, flying vehicles become a distinct possibility.

The best protection after abandoning a vehicle is lying flat in a ditch or recessed area of the ground.

Texas faces more tornadoes than any other state. The Texas Almanac reports an average of 132 tornadoes touching down in the state every year, with 6,461 reported between 1959 and 2002.

For those who live where tornadoes occur with greater frequency, it's a good idea to keep a watchful eye on a darkening sky. But the NWS advises all Texans facing an approaching storm to stay abreast of weather advisories through the local radio or TV stations and be ready to take shelter. ❖

**Tips: tornado survival**

The National Weather Service advises those facing tornado warnings, tornado watches, or severe thunderstorm watches to take these steps to improve chances for survival.

- Watch for changes in the sky.
- Get the latest information on the storm by listening to radio or watching television.
- Take shelter if threatening conditions exist or there are signs of an approaching tornado.

The NWS offers these additional specific tips for storm survival:

- Do not seek shelter under a highway bridge.
- Get out of vehicles of any kind.
- If at home or in a building, move to a shelter such as a basement.
- If underground shelter is unavailable, move to an interior room or hallway on the lowest floor and get under a sturdy piece of furniture.
- Stay away from windows.
- Mobile homes of any kind offer little protection from tornadoes and should be abandoned.
- If no building or other safe structure is nearby, seek a recessed or flat place on the ground as far from any roads as possible. This avoids being hit by flying vehicles or parts. ❖

# Two from TxDOT find missing tyke

Two-year-old J. W. Eppler had been missing for a couple of hours from his home on a ranch in Albany when Tommie Brown, Shackelford County maintenance supervisor, heard over his radio a call for assistance from the Sheriff's office.

Brown, being from the area, knew the rugged terrain of the Nail Ranch. He summoned a few of his maintenance folks on their way back to the shop to help in the search.

Jesse Camacho, Ray Ramos, Charlie Tischler, Allen Hebel and Jim Hill answered Brown's call. Reaching the staging area in front of the boy's home deep in the ranch, Camacho and Ramos teamed up and started their search behind the Eppler residence.

J. W., blond-haired and blue-eyed, had wandered out of his front yard. He had managed to open the gate and disappear.

"The whole scenario was frightening," Camacho said. "About a block in front of the house there is a large, steep and deep stock tank and a few yards behind the home is a straight drop off into boulders and cactus."

The search was in full swing as Camacho and Ramos walked a creek bed until it ran into the fence line. A search plane circled overhead and a helicopter and dogs were on the way.

As the two maintenance technicians moved along the creek — Camacho in the bed and Ramos along the rim — Ramos said they

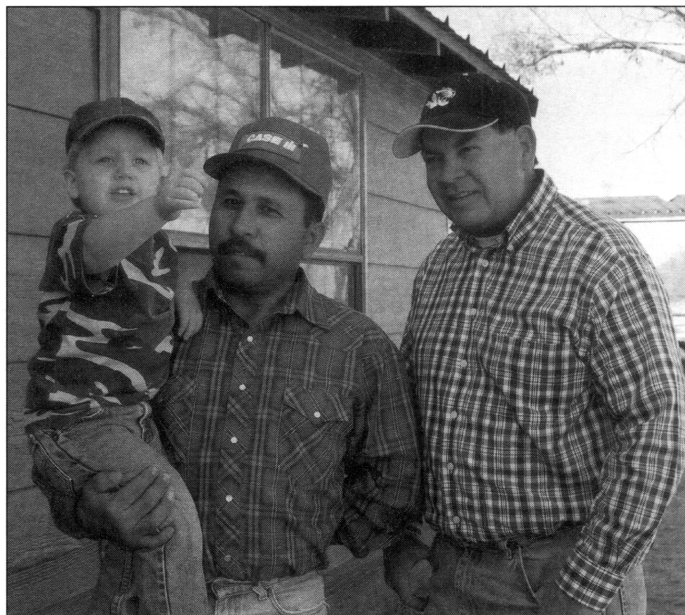
jumped coyotes, deer, and wild hogs.

"All kinds of thoughts went through my mind," Ramos said. "Having a child and grandchild myself, I walked with a heavy heart not knowing what we might find."

As they neared the fence line, they could hear the search airplane. "We were about to turn back as we had searched the area for more than an hour with no sign of activity," Camacho said. "Suddenly, we heard noises. All we could see were a couple of kittens playing in the dirt." Then, looking closer, Ramos spotted some blond hair between the tree limbs.

"We ran towards the boy and found him playing in the dirt near the kittens," he continued. "We called his name and he just looked up at us and grinned and went back to digging."

J. W. had followed a cow trail to a channel off the creek covered overhead by brush and trees. To make matters worse, the tyke wore his favorite hat — a camouflage baseball cap. In that location and wearing that cap, Ramos said, the

search plane could not have spotted him.

An excited Camacho and Ramos waved their hats at the plane after finding J.W. Not knowing if they had been seen, they also called a deputy sheriff walking nearby and he radioed for ground transportation.

Camacho carried J.W. to the Jeep when it arrived. Back at the ranch, emergency personnel checked the boy and pronounced him OK.

Shaya Eppler said that, when she discovered J. W. missing, she immediately ran up and down the road in front of their ranch house screaming for her son. When she was unable to find him, she called for help. Fortunately, TxDOT lent a hand. ✪

the Highway Trust Fund, to streamline procedures, to shorten delays, and to return management authority to the states.

While with FHWA, Barnhart established 42 centers at U.S. colleges and universities to promote technology transfer, and he restructured and strengthened the agency's programs for motor carriers and for interna-

tional highways.

Barnhart came to the Federal Highway Administration from Pasadena, Texas, where he lived when he served as a member of the State Highway Commission (now Transportation Commission) and forged a successful career in the utilities construction and insurance businesses. He also served as city councilman, state legislator, and chairman of the Texas Republican Party. ✪

# Fit Happens

## TxDOT people in Austin go 6.2 miles for the health of it

It's tough to walk and drink a cup of water at the same time. But water and sport drinks became "hot" commodities as almost 7,000 Texans — including 400+ TxDOT employees — navigated a 6.2-mile course in Austin during Gov. Rick Perry's Texas Round-Up fun-run and walk.

The April 17 event launched a new statewide health and fitness initiative, urging Texans to make healthier lifestyle choices.

According to the Center for Disease Control and Prevention (CDC), 75 percent of adult Texans don't get the recommended level of physical activity: 30 minutes or more, five days per week. The CDC says 62 percent of adults and 35 percent of Texas children are either overweight or obese. This costs the state, the CDC says, as much as \$10 billion annually, largely due to more frequent doctor visits and lost productivity.

TxDOT workers accepted the challenge to get moving and on race day wore matching TxDOT "road runner" shirts designed by Mike

Craig of the Vehicle Titles and Registration Division.

Others in the run also showed their creativity, from a trio of women who donned cowboy hats and attached beads to fringed strips along the bottom of their "Fit Happens" T-shirt to a gentleman, white hair flowing in the wind as he walked, whose T-shirt proclaimed him to be 93 years old, a realtor, and "still in love."

The 10-kilometer course began at the north end of the Capitol, moved north up Guadalupe Street, through the University of Texas area, Hyde Park, and back to Congress Avenue.

As the route narrowed from two lanes to one near 24th Street, participants funneled into the right lane and a local police officer joked, "If you want to become a statistic, you can get in the left lane."

On Duval, runners encountered cheerful neighbors with thumbs on their water hoses, spraying welcome arches of cool mist on those who passed by.

Many TxDOT employees formed teams to participate in the Round-Up event. Others completed

a six-week activity log, exercising 30 minutes or more five times per week at a minimum. Some did both.

Registered TxDOT groups included a department-wide team, along with teams from Amarillo, Bryan, El Paso, Paris, Wichita Falls, Childress, Houston, Tyler, San Antonio, Austin and Waco districts. Teams from the Construction, Information Systems, Maintenance, Bridge, Design, Traffic Operations, and Vehicle Titles and Registration (VTR) divisions, and from the Office of Civil Rights also participated.

"We hope this race inspired our co-workers to give more thought to their health and get moving," says VTR division director Jerry Dike, who coordinated TxDOT's participation in the challenge.

"We appreciate the governor and the TxDOT administration supporting this health, wellness and fitness program for all TxDOT employees," Dike said. ☺

## Tale of two bridges

# Flood, crash damage I-20 spans — west and east

The average annual rainfall in Reeves County is 11 inches — but sometimes Texas weather is far from average.

A spring storm dumped eight inches of rain in the watershed of Salt Draw between Pecos and Toyah on April 4, quickly transforming the normally dry draw into a chocolate-milk-colored torrent.

By 6:30 p.m. that day, Reeves County sheriffs' deputies and Department of Public Safety troopers stood by where Interstate 20 crosses the draw as water lapped dangerously close to the bridges. Officers stopped traffic on the interstate, but they could not stop the flash flooding.

At 7:20 p.m., an 86-foot section of the eastbound bridge collapsed into the water, then rushing 25-feet deep through the draw. Thanks to law enforcement and TxDOT barricades, no one was injured, but a major cross-country transportation corridor had been severed.

The rain also flooded nearby Toyah, a former railroad town with a population of 103. Three feet of water swept through the town, damaging some 50 residences.

Early the following day, Mike McAnally, Odessa District director

of operations, and Carolyn Dill, district maintenance engineer, arrived at the scene of the washout to assess the situation.

Built in 1968, the bridges daily handle 6,400 vehicles, mostly trucks. A big chunk of the eastbound bridge was gone and the westbound segment closed until its reliability could be assured.

By mid-week, after a second inspection of the bridge by a Bridge Division team from Austin, TxDOT engineers concluded that once the westbound bridge was shored up, it could be opened to traffic.

An emergency contract for \$1.2 million got the westbound bridge opened to two-way traffic on April

18. Restoration of the eastbound bridge was completed May 26, with the westbound span expected to be finished by the end of June. Gilbert Texas Inc., based in Fort Worth, got the \$3.65 million contract to handle the permanent repairs.

April turned out not to be a very good month for I-20. About the time the interstate re-opened to two-way traffic in west Texas, hundreds of miles farther east a 39-ton steel girder broke loose from a tractor-trailer rig and smashed into two bridge columns on the interstate west of Kilgore in TxDOT's Tyler District.

The accident occurred at 1:10 p.m., April 16, at the FM 2207 overpass on I-20.

"We're lucky the bridge didn't come down," a DPS trooper told the Longview News-Journal.

TxDOT closed the freeway to westbound traffic until the bridge could be made safe. Full repairs had been completed by May 28.

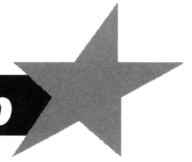
The contract for emergency repairs went to Longview Bridge and Road Inc. for \$149,599. ❄

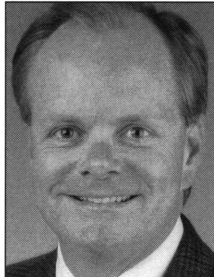






## TEGTMAYER LEADS WICHITA FALLS

Tegtmeyer had been director of construction for the Dallas District.

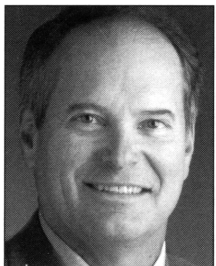
He began his TxDOT career in 1984 as an engineering assistant in the Waco District. He transferred to the Dallas District as an engineer in 1989, where he supervised the design section in the Hutchins Area Office.

He also served as project engineer in the East Dallas Project Office and area engineer for the Northwest Dallas County Area Office. In this position he was responsible for the interchange known as the Dallas High Five. At the time, this \$261 million project was the largest ever let in TxDOT history.

Tegtmeyer received his bachelor's degree in civil engineering in 1984 from Iowa State University.

## KEN BOHUSLAV TO RETIRE

Ken Bohuslav, director of the TxDOT Design Division, will retire June 30. Director of the division since 2001, Bohuslav has been credited with helping the department

stabilize the monthly lettings of construction contracts, which led to improved competition among bidders and has helped reduce project costs.

TxDOT Executive Director Mike Behrens said Bohuslav in 2003 directed the record-setting construction letting of \$4 billion, which included \$213 million in cost under-runs. Behrens also credited Bohuslav with developing and implementing new statewide policies on management of highway access and frontage roads.

Bohuslav began his TxDOT career in 1973 in the Safety and Maintenance Operations Division. In 1991 he received from the Texas Transportation Institute the Gibb Gilchrist Award recognizing outstanding service in highway engineering. A year later he received the Texas Award for Historic Preservation from the governor and the Texas Historical Commission.

## ERS SUMMER ENROLLMENT

The Texas Employees Retirement System (ERS) has scheduled the summer enrollment for the 2005 benefits-plan year for July 26-Aug. 20.

The theme for this year's enrollment will be "benefitness," which observes the governor's recent fitness initiatives such as the Texas Roundup and 10K walk.

ERS encourages employees to enroll and make changes through ERS Online.

Representatives of the TxDOT Human Resources Division say the best way to be prepared to access ERS Online for the summer enrollment is to ensure ahead of time that an employee's password in ERS is correct and current.

They also say the following steps will help:

1. Access the ERS Web site ([www.ers.state.tx.us](http://www.ers.state.tx.us)) either through TxDOT intranet, or through the Internet.

2. Click on ERS Online, which is one of the buttons located in the left column of the ERS home page.

3. Never used ERS Online? Forgotten the password? Follow the

instructions to request a password. ERS will send a password by mail, which enables members to enter an e-mail address if they have one. Users then can customize the password, and secure quick entry into ERS Online.

4. If necessary, call ERS at (512) 867-7711 (Austin), or (877) 275-4377 to request a password by mail.

The summer edition of For Your Benefit, a newsletter from ERS, will serve as the summer-enrollment guide. The newsletter will be sent electronically as soon as it is provided by ERS. Paper copies will be made available to those employees lacking computer access.

## HEALTH INSURANCE COSTS UP

The cost of premiums for health insurance covering state employees, retirees and dependents will increase Sept. 1.

The state will continue to pay the full premium cost on employee-only and retiree-only health coverage, including the increased cost of the coverage.

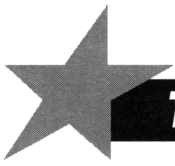
However, those employees who cover dependents will see an increase in out-of-pocket premiums. ERS says system members with coverage for dependents will get a tax break on the cost of the out-of-pocket premium amounts since those premiums are not subject to federal income or Social Security taxes through the automatic premium-conversion program.

For HealthSelect, the plan that covers 90 percent of ERS members, premiums will increase 5.13 percent.

HMO premiums will increase an average of 8.9 percent. The amount of the increase will be from 4.6 percent to 20.7 percent, depending on the specific HMO and geographic service area.

The state will continue to pay 50 percent of premiums for health insurance on dependents.

### TxDOT TIPS CAP

TxDOT is set to lead by example in the fight to reduce air pollution as it unveils a new program involving employees participating in the TxDOT Clean Air Plan (CAP).

The Environmental Affairs Division oversees the program. The division kicked off the program's pilot phase on June 1 and will evaluate it after Aug. 31.

The program aims to change employees' commuting habits and other routines of driving — even including the purchase of hybrid-power vehicles.

Further, TxDOT administration has directed districts, divisions and offices to select up to nine clean-air measures from an approved list of 30. The number of measures to be used depends on the level of air pollution in a given area.

The measures include choices such as using cleaner fuels, buying solar-power message boards, and not mowing TxDOT property or right of way on ozone-action days. All the measures are listed at the division's intranet site.

During the program's pilot phase, TxDOT employees serving as air-quality coordinators will encourage participation as well as collect and record data about implementation of the measures.

The program will award points to each of the measures, allowing participants to be recognized and rewarded for their efforts.

### TRANSPORTATION WEEK

The Texas Legislature designated May 16-22 as Texas Transportation Week to coincide with National Transportation Week and honor accomplishments in transportation. Most observances in the state were low-key, but transportation means big things in Texas. For instance, transportation enhancements and projects add 47,000 jobs to the Texas

economy for every \$1 billion in transportation dollars spent, says the U.S. Department of Transportation.

### TEXAS MUSIC FEATURED

TxDOT's Travel Division has produced a new guide for those on the road who hanker for Texas music. The booklet, *Sites and Sounds: A Texas Music Road Trip*, is offered at no cost to readers and blends travel by vehicle with Lone Star music.

Walker, a senior travel counselor with TxDOT, received the 2004 Roadrunner Award for outstanding service to the traveling public, TxDOT and the state.

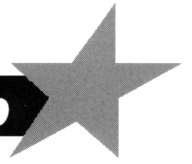

TxDOT Executive Director **Mike Behrens** has been appointed by the governor to the Texas Incentive and Productivity Commission. The panel administers and promotes programs offering state employees incentives, rewards and recognition for ideas that enhance efficiency and productivity. His term expires Feb. 1, 2006.

### **GROUP PRAISES TxDOT**

For reducing lost-time injuries and the rate of vehicle incidents, the Texas Safety Association recognized several TxDOT districts in San Antonio at the Public Employees Awards Ceremony in late March.

TxDOT districts recognized are El Paso, Paris, Wichita Falls, Amarillo, San Angelo, Lubbock, Waco, Tyler, Lufkin, Houston, Austin, Dallas, Atlanta, Beaumont, and Childress.

The non-profit association was established in 1938 to help conserve human life and property in every field of safety and health maintenance. The ceremony was part of the association's 65th annual Southwest Conference and Expo.

### **SAFETY CAMPAIGN RENEWED**

Texas again took part in the national Click It or Ticket program from May 24 to June 6 to get more motorists to buckle up. This year the campaign, covering the Memorial Day holiday, focused on getting drivers of pickups to use safety belts.

TxDOT reports that the use of safety belts in Texas increased last year from 81 percent to almost 85

percent. Campaign officials credit the improvement to the campaign's combination of advertising and stepped-up enforcement of the state's laws requiring use of safety belts and child-safety seats. They also say the campaign has saved lives.

Beginning in early May, an outdoor display promoting use of safety belts was placed in front of the TxDOT main office building in Austin. It features a Texas-size safety belt across a large-scale outline of the state.

### **AWARD FOR 'CLICK IT' VIDEO**

A video public-service announcement, "Police Everywhere," received first place in the professional production category at the late-April conference in San Diego, Calif., of Operation CARE (Combined Accident Reduction Effort).

Submitted by the Texas Department of Public Safety, the entry promotes the use of seat belts and child-safety seats through the Click It or Ticket publicity campaign. Sherry Matthews Advocacy Marketing in Austin produced the video through a grant from TxDOT.

### **NHTSA HONORS JACQUE**

The National Highway Traffic Safety Administration recently honored **Jacque Saburido** for her service to the public.

As a concerned citizen and victim of a drunk driver, Saburido has worked with TxDOT to support traffic-safety efforts.

The award cited her for "working tirelessly in the public spotlight despite injuries and pain, and exerting valiant and relentless effort to keep impaired driving tragedies from happening to others."

Saburido and 12 others received the awards on March 29 at a conference on highway-safety priorities in San Diego. Terry Pence, director of TxDOT's Traffic Safety Program, attended.

"She's one of my heroes," Pence

said, commenting on Saburido's perseverance. "She's doing an awesome job."

### **PARTNERS IN ITS DRAW KUDOS**

Like air traffic controllers, technicians at Austin's new Combined Traffic Emergency Communications Center rarely are seen, but they are there keeping watch over the city's highways.

The center, from which traffic on major roadways in the Austin area is monitored, recently received the first-place award for public partnership at the national ITS America convention in San Antonio. ITS is short for intelligent transportation system.

TxDOT involved other agencies from the center's conception rather than inviting them to participate after the facility was built. Along with TxDOT, other agencies recognized are Travis County, City of Austin, and the Capital Metropolitan Transportation Authority. The agencies worked together before construction began to decide how best the needs of each could be served.

"I am very proud to accept the award on behalf of everyone who has worked so hard to make this project become a reality," said **Brian Burk**, a TxDOT transportation operations engineer. "A lot of people have put in an enormous amount of effort into building this facility and the people of Austin are the beneficiaries."

Intelligent transportation systems provide real-time traffic data to the center, which then provides the information to motorists via radio, electronic message boards, and dynamic lane-assignment markers. The center also can serve as a command facility when needed.

### **CAREER DAYS SITE HAILED**

# Close call

## Work-zone crash narrowly misses TxDOT inspectors; contractors injured

With a truck barreling toward them, all the two TxDOT inspectors had time to do before they jumped a guardrail to get out of the way was shout a warning to nearby contractors.

Their shouts were not enough, though, to prevent the late-April collision or to keep the workers from injury.

Inspectors Victor Songer and Larry Gipson, with the Dallas District, had joined contractors in the work zone on Interstate 35 East, nine miles south of Waxahachie in Ellis County. The lane was marked with barriers, orange barrels and cones — all indi-

cating the lane was closed.

Suddenly, Songer saw and Gipson heard a truck coming up the closed lane. The vehicle, a car carrier with tires squealing, came directly at them and the contractors.

As the inspectors jumped the guardrail, both hoped the truck would pull back into the travel lane. It never did.

The truck went through the barriers, hit an asphalt machine, and threw the four contractors working on or near the spreader in different directions. All were hurt, one of them seriously.

The crew chief and one worker, both in the north lane of the work zone, were down. The worker next to the crew chief was thrown farther



up the closed lane.

The most seriously injured contractor had been atop the spreader. He was thrown from the spreader into the rear of a dump truck with such force that it broke his hardhat when he hit. He came to rest on the other side of the guardrail that Gipson and Songer had jumped. Injuries included a fractured skull, broken collarbone, punctured lung, a gash in his forehead, and a deep gash on his neck. He was airlifted to a nearby hospital where he stayed for several days.

Many weeks later, all are recovering from their wounds but the crew chief faces more spinal surgery.

Songer and Gipson, TxDOT construction inspectors for four

# 123 Safe Days of Summer

TxDOT's annual *123 Safe Days of Summer* program has begun its eighth season. This program heightens safety awareness and emphasizes safety on roadway work sites during

the busiest time of the year.

As in past years, the Occupational Safety Division has set a theme for the program that highlights workplace safety May through August. This year's emphasis is "Back to Basics."

With the program, the division renews its challenge to each TxDOT district, division and office to have a summer free of incident and injury. Division officials remind that the campaign's success relies on each employee ensuring that this is

years, say the experience was their first close call. They hope it's the last.

"When I heard the sound of squealing tires, I didn't even think about it," Gipson says. "I yelled to (Songer) and we headed for safety. We jumped over the guardrail."

Songer says he had been looking at the flagger every so often to see how traffic was flowing. "When I looked up again I saw the truck veer out of the travel lane," he says.

When the vehicle hit the barricades, Songer jumped the guardrail. "If I hadn't been looking up, he probably would have gotten me," Songer says.

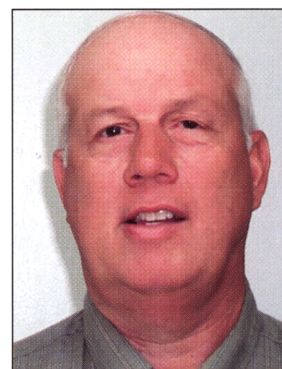
Gipson echoes Songer: "We were lucky we weren't on a bridge

because, if we had been, there would have been no place to go. We might not be here now."

Road construction is considered one of the most dangerous jobs in the country. Distracted drivers and speeding vehicles nearby add to the danger.

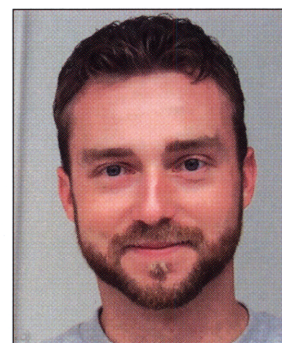
In 2002, Texas led all states with 192 fatalities in work zones and has led the nation in work zone fatalities for 10 years.

Gipson and Songer both feel that those who have a narrow escape in a work zone go back to their jobs changed. They work as before, they say, but in the back of their minds there is a gnawing doubt they may not be as lucky next time. ☘

the safest summer in TxDOT history.

The TxDOT district achieving the greatest reduction in injuries and vehicle incidents and showing overall improvement receives an award at the annual transportation

conference in October.

Because of the seasonal increase in traffic, potential grows for more collisions and injuries during the summer. Most of this increased traffic can be linked to the increase in work on roads, a higher volume

of traffic, and the many new employees hired for the summer.

New employees and summer hires are in a high-risk group for injuries and collisions because of their limited experience. Veteran

employees, if they become complacent, also face increased risks.

As part of the department's year-round attention to safety, the division asks employees, supervisors and managers to focus on these basic practices of safety at work.

## SEAT BELTS

The *Handbook of Safe Practices* directs that "Seat belts, when installed, shall be used in all vehicles and off-road equipment. This includes all vehicles, regardless of ownership, when used on state business. No employee is exempt from wearing a seat belt, if a belt is provided. This includes passengers in rear seats. Original seat-belt equipment installed by the manufacturer shall not be removed from any department vehicle or equipment for the purpose of not having the belt available for use."

TxDOT has experienced several recent cases in which employees were involved in collisions and were thrown from the vehicle because they weren't using a seat belt. Use of seat belts is not just department policy; it is a state law.

## PROTECTIVE EQUIPMENT

Policies and procedures outlined in the *Occupational Safety Manual* and the *Handbook of Safe Practices* apply to all TxDOT employees.

Protective equipment commonly required for TxDOT operations is described below. Other protective equipment such as respirators, hearing protection, and aprons may be required for specific exposures.

Specific requirements for use, availability, reimbursement, and more can be found on the TxDOT intranet in the *Occupational Safety Manual*, Chapters 4, 5 & 7.

Employees should work with supervisors and safety coordinators to make sure all appropriate protective gear is available for the assigned task.

**Hard hats** — Employees and vis-

itors shall wear white, safety-rated, department-approved hard hats when outside the vehicle at all outdoor worksites. This includes employees and visitors who occasionally visit worksites on either the highway surface or right of way. This also applies when working in areas where there is a danger of head injury from impact, falling or flying objects, electrical shock or burns. Further, the policy applies when performing any task requiring safety-hat protection as described elsewhere in the department's *Safety Standards and Safe Practices*.

**Safety vests** — Employees and visitors shall wear TxDOT-approved safety vests when outside the vehicle at all outdoor work sites. This includes employees/visitors who occasionally visit work sites on either the highway surface or right of way. Also, vests shall be worn when performing any task requiring such protection as described elsewhere in the department's *Safety Standards and Safe Practices*.

**Safety footwear** — Safety footwear shall be worn while working on the right of way or road surface, in shops or warehouses, during material-handling or mowing operations, or during any activity or in any environment that would increase the likelihood of foot injury. Shoes or boots are available through the TxDOT warehouse system. Also, employees can be reimbursed for purchasing shoes or boots on their own.

**Protective eyewear** — Safety eyewear should be worn when there is a potential for eye injury. TxDOT provides several options for eye protection, including a reimbursement option for prescription safety glasses.

**Gloves** — Several styles of gloves are provided and should be worn when working with hazardous materials, electrical hazards, or when hands are exposed to possible injury from impacts, cuts, or abrasions.

**Sun-block lotion** — Sunscreen

should be applied each morning and re-applied as necessary throughout the day.

## LIFTING PROPERLY

Employees should use mechanical lifting devices or other alternatives (smaller packaging), when and where possible. Employees should ask for help lifting, if needed.

## EXITING EQUIPMENT

Employees shall use a three-point hold while exiting or entering equipment.

## SAFETY LEADERSHIP

Construction and maintenance supervisors and crew leaders must ensure that a safety orientation is provided to all new and summer employees, including the completion of Form 1746, Drivers' Orientation and Evaluation Certification

Also, they should conduct a brief safety review (5 to 10 minutes) or tailgate meeting every morning to discuss the activities planned for that day. This meeting establishes the game plan for reducing incidents and injuries, and should cover items such as required protective gear, traffic control, and potential hazards.

## SAFETY MEETINGS

Conducted during the *123 Safe Days of Summer* program, these meetings are essential to the safety and health of every TxDOT employee. Summer safety meetings should address high-exposure areas, collision prevention, and incidents from past summers.

Training videos from TxDOT should be used to supplement the information covered in the safety meetings. Titles for these videos include *123 Safe Days of Summer*, *Mobile Work Zone Operations*, *TxDOT Backing Safety*, *Defensive Flagging: A Survivor's Guide*, and *TxDOT: Defensive Driving*. A list of all safety videos available for checkout is on the division's intranet site. ☘

# Work-zone deaths increase in Texas

- An increase in the number of highway work-zone deaths in Texas has prompted state transportation officials to ask motorists to use caution and heed warning signs in construction areas.

Texas reported 192 highway work zone fatalities in 2002, up from 140 in 2001.

The recent release of the figures came on the eve of National Work Zone Awareness Week (April 4 – 10), giving transportation officials an opportunity to get the message out about the increase in deaths in highway work zones.

“We are striving to lower this troubling statistic by developing additional safety measures and supporting research dealing with work zones,” said Mike Behrens, TxDOT executive director. “We hope motorists will do their part to increase safety.”

In recent years, highway work zones have been improved through the use of plastic construction barrels, signs and barricades. These are designed to reduce damage to vehi-

cles and injury to drivers.

Besides protecting workers from traffic, portable concrete barriers and crash cushions also protect drivers from dangers such as steep drop-offs and construction equipment.

TxDOT workers now wear safety vests with reflective material all the way around, rather than just the front and back. The vests increase the visibility of the flaggers and maintenance crews.

TxDOT has begun using prismatic fluorescent-orange coloring on all work-zone signs and safety devices in all new highway work zones in Texas. The fluorescent coloring makes work-zone signs more visible during dawn, dusk and nighttime and in fog.

Texas, which has led the nation in deaths in highway work zones since 1994, was followed in 2002 by California (119), Georgia (118), Florida (87), New York (60), North Carolina (47), Arkansas (40), Tennessee (38), Pennsylvania (33) and Alabama (33).

Deaths in highway work zones

have increased 70 percent since 1997, according to federal data recently posted at the National Work Zone Safety Information Clearinghouse.

The data, compiled by the National Highway Traffic Safety Administration, show that 1,181 people died in roadway construction zones in 2002 — an increase of 102 deaths compared to 2001 figures.

Motorists can increase safety in work zones several ways:

- Stay alert and give full attention to the roadway, signs and workers in work zones.
- Turn on headlights to make the vehicle more visible.
- Never tailgate or speed.
- Slow to the posted limits, even if workers are not visible.
- Never change lanes in work zones.
- Minimize or eliminate distractions such as cellular phones and onboard navigation systems.
- Expect the unexpected in a roadway work zone.
- Lastly, be patient. ☆

## RUMBLE strips help TxDOT save lives

**You're behind the wheel of an automobile — tired, sleepy, distracted.**

**Suddenly, a loud RUMBLE assaults your hearing.**

**The steering wheel vibrates.**

**You snap to attention.**

**What happened?**

**TxDOT rumble strips may just have saved your life.**

The Federal Highway Administration reports that run-off-the-road accidents account for a third of all traffic deaths in the United States. In 2000, almost 16,000 traffic deaths were attributed to this type crash at a taxpayer cost of almost \$80 billion.

Fatigue, drowsiness and driver inattention play a big part in these single-vehicle crashes. In 1998, the National Sleep Foundation reported that more than 52 percent of all adults surveyed in the past year had driven a vehicle while feeling drowsy.

TxDOT is addressing this problem with rumble strips. When tires cross these raised or grooved pat-

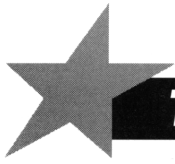
terns along the edges of a roadway, drivers hear a loud rumble and feel a strong vibration that alerts them they are leaving the main lane.

Research indicates rumble strips can reduce run-off-the-road crashes by up to 50 percent.

The strips cost less than 12 cents a foot and are installed either during initial construction or later.

TxDOT often puts rumble strips along rural interstate and multi-lane divided highways, which tend to have a higher incidence of one-car accidents.

Further, TxDOT is researching the use of center-line rumble strips to help prevent head-on collisions on undivided highways. ☆

**Huggins**, administration director, and **Brad Tate**, information-resource support specialist, for the design and maintenance of a Web site for Construction Career Days.

Humberto Martinez, FHWA associate director of professional development, presented plaques to Huggins and Tate in appreciation for their support and promotion of the Construction Career Days events that allow students to interact with construction employers and equipment.

Career-day events are part of a nationwide initiative that promotes the construction industry to prospective high school students.

"Our message has had a positive impact on hundreds of thousands of students, and strengthened the industry that stands at the heart of our nation's unequalled mobility," Martinez said. "The Web site has opened up communication between members around the country."

Under the direction of Huggins, the Fort Worth District sponsored Construction Career Days for four years, including 1999 when the first event was held in Lewisville. Since then, more than 104,000 students from 22 states have experienced Construction Career Days.

### Annual aviation awards

TxDOT presented a variety of awards at the 22nd annual Aviation Conference held recently in Austin.

The Brenham Municipal Airport was named the 2004 Airport of the Year. Owned by the City of Brenham, the airport was recognized for various improvements allowing it to remain a vital asset to the community.

TxDOT hosted the conference with the Texas Airport Management Association. Participants included airport managers, city and county officials, and the Federal Aviation Administration.

The Dallas Executive Airport, a 1,000-acre facility owned and operated by the city of Dallas, was named 2004 Reliever Airport of the Year.

Since 1998, more than \$8 million in private investments have been committed to the development of the airport.

Airport administrators developed a program that includes construction of a new terminal building and air-traffic control tower. Improvements are planned for pavements, fencing, signing, lighting, and the electrical system.

The Coleman Municipal Airport was named the 2004 Most Improved Airport of the Year.

The city-owned facility is a public-use general aviation airport that supports the local economy and community. It provides several community-based services and programs to enhance the health, safety, welfare, and quality of life of area citizens.

Coleman Municipal Airport recently completed a capital improvement program in which all the existing pavement surfaces were rehabilitated and painted. A terminal redesign, hangar rehabilitation, installation of security fencing, and remodeling of the pilot's lounge were also among the improvements.

Isabelle Blanchard, who manages the Pecos Municipal Airport, was hailed as the 2004 Airport Manager of the Year.

She oversaw the \$1.6 million reconstruction project making pavement improvements to the Pecos Municipal Airport in 2002.

A licensed pilot since she was 18, Blanchard works with the Young Eagles youth-aviation group and pilots. She also teaches flight instruction at the airport.

Three students from different age groups were hailed as winners in the 2004 International Aviation Art Contest. Winners included Brooke Campbell of Princeton Elementary in Princeton, Jessie Kelly of Holy Trinity Catholic School in

Grapevine, and Alice Xu of Cinco Ranch High School in Katy.

Winners received a certificate. The theme of this year's art contest was "Flying Saves Lives."

The National Aeronautic Association, the National Association of State Aviation Officials, and the Federal Aviation Administration (with the Federation Aeronautique Internationale), sponsor the contest designed to motivate and encourage young people to become more familiar with and participate in aeronautics, engineering and science.

### NEWS NOTES ...

■ Bryan District reports that in March the Washington County maintenance employees planted a live-oak tree in memory of supervisor Kendal Mosley, who died in October 2003. They planted the tree on the hillside next to the Washington County welcome monument on U.S. 290 East.

■ Texans observed the 19th annual Don't Mess with Texas Trash-off in April with more than 22,000 volunteers and 1,400 groups participating. The annual clean-up effort, in partnership with Keep Texas Beautiful, removes trash from roadways and brightens the state for all comers. Sponsored by TxDOT's Travel Division, the trash-off features advertising, a state-wide road tour with an attention-grabbing vehicle and a cleanup of 16 college campuses in a first-ever event sponsored by Dairy Queen.

■ TxDOT's 2003 Report on Texas Bridges, now available to the public, found that 75 percent of all Texas bridges have a good condition rating, up five percent from 2000.

Last year, TxDOT contracted projects to upgrade 169 structurally deficient bridges and 78 functionally obsolete bridges. ☆



# TxDOT tests use of Internet at rest areas

Texas is going “wi-fi,” becoming the first state in the nation to provide free wireless access to the Internet at its safety-rest areas.

TxDOT began experimenting with wireless Internet service last fall, when the department provided the capability at twin rest areas on U.S. 287 in Donley County. Free wireless service also is available at two rest areas on the same highway in Hardeman County.

“The feedback we’ve received so far has been very positive,” said Andy Keith, who manages the safety-rest area program with the TxDOT Maintenance Division.

“Texas highways are seeing an increasing number of business travelers, truckers and RVers — and access to e-mail is important to them,” Keith says. “They have really responded favorably to our four ‘hot spots’ on U.S. 287.”

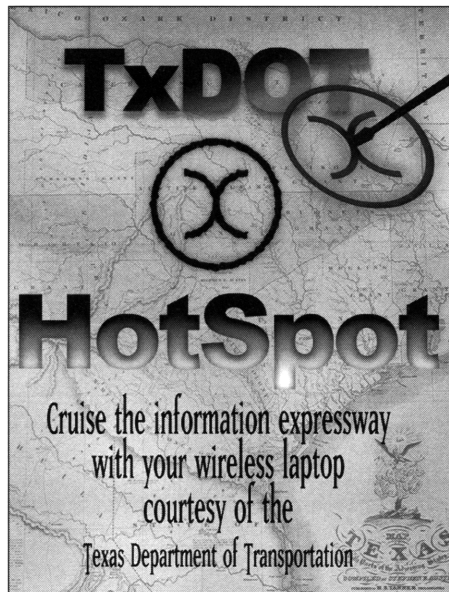

TxDOT has taken a first step to expand the service to its 84 safety-rest areas and 12 travel-information centers by seeking vendors able to provide free wireless Internet service. Vendors would recover the cost of this free service by charging users for pay-phone-like Internet access at indoor kiosks.

Keith said he envisions computers in the kiosks being available in 15-minute increments by swiping a credit card through a reader. But wireless access, he says, will be free for anyone with their own equipment.

“Over 50 million people a year visit our rest areas,” Keith said. “When we get this program up and running, anyone with wireless-equipped laptops or other devices will be able to send e-mail or browse the Internet for free at our safety-rest areas and travel-information centers. People not traveling with wireless equipment will be able to connect to the Internet at kiosks for a reasonable fee to be collected by the vendor.”

“We think this will be a huge

win-win for Texas travelers,” Keith said. “Knowing free Internet service is available at our rest areas will get drivers to make regular stops. Since fatigue is a factor in 1.5 percent of all crashes, anything we can do to get people to pull off the road and take a break is going to make our highways safer.”

An estimated 1,500 people die in fatigue-related crashes each year in the United States, according to the National Highway Traffic Safety Administration. An additional 77,000 are injured.

In Texas in 2001, the latest year for which the Texas Department of Public Safety has figures, 256 fatal crashes in which the driver was listed as fatigued or asleep were reported. In addition, 4,558 injury accidents attributable to fatigue occurred that year.

Any firm in the business of providing wireless Internet service has until 3 p.m. June 25 to make an offer to TxDOT for evaluation. TxDOT will then review the offers and award a contract.

“The safety-rest areas are there to make the roadways safer for today’s traveling public,” Keith said.

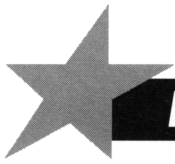
“Wireless Internet access meets the modern traveler’s needs so we want this to happen as quickly as possible.” ★

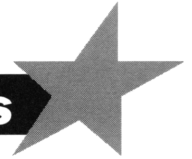
I was crossing the causeway between Portland and Corpus recently when my tire blew on my car. I was unable to pull off immediately due to construction.

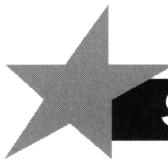

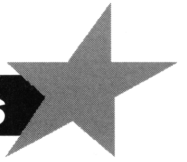
