- 4 PROTECTIVE SERVICES CASE. A parent may enter into an authorization
- 5 agreement with a relative or other person with whom a child is
- 6 placed under a parental child safety placement agreement approved
- 7 by the Department of Family and Protective Services to allow the
- 8 person to perform the acts described by Section 34.002(a) with
- 9 regard to the child:
- 10 (1) during an investigation of abuse or neglect; or
- 11 (2) while the department is providing services to the
- 12 parent.
- SECTION 4. This Act takes effect September 1, 2011.
