| 13 | (2) gifts and grants contributed to the fund; |
| 14 | (3) the earnings of the fund; [and] |

| 16 | lottery game operated under Section 466.027 or transferred to the |
| 17 | fund under Section 466.408(b); and |
| 18 | (5) [(2)] money deposited to the credit of the fund |

| 20 | SECTION 2. Section 502.1746, Transportation Code, is |
| 21 | amended by amending Subsection (b) and adding Subsections (c), (d), |
| 22 | and (e) to read as follows: |

- (3) provide an opportunity for a person to contribute

- 26 SECTION 3. The change in law made by this Act to Section
- 27 502.1746, Transportation Code, applies only to a motor vehicle

registration renewal notice issued for a registration that expires

2 on or after January 1, 2012.

SECTION 4. This Act takes effect immediately if it receives 3

a vote of two-thirds of all the members elected to each house, as

provided by Section 39, Article III, Texas Constitution. If this

Act does not receive the vote necessary for immediate effect, this
