4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. The heading to Chapter 55, Occupations Code, is
6 amended to read as follows:

7 CHAPTER 55. [~~RENEWAL OF~~] LICENSE WHILE ON MILITARY DUTY AND FOR
8 MILITARY SPOUSE

9 SECTION 2. Chapter 55, Occupations Code, is amended by
10 adding Section 55.004 to read as follows:

11 Sec. 55.004. ALTERNATIVE LICENSE PROCEDURE FOR MILITARY
12 SPOUSE. (a) A state agency that issues a license shall adopt rules
13 for the issuance of the license to an applicant who is the spouse of
14 a person serving on active duty as a member of the armed forces of
15 the United States and:

16 (1) holds a current license issued by another state
17 that has licensing requirements that are substantially equivalent
18 to the requirements for the license; or

19 (2) within the five years preceding the application
20 date held the license in this state that expired while the applicant
21 lived in another state for at least six months.

22 (b) Rules adopted under this section must include
23 provisions to allow alternative demonstrations of competency to
24 meet the requirements for obtaining the license.

1 (c) The executive director of a state agency may issue a
2 license by endorsement in the same manner as the Texas Commission of
3 Licensing and Regulation under Section 51.404 to an applicant
4 described by Subsection (a).

5 SECTION 3. This Act takes effect immediately if it receives
6 a vote of two-thirds of all the members elected to each house, as
7 provided by Section 39, Article III, Texas Constitution. If this
8 Act does not receive the vote necessary for immediate effect, this
9 Act takes effect September 1, 2011.
