- 5 Government Code, as amended by this Act, applies only to an approval
- 6 of a plat filed:
- 7 (1) on or after the effective date of this Act; or
- 8 (2) before the effective date of this Act if the plat
- 9 has not received final approval before the effective date of this
- 10 Act.
- 11 SECTION 3. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2011.
