5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

6 SECTION 1. Subsections (b) and (c), Section 74.0032,
7 Agriculture Code, are amended to read as follows:

8 (b) If adverse weather conditions or other good cause
9 exists, the administrative committee that governs the applicable
10 pest management zone may request that the department grant an
11 extension of the cotton stalk destruction deadline for any
12 specified part of the pest management zone or for the entire pest
13 management zone. A request under this subsection must be made
14 within the period specified by department rule [~~not later than 10~~
15 ~~business days before the applicable cotton stalk destruction~~
16 ~~deadline~~]. A field is not subject to a hostable cotton fee if the
17 department grants an extension of the deadline. The Texas Boll
18 Weevil Eradication Foundation shall submit to the department an
19 estimate of the amount by which an extension under this subsection
20 will increase the cost of administering the boll weevil eradication
21 program.

22 (c) If the applicable administrative committee does not
23 request an extension, or if the department denies a request for an
24 extension of the cotton stalk destruction deadline for a specified

1 part of a pest management zone, a cotton grower may apply for an
2 individual extension of the deadline. A request under this
3 subsection must be made within the period specified by department
4 rule [~~not later than 10 business days before the applicable pest~~
5 ~~management zone's stalk destruction deadline~~].

6 SECTION 2. The changes in law made by Section 74.0032,
7 Agriculture Code, as amended by this Act, apply only to a request
8 for an extension made on or after the effective date of this Act. A
9 request for an extension made before the effective date of this Act
10 is subject to the law in effect on that date, and that law is
11 continued in effect for that purpose.

12 SECTION 3. This Act takes effect September 1, 2011._____
