- 17 program. The certification is valid for two years from the date of
- 18 issuance. The attorney general shall also adopt rules establishing
- 19 minimum standards for the suspension, decertification, or
- 20 probation of a training program that violates this chapter.
- 21 (c) The attorney general shall adopt rules establishing
- 22 minimum standards for the certification of a sexual assault nurse
- 23 examiner and the renewal of that certification by the nurse
- 24 <u>examiner</u>, including standards for examiner training courses and for

- 1 the interstate reciprocity of sexual assault nurse examiners. The
- 2 certification is valid for two years from the date of issuance. The
- 3 attorney general shall also adopt rules establishing minimum
- 4 standards for the suspension, decertification, or probation of a
- 5 sexual assault nurse examiner who violates this chapter.
- 6 SECTION 3. Not later than December 1, 2011, the attorney
- 7 general shall adopt the rules required by Subsections (b) and (c),
- 8 Section 420.011, Government Code, as amended by this Act.
- 9 SECTION 4. This Act takes effect September 1, 2011.
