

AN ACT

relating to governmental and certain quasi-governmental entities subject to the sunset review process.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

ARTICLE 1. ENTITIES GIVEN 2013 SUNSET DATE

SECTION 1.01. WINDHAM SCHOOL DISTRICT WITHIN TEXAS DEPARTMENT OF CRIMINAL JUSTICE. Chapter 19, Education Code, is amended by adding Section 19.0021 to read as follows:

Sec. 19.0021. LIMITED PURPOSE REVIEW. (a) As part of its review of the Texas Department of Criminal Justice for the 83rd Legislature, the Sunset Advisory Commission shall conduct a limited purpose review of the structure, management, and operations of the Windham School District.

(b) The Sunset Advisory Commission shall include in the commission's report to the 83rd Legislature any recommendations relating to the Windham School District that the commission considers appropriate.

(c) This section expires September 1, 2013.

SECTION 1.02. TEXAS HIGHER EDUCATION COORDINATING BOARD. Section 61.0211, Education Code, is amended to read as follows:

Sec. 61.0211. SUNSET PROVISION. The Texas Higher Education Coordinating Board is subject to Chapter 325, Government Code (Texas Sunset Act). Unless continued in existence as provided by that chapter, the board is abolished and this chapter expires

1 September 1, 2013 [~~2015~~].

2 SECTION 1.03. TEXAS ETHICS COMMISSION. Section 571.022,  
3 Government Code, is amended to read as follows:

4 Sec. 571.022. SUNSET PROVISION. The commission is subject  
5 to review under Chapter 325 (Texas Sunset Act), but is not abolished  
6 under that chapter. The commission shall be reviewed during the  
7 periods in which state agencies abolished in 2013 [~~2015~~] and every  
8 12th year after that year are reviewed.

9 SECTION 1.04. TEXAS WINDSTORM INSURANCE ASSOCIATION.  
10 Subsection (b), Section 2210.002, Insurance Code, is amended to  
11 read as follows:

12 (b) The association is subject to review under Chapter 325,  
13 Government Code (Texas Sunset Act), but is not abolished under that  
14 chapter. The association shall be reviewed during the period in  
15 which state agencies abolished in 2013 [~~2015~~] are reviewed. The  
16 association shall pay the costs incurred by the Sunset Advisory  
17 Commission in performing the review of the association under this  
18 subsection. The Sunset Advisory Commission shall determine the  
19 costs of the review performed under this subsection, and the  
20 association shall pay the amount of those costs promptly on receipt  
21 of a statement from the Sunset Advisory Commission regarding those  
22 costs. This subsection expires September 1, 2013 [~~2015~~].

23 SECTION 1.05. TEXAS BOARD OF PROFESSIONAL ENGINEERS.  
24 Section 1001.005, Occupations Code, is amended to read as follows:

25 Sec. 1001.005. APPLICATION OF SUNSET ACT. The Texas Board  
26 of Professional Engineers is subject to Chapter 325, Government  
27 Code (Texas Sunset Act). Unless continued in existence as provided

1 by that chapter, the board is abolished and this chapter expires  
2 September 1, 2013 [~~2015~~].

3 SECTION 1.06. TEXAS BOARD OF ARCHITECTURAL EXAMINERS.

4 Section 1051.003, Occupations Code, is amended to read as follows:

5 Sec. 1051.003. APPLICATION OF SUNSET ACT. The Texas Board  
6 of Architectural Examiners is subject to Chapter 325, Government  
7 Code (Texas Sunset Act). Unless continued in existence as provided  
8 by that chapter, the board is abolished and this subtitle expires  
9 September 1, 2013 [~~2015~~].

10 SECTION 1.07. RAILROAD COMMISSION OF TEXAS. (a) Section  
11 81.01001, Natural Resources Code, is amended to read as follows:

12 Sec. 81.01001. SUNSET PROVISION. The Railroad Commission  
13 of Texas is subject to Chapter 325, Government Code (Texas Sunset  
14 Act). Unless continued in existence as provided by that chapter,  
15 the commission is abolished September 1, 2013 [~~2011~~].

16 (b) This section takes effect only if the 82nd Legislature,  
17 Regular Session, 2011, does not enact other legislation that  
18 becomes law and that amends Section 81.01001, Natural Resources  
19 Code, to extend the sunset date of the Railroad Commission of Texas.  
20 If the 82nd Legislature, Regular Session, 2011, enacts legislation  
21 of that kind, this section has no effect.

22 (c) The review of the Railroad Commission of Texas by the  
23 Sunset Advisory Commission in preparation for the work of the 83rd  
24 Legislature in Regular Session is not limited to the  
25 appropriateness of recommendations made by the commission to the  
26 82nd Legislature. In the commission's report to the 83rd  
27 Legislature, the commission may include any recommendations it

1 considers appropriate.

2 SECTION 1.08. PUBLIC UTILITY COMMISSION OF TEXAS.

3 (a) Section 12.005, Utilities Code, is amended to read as follows:

4 Sec. 12.005. APPLICATION OF SUNSET ACT. The Public Utility  
5 Commission of Texas is subject to Chapter 325, Government Code  
6 (Texas Sunset Act). Unless continued in existence as provided by  
7 that chapter or by Chapter 39, the commission is abolished and this  
8 title expires September 1, 2013 [~~2011~~].

9 (b) This section takes effect only if the 82nd Legislature,  
10 Regular Session, 2011, does not enact other legislation that  
11 becomes law and that amends Section 12.005, Utilities Code, to  
12 extend the sunset date of the Public Utility Commission of Texas.  
13 If the 82nd Legislature, Regular Session, 2011, enacts legislation  
14 of that kind, this section has no effect.

15 SECTION 1.09. ELECTRIC RELIABILITY COUNCIL OF TEXAS.

16 (a) Section 39.151, Utilities Code, is amended by adding  
17 Subsections (n) and (n-1) to read as follows:

18 (n) An independent organization certified by the commission  
19 under this section is subject to review under Chapter 325,  
20 Government Code (Texas Sunset Act), but is not abolished under that  
21 chapter. The independent organization shall be reviewed during  
22 the periods in which the Public Utility Commission of Texas is  
23 reviewed.

24 (n-1) Notwithstanding Subsection (n), an independent  
25 organization certified by the commission under this section is not  
26 subject to review in preparation for the work of the 83rd  
27 Legislature in Regular Session. This subsection expires September

1 1, 2013.

2 (b) This section takes effect only if the 82nd Legislature,  
3 Regular Session, 2011, does not enact other legislation that  
4 becomes law and that amends Section 39.151, Utilities Code, to  
5 subject an independent organization certified by the Public Utility  
6 Commission of Texas under that section to sunset review during the  
7 periods in which the commission is reviewed. If the 82nd  
8 Legislature, Regular Session, 2011, enacts legislation of that  
9 kind, this section has no effect.

10 SECTION 1.10. PORT OF HOUSTON AUTHORITY. Chapter 97, Acts  
11 of the 40th Legislature, 1st Called Session, 1927, is amended by  
12 adding Section 9 to read as follows:

13 Sec. 9. SUNSET REVIEW. (a) The Port of Houston Authority  
14 of Harris County, Texas, is subject to review under Chapter 325,  
15 Government Code (Texas Sunset Act), as if it were a state agency but  
16 may not be abolished under that chapter. The review shall be  
17 conducted as if the authority were scheduled to be abolished  
18 September 1, 2013.

19 (b) The reviews must assess the authority's governance,  
20 management, and operating structure, and the authority's  
21 compliance with legislative requirements.

22 (c) The authority shall pay the cost incurred by the Sunset  
23 Advisory Commission in performing a review of the authority under  
24 this section. The Sunset Advisory Commission shall determine the  
25 cost, and the authority shall pay the amount promptly on receipt of  
26 a statement from the Sunset Advisory Commission detailing the cost.

27 (d) This section expires September 1, 2013.

ARTICLE 2. ENTITIES GIVEN 2015 SUNSET DATE

SECTION 2.01. REGIONAL EDUCATION SERVICE CENTERS.

Subchapter A, Chapter 8, Education Code, is amended by adding Section 8.010 to read as follows:

Sec. 8.010. SUNSET PROVISION. Regional education service centers are subject to Chapter 325, Government Code (Texas Sunset Act). Unless continued in existence as provided by that chapter, the centers are abolished and this chapter expires September 1, 2015.

SECTION 2.02. FINANCE COMMISSION OF TEXAS. Section 11.108, Finance Code, is amended to read as follows:

Sec. 11.108. SUNSET PROVISION. The finance commission is subject to Chapter 325, Government Code (Texas Sunset Act). Unless continued in existence as provided by that chapter, the commission is abolished September 1, 2015 [~~2013~~].

SECTION 2.03. OFFICE OF BANKING COMMISSIONER. Section 12.109, Finance Code, is amended to read as follows:

Sec. 12.109. SUNSET PROVISION. The office of banking commissioner is subject to Chapter 325, Government Code (Texas Sunset Act). Unless continued in existence as provided by that chapter, the office is abolished September 1, 2015 [~~2013~~].

SECTION 2.04. OFFICE OF SAVINGS AND MORTGAGE LENDING COMMISSIONER AND THE DEPARTMENT OF SAVINGS AND MORTGAGE LENDING.

Section 13.012, Finance Code, is amended to read as follows:

Sec. 13.012. SUNSET PROVISION. The office of savings and mortgage lending commissioner and the Department of Savings and Mortgage Lending are subject to Chapter 325, Government Code (Texas

1 Sunset Act). Unless continued in existence as provided by that  
2 chapter, the office and department are abolished September 1, 2015  
3 [~~2013~~].

4 SECTION 2.05. OFFICE OF CONSUMER CREDIT COMMISSIONER.  
5 Section 14.066, Finance Code, is amended to read as follows:

6 Sec. 14.066. SUNSET PROVISION. The office is subject to  
7 Chapter 325, Government Code (Texas Sunset Act). Unless continued  
8 in existence as provided by that chapter, the office is abolished  
9 September 1, 2015 [~~2013~~].

10 SECTION 2.06. HEALTH AND HUMAN SERVICES COMMISSION.  
11 Section 531.004, Government Code, is amended to read as follows:

17 SECTION 2.07. TAX DIVISION OF THE STATE OFFICE OF  
18 ADMINISTRATIVE HEARINGS. Subsection (b), Section 2003.102,  
19 Government Code, is amended to read as follows:

20 (b) The Sunset Advisory Commission shall evaluate the tax  
21 division and present to the 84th [~~83rd~~] Legislature a report on that  
22 evaluation and the commission's recommendations in relation to the  
23 tax division.

24 SECTION 2.08. CONFORMING AMENDMENT RELATING TO FORMER TEXAS
